Welcome to the second annual Aspen Security Forum. Last summer's debut forum exceeded our expectations in every respect. In just one year, the Forum is firmly established as *the* "go to" event of the year for homeland security/counterterrorism professionals and those intensely interested in this field.

A number of things distinguish the Aspen Security Forum from the many other forums and conferences in this issue area. First is the wide range of topics covered and the breadth and depth of speakers who cover them. And, not incidentally, all sessions are on the record, so the information obtained can be widely shared and put to good use.

Fourth, the Forum takes place in a magical setting, amid the majestic mountains that surround our Aspen Meadows campus and cooled by the gentle breezes of a glorious Aspen summer. Like the dialogue, this bucolic setting is itself thought-provoking and mind-expanding.

And, unlike the typical conference in Washington and other big cities where speakers and attendees tend to come and go, Forum participants tend to "come and stay." This sustained participation leads to chance encounters and impromptu gatherings, at breaks, or over drinks or meals, and during long walks, that help to cement existing relationships and to build new ones with key decision makers and thought leaders.

We are delighted by your being with us for the Aspen Security Forum in this critical year marking the tenth anniversary of 9/11. The key question for the forum this year – and, I believe, for the nation as a whole – is whether our success in finding and killing Osama bin Laden is the beginning of the end of the "war on terrorism," or merely the end of the beginning, leading to a new, and perhaps even more dangerous phase in this now decade-long war. We look forward to exploring this overarching issue and many others with you as you settle in and engage with us for the next few days here at Aspen Meadows.

The program occasionally features government officials and other newsmakers for luncheon roundtable discussions about key homeland security/counterterrorism issues. ### Aspen Homeland Security Group

Modeled on the longstanding Aspen Strategy Group, a bipartisan group of foreign policy experts, the Aspen Homeland Security Group is a bipartisan group of homeland security and counterterrorism experts whom the program periodically convenes in Washington, DC and at our Aspen campus to discuss issues in depth and make recommendations to policymakers. The Aspen Homeland Security Group is co-chaired by former Secretary of Homeland Security Michael Chertoff and former Congresswoman Jane Harman.

### Roundtable on How the Venture Capital Industry Can Help to Secure the Homeland

In partnership with the Office of the Director of National Intelligence, Stanford University, and a Silicon Valley venture capital firm, Levensohn Venture Partners, the program convened Silicon Valley venture capitalists and key Washington decision makers in the homeland security and intelligence communities at Stanford in October, 2009 to discuss how the venture capital industry can play a greater role in founding and funding homeland security-related technologies. A follow-up discussion took place in October, 2010 in Cambridge, MA for Boston-area venture capitalists. The Homeland Security Program is planning additional discussions in other VC hubs around the country.

### Cities' Preparedness for Terrorism Roundtables

Thanks to a generous lead grant from the Ford Foundation, supplemented by additional grants from the Rockefeller Foundation, the McCormick Foundation, and the Houston Endowment, the program convened policymakers and leading thinkers in five cities—New York, Los Angeles, Chicago, Houston, and New Orleans—to assess those cities' preparedness for terrorism. 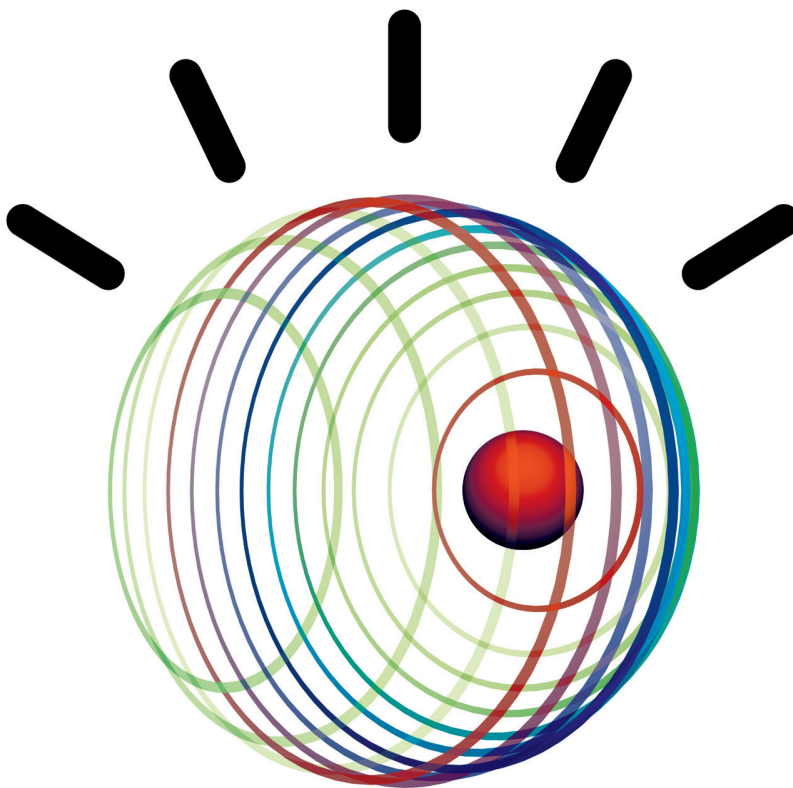

## A smarter planet is a more secure planet.

The digital instrumentation and global interconnection of our planet are generating a treasure trove of information. By one estimate, the volume of created content will quintuple in the next two years—to more than 2.5 zettabytes. This data can help us tackle broad, systemic problems and inefficiencies that have vexed the world for decades.

It also raises new challenges. According to the FBI, cybercrime is now more widespread than narcotics, and its techniques are evolving, its targeting becoming more focused. Further, as the digital and physical infrastructures of our world increasingly merge—infusing our power grids, banking systems, retail supply chains and city streets with intelligence—the question arises: are we now exposing them to the same risks as our Web sites?

Thankfully, the answer is no. The emerging “secure by design” model is based on how people, processes and technology come together in a unified system. It embeds protective measures and features at key points and uses high-speed data analytics to help uncover threats before attackers launch them.

# SPEAKER BIOGRAPHIES



**CHARLES E. ALLEN** is a principal at the Chertoff Group, where he focuses on homeland security threat assessments and information sharing programs, counter-terrorism and counter-proliferation threat analysis, critical infrastructure risk assessments, crisis and risk management, and corporate strategic planning. Prior to joining the Chertoff Group, Allen served as under secretary for intelligence and analysis as well as assistant secretary for information analysis and chief of intelligence at the US Department of Homeland Security. Allen also spent more than 40 years at the CIA, where he became the principal adviser to the Director of Central Intelligence on collection management and chaired the National Intelligence Collection Board. He served as CIA's national intelligence officer for warning, director of the national warning staff, national intelligence officer for counterterrorism, and deputy chief for intelligence of CIA's Counterterrorism Center. He also directed the DCI Hostage Location Task Force.



**ABDULLAH AL-SAIDI** was appointed ambassador of Yemen to the United Nations on July 22, 2002. Prior to his appointment, he served as his country's vice minister for foreign affairs. From 1997 to 1998, he was the director of law and treaties department at the ministry of foreign affairs, and from 1996 to 1998 he held the position of general director of the research department in the technical division of the Presidential Office. From 1986 to 1988, Al-Saidi was director of the deputy foreign minister's office. In 1997, he was a member of the Yemeni delegation to the United Nations Mission. From 1990 to 1991, he was a member of Yemen's delegation on the Security Council.



**DOUGLAS B. BAKER** is the co-founder and managing director of Monument Capital Group LLC, a private investment firm focused on the homeland and defense sector. Previously, Baker served as special assistant to President George W. Bush, where he was responsible for developing, managing programs, and evaluating

technologies that impact border and transportation security. Baker was associated with the law firm of Looper, Reed, Mark & McGraw in Houston, Texas. He practiced public and administrative law.



**RICHARD BARRETT** has been the coordinator of a New York-based team appointed by the United Nations Secretary-General in March 2004 to advise the Security Council on the effective development and implementation of a sanctions regime aimed at individuals and groups associated with Al-Qaida and the Taliban. He is also a member of the Secretary-General's Task Force, established in 2005 to promote a coherent approach to counter-terrorism within the United Nations. Within the Task Force he has particular responsibility for issues to do with radicalisation and extremism that lead to terrorism, terrorist use of the Internet, and terrorist financing. Before working for the United Nations he had a full career with the British government.



**DANIEL BENJAMIN** is the coordinator for counterterrorism at the US Department of State. Prior to his appointment, Ambassador Benjamin was director of the Center on the United States and Europe and a senior fellow at the Brookings Institution. He was a senior fellow at the Center for Strategic and International Studies and has served on the National Security Council staff and as a special assistant and speechwriter to President William J. Clinton. Before entering the government, he was a foreign correspondent for *TIME Magazine* and *The Wall Street Journal*. Ambassador Benjamin has co-written two books, *The Age of Sacred Terror* and *The Next Attack*, and he has published numerous articles in major news publications.



**RICHARD BEN-VENISTE** is a litigator who focuses on civil litigation and white collar criminal cases. He also advises organizations and individuals involved in congressional investigations. In 2009, Ben-Veniste served on a task force created by the secretary of the US Department of Homeland Security to assess the



national alert system and make recommendations for improvement. From 2003 to 2004, Ben-Veniste served as one of ten commissioners on the bipartisan National Commission on Terrorist Attacks upon the United States (9/11 Commission). Ben-Veniste also served as one of the lead prosecutors on the Watergate Special Prosecution Force and chief counsel (minority) of the Senate Whitewater Committee.



**PETER BERGEN** is the author of *The Longest War*, as well as *Holy War, Inc.*, and *The Osama bin Laden I Know* — both named among the best non-fiction books of the year by *The Washington Post*. He is CNN's national security analyst and a fellow at the New America

Foundation and New York University's Center on Law & Security. Bergen was an adjunct lecturer at the Kennedy School of Government at Harvard University in 2008, and he worked as an adjunct professor at the School of Advanced International Studies at Johns Hopkins University for several years.



**GARY BERNTSEN** is a 23-year veteran of the CIA's clandestine service and the best-selling author of *Jawbreaker: The Attack on Bin Laden and Al Qaeda*, and *Human Intelligence Counterterrorism and National Leadership*. He led the CIA's deployment after the East Africa

bombings and then in Afghanistan following the September 11, 2001 attacks. The CIA awarded Berntsen the distinguished intelligence medal and the intelligence star in 1998 and 2004. In 2006, Intelcon, a private sector supporter of the intelligence community, awarded him the first William F. Buckley Award for Leadership. In 2007-2008, Gary returned to Afghanistan as a civilian advisor to the 173rd Airborne Brigade Combat Team and worked against militant improvised explosive device (IED) networks.



**J. COFER BLACK** is vice president for global operations at Blackbird Technologies and an internationally recognized, 30-year career US government leader and expert in counterterrorism and national security. From 2005-2008, Ambassador

Black conducted international business development as vice chairman of Blackwater Worldwide and also served as chairman of Total Intelligence Solutions. During 2002-2005, at the Assistant Secretary of State level, he reported to the US Secretary of State for developing, coordinating, and implementing American counterterrorism policy as coordinator. He served a 28-year career at the CIA, reaching senior intelligence service level as director, Counterterrorist Center. He completed six successful operational CIA tours abroad in field management positions focusing on counterterrorism, but also addressing regional security issues, counterintelligence, and covert action.



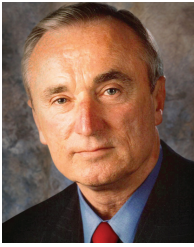
**DENNIS C. BLAIR** served as director of national intelligence from January 2009 to May 2010. He led 16 national intelligence agencies, administering a budget of \$50 billion and providing integrated intelligence support to the President, Congress, and operations in the

During his Navy career, Admiral Blair served as commander in chief, US Pacific Command. Ashore, he served as director of the joint staff and held budget and policy positions on the National Security Council and several major Navy staffs.

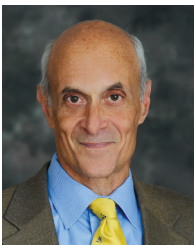

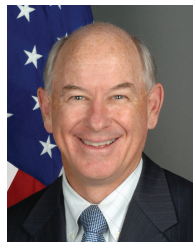

Earlier, as a federal prosecutor, he investigated and prosecuted cases of political corruption, organized crime, corporate fraud, and terrorism – including the investigation of the 9/11 terrorist attacks. In addition to his role at Chertoff Group, Chertoff is also senior of counsel at Covington & Burling LLP and a member of the firm's white collar defense and investigations practice group.



**JOSEPH CIRINCIONE** is president of Ploughshares Fund, a global security foundation. He previously served as vice president for national security and international policy at the Center for American Progress and director for nonproliferation at the Carnegie Endowment for International Peace. Cirincione worked for nine years in the US House of Representatives on the professional staff of the committee on armed services and the committee on government operations. He is the author of *Bomb Scare: The History and Future of Nuclear Weapons* and *Deadly Arsenals: Nuclear, Biological and Chemical Threats*. He is a member of the Council on Foreign Relations and he serves on the World Economic Forum global council on catastrophic risks.



**DAVID COLE** teaches constitutional law, national security, and criminal justice at Georgetown University Law Center. He is also a volunteer attorney for the Center for Constitutional Rights, the legal affairs correspondent for *The Nation*, and a commentator on NPR's "All Things Considered." He has been published widely in law journals and mainstream media, including the *Yale Law Journal*, *California Law Review*, *Stanford Law Review*, *New York Times*, *Washington Post*, *Wall Street Journal*, and *Los Angeles Times*. He is the author of six books, the most recent of which is *The Torture Memos: Rationalizing the Unthinkable* (2009).



**PHILIP J. (P.J.) CROWLEY** is the Omar Bradley chair of strategic leadership at Dickinson College, Penn State University Dickinson School of Law, and the Army War College. Across a 30-year government career, Crowley served as the assistant secretary of state for public affairs and spokesman for the US Department of State for the Obama administration and on National Security Council staff during the Clinton administration. He is a retired Air Force colonel. As a senior fellow at the Center for American Progress, he authored several studies on national security issues, including *Safe at Home*, a detailed strategy to protect the American homeland.



**GILLES DE KERCHOVE** is the European Union's counterterrorism coordinator. He was appointed to this position in 2007 by Javier Solana, the former secretary general of the council and EU high representative for the common foreign security policy. In this function, de Kerchove, a native of Belgium, coordinates the work of the council of the EU in the field of counterterrorism, maintaining an overview of all the instruments at the Union's disposal; closely monitoring the implementation of the EU counterterrorism strategy; fostering better communication between the EU and third countries; and ensuring that the Union plays an active role in the fight against terrorism.



**CLARK KENT ERVIN** is the founder and director of the Homeland Security Program at the Aspen Institute. He joined the Institute following his time in government as the Inspector General of the State Department and as the first Inspector General of the Homeland

Security Department. A graduate of Harvard and Oxford, Ervin is a member of Secretary Janet Napolitano's Homeland Security Advisory Council, and a member of the Commission on Wartime Contracting in Iraq and Afghanistan. Ervin is a regular commentator on CNN, MSNBC, ABC, and NPR; he has been cited as an expert in national and international publications like *TIME*, *The Wall Street Journal*, and *The Economist*; and his opinion pieces have appeared in *The New York Times* and *The Washington Post*. His 2006 book, *Open Target: Where America is Vulnerable to Attack*, was published by Palgrave Macmillan.



**MICHAEL FISHER** was named chief of the US Border Patrol in May 2010. Earlier, during his transition to the US Department of Homeland Security in March 2003, he was assigned as the deputy director for US Customs and Border Protection's Office of Anti-Terrorism in Washington,

DC. In this capacity, he staffed and directed the office during periods of increased threat and was CBP's liaison to the inter-agency intelligence community for anti-

terrorist planning and operations coordination. Fisher then served in Border Patrol headquarters before being assigned to the field in 2006 as the deputy chief in San Diego Sector. He was promoted to chief patrol agent of San Diego sector in June 2007.



**STEPHEN FLYNN** is the president of the Center for National Policy. He is also a consulting professor at the Center of International Security and Cooperation at Stanford University and a senior fellow at the Wharton School's risk management and decision

processes center at the University of Pennsylvania. He serves as a member of the bipartisan National Security Preparedness Group. In the fall of 2008, he served as the lead homeland security policy advisor on the Presidential Transition Team for President-elect Barack Obama. Flynn spent a decade as a senior fellow for National Security Studies at the Council on Foreign Relations where he authored the critically acclaimed *The Edge of Disaster: Rebuilding a Resilient Nation* (2007) and the national bestseller *America the Vulnerable* (2004).



**ROBERT GALLUCCI** became president of the John D. and Catherine T. MacArthur Foundation on July 1, 2009. Previously, he served as dean of Georgetown University's Edmund A. Walsh School of Foreign Service for 13 years. He completed 21 years of government service, serving

since August 1994 with the US Department of State as ambassador at large. In March 1998, the State Department announced his appointment as special envoy to deal with the threat posed by the proliferation of ballistic missiles and weapons of mass destruction. He held this position, concurrent with his appointment as dean, until January 2001.



**MEGAN GARCIA** has been a fellow in the President's office at the William and Flora Hewlett Foundation since 2010, where she manages the foundation's nuclear security initiative, a portfolio of grants aimed at increasing nuclear security. Before that, she worked as legislative assistant to US Congresswoman Jan Schakowsky, where she was responsible for a portfolio of issues including national security, foreign affairs, international trade, and homeland security. While working for Congresswoman Schakowsky, Megan became an expert on private security contracting and civilian-military engagement. She was a policy fellow for US Senator Sherrod Brown during his time in the House of Representatives, a consultant to USAID's Office of Military Affairs, and worked for Public Citizen California.



**ALBERTO R. GONZALES** was sworn in as the nation's 80th Attorney General in February 2005. Prior to serving at the US Department of Justice, he was commissioned as White House counsel to President George W. Bush in January 2001. Before that, he served as a justice of the Supreme Court of Texas. Prior to his appointment to the Texas Supreme Court in 1999, he served as Texas' 100th Secretary of State from December 2, 1997 to January 10, 1999 and as the general counsel to Governor Bush for three years.



**STEPHEN J. HADLEY** served as the assistant to the president for National Security Affairs until 2009. He was the assistant to the president and deputy national security adviser, serving under National Security Adviser Condoleezza Rice until 2005. From 1989 to 1993, Hadley served as the assistant secretary of defense for international security policy under then-Secretary of Defense Dick Cheney. Prior to this position, Hadley was counsel to the Tower Commission in 1987 and served on the National Security Council from 1974 to 1977. During his professional career, Steve has served on a number of corporate and advisory boards, most recently as co-chair of the 2010 Quadrennial Defense Review Independent Panel.



**EKLIL HAKIMI** is Afghanistan's Ambassador to the United States. He was appointed by Hamid Karzai, president of the Islamic Republic of Afghanistan, to play a major role in facilitating and assisting with the massive reconstruction efforts that lie ahead. In 2005, Ambassador Hakimi was appointed as ambassador extraordinary and plenipotentiary of Afghanistan to the People's Republic of China, while serving as non-resident ambassador to Mongolia and Socialist Republic of Vietnam. He also served as Afghanistan's ambassador to Japan and was appointed as deputy foreign minister for political affairs in 2010. He played an influential role in strengthening ties between donor countries and various ministries of Afghanistan, as well as in regional cooperation and integration through economic projects, diplomatic outreach, and coordination between regional and international actors.



**HUSAIN HAQQANI** is Pakistan's ambassador to the United States in Washington, DC. Previously, he served as a trusted advisor of late Pakistani Prime Minister Benazir Bhutto, a professor at Boston University, and co-chair of the Hudson Institute's Center on Islam, Democracy, and the Future of the Muslim World, as well as editor of the journal *Current Trends in Islamist Thought*. Ambassador Haqqani came to the US in 2002 as a visiting scholar at the Carnegie Endowment for International Peace in Washington, DC, and an adjunct professor at the School of Advanced International Studies at Johns Hopkins University. Also an accomplished journalist, Ambassador Haqqani has a syndicated column and has been published in numerous international publications.



**JANE HARMAN** resigned from Congress on February 2 to join the Woodrow Wilson Center as director, president, and CEO. Harman served on all the major security committees: armed services, intelligence, and homeland security. She has made numerous congressional fact-finding missions to hotspots around the world including Afghanistan, Pakistan, Yemen, and Guantanamo Bay, among others, to assess threats against the US. Harman received the Defense



Department Medal for Distinguished Service in 1998, the CIA Seal Medal in 2007, and the National Intelligence Distinguished Public Service Medal in March 2011. Prior to serving in Congress, she was a top aide in the US Senate, deputy cabinet secretary to President Jimmy Carter, and special counsel to the Department of Defense.



**MICHAEL V. HAYDEN** became director of the CIA in 2006 after nearly 40 years in the US Air Force. General Hayden served as director of the National Security Agency from 1999 to 2005. From April 2005 to May 2006, General Hayden served as deputy director of national intelligence

and oversaw the entire intelligence community, including the CIA, NSA, the National Geospatial-Intelligence Agency, and the National Reconnaissance Office. In his military career, General Hayden served as commander of the Air Intelligence Agency and director of the Joint Command and Control Warfare Center. He has also served in senior staff positions at the Pentagon, at the headquarters of the US European Command, and at the National Security Council.



**TIMOTHY J. HEALY** was appointed director of the Terrorist Screening Center in May 2009. Prior to being named TSC director, Healy served as an FBI special agent and as a program manager in the FBI Headquarters Economic Crime Unit, focusing on telemarketing

fraud. In 2000, he initiated the Internet Fraud Complaint Center and was promoted as its first unit chief. During the 9/11 terrorist attacks, Healy and his staff developed a website to receive online tips which became the basis for the "Submit a Tip" feature of the FBI's website. As a supervisory special agent, Healy developed a software system, GUARDIAN, to track suspicious activity, which was later adopted by FBI headquarters.



**BARRY HENSLEY** is the executive director, Counter Threat Unit<sup>SM</sup> (CTU) Research Group, Dell SecureWorks. Colonel Hensley was also the former director of the Army's global network operations and security center. In this capacity, he was responsible

for directing the operations and defense of the Army's portion of the global information grid. Hensley was also the director of operations, joint task force global network operations, Arlington, where he was responsible for the Department of Defense's global network operations center. Hensley has worked in a various leadership positions within the communications and information security career field throughout his 24-year Army career including assignments with US Special Operations Command and deployments to Saudi Arabia, Kuwait, Somalia, and Iraq.



**BRIAN MICHAEL JENKINS** is senior adviser to the president at the RAND Corporation and formerly served as chair of the political science department at RAND. In 1996, President William J. Clinton appointed Jenkins to the White House commission on aviation safety and security.

From 1999 to 2000, he served as adviser to the National Commission on Terrorism and in 2000 was appointed to the US Comptroller General's advisory board. He is a research associate at the Mineta Transportation Institute, where he directs the continuing research on protecting surface transportation against terrorist attacks. Jenkins is the author of *Will Terrorists Go Nuclear* (2008).



**KATHLEEN L. KIERNAN** is the CEO of Kiernan Group Holdings, an international consulting firm that supports public and private sector clients. She previously served as the assistant director for the Office of Strategic Intelligence and Information for the Bureau of Alcohol, Tobacco,

Firearms, and Explosives where she was responsible for the design and implementation of an intelligence-led organizational strategy to mine and disseminate data related to explosives, firearms, and illegal tobacco diversion, the traditional and non-traditional tools of terrorism. Dr. Kiernan served as the ATF representative to the counterterrorism center at CIA during 1993 to 1995. Dr. Kiernan is a special advisor to the director of the Combating Terrorism Task Force in the Department of Defense.



**MATI KOCHAVI** is founder and CEO of AGT International, a privately held group of companies that deliver advanced-technology security systems and intelligence solutions for governments and corporations around the world. From 1999 to 2001, Kusser served as a program officer at US Customs headquarters in Washington, DC, and from 1994 until 1999, as a US Customs inspector at the San Ysidro, California port of entry. He began his career with the US

Customs Service in 1991 as a cooperative education student in Los Angeles, California.



**MICHAEL E. LEITER** is the former director of the National Counterterrorism Center. He was sworn in as the director of the National Counterterrorism Center on June 12, 2008, after serving as the acting director since November 2007. In this role, Leiter reported to the DNI director. NCTC conducts strategic operational planning for counterterrorism activities to integrate all elements of US national power: in this responsibility Leiter reported to President Obama. Leiter has served in the office of the director of national intelligence, as a member of the WMD commission, and as an assistant US attorney for the Eastern District of Virginia. Additionally, he was a law clerk to US Supreme Court Justice Stephen Breyer.



**CARIE LEMACK** is the co-founder of Global Survivors Network, a global organization for victims of terror to speak out against terrorism and radicalization. Since launching GSN in 2009, she has coordinated and inspired events in Jordan, Pakistan, and Indonesia, produced the award-winning documentary *Killing in the Name*, spearheaded [www.globalsurvivors.org](http://www.globalsurvivors.org), and generated interest and coverage in media outlets worldwide. Lemack co-founded and led the nonprofit, nonpartisan organization, Families of September 11, after her mother, Judy Larocque, was killed in the attack. She is a visiting fellow at the Center on Global Counterterrorism Cooperation and a term member at the Council on Foreign Relations.



**STUART LEVEY** served as undersecretary for terrorism and financial intelligence at the US Department of Treasury under both the George W. Bush and Barack Obama presidential administrations. Before this position, Levey focused on counterterrorism and national security issues as the principal associate deputy attorney general at the US Department of Justice. Current work examines the intersection of finance and national security, especially the potential and the limits of

financial pressure as a tool of national security policy and the implications of that tool for the private sector.



**JACK LICHTENSTEIN** is the vice president for governmental affairs and public policy for ASIS International, overseeing its relations with Congress and the executive branch. Lichtenstein's public service was as an appointed official in the administrations of President

focused on the Middle East, covering the revolution in Egypt and filing special reports on American investment in Iran and women in Saudi Arabia and the UAE. Her documentary work includes "India Rising: The New Empire," "City of Money & Mystery," "The Russian Gamble," "On Assignment: Iraq," and "Dollars & Danger: Africa, The Final Frontier." Burnett is a member of the Council on Foreign Relations.



**MASSIMO CALABRESI** is a Washington correspondent for *TIME*. He has held many positions at *TIME*'s New York bureau, including national security correspondent and bureau chief. Calabresi was named White House correspondent in 2007 and national security

correspondent in 1999. He was part of the reporting team that won the National Magazine Award for single-issue coverage of the terrorist attacks of September 11, 2001. That year, he became *TIME*'s diplomatic correspondent, writing and reporting cover stories on Condoleezza Rice, Colin Powell, intelligence reform, and diplomacy. Prior to his tenure for *TIME* in Washington, DC, Calabresi was named bureau chief for Central Europe and the Balkans in 1995.



**KIMBERLY DOZIER** joined the Associated Press in 2010, covering intelligence and counterterrorism. Formerly a CBS News correspondent, she covered national security in Washington, DC, from 2007 to 2010, and worked primarily in Iraq from 2003 to 2006. In 14 years

overseas, her assignments included the Palestinian uprisings, Iraq under Saddam, the hunt for Osama bin Laden, the Kosovo refugee crisis, and the "troubles" in Northern Ireland. Her 2008 memoir *Breathing the Fire* detailed her recovery from the car bomb that hit her team in Baghdad in 2006. Profits from the fall 2011 paperback version go to wounded warrior charities.



**TOM FRANK** covers homeland security for *USA Today* in Washington, DC. He has been with the paper since late 2004, coming from *Newsday* where he spent seven years covering politics and government, first on Long Island and then in Washington. He has done four

reporting stints in Iraq and was an embedded reporter with the US Army during the 2003 invasion. He also has worked at the *Denver Post*, *Providence Journal*, and *Easton (Pa.) Express*. He teaches journalism at the University of Maryland and is a graduate of Wesleyan University in Connecticut. He lives in Washington, DC.



**JOSH GERSTEIN** is a White House reporter for POLITICO who specializes in legal and national security issues. Gerstein has reported extensively on how President Barack Obama's pledge to close the Guantanamo Bay prison for war-on-terror captives went awry, the Obama

administration's little-heralded crackdown on leaks, and the surprisingly icy relationship between the press and the Obama White House. Gerstein is a former White House correspondent and Beijing correspondent for ABC News, who reported for the network from Afghanistan and Pakistan. He also worked for CNN's investigative unit and as a national reporter for *The New York Sun*.



**SUSAN GLASSER** is editor in chief of *Foreign Policy*, the magazine of global politics, economics, and ideas. A longtime foreign correspondent and editor for the *Washington Post*, Glasser joined *Foreign Policy* in 2008. Glasser spent four years as co-chief of the *Post*'s Moscow Bureau. Together with her husband, *New York Times* White House correspondent Peter Baker, she wrote *Kremlin Rising: Vladimir Putin's Russia and the End of Revolution*, which was published in 2005. Glasser also covered the wars in Afghanistan and Iraq as a correspondent for the *Post*, including the battle of Tora Bora. Prior to that, Glasser worked for eight years at *Roll Call*, the preeminent newspaper covering the US Congress.



**CATHERINE HERRIDGE** is an award-winning national correspondent for the Fox News Channel and was first assigned to the homeland security beat in 2001. She now covers intelligence, the Justice Department, and the Department of Homeland Security. Drawing on her investigation into the American-born Al-Qaeda cleric Anwar al-Awlaki, Herridge's first book called *The Next Wave* was published by Crown on June 21. Herridge's reporting also formed the basis of "The Secrets of 9/11" which aired in May 2011 and focuses on Awlaki as an overlooked key player in the 9/11 attacks. Herridge began her career as a London-based radio reporter for ABC News. She has reported from Afghanistan, Iraq, Qatar, Israel, the former Yugoslavia, Northern Ireland, Guantanamo Bay, and New York City on 9/11.



**ALLAN HOLMES** is the editor of the technology regulation team for Bloomberg Government. He leads a team of reporters and editors who work closely with technology analysts to produce content on how US federal regulations, legislation, policies, and spending affect technology companies. Holmes previously was executive editor of *Government Executive*, an Atlantic Media property. Prior to joining *Government Executive*, he was the Washington bureau chief at *CIO magazine*. Holmes has covered business, focusing on finance and transportation; state

government; and health care, including President Clinton's health reform initiative in 1993 and 1994. He has written for *The New York Times*, *TIME* magazine, and *U.S. News and World Report*.



**WALTER ISAACSON** is president and CEO of the Aspen Institute. He has been the chairman and CEO of CNN and editor of *TIME* magazine. He is the author of *Einstein: His Life and Universe* (2007), *Benjamin Franklin: An American Life* (2003), and *Kissinger: A Biography* (1992), and coauthor of *The Wise Men: Six Friends and the World They Made* (1986). He is the chairman of the board of Teach for America, which recruits recent college graduates to teach in underserved communities. He was appointed by President Barack Obama and confirmed by the Senate to serve as the chairman of the Broadcasting Board of Governors, which oversees Voice of America, Radio Free Europe, and other international broadcasts of the United States. He is vice-chair of Partners for a New Beginning, a public-private group tasked with forging ties between the United States and the Muslim world. From 2005-2007, after Hurricane Katrina, he was the vice-chair of the Louisiana Recovery Authority. He serves on many other boards and advisory councils.



**MICHAEL ISIKOFF** is the national investigative correspondent for NBC and previously held the same position with *Newsweek*. He has written extensively on the US government's war on terrorism, the conflicts in Iraq and Afghanistan, presidential politics, and other national issues. His book, *Hubris: The Inside Story of Spin, Scandal, and the Selling of the Iraq War*, co-written with David Corn, was an instant *New York Times* bestseller when it was published in September 2006. Since January 2009, Isikoff has been an MSNBC contributor, making regular appearances on the "Rachel Maddow Show" and "Hardball with Chris Matthews." He is the co-author of the blog *DeClassified: Investigative Reporting in Real Time*.



**DANIEL KLAIDMAN** was *Newsweek's* managing editor until this past February. From 2001 until 2006, he was the magazine's Washington bureau chief, where he led its award winning coverage of 9/11 and the wars in Iraq and Afghanistan. Before that he was *Newsweek's*

Middle East correspondent, based in Jerusalem. He joined *Newsweek* in 1996 as an investigative reporter in Washington. Currently Klaidman is writing a book on the Obama administration's handling of counterterrorism policy, due out in the spring of 2012 and published by Houghton, Mifflin Harcourt. In September he begins a Ferris professorship at Princeton, where he'll be teaching a course on investigative reporting and national security journalism.



**DAHLIA LITHWICK** is a senior editor at *Slate*. She writes "Supreme Court Dispatches" and has covered the Microsoft trial and other legal issues for *Slate*. Before joining *Slate* as a freelancer in 1999, she worked for a family law firm in Reno, Nev. Her work has appeared in

the *New Republic*, *Elle*, the *Ottawa Citizen*, and the *Washington Post*. She is co-author of *Me v. Everybody: Absurd Contracts for an Absurd World*, a legal humor book. She is a graduate of Yale University and Stanford Law School.



**RYAN LIZZA** is *The New Yorker's* Washington correspondent. He covers the 2012 presidential campaign and national politics. Lizza joined *The New Yorker* after working at *The New Republic*, where he was a political correspondent from 1998 to 2007, covering the White House

and presidential politics. He was formerly a correspondent for *GQ* and a contributing editor for *New York*. He has also written for the *New York Times*, *Washington Monthly*, and the *Atlantic Monthly*.



**ROB MARGETTA** is associate editor of *Congressional Quarterly's* Homeland Security website. He has served as a homeland reporter for CQ since 2007, focusing on Coast Guard affairs, legislation, federal budget, border security, air travel, science and technology, and the security industry. Prior to joining CQ, he worked as a crime reporter in Massachusetts.



**JEANNE MESERVE** is CNN's homeland security correspondent. Since the terror attacks of September 11, she has covered a broad array of terrorism, law enforcement, security, and preparedness stories. She was at the forefront of CNN's coverage of the cargo

plane toner cartridge plot and the attempted Times Square bombing. Meserve, previously an anchor, won both a New York Festivals Gold Medal Award and an Emmy for her anchoring at CNN. Before joining CNN, Meserve worked for ABC News where she spent three years as a State Department correspondent, reporting from China, Israel, and other global hotspots.



**ROBERT O'HARROW**, as a reporter for the financial and investigative staffs of the *Washington Post*, has carved out a data privacy beat and uncovered stories about the use of information that has led to changes in state and federal law. In 2000, O'Harrow was a finalist for a Pulitzer Prize. He was a recipient of the 2003 Carnegie Mellon Cybersecurity Reporting Award.



**MARTHA RADDATZ** was named senior foreign affairs correspondent for ABC News in November 2008, after serving as chief White House correspondent. Raddatz joined ABC News in January 1999 as the network's State Department correspondent, where she covered the conflict in the Middle East. In May 2004, Raddatz was named senior national security correspondent. From 1993 to 1998, Raddatz was the Pentagon correspondent for National Public Radio, where she reported on foreign policy, defense, and intelligence issues. Raddatz's coverage at the State Department after the attacks of Sept. 11 was recognized with a Peabody Award as well as an Emmy Award.



**LESLEY STAHL** has been a "60 Minutes" correspondent since March 1991. In September 2005, Stahl landed the first interview with American hostage Roy Hallums who was held captive by Iraqis for 10 months. Her other exclusive "60 Minutes" interviews with former Bush administration officials Paul O'Neill and Richard Clarke ranked among the biggest news stories of 2004. Prior to joining "60 Minutes," Stahl served as CBS News White House correspondent during three presidential administrations. The stories she has covered since joining CBS News in the Washington bureau in 1972 range from Watergate through the 1981 assassination attempt on President Reagan to the 1991 Gulf War.



**DAVID E. SANGER** is the chief Washington correspondent for *The New York Times*. He served as the *Times'* White House correspondent from 1999 until late 2006. He has reported from New York, Tokyo, and Washington, covering a wide variety of issues surrounding foreign policy, globalization, nuclear proliferation, and Asian affairs. Previously, he served as chief Washington economic correspondent and as Tokyo bureau chief. Twice in his 28-year career at the *Times*, Sanger has been a member of teams that won the Pulitzer Prize. His documentary "Nuclear Jihad" won the 2007 DuPont Award for its exploration of the workings of the A.Q. Khan nuclear proliferation network.



**DINA TEMPLE-RASTON** is a counterterrorism correspondent for NPR. Adding to the coverage of NPR's national security team, Temple-Raston reports about counterterrorism at home and abroad for NPR News. A long-time foreign correspondent for Bloomberg News in Asia, Temple-Raston opened Bloomberg's Shanghai and Hong Kong offices working for both Bloomberg's financial wire and radio operations. She also served as Bloomberg News' White House correspondent during both Clinton administrations and covered financial markets and economics for both USA Today and CNN. Temple-Raston is an award-winning author, having written two books related to civil liberties and national security. The first is *In Defense of Our America* (HarperCollins) and was written with Anthony D. Romero, the executive director of the ACLU. The other is *The Jihad Next Door* (Public Affairs).



**NOAH SHACHTMAN** is a contributing editor at *Wired* magazine and the editor of its national security blog, "Danger Room." A non-resident fellow at the Brookings Institution, he has written about technology and national security for *The New York Times Magazine*, *The Wall Street Journal*, and *Foreign Policy*, among others. The offices of the Undersecretary of Defense for Intelligence, the Undersecretary of Defense for Policy, and the Director of National Intelligence have all asked him to contribute to discussions on cyber security and emerging threats. The Associated Press, CNN, Fox News, MSNBC, PBS, and NPR have looked to him to provide insight on military developments.





**SHAUN WATERMAN** is a reporter for the *Washington Times*, covering defense and homeland security and has covered the Department of Homeland Security since its creation. Prior to joining the *Washington Times* last year, he was a senior editor and

correspondent for United Press International for nearly a decade. His reporting on the Sept. 11 Commission and the tortuous process by which some of its recommendations finally became law earned him the 2005 "Dateline Washington" award from the Society of Professional Journalists. Prior to joining UPI, Waterman worked as a senior producer for the British Broadcasting Corporation, which he joined in 1992 as a news trainee. In 1999, he was appointed to run the BBC's American radio news desk in Washington.



**PETE WILLIAMS** has covered the Justice Department and the US Supreme Court for NBC News since 1993 and has covered the Department of Homeland Security since its creation. He is a recipient of a national news Emmy award and a three-time Emmy nominee and is the

senior television correspondent at the Supreme Court. He came to Washington in 1986 to join the staff of Congressman Dick Cheney as a legislative assistant and press secretary. Williams was appointed assistant secretary of defense for public affairs in 1989. He served as Pentagon spokesman during the Persian Gulf War and military operations in Panama and Somalia. The National Association of Government Communicators named him Communicator of the Year in 1991.

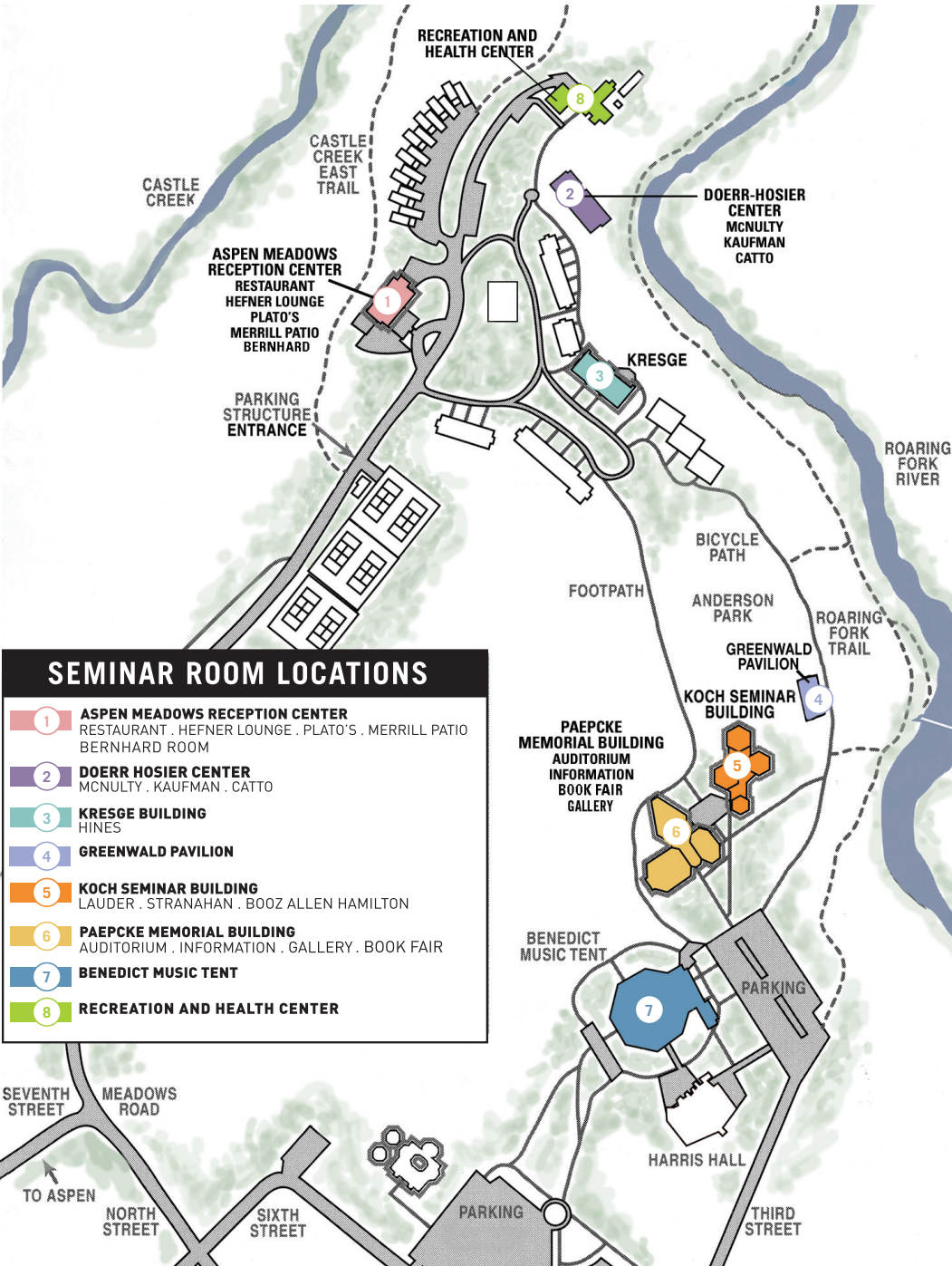

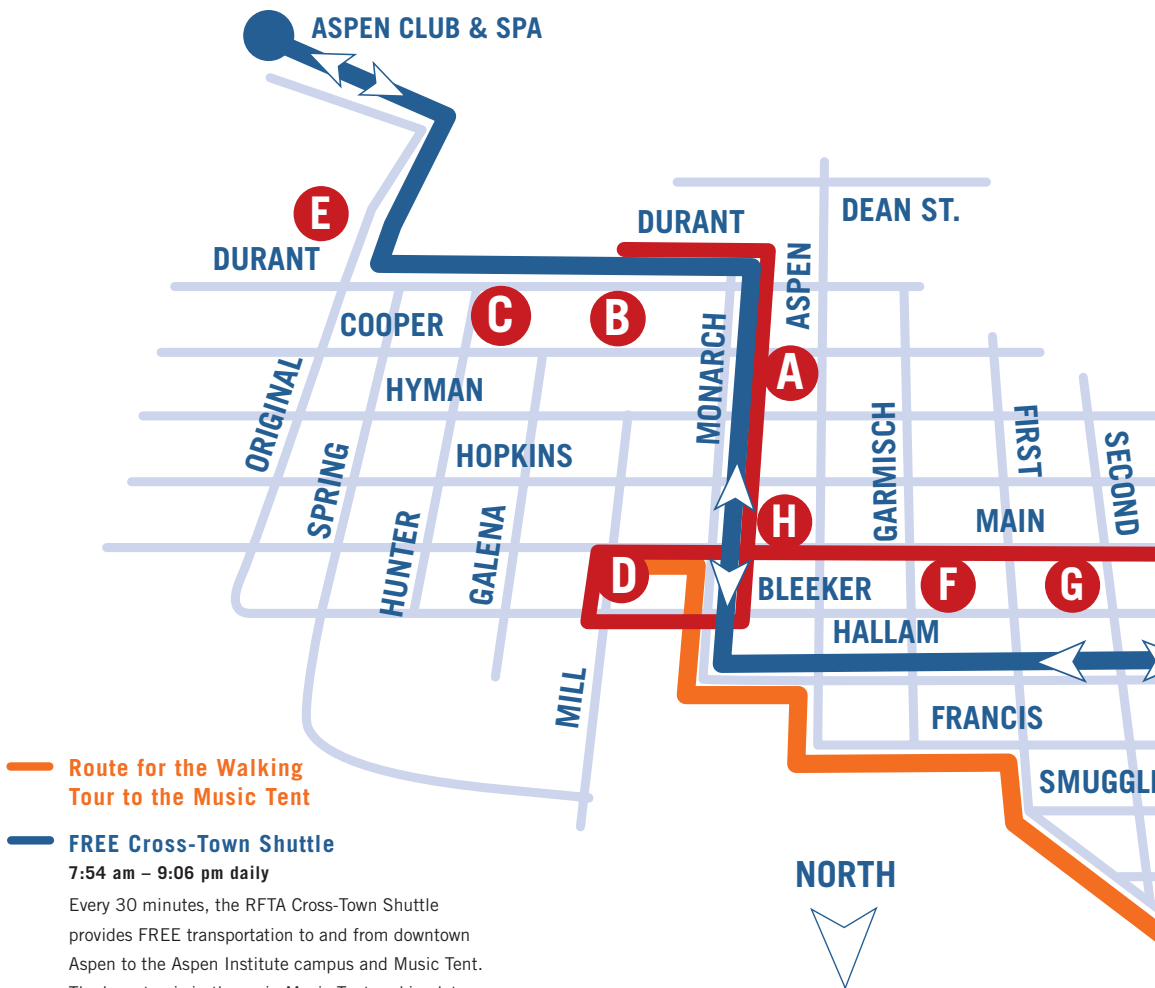
