**The Gateshead (Parish) Order 2006**

Made - - - - - 10<sup>th</sup> March 2006

Coming into force in accordance with article 1(1)

The Secretary of State, in exercise of the powers conferred upon him by sections 14 and 23 of the Local Government and Rating Act 1997(a), and of all other powers enabling him in that behalf, hereby makes the following Order, which gives effect (without modification) to a recommendation made to him by Gateshead Metropolitan Borough Council, following a review conducted by them in accordance with Part 2 of that Act, for the abolition of the area of a parish within the borough of Gateshead and the winding up and dissolution of the parish council for that area:

**Citation, commencement and interpretation**

1.— (1) This Order may be cited as the Gateshead (Parish) Order 2006 and shall come into force on 1st April 2006.

(2) In this Order “the map” means the map prepared by the Office of the Deputy Prime Minister, marked “Map referred to in the Gateshead (Parish) Order 2006” and deposited in accordance with regulation 6(1) of the Local Government (Parishes and Parish Councils) Regulations 1999 (b).

**Abolition of parish and parish council**

2. The parish of Birtley which is shaded in pink on the map shall be abolished and the parish council for that parish shall be wound up and dissolved.

**Order date**

3. 1st April 2006 is the order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999.

## **EXPLANATORY NOTE**

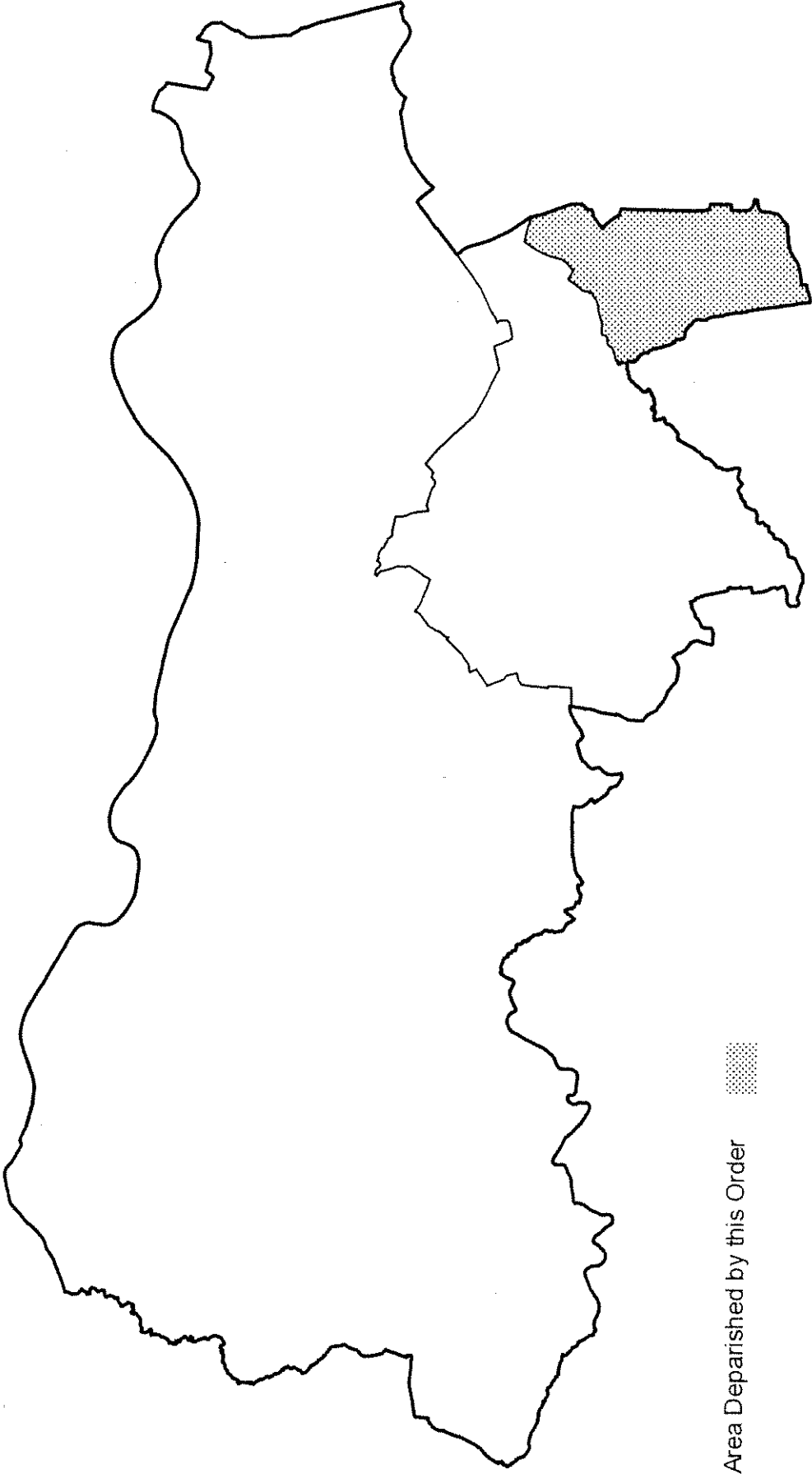
*(This note is not part of the Order)*

This Order gives effect (without modification) to a recommendation for the abolition of the parish of Birtley and its parish council as a result of a review conducted by Gateshead Metropolitan Borough Council. The Order does not transfer the area of the parish of Birtley or any part of that area to any other parish.
