

DEPARTMENT ORDER NO. 11-2015

JURISDICTION OF FOREIGN SERVICE POSTS

Article 1. Legal Basis

In accordance with Section 12 of Republic Act 7157 or the Philippine Foreign Service Act of 1991, entitled "Establishment of Foreign Service Posts," this Order identifies the jurisdictions of Foreign Service Posts.

Article 2. Definitions

- 2.1 Foreign Service Post** - shall refer to a Philippine Embassy or a Philippine Consulate General.
- 2.2 Host Country** - shall refer to a country where a Foreign Service Post is located.
- 2.3 Concurrent Jurisdiction** - shall refer to a country where a Philippine Ambassador is accredited on a non-resident basis.
- 2.4 Consular Jurisdiction** - shall refer to a territory over which a Post is responsible for consular and Assistance to Nationals (ATN) services.

Article 5. Separability Clause

If any part of this Department Order is declared contrary to law or unconstitutional by competent authority, the other parts not covered by such declaration shall remain in full force and effect.

Article 6. Repealing Clause

All other Department issuances or parts thereof inconsistent with the provisions of this Order are hereby repealed or amended accordingly.

Article 7. Effectivity

This Department Order shall take effect fifteen (15) days from the date of filing thereof with the Office of National Administrative Register (ONAR) of the UP Law Center.
