I. SITUATION OVERVIEW

The Low Pressure Area (LPA) east of Visayas developed into a Tropical Depression on 01 October 2015 and was named "KABAYAN". On the same day, it intensified into a Tropical Storm (TS) and was given an international name MUJIGAE. "KABAYAN" is the 11th tropical cyclone which entered the Philippine Area of Responsibility (PAR) this year.

It made landfall over Aurora on 01 October 2015 and tracked across Central Luzon. It left the Philippine land mass through Pangasinan and finally exited the western border of the PAR in the early morning of 03 Oct 2015 as a Severe Tropical Storm or STS.

During the passage of "KABAYAN", PSWS No. 02 was the highest storm warning signal hoisted, with highest maximum sustained winds recorded at 95 kph near the center, gustiness of up to 120 kph, and highest 24-hour rainfall amount of 134.0 mm which was recorded in Iba, Zambales. "KABAYAN" stayed in the PAR from 01 to 03 October 2015 and enhanced the Southwest monsoon that brought light to moderate rains and isolated thunderstorms over Luzon and western sections of Visayas and Mindanao.

II. EFFECTS

A. INCIDENTS MONITORED (TAB A)

1. A total of **15 incidents were monitored** – two (2) landslides, one (1) flooding, two (2) vehicular accidents, and ten (10) maritime incidents

B. CASUALTIES (TAB B)

1. A total of two (2) persons were injured in Region I. While, (63) fishermen went missing in Regions I and III; of which, 37 were already rescued.

C. AFFECTED POPULATION

 A total of <u>4,565 families or 22,368 persons</u> are affected in the Provinces of La Union, Aurora, Bulacan, Nueva Ecija, and Zambales. Of which, 1,391 families or 6,480 persons are being served in 7 evacuation centers:

D. SUSPENSION OF CLASSES (TAB C)

1. Classes were suspended in some areas in Regions I, II, III, IV-A, NCR, and CAR on 02 October 2015.

E. FLOODED AREAS (TAB D)

1. A total of **48 barangays are still flooded** in the Provinces of Pangasinan, Bulacan, Nueva Ecija, and Pampanga

F. STATUS OF LIFELINES

1. Roads and Bridges (TAB E)

a. A total of twelve (12) roads and two (2) bridges are rendered not passable due to flooding and landslides in Regions III and CAR.

2. Power Supply (TAB F)

- a. Power outage is still being experienced in some areas in the Provinces of Pangasinan, Aurora, and Benguet.
- b. On 03 October 2015, 90% of power was restored in Baguio City and in the Province of Benguet.

G. COST OF DAMAGES

1. A total of ₱1,120,716.59 estimated cost of damages to agriculture was reported in the Provinces of Pangasinan (₱4,101.34) and Aurora (₱1,116,615.25).

III. DISASTER PREPAREDNESS

A. NATIONAL / NDRRMC

1. NDRRMC Operations Center (NDRRMOC)

a. Alert status at the NDRRMC Operations Center was raised to Blue Alert Status effective 01 October 2015, 3:00 PM, to continuously monitor and ensure dissemination of Weather Advisories, 24-hour Public Weather Forecasts, Gale Warnings, and General Flood Advisories to all RDRRMCs/OCDRCs through SMS, facsimile, and websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs) from the provincial down to the municipal levels.

- b. Pre-Disaster Risk Assessment (PDRA) Meeting was conducted on 01 October 2015, 2:00 PM and 02 October 2015, 8:00 AM at the NDRRMC Conference, Camp General Aguinaldo, Quezon City.
- c. Directed OCD Regional Centers I, II, III, IV-A, IV-B, V, VI, NCR, and CAR to conduct PDRA Meeting and raise respective alert levels corresponding to the forecast situation in their respective AORs to ensure the execution of preparedness actions and coordination with concerned agencies.
- d. Issued and disseminated a memorandum to DOST-PAGASA, AFP, PNP, PCG, BFP and DOST-Project NOAH requiring the agencies to send their Detailed Duty Officers (DDOs) to render duty at the NDRRMOC to ensure continuous coordination and to assist in facilitating the submission of consolidated preparedness measures of their respective agencies.
- e. Sent DOST-PAGASA and DOST-Project NOAH presentations to concerned regions.

2. Department of Science and Technology

Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA)

a. Monitored the situation and disseminated Weather Advisories, Severe Weather Bulletins, Gale Warnings, General Flood Advisories, Dam Monitoring, and 24-hour Public Weather Forecast.

PAGASA CAR

a. Presented the current weather situation and forecast for CAR and emphasized that TS "KABAYAN" might enhance the southwest monsoon.

PAGASA VI

a. Provided a briefing on the status of TS "KABAYAN", emphasized that there is a possibility of rainfall in Guimaras and Northern Panay, and light to moderate, at times, heavy rains are expected until 02 October 2015 and cloudy to light rains on 03 October 2015.

Project Nationwide Operational Assessment of Hazards (Project-NOAH)

- a. Monitored near-real time information coming from Doppler radars, automated rain gauges, weather station, and stream gauges.
- Observes continuous rainfall and sharp increases in river water levels and forwards information to NDRRM Operations Center for further validation and dissimenation.

DOST IV-A

 Utilized Project HANDA text blast system for continuous dissemination of weather advisories to RDRRMC IV-A member agencies, LCEs, and local DRRMOs.

3. Department of Interior and Local Government (DILG)

- a. Directed DILG Regional Offices through Central Office Disaster Information Coordinating Center (CODIX) to activate their respective Disaster Monitoring Systems effective immediately and ensure that LDRRMCs are actively doing actions as suggested in Operation Listo and to prepare people especially those living in low-lying and/or landslide prone areas, highways, and river banks.
- b. Advised Provincial Directors, City Directors, and City/Municipal Local Government Operations Officers to coordinate closely with Local Chief Executives, Chief of Police, and Fire Marshalls to ensure their readiness to provide first response in case of emergencies and disasters.

DILG I

- a. Disseminated Weather Advisories/Bulletins to P/C/MDDRMCs.
- b. Coordinated with DILG Provincial Offices for TS "KABAYAN" updates.
- c. Submitted situational reports to DILG CODIX every 12 hours.

- d. Disseminated Memo List of Areas with 100mm and above accumulated rainfall and activation of Disaster Monitoring Systems to the Provinces of Ilocos Norte, Ilocos Sur, La Union, and Pangasinan.
- e. Showed the Hotdog Forecast and Potential Areas Risk for TS "KABAYAN".
- f. Activated DILG Region I Operations Center

DILG III

- a. Issued advisory on activation of Disaster Operations Center for Tropical Storm "KABAYAN" and advised to observe existing Disaster Preparedness Protocols and proper Proof of Service under Operation Listo.
- b. Activated Regional Operations Center effective at 4:00 PM, 01 October 2015.

DILG IV-A

- a. Issued advisories to all DILG provincial and city directors, cluster officers, Municipal Local Government Operations Officers (MLGOOs), and Local Chief Executives (LCEs) to activate their respective monitoring systems and advised all LDRRMCs to undertake precautionary measuers for the possible effects of the tropical depression.
- b. Alerted all provincial, city, and municipal offices to activate their skeletal forces and closely coordinate with LCEs, chief of police, fire marshals, and other concerned authorities for strict enforcement and protocols.
- c. Directed all field officers to ensure that LDRRMCs are actively doing actions suggested in Oplan Listo.

DILG V

a. Released advisory to all provincial directors, cluster heads, and MGOO focal persons to ensure safety of their respective constituents particularly in low-lying areas and landslide-prone areas.

DILG VI

- a. Placed their Operations Center on alert status.
- b. Alerted all field offices to coordinate closely with LGUs.

DILG CAR

- c. Ensured close coordination with the Local Government Units (LGU).
- d. Issued memorandum for the activation of the LDRRMCs and prepare for the possible impacts of TS KABAYAN in their AOR with the guidance of Oplan Listo.

a. Placed Quick Action Response on standby status.

- b. Monitors the inventory of stockpile and prepositioned goods.
- c. Prepositioned Non-Food Items (NFIs) amounting to ₱4,122,237.00.
- d. Organized Social Welfare and Development (SWAD) Teams.

DSWD II

- Alerted all SWAD Teams and Disaster Monitoring and Response Teams (DMRT)

- b. Provided advisories on the list of landslide/erosion/flood-prone areas in all municipalities in the region.
- c. Distributed IEC materials such as posters, brochures/flyers, hand-outs, maps (soft and hard copies) to LGUs, students, clienteles, etc.
- d. Advised mining companies to monitor their Mine Waste dumps and siltation ponds.

a. Issued landslide advisories to all landslide-prone areas.

a. Issued advisories to all concerned LGUs encouraging pre-emptive evacuation of residents in high-risk areas and released advisories for temporary suspensions of small scale miners to avoid accidents.

- a. Activated their Quick Response Center to closely monitor the weather situation in the region.
- b. Advised farmers to harvest crops and to secure agri-inputs and livestock.

10. Department of Tourism (DOT)

DOT IV-A

- a. Directed industry partners to take precautionary measures to ensure the safety and security of their guests and properties.
- b. Made an appeal to tourists and visitors in the region to avoid going to hazard prone areas.

11. Armed Forces of the Philippines (AFP)

a. Monitored the tropical storm and continues to monitor the areas that are prone to landslide and flooding for the conduct of pre-emptive evacuation, proactive measures, and HADR operations in coordination with LGUs and LDRRMCs.

Southern Luzon Command (SOLCOM)

- a. Placed personnel and equipment on standby for possible conduct of Humanitarian Assistance and Response (HADR) operations.
- b. Identified strategic areas for prepositioning of quick response Disaster Response Operations (DRO) teams.
- c. Directed Operational Command (OPCOM) units to alert DRRO assets and initiate coordination with LDRRMCs.
- d. Ensured the availability of vehicles and air assets.

Philippine Air Force (PAF) – Tactical Operations Group (TOG) 5

a. Placed Disaster Response Teams (DRTs) on standby.

PAF - TOG 1

a. Placed all available air assets and response teams on standby.

Philippine Navy (PN)- TOG

a. Monitored the tropical storm.

PN I

- a. Declared Red Alert status on 01 October 2015, 4:20 PM.
- b. Directed to submit situational reports every four (4) hours.
- c. Prepared surface assets for possible deployment.

203rd Brigade

a. Alerted DRO platoons of 4IB, 76IB, and 203rd Brigade for deployment in case of flood and landslide.

503rd BDE, 50th IB and 54th IB

- a. Activated disaster response teams and prepared disaster response equipment.
- b. Established links and prepositioned assets to provinces issued with PSWS.
- c. Activated the emergency communication equipment.

12. Philippine National Police (PNP)

Directorate for Police Community Relations

- c. Prepositioned their disaster response teams in disaster-prone and low-lying areas.
- d. Advised fishing boats and other small sea crafts not to venture out into the seaboards.

PRO IV-A

- a. Directed all provincial directors, Chief of Police to prepare assets for possible deployment, coordinate with LDRRMCs and other force multipliers, and to activate their respective Disaster Operations Center.
- b. Placed Regional Public Safety Batallion (RPSB) SAR personnel on standby.

- d. Prohibition of sailing/fishing due to adverse weather condition.
- e. Heightened security of sea ports where there are stranded passengers.

- b. Directed all Police Provincial Offices (PPOs) and Naga City Police Office to prepare and place SAR personnel and equipment on standby and coordinate with their respective Provincial and City DRRMCs for possible SAR operations in their respective AOR.
- c. PNP Daet placed Search and Rescue Team on standby for possible deployment.

a. Directed all Regional Offices to activate their respective stations and to ensure the availability of fire, rescue, emergency, and medical personnel, apparatus, and auxiliaty units.
