Tells Yevseks to Differentiate Between Pre-Soviet Peasants and Present Jewish Colonists

(Jewish Telegraphic Agency) Moscow, Feb. 26-"The left-wingers should understand the difference between the old pre-revolutionary peasants and the new post-revolutionary Jewish colonists," declared J. Merez-hin, Jewish Communist leader, addressing a meeting of the Ozet, the society for settling the Jews on the land, called to discuss the question of col-lectivizing the Jewish colonies. Replying to certain Jewish Commun-

ist leaders who doubt whether the collectivization of the Jewish colonies should be completed within this year as decided by the Comzet, the government department for settling the Jews on the land, Merezhin said that "the Comzet's collectivization tempo will do less harm to the Jewish colonies than the present tendency of certain Jewish left-wingers who are anxious to liquidate the kulaks in the Jewish colonies as was done with the non-Jewish peasants."

He pointed out that in the entire Cherson region there are perhaps three Jewish kulaks, but that despite that, "the Iewish Communists in Kalinin-(Continued on Page 4)

Memory of Christian, Who Was Protector of Jews, Honored

(Jewish Telegraphic Agency) Grodno, Feb. 26-Two thousand people assembled here yesterday in the Great Synagogue to attend a memorial service for the Christian Colonel Kshishek. Hundreds shed tears and sighed, and cries were heard when the rabbi recalled the deeds of Colonel Kshishek as the chief of the Grodno military forces, as a friend of humanity and protector of the Jews, who never refused to intervene on their behalf. The Jews here were particularly thankful to him because when the govern-ment took over the famous Sherere-shevsky tobacco factory, he influenced the Jewish employes to remain, as a result of which 40 percent of the people now employed there are Jews.

Boycott Agitator Fined and Sentenced to Three Months

(Jewish Telegraphic Agency) Jerusalem, Feb. 26-A boycott agitator by the name of Hassan from Iaffa has been sentenced to three months in prison and fined fifty dollars. Assistant District Commissioner Crosby, in sentencing him, regretted that the law does not permit a heavier sentence. He warned Hassan that his punish-ment would be much more severe for a second offense.

MOTZA JEW FREED OF MURDER CHARGE

Letters Made Public Reveal Revisionists' Negotiations With Zionist Executive a Failure (Jewish Telegraphic Agency)

London, Feb. 26-Negotiations be-tween the Zionist Revisionists and the Zionist Executive concerning the pol-itical position of Zionism and the internal situation of the movement are thought to have broken down as the result of a letter, dated February 20, addressed by the Zionist Executive to the Revisionists which, together with other correspondence, is now made public by the Revisionists.

The Zionist Executive definitely declines the Revisionists' proposal to en-trust the political work in the future to a committee independent of the Zionists, the Zionist Executive points out that the direction of political work passed from the Executive of the Zionist Organization to the Executive of the Jewish Agency and therefore the Jewish Agency is the only appropriate organ that can decide whether the conduct of political affairs should be transferred to a special committee.

The reply further states that should such a demand come before the Jewish Agency, the Zionist Executive would oppose it. As an alternative to the Revisionists' demand, the Zionist Ex-ecutive suggests that they nominate a member to the political committee, who will meet with the Zionist Executive from time to time as other re-

"The program of settling Jews on the land was commenced by the Joint the land was commenced by the Joint Distribution Committee, under the active direction of Dr. Joseph A. Rosen, in 1924. Since then the Agro-Joint has expended \$8,000.000 in this activity, and the Jewish population engaged in farming has increased from 15,000 families at the end of 1923 to over 50,000 in 1929, or a total of about 200,000 Jews. The settlement of 4,500 additional families is contemplated as the program for the current year and there are thousands of applications for which the Agro-Joint has neither the funds nor available land. Daily the offices of the Agro-Joint are beseiged by an increasing number of applicants

Registration Proponent Amends Bill to Bargain with Foes (Jewish Telegraphic Agency)

Washington, Feb. 26-Congressman Cable of Ohio has made a new move to overcome the opposition to his voluntary alien registration bill, by reintrolegalization of those aliens who entered the United States unlawfully up to July 1, 1924. At present only those aliens who entered unlawfully prior to June 3, 1920 can secure legalization.

The correspondent of the Jewish Telegraphic Agency learns that Congressman Cable, knowing that the opponents of his registration bill are anxious to obtain an extension for illegal entrants, hit upon this amendment as a bargaining point on which to make a deal with them. That he is willing to do this discloses his anxiety to obtain action on the registration bill, as he is known to be a confirmed restrictionist.

Congressman Cable has also introduced a bill to remove certain disabilities from American women, namely to exempt from the quota husbands of American citizens and also to enable immediate naturalization and temporary admission outside the quota for this purpose of women formerly American citizens who lost their citizenship by marrying an alien prior to September 22, 1922.

Arabs Would Organize \$2,500,00 Company

(Jewish Telegraphic Agency) Jerusalem, Feb. 26-A proposal to organize a company with a capital of \$2,500,000 by half a million Arabs each contributing five dollars annually, is contained in a directory circulated by the boycotters in Jaffa, Jerusalem, Nablus. Haifa and Gaza, listing three hundred merchants whose goods and pa-triotism are advertised. The boycotters oppose excessive use of motorcars and censure the land agents.

Mr. Lipsky is expected to make an announcement of importance with regard to cooperation between the various Zionist factions in this country. There will be an open discussion of Mr. Lipsky's address, Rabbi Stephen S. Wise will also dis-

cuss the present situation in Zionism in an address before the Forum of the Independent Order Brith Abraham mext Sunday afternoon, March 2, at Morris High School, Bronx. The sub-ject of Dr. Wise's address will be "Problems of Palestine—Past and Present."

2,000 Homeless Jewish Men

and Boys in New York City There are two thousand homeless Jewish men and boys in New York City, who wander through the streets of the metropolis yearly, according to a report just made public by the Committee on Homeless ,which was established by the Jewish Social Service Association and the United Jewish Aid Societies of Brooklyn, under the chair-manship of Howard S. Cullman.

During the past year the committee has examined 640 men, most of whom, to the surprise of the committee, consisted of the younger element. "Such youngsters," says the report, "were generally bright, impressionable, impudent, incorrigible, and, in some cases, sufficiently daring and delinquent to make them potential criminals." The committee would try to lead these boys on the proper path, and to effect a reconciliation with their parents.

Brooklyn Jewish Hospital Had More Free Cases Than Others

The Brooklyn Jewish Hospital treated 56,519 persons during the past year, which was the first year of residence in its new 650-bed building, and has given more free service than any other non-municipal hospital in Brooklyn. This was the statement made by Joseph J. Baker, president of the hospital, in his report rendered Tuesday night at the annual meeting held in the hospital's auditorium.

The hospital's dispensary had 137,797 visits during 1929, said Mr. Baker. Health Commissioner Wynne, who was the principal guest speaker at the meeting, praised the directors and staff of the Brooklyn Jewish Hospital for of the Brooklyn Jewish Hospital for splendid service and management. Court Permits Jewish Father to Bury Daughter Reconverted to Judaism on Her Death Bed

(Jewish Telegraphic Agency) Pittsburgh, Feb. 26-Testimony in the Allegheny County Common Pleas Court that a former Jewess, converted to the Roman Catholic faith on her second marriage, was reconverted to Judaism during her recent fatal illness. resulted in a decision today by Judge George V. to bury his daughter. The Court's ruling was made in an equity action instituted by Thomas Butler, second husband of the dead woman, who sought to restrain relatives of his wife from burying her. The action was brought against A. K. Birnkrant, the woman's father, Bernard and Wilbert Rice, sons of the woman by her first marriage, and Walter S. Willig, an undertaker. The case is unusual in the legal annals of western Pennsylvania

The woman died yesterday at her father's home, where she had lived since her discharge from the hospital. Her husband was with her at the time of her death. Butler said he had made arrangements for the funeral and had engaged an undertaker, but when the latter called for the body, the woman's father declined to let him have it.

Mrs. Butler is said to have married Butler in the Roman Catholic faith in McKeesport in 1920.

who desire to enter the settlements. "The program of Jewish farm settle-ment has had to be conducted under unusual circumstances and from time to time has been faced with serious problems. Notwithstanding all this, it has now been virtually established that the Jews settled on the land fare better and occupy a more economic position in the life of Russia than the great majority of the Jews in the cities and villages.

"This organization, of which Messrs. Julius Rosenwald and Felix M. Warburg are honorary presidents, has en-abled thousands of Jewish families to leave the cities and villages where they were herded in ghettos and constituted an outcast class practically without rights of citizenship, to become self-

"Last Fall, during the rigors of the Government grain collections, several hundred Jewish settlers tried to leave the Jewish settlements in the Crimea to return to their cities and villages. It did not take them long to discover that there conditions were much worse. With very few exceptions, all of these settlers have applied for reinstatement in their old settlements.

"The question of collectivizing the farms, which is now agitating Russia. has brought up a new problem in our farm program. It would be impossible to carry on the Jewish farm work in Russia under a different system from some respects, the collectivization program will not be completely new, as a considerable amount of our work has been carried on, from the very begin-ning, on a cooperative basis. The collectivization plan is an experiment and if the experiment should prove successful for the peasantry at large, it may benefit the Jewish settlers as well; should it fail, the Jews will be in the same position as the remainder of the

population.
"The Russian Government has cooperated to the fullest extent with the Agro-Joint and with the American Society for Jewish Farm Settlements in Russia, Inc., and besides making available large tracts of land, of more than one and three-quarter million acres, and advancing substantial credits, provides substantial amounts yearly in its

"The question of religious persecution in Russia is not solely or primarily a Jewish question. It affects Christians, Moslems and Jews alike. Deeply as we deplore the anti-religious policy of the Soviet authorities, we cannot help but note that under all circum-stances 3,000,000 Jews will remain in Russia, will have to stay there and will have to become producers under the Russian law and system, before their economic and civic position can be of formation. made secure.

It is they who spontaneously developed the move-ment of Jewish farm settlement in Russia, who availed themselves of the opportunities offered them and who entreat us now to stand by them and not to desert them especially in the hour of their trial.

"Nobody minimizes the difficulty of the situation now prevailing in Russia, not alone for Jewish settlers, but for the hundreds of thousands of the Jewish urban population. In our endeavor to bring aid to the Jews of Russia, we shall not be deterred by carping criti-cism and misinformation,"

This left wing blindness resulted in the selling out of the property of those taxed, who were really only middle-class colonists and not kulaks. The same thing happened in the Jewish colonies of the Odessa region."

Criticizing these acts as extremely silly, Merezhin explained that the feeling for private property is not strongly developed among the Jewish colonists because their property belongs to the government or foreign relief organizations which give credit to the Jewish colonists.

After cautioning the left wingers to distinguish carefully between the preossinguish carefully between the pre-revolutionary peasants and the post-revolutionary Jewish colonization chair declared that "Jewish colonization is a pure Soviet creation that was started after the Revolution along Soviet lines and under Soviet control. Hence those who think themselves left wingers in Jewish colonization work are actually denying the Soviet

achievements," he warned.

Speaking of the foreign Jewish relief, Merezhin pointed out that their net, acerezum pointed out that their contributions were steadily growing smaller. He said that while five years ago the contribution of the Soviet government to Jewish colonization. work was less than that of the foreign organizations, it is now much greater than their contribution

While emphasizing the importance of the foreign Jewish relief which contributes large sums in American money and American machinery, Merezhin explained that anything coming from the Agro-Joint is not relief but a loan to the Soviet government which will be repaid in American currency plus five percent interest at the end of 17

the services before a large gathering. Dr. Friedman paid tribute to the donor, the late Louis Heineman of Jamestown, N. Y., whose gift makes possible the care of these unfortunate little children. a predisposition for tuberculosis.

Mrs. Seraphine Pisko, honorary executive secretary of the hospital, and a leading figure in the institution, came to the dedication in a wheel chair. She arose from a sickbed to speak before the children to whom she acts as godmother.

Other speakers were Dr. Robert Levy, chairman of the medical advisory board of the hospital, Dr. William Rosenau, Baltimore; and Dr. Moise Bergman, of Pueblo. Rabbi C. H. Kauvar of this city pronounced the benediction.

Dr. Levy said, "Children from 38 states besides Colorado have been cared for in our institution." The new building, he explained, enables the hospital to separate tuberculous children from those who have only tubercular

Hospital to Open in Tiberias

The fifth modern hospital in Pales-tine to be maintained and conducted by Hadassah, the Women's Zionist Organization of America, will be formally opened in Tiberias on May 1, according to an announcement by Mrs. Edward Jacobs, chairman of the Palestine Committee of Hadassah.

The institution will be known as the Peter I. Schweitzer Hospital, after its founder, the late Peter J. Schweitzer, of New York, who gave \$85,000 for the building of the hospital. Mr. Schweitzer was treasurer of the Zionist Organization of America when Justice Louis D. Brandeis was president. Interest in the hospital project has been continued by Mrs. Schweitzer, who has just added \$8,000 to her husband's contribution.

Other contributions for the hospital are \$17,500, voted by the last Zionist Congress, and \$3,500 from the Pales-Emergency Relief Committee, which was organized during the Arab riots. The Jewish community of Tiberias will participate in the maintenance of the hospital,
