The survey is of short duration and will be conducted at a remote location and the *Guidance to Manage the Risk to Marine Mammals from Man Made Sound Sources in Irish Waters DAHG* (2014) will be implemented to mitigate any noise impacts on marine mammals, therefore it was concluded that no significant effect was likely.
