

You should re-register to vote when you move to a new residence, change your mailing address, change your name, or change your party preference.

Voting in a California Primary Election

In June of 2010, California voters approved Proposition 14 (The Top Two Open Primary Act). The new law made many changes to how primaries are conducted in California. Previously, there were only two types of offices: partisan and nonpartisan. The new law created three types of offices: partynominated, voter-nominated, and nonpartisan.

In a non-presidential primary election like this one, voters will only vote on voter-nominated and nonpartisan offices.

Voter-nominated Offices

- Includes contests for:
 - United States Senator
 - United States Representative
 - Statewide elective offices
 - State Board of Equalization
 - State Senator
 - Member of the State Assembly
- The party preference of the candidate is listed on the ballot.
- Voters <u>may</u> write in the name of a candidate whose name is not on the ballot.
- The top two vote-getters will proceed to the General Election.

Nonpartisan Offices

- Includes contests for:
 - Judicial office
 - State Superintendent of Public Instruction
 - County offices
 - City offices
- The party preference of the candidate is not listed on the ballot.
- Voters <u>may</u> write in the name of a candidate whose name is not on the ballot.
- For nonpartisan judicial, state, and county offices, the top two vote-getters will proceed to the General Election. However, if a candidate receives more than 50% of the vote, that candidate is elected to office.
- For most city offices, candidates that receive the most votes are elected to office.

Voting in a California Primary Election (continued)

Ballots

All voters will receive a two-card Official Ballot with contests on each side of both cards. The Official Ballot will include:

Primary Election contests:

- Voter-nominated offices
- Nonpartisan offices

Measures:

- State propositions
- Local ballot measures (only in certain cities)



Caution

Be aware of the following contests on your ballot:

Contest for Governor

- There are 27 candidates in this contest.
- The candidates are listed in two columns on the Official Ballot.
- You can only vote for one candidate for this contest.

Contest for United States Senator

- There are 32 candidates in this contest.
- The candidates are listed in two columns on the Official Ballot.
- You can only vote for one candidate for this contest.


1) Vote By Mail

Take advantage of voting by mail:

- Vote at home
- Vote when you want
- Track your ballot online

Get on the mail ballot list:

- Voters on the permanent mail ballot voter list will receive ballots by mail.
 Mail ballots will be delivered to the U.S. Post Office on Wednesday,
 May 9.
- Refer to the back of this guide to see if you are a permanent mail ballot voter.



- Request to be on the list; or
- Request a mail ballot for the current election only.



Request a mail ballot:

- Apply online by visiting SBCountyElections.com and signing in to My Elections Gateway; or
- Complete and return the application on the back of this guide; or
- Apply in person by visiting the Elections Office.

The deadline to request a mail ballot is Tuesday, May 29.

Return your mail ballot:

- Mail via the U.S. Postal Service. Mail ballots must be postmarked on or before Election Day, June 5, and received no later than three business days after the election.
- Drop off at the Elections Office, any city clerk's office, any county library, any early vote site, or any polling place on Election Day.

Caution

Mail ballot voters:

If you want to vote at your assigned polling place instead of voting by mail, bring your mail ballot with you.

If you don't, you can still vote, but will have to vote a provisional ballot.

Language Assistance for Voters

The Elections Office provides language assistance in Chinese, Korean, Tagalog, and Vietnamese to voters residing in precincts where 3% or more of the voting age residents would have difficulty voting in English without assistance.

- At all early vote sites and in precincts where language assistance is offered:
 - Translated sample ballots are available to assist with voting the official ballot.
 - Bilingual poll workers may be available to provide assistance.

Assistance for Voters with Disabilities

The Elections Office provides a number of services to increase access and encourage participation by voters with disabilities.



At polling places and Early Vote sites

San Bernardino County polling places and Early Vote sites have an accessible path of travel and accessible parking. Polling places and Early Vote sites also include the following resources:

- Electronic touch screen voting machine, including audio ballots and large text option
- Assistance by poll workers
- Curbside voting
- Page magnifiers
- Wheelchair accessible voting booths

If you cannot mark your ballot, you may bring one or two persons to assist you with marking it.

DIS-INF N SB 001-018

Voter Bill of Rights

You have the following rights:

- The right to vote if you are a registered voter. You are eligible to vote if you are:
 - a U.S. citizen living in California
 - at least 18 years old
 - registered where you currently live
 - not currently in a state or federal prison or on parole for conviction of a felony
 - not currently found mentally incompetent to vote by a court
- The right to vote if you are a registered voter even if your name is not on the list. You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.
- 3. The right to vote if you are still in line when the polls close.
- The right to cast a secret ballot without anyone bothering you or telling you how to vote.
- The right to get a new ballot if you have made a mistake, if you have not already cast your ballot. You can:
 - Ask an elections official at a polling place for a new ballot,
 - Exchange your vote-by-mail ballot for a new one at an elections office or at your polling place, or
 - Vote using a provisional ballot.

- The right to get help casting your ballot from anyone you choose, except from your employer or union representative.
- The right to drop off your completed vote-by-mail ballot at any polling place in California.
- The right to get election materials in a language other than English if enough people in your voting precinct speak that language.
- 9. The right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.
- The right to report any illegal or fraudulent election activity to an elections official or the Secretary of State's office.



Voting Instructions

Marking your official ballot

- 1. Use a BLACK or BLUE pen or a #2 pencil.
- To vote, connect the arrow ■ pointing to your choice with a single line like this: ■

Example:



- Do not vote for more candidates than the number indicated for each contest. If you vote for more, your vote will not count for that contest.
- 4. To vote for a candidate whose name is not on the ballot, print the name of the candidate on the blank write-in line and connect the arrow pointing to that candidate.
- To vote for a state proposition or a local measure, connect the arrow
 pointing to either YES or NO with a single line.
- If you make a mistake or damage your ballot, request a replacement ballot.

MEASURE L INFORMATION

IMPARTIAL ANALYSIS OF MEASURE L

This Impartial Analysis of Measure L has been prepared by the Town Attorney pursuant to Section 9280 of the California Elections Code.

In 2017, the Yucca Valley Town Council adopted Ordinance 268 which prohibits all commercial marijuana operations in the Town. Measure L seeks voter approval to modify the Town's prohibition on commercial marijuana operations to allow indoor cultivation, manufacturing, distribution and testing of marijuana by operators with a state-issued license in certain locations in the Town ("Exempted Commercial Cannabis Activity").

If Measure L is approved, operations granted Exempted Commercial Cannabis Activity status will be exempt from the Town's prohibition on commercial marijuana operations and will be allowed in certain zones of the Town. Retail sales, outdoor cultivation and microbusinesses would remain prohibited.

To obtain Exempted Commercial Cannabis Activity status, applicants must undergo an application process to obtain the Town Clerk's approval. The Town Clerk must approve an application for Exempted Commercial Cannabis Activity status if a completed application form is submitted for a location that is within the Industrial Zoning District or in the Old Town Industrial/Commercial use district located within the Old Town Yucca Valley Specific Plan. Applications for manufacturing that involve volatile solvents must be at least 250 feet away from any established residential zoning district.

Any commercial marijuana operation granted Exempted Commercial Cannabis Activity status must comply with operating standards, including location limitations and compliance with all other Town laws. If any Exempted Commercial Cannabis Activity operator violates any applicable provisions of Measure L, the Town may enforce such violations as a public nuisance or under other municipal code provisions.

Measure L does not place limitations on the number of operations which may be granted Exempted Commercial Cannabis Activity status within the Town. Further, Measure L does not establish minimum distance requirements which set forth how far away operations granted Exempted Commercial Cannabis Activity status must be from each other, parks, private or public schools, religious institutions or private or public recreation and athletic facilities.

Measure L will result in a codification error within the municipal code because it seeks to adopt new cannabis-related provisions in the existing Chapter 9.54 which currently contains the Town's short term rental regulations. As a result, the Town's short term rental regulations must be renumbered if this Measure is approved.

Measure L was placed on the ballot by initiative petition that was signed by a legally sufficient number of registered voters of the Town of Yucca Valley.

MEASURE M INFORMATION

IMPARTIAL ANALYSIS OF MEASURE M

This Impartial Analysis of Measure M has been prepared by the City Attorney pursuant to Section 9280 of the California Elections Code.

Measure M was placed on the June 5, 2018, Special Municipal Election ballot by unanimous vote of the City Council. If adopted, this measure will permanently extend the existing 8% Utility User Tax ("UUT").

The UUT is a general tax on utility (telephone, cellular, electricity, gas, sewer, water, and cable television) charges to Rialto businesses and residents. This measure preserves current exemptions for individuals 65 years of age or older and members of very low income households, as defined by California Health & Safety Code Section 50105.

Unless extended by this measure, the UUT will expire on June 30, 2018.

The UUT provides approximately \$14 million per year to support public services. Historically, the UUT has accounted for approximately 20% of the City's General Fund revenue and has been the City's largest single revenue source. Without the UUT, the City will experience reductions to public safety (e.g., police and fire), recreation, public works, and other core governmental services. The City may also delay capital improvement projects, including fire stations, road repairs, and park improvements. Public safety expenses represent approximately 65% of all City operating expenditures.

The people of the City of Rialto have the exclusive authority to extend the UUT under the California Constitution. Therefore, the Rialto City Council does not have the authority to extend this tax, without submitting the measure to the voters of the City of Rialto.

A **"Yes"** vote means you approve the permanent extension of the UUT. A **"No"** vote means you disapprove the permanent extension of the UUT. This ballot measure would take effect only if a majority of those voting cast a "Yes" vote for it at the June 5, 2018. election.

ARGUMENT IN FAVOR OF MEASURE M

This Argument in Favor of Measure M was submitted pursuant to Section 9282 of the California Elections Code. It is the opinion of the author(s), and has been printed exactly as submitted.

The City of Rialto exists to provide you with a safe, healthy and prosperous place to live, raise your family and work. Mindful of this, the City is committed to providing a level of services you need and have come to expect in our community.

The Utility Users Tax, originally approved by voters in 2003, has been an essential source of funding throughout that period, providing increased public safety, code enforcement, street maintenance, senior center operation and more. The UUT generates \$14 million per year - approximately 20 percent of total General Fund revenues.

Approval of Measure M maintains the tax at its current 8% rate on an ongoing basis. It is not an additional tax, and very low-income households and seniors over 65 qualify for full exemptions.

Extending the UUT is necessary to preserve vital City services. While general fund revenues have grown by \$18.4 million since 2013, the City's costs have grown by \$22.6 million over the same period. After the Great Recession, City expenditures on personnel, programs and services rose to make up in order to better serve the community.

Without a UUT extension, projected FY 2018 revenues would fall from \$77.6 million to \$63.3 million. The impact would be felt citywide, including:

- Loss of 36 full-time police positions, resulting in significant impact to emergency response times.
- Loss of 23 full-time positions in the Fire Department and the closure of one fire station, resulting in one less ambulance and fire engine on the streets.
- Loss of 11 full-time positions in Public Works, resulting in service reductions to street, sidewalks, weed and graffiti abatement, trash clean up, parks, facilities and fleet maintenance.
- In all, a loss of approximately 93 positions and service reductions.
