ISDN Holdings Limited ("ISDN") acquires 49% of Germanybased Dirak Asia

Acquisition will have a positive impact on ISDN's bottom line

Singapore, 29 October 2007 – SGX Main Board listed ISDN, has entered into an agreement to acquire a 49% stake in Dirak Asia Pte Ltd ("Dirak Asia") for a purchase consideration of S\$5.9 million cash and \$5.9 million of new ISDN shares, subject to the relevant regulatory and shareholders approvals. 50% of Dirak Asia is currently owned by Mr. Teo Cher Koon, who is also ISDN's Managing Director and President.

Dirak Asia was set up as a joint venture company between Mr Teo Cher Koon and German–based Dirak Holding GmbH in 1997 has consistently generated approximately 55 % CAGR in the past three years.

Mr. Teo Cher Koon said the proposed acquisition is a strategic for ISDN's diversification plans and for the Group to introduce new revenue streams. The acquisition is expected to have a positive impact on ISDN's bottom line. Mr. Teo has undertaken to provide a cumulative profit guarantee of \$7 million net profit after tax to ISDN for financial years of 2007 and 2008 combined. The proposed acquisition will add at least S\$2 million to the NPAT of ISDN for financial year 2008.

DIRAK GmbH & Co. KG ("Dirak", the holding company of Dirak Holding GmbH) group of companies, has a strong innovation heritage with their ownership of more than 250 patents. Most of these patents were created by Dirak's Founder and President, Dieter Ramsauer, who was recently nominated as one of the finalists for the prestigious 2007 Engineer of the Year Award by US-based Design News (see article in http://www.designnews.com/article/CA6478192.html).

Dirak Asia has a strong manufacturing base in Suzhou, China, since 2002. Plans are in the pipeline to expand the facilities to meet growing demand from the China market as well as for export. Mr. Teo said, "This acquisition opens a new vista of opportunities for ISDN to

provide a wider scope of engineering support services to our growing pool of global and domestic clienteles."

"It makes perfect economic sense for Dirak to be in partnership with ISDN to tap into our extensive distribution networks of over 50 offices in China and Asia," he added.

Mr. Teo concluded: "ISDN will continue to seek out for more of such partnership to expand the value chain for our customers and as a way to enhance our shareholder value."


