LOCAL GOVERNMENT, ENGLAND AND WALES CHANGES IN LOCAL GOVERNMENT AREAS The Waveney (Parishes) Order 1987

13th March 1987

Coming into force

for the purposes described

in article 2(1)

16th March 1987

for all other purposes

1st April 1987

Whereas the Waveney District Council, acting pursuant to section 48(8) of the Local Government Act 1972 (a), has made recommendations to the Local Government Boundary Commission for England for proposals about parishes in the district:

And whereas in consequence of those recommendations the Commission has seen fit, pursuant to sections 47, 48(9) and 51(1) of that Act, to make proposals to the Secretary of State:

And whereas more than six weeks has elapsed since those proposals were made:

And whereas the Secretary of State has decided to give effect to the proposals:

Now, therefore, the Secretary of State, in exercise of his powers under sections 51(2) and 67(4) and (5) of that Act and of all other powers enabling him in that behalf, hereby makes the following order:

Title and Commencement

1. This order may be cited as the Waveney (Parishes) Order 1987.

- 2. (1) 16th March 1987 is hereby specified as the day on which this order shall come into force for any purpose set out in regulation 4(1) (coming into operation of order) of the Local Government Area Changes Regulations 1976 (a).
- (2) For all other purposes, this order shall come into force on 1st April 1987.

Interpretation

3. In this order -

"boundary maps" means the 6 maps prepared by the Department of the Environment, marked "Maps of the Waveney (Parishes) Order 1987", duly numbered for reference, and deposited in accordance with regulation 5 of the Local Government Area Changes Regulations 1976;

"county electoral division" means an electoral division of the county of Suffolk;

"district council" means the Waveney District Council; and

"district ward" means a ward of the district of Waveney.

Creation of new parishes

- 4. (1) There shall be created in the district of Waveney 4 new parishes to be called Brampton with Stoven; Reydon; Somerleyton, Ashby and Herringfleet; and Wangford with Henham.
- (2) The new parish of Brampton with Stoven shall consist of the areas of the parishes of Brampton and Stoven as consituted immediately before 1st April 1987.
 - (3) The new parish of Reydon shall consist of:

⁽a) S.I. 1976/246, as amended by S.I. 1978/247.

- (a) the areas of the parishes of Easton Bavents and Reydon as constituted immediately before 1st April 1987, with the exception of the area marked A2 on boundary map 2; and
- (b) the area of the parish of Southwold marked D1 on boundary map 2.
- (4) The new parish of Somerleyton, Ashby and Herringfleet shall consist of the areas of the parishes of Ashby, Herringfleet and Somerleyton as constituted immediately before 1st April 1987.
- (5) The new parish of Wangford with Henham shall consist of the areas of the Parishes of Henham and Wangford as constituted immediately before 1st April 1987.

Creation of new parish councils

- 5. (1) There shall be a parish council for each new parish created by article 4.
- (2) From 1st April 1987 until the fourth day after the ordinary day of election of councillors in 1987 the parish council of the new parish of Brampton with Stoven shall consist of those parish councillors representing the parish of Brampton immediately before 1st April 1987. Thereafter it shall consist of 8 parish councillors.
- (3) From 1st April 1987 until the fourth day after the ordinary day of election of councillors in 1987 the parish council of the new parish of Reydon shall consist of those parish councillors representing the parish of Reydon immediately before 1st April 1987. Thereafter it shall consist of 15 parish councillors.
- (4) From 1st April 1987 until the fourth day after the ordinary day of election of councillors in 1987 the parish council of the new parish of Somerleyton, Ashby and Herringfleet shall consist of those parish councillors representing the parish of Herringfleet and those parish councillors representing the parishes of Ashby and Somerleyton immediately before 1st April 1987. Thereafter it shall consist of 12 parish councillors.

- (5) From 1st April 1987 until the fourth day after the ordinary day of election of councillors in 1987 the parish council of the new parish of Wangford with Henham shall consist of those parish councillors representing the parish of Wangford immediately before 1st April 1987. Thereafter it shall consist of 10 parish councillors.
 - (6) The proper officer of the district council shall convene -
 - (a) the first annual meeting of the parish council for each new parish; and
 - (b) the first assembly of the parish meeting for each new parish.

If in any new parish the first assembly of the parish meeting is held before the first annual meeting of the parish council, the parish meeting for that parish may appoint a person to take the chair, who shall have, for the purpose of that occasion only, the powers and authority of the chairman.

(7) In the financial year beginning on 1st April 1987, the district council shall levy rates in each new parish, and make payments to each parish council of a new parish, as if that parish council had issued a precept to the district council requiring the payment of a sum equal to the product of a rate of the amount in the pound shown below, calculated on the total rateable value of the new parish as set out in the valuation list at the beginning of that financial year -

Brampton with Stoven	1.0 p
Reydon	1.9 p
Somerleyton, Ashby and Herringfleet	1.7 p
Wangford with Henham	2.6 p

Transfers between parishes

- 6. (1) Each area marked as shown in column 1 of the Schedule hereto on the boundary map numbered in column 2 shall be transferred from the relevant parish named in column 3 to that named in column 4.
 - (2) Where in column 5 there is mentioned in relation to any area -

- (a) a district ward; or
- (b) a county electoral division;

that area shall additionally be transferred to that ward or division.

Areas ceasing to form part of any parish

- 7. (1) The part of the parish of Carlton Colville marked Bl on boundary map 4 shall cease to **b**e part of any parish, and shall be transferred to the Carlton district ward and the Oulton Broad county electoral division.
- (2) The part of the parish of Carlton Colville marked B2 on boundary map 4 and the parts of the parish of Gisleham marked B3 and B4 on boundary map 4 shall cease to be part of any parish, and shall be transferred to the Pakefield district ward and county electoral division.
- (3) The part of the parish of Corton which is marked B5 on boundary map 1 shall cease to be part of any parish and shall be transferred to the St Margarets district ward and the Lowestoff St Margaret's county electoral division.

Areas becoming part of a parish

- 8. (1) The part of the unparished area of the district of Waveney which is marked C2 on boundary map 4 shall become part of the parish of Carlton Colville, and shall be transferred to the Carlton Colville district ward and the Lothingland South county electoral division.
- (2) The part of the unparished area of the district of Waveney which is marked C3 on boundary map 4 shall become part of the parish of Gisleham, and shall be transferred to the Kessingland district ward and the Lothingland South county electoral division.
- (3) The part of the unparished area of the district of Waveney which is marked C1 on boundary map 1 shall become part of the parish of Oulton, and shall be transferred to the Lothingland district ward and the Lothingland North county electoral division.

Dissolution of parishes and parish authorities

9. The parish councils or the parish trustees (as appropriate) of the parishes shown in column 1 of the table below shall cease to exist. The residuary successor of each dissolved parish shall be the relevant parish shown in column 2, which shall also have custody of the public books and documents of the dissolved parishes -

This order affects parishes and the unparished area in the district of Waveney.

It -

- (a) creates 4 new parishes by amalgamation of 9 existing parishes;
- (b) makes transfers between parishes; and
- (c) makes transfers between parishes and the unparished area.

A parish council is established for each new parish.

The map forming part of this note (page 10) gives a general guide to the areas affected as from 1st April 1987.


