ALTERATION TO BOUNDARIES OF LOCAL AUTHORITIES PART IV

THE FOLLOWING BOUNDARY CHANGES CAME INTO EFFECT ON OR BEFORE 1 APRIL 1982

AVON

The Wansdyke (Parishes) Order 1981 (SI.1981 No 1349) effects adjustments between parishes in the District of Wansdyke and between two such parishes and a part of the district which is not comprised in any parish.

The Woodspring (Parishes) Order 1982 (SI 1982 No 392)

- (a) effects the transfer of parts of certain parishes, to other parishes;
- (b) effects adjustments between the Parish of Kewstoke and the part of the district which is not comprised in any parish.

BUCKINGHAMSHIRE

The Aylesbury Vale (Parishes) Order 1981 (SI 1981 No 1682) effects:-

- (a) the constitution of a new parish viz. the Parish of Gawcott with Lenborough; comprising part of the Town of Buckingham;
- (b) the transfer of one whole parish (Grove), and parts of other parishes; and
- (c) some adjustments between parishes and a part of the district not comprised in any parish.

## CAMBRIDGESHIRE

The Elm, March and Outwell (Areas) Order 1981 (SI 1981 No 1074) effects two transfers as between parishes in the District of Fenland.

The Huntingdon (Parishes) Order 1982 (SI 1982 No 197)

- (a) constitutes two new parishes viz the Parish of Godmanchester, comprising part of the Town of Huntingdon and Godmanchester (the remaining part of that town being renamed Huntingdon), and the Parish of Perry, comprising parts of the Parishes of Grafham and Great Staughton;
- (b) effects the transfers of parts of parishes, in the district to other parishes.

The Parish of Whittlesey Order 1981 (SI 1981 No 1075) constitutes a new parish viz the Parish of Whittlesey, comprising the area of the former urban district of Whittlesey, in the District of Fenland.

## CHESHIRE

The Congleton (Parishes) Order 1981 (SI 1981 No 1452) effects the transfer of parts of certain parishes, in the Borough of Congleton, to other parishes.

## CLEVELAND

The Langbaugh (Parishes) Order 1981 (SI 1981 No 1667) deals with the area of the former urban district of Skelton and Brotton in the Borough of Langbaugh. Part of it is added to the Town of Loftus. The remainder is formed into the new parishes of Lockwood and Skelton and Brotton.

## CUMBRIA

The Allerdale (Parishes) Order 1982 (SI 1982 No 195)

- (a) constitutes a new parish viz the Parish of Workington;
- (b) effects the transfer of parts of certain parishes, in the district, to other parishes.

## ESSEX

The Braintree (Parishes) Order 1981 (SI 1981 No 1628) constitutes three new parishes - Riverhall, Silver End and Witham - in the area of the former urban district of Witham.

## GREATER LONDON

The Greater London and Buckinghamshire (Areas) Order 1981 (SI 1981 No 1696) transfers part of the County of Buckinghamshire (and of the District of South Bucks and the Parish of Denham) to Greater London (and to the London Borough of Hillingdon).

## GREATER MANCHESTER

The Greater Manchester and Lancashire (Areas) Order 1981 (SI 1981 No 1649) transfers part of the County of Greater Manchester (and of the Borough of Wigan) to the County of Lancashire (and to the District of West Lancashire).

## HAMPSHIRE

The East Hampshire (Parishes) Order 1981 (SI 1981 No 1629)

effects:-

- (a) the constitution of a new parish viz the Parish of Lindford, comprising part of the Parish of Whitehill;

- (b) the transfer of parts of parishes to other parishes.

The Eastleigh (Parishes) Order 1981 (SI 1981 No 1348)

effects

- (a) the transfers of parts of certain parishes, in the Borough of Eastleigh, to other parishes;
- (b) adjustments between the Parish of Fair Oak and the part of the borough which is not comprised in any parish.

#### HUMBERSIDE

The Humberston and New Waltham (Areas) Order 1981 (SI 1981 No 1326) transfers parts of the Parish of Humberston in the Borough of Cleethorpes to the Parish of New Waltham in that Borough.

#### LEICESTERSHIRE

The Belvoir, Bottesford and Redmile (Areas) Order 1982 (SI 1982 No 128) transfers parts of the Parishes of Bottesford and Redmile in the Borough of Melton to the Parish of Belvoir in that borough.

The Charnwood (Parishes) Order 1982 (SI 1982 No 196)

- (a) constitutes two new parishes viz the Parish of Hathern comprising part of the area of the former borough of Loughborough, and the Parish of Shepshed, comprising the area of the former urban district of Shepshed;
- (b) effects transfers as between some parishes in the borough.

#### LINCOLNSHIRE

The Lincoln and North Kesteven (Areas) Order 1982 (SI 1982 No 141) alters the boundary between the City of Lincoln and the District of North Kesteven by transferring:

- (a) small parts of the City to the District and to the parishes of North Hykeham and Skellingthorpe; and
- (b) small parts of the District and parishes to the City.

The West Lindsey (Parishes) Order 1981 (SI 1981 No 1453) effects some transfers as between parishes in the district.

#### MERSEYSIDE

The Sefton (Parishes) Order 1981 (SI 1981 No 1773)

- (a) effects transfers of areas between parishes in the Borough of Sefton, involving the abolition of the Parish of Netherton;
- (b) adjustments between the Parish of Altcar-in-Merseyside and a part of the borough which is not included in any parish.

## NORFOLK

The South Norfolk (Parishes) Order 1981 (SI 1981 No 1597) effects some transfers as between parishes in the District of South Norfolk.

## NORTHAMPTONSHIRE

The Parish of Finedon Order 1981 (SI 1981 No 1715) constitutes a new parish viz the Parish of Finedon, comprising part of the area of the former urban district of Wellingborough, in the Borough of Wellingborough.

## NORTH YORKSHIRE

The Craven (Parishes) Order 1981 (SI 1981 No 1827) effects the transfer of parts of certain parishes, in the District of Craven to other parishes.

## SOMERSET

The Cheddar and Wedmore (Areas) Order 1981 (SI 1981 No 1343) transfers part of the Parish of Cheddar in the District of Sedgemoor to the Parish of Wedmore in that district.

The Yeovil (Parishes) Order 1982 (SI 1982 No 185)

- (a) constitutes two new parishes viz the Parish of Yeovil comprising the greater part of the area of the former borough of Yeovil and some other areas, and the Parish of Horton, comprising part of the parish of Ilminster (Without).
- (b) effects the inclusion of the remainder of the area of the former borough in parishes.
- (c) effects other transfers as between parishes.

These changes involve the abolition of the Parish of Ilminster (Without).

## SUFFOLK

The Mid Suffolk (Parishes) Order 1981 (SI 1981 No 1774)

- (a) amalgamates the Parishes of Brome and Oakley, in the District of Mid Suffolk, to constitute the Parish of Brome and Oakley.
- (b) effects the transfer of parts of parishes, in the district, to other parishes.

## SURREY

The Mole Valley (Parishes) Order 1981 (SI 1981 No 1844)

effects:

- (a) the constitution of two new parishes:
  - (i) Brockham comprising part of the area of the former urban district of Dorking and part of the parish of Betchworth.

- (ii) Mickleham comprising parts of the area of the former urban districts of Dorking and Leatherhead.
- (b) the transfer of parts of parishes to other parishes.
- (c) some adjustments between parishes and the part of the district not comprised in any parish.

- (b) effects the transfer of parts of parishes in the borough to other parishes;
- (c) effects some adjustments between parishes and part of the borough which is not comprised in any parish.

ESSEX

The Colchester (Parishes) Order 1981 (SI 1981 No 286) effects adjustments between parishes in the Borough of Colchester and part of the borough which is not included in any parish.

The Tendring (Parishes) Order 1981 (SI 1981 No 288) effects some transfers as between parishes in the District of Tendring.

GREATER MANCHESTER

The Manchester and Trafford (areas) Order 1980 (SI 1980 No 1920) transfers part of the City of Manchester to the Borough of Trafford.

HAMPSHIRE

The Hart (Parishes) Order 1981 (SI 1981 No 268)

- (a) effects the transfer of parts of certain parishes in the district of Hart to other parishes;
- (b) some adjustment between the Parish of Crookham Village and the part of the district which is not comprised in any parish (the area of the former urban district of Fleet).

HERTFORDSHIRE

The Great Gaddesden (Area) Order 1980 (SI 1980 No 1939) provides that part of the Parish of Great Gaddesden in the District of Decorum shall cease to form part of any parish and shall form part of the Grove Hill ward of the district.

HUMBERSIDE

The Oswestry (Parishes) Order 1981 (SI 1981 No 186) effects the transfer of parts of certain parishes in the Borough of Oswestry to other parishes.

- (a) constitutes a new parish, viz the Parish of Burtle, in the District of Sedgemoor;
- (b) effects the transfer of the Parish of Charlinch to the Parish of Spaxton and parts of other parishes in the district to other parishes;
- (c) effects some adjustments between parishes and the part of the district which is not comprised in any parish.

#### WILTSHIRE

The North Wiltshire and Thamesdown (Areas) Order 1980 (SI 1980 No 1558) transfers parts of the Parishes of Lydiard Millicent, Lydiard Tregoze and Purton from the District of North Wiltshire to the Borough of Thamesdown.

#### WATERCOURSE ORDERS - SECTION 73

The Oxfordshire and Wiltshire (Areas) Order 1980 (SI 1980 No 1919), Minor alterations having been made to a watercourse (River Cole and Cole Back Brook), this order alters the county boundaries of Oxfordshire and Wiltshire to follow, for the most part, the new watercourse.
