1) Benefits

- a These posts carry usual allowances i.e. Dearness Allowance (DA), House Rent Allowance (HRA), Transport Allowance (TA) etc. as admissible to the Central Government employees and as made applicable to CSIR. Council employees are also eligible for accommodation of their entitled type as per CSIR allotment rules depending upon the availability in which case HRA will not be admissible.
- b In addition to the emoluments indicated against each category of posts, benefits such as applicability of reimbursement of Medical Expenses, Leave Travel Concession (LTC), Conveyance Advance and House Building Advance are available as per CSIR rules.
- c The post will be governed by the New Pension Scheme applicable w.e.f. 01.01.2004 as notified by the Government of India and adopted by CSIR vide their No.17/68/2001-E.II dated 23.12.2003 and other instructions issued on the subject.
- d CSIR provides excellent opportunities to deserving candidates for career advancement under Revised Merit and Normal Assessment Scheme for Technical staff.

2) General Information & conditions:

- a. The number of vacancies indicated against each category is provisional. The Director, CSIR-CECRI has discretion to increase or decrease the number of posts or cancel the recruitment process at any stage.
- b. The applicant must be a citizen of India.
- c. All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement as on the last date of receipt of the on-line applications. They are advised to satisfy themselves before applying that they possess atleast the essential qualifications laid down for various posts as on the last date of receipt of the on-line applications. No interim enquiry asking for advice as to eligibility will be entertained.
 - The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle the candidates to be called for **Skill/Trade Test/Written exam**. The duly constituted Screening Committee will adopt its own criteria for short-listing the candidates. The candidate should therefore, mention in the application all the qualifications and experience in the relevant area over and above the minimum prescribed qualification, supported with necessary documents.
 - The application should be accompanied by self-attested copies of the relevant educational qualification, experience. The prescribed qualifications should have been obtained through recognized Universities / Institutions. Incomplete applications/applications received without the required certificates / documents are liable to be rejected.
- d. In respect of equivalent clause in Essential Educational Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date) under which it has been so treated otherwise the application is liable to be rejected.
- e. The period of experience rendered by a candidate on part time basis, daily wages, visiting/ guest faculty will not be counted while calculating the valid experience for short listing the candidates for Skill/Trade test.
- f. If any document/ certificate furnished is in a language other than Hindi or English, a transcript of the same duly attested by a Gazetted officer or notary is to be submitted.
- g. The date for determining the upper age limit, qualifications and /or experience shall be the closing date prescribed for receipt of on-line applications.
- h. The period of experience in a discipline / area of work, wherever prescribed, shall be counted after the date of acquiring the minimum educational qualifications prescribed for that Grade.

- i. Persons with Benchmark Disabilities (PwBD) fulfilling the eligibility conditions prescribed under GOI instructions are encouraged to apply.
- j. Any discrepancy found between the information given in the application and as evident in original documents will make the candidate ineligible for appearing in **Skill/Trade Test /Written examination**.
- k. The decision of the Director, **CSIR-CECRI** in all matters relating to eligibility, acceptance or rejection of applications, <u>mode of selection</u> and conduct of skill/Trade Test/ Written exam will be final and binding on the candidates.
- I. Canvassing in any form and / or bringing any political influence or otherwise will be treated as a disqualification for the post.
- m. NO INTERIM ENQUIRY OR CORRESPONDENCE WILL BE ENTERTAINED.
- n. Job requirement is indicative; the candidates may be assigned any other job depending on requirement of the Institute.
- o. The selected candidates will be posted in CSIR–CECRI, Karaikudi or its units at Chennai and Mandapam. The candidate(s) is/are required to work in shifts/during odd hours as and when required and he/she can be transferred to any of the CSIR Labs/Institutes anywhere in India.

3) Age limit & Relaxation:

- a. The upper age limit is relaxable upto 5 years for SC/ST and 3 years for OBC as per Government orders in force only in those cases where the posts are reserved for respective categories, on production of relevant certificate in the prescribed format signed by the specified authority.
- b. The Certificate for Backward Caste must clearly indicate that the candidate does not belong to the persons/sections (Creamy Layer) mentioned in Column 3 of Schedule to the Government of India, Department of Personnel & Training O.M. No. 36012/22/93-Estt(SCT) dated 8/9/93 as amended from time to time. The OBC certificates should be in the format FOR APPOINTMENT TO POSTS UNDER THE GOVERNMENT OF INDIA with reference to relevant Government of India Orders meeting the Creamy Layer Criteria as laid down by Government of India and not for appointment in any of the States bearing references to those State Government Orders. OBC candidate's eligibility will be based on Castes borne in the Central List of Govt. of India. Their Sub-caste should match with the entries in Central List of OBC, failing which their candidature will not be considered under any of the applied reserved category and will be treated as UR, if otherwise eligible. The OBC candidates who belong to "Creamy layer" are not entitled to concession admissible to OBC category and such candidates have to indicate their category as General.
- c. The Benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority as per DoPT O.M. No.36039/1/2019-Estt(Res) dated 31st January 2019. The income and Asset Certificate issued by specified authorities in the prescribed format shall only be accepted as proof of candidate's claim as belonging to EWS.
- d. Upper age limit is also relaxable upto five years for the regular employees working in CSIR laboratories / Institutes, Government Departments, autonomous bodies and public sector undertakings.
- e. As per GOI provisions, age relaxation for Widows, Divorced Women and Women Judicially separated from Husbands, who are not remarried, the upper age limit is relaxable up to the age of 35 years (upto 40 years for members of Scheduled Castes/Scheduled Tribes and upto 38 years for members belonging to the Other Backward Classes in respect of the posts reserved for them). The persons claiming age relaxation under this sub-para would be required to produce the following documentary evidence:
 - i. In case of Widow, Death Certificate of her husband together with the Affidavit that she has not remarried since.
 - ii. In case of divorced Women and Women judicially separated from their husbands, a certified copy of the judgement/decree of the appropriate Court to prove the fact of divorce or the judicial separation, as the case may be, with an Affidavit in respect of divorced Women that they have not remarried since.

- f. Relaxation in age, over and above the stipulated limit, educational qualification and / or experience may be considered in case of exceptionally meritorious candidates or if sufficient number of candidates possessing the requisite qualification and/ or experience are not available to fill up the posts.
- g. Relaxation of five years will also be permissible to those who had ordinarily been domiciled in the Kashmir division of the state of Jammu and Kashmir during the period from 1-1-1980 to 31-12-1989 subject to production of relevant certificate from the concerned authority.
- h. Relaxation in case of ex–servicemen will also be applicable as per provisions.
- i. Appointments to the reserved posts will be provisional and subject to the verification of caste certificates through proper channels. If the verification reveals that the claim of the candidate belong to the SC/ST/OBC/EWS is false, his/her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.

j. Age relaxation to Persons with Benchmark Disability (PwBD):

Age relaxation of 10 years for Unreserved [total 15 years for SC/ST and 13 years for OBC candidates] in upper age limit shall be allowed to persons suffering from the following benchmark disabilities as per GOI instructions:

(i) Category A - blindness and low vision;

(ii) Category B - deaf and hard of hearing;

(iii) Category C - locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;

(iv) Category D - autism, intellectual disability, specific learning disability and mental illness;

(v) Category E - Multiple disabilities from amongst persons under clauses (A) to (D) including deaf- blindness.

Note: Definition of the above specified disabilities will be as per "THE RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016".

The persons claiming age relaxation under this sub-para would be eligible for relaxation in conditions/reservation in posts who suffer from not less than 40% of relevant benchmark disability. Those Persons with Benchmark Disabilities (PwBD) who have availed the relaxation and/or reservation will have to submit Certificate of Disability issued by the Competent Authority as per the Form I and II of rule 18 (1) under chapter 7 of Rights of Persons with Disabilities Rules, 2017 dated 15.06.2017. The existing certificates of disability issued under the Persons with Disabilities Act 1995 (since repealed) shall continue to be valid for the period specified therein.

No Application Fee is payable by them. All other relaxations/concessions will be as per the Government of India orders. PLEASE NOTE, PwBD CANDIDATES SHOULD MENTION IN APPLICATIONS, THEIR CASTE/COMMUNITY LIKE SC/ST/OBC/GEN/EWS and also produce Certificate of the concerned Caste/Community, as this is a horizontal reservation. Candidates with benchmark physical disability only would be considered as Persons with Disabilities (PwD) and entitled to reservation for Persons with Disabilities. A candidate under the category PwBD will be considered to be eligible for appointment only if he/she (after such physical examination as the appointing authority may prescribe) is found to satisfy the requirements of physical and medical standards for the above post.

k. All the Age relaxations indicated above are not exhaustive. For detailed information of age relaxations, please refer the orders of Government of India/CSIR.

Candidates are required to submit a latest OBC/EWS Certificate issued by Competent Authority.

4) Mode of selection:

The candidates short-listed by the duly constituted Screening Committee will be called for a Skill/Trade test. Those who qualify in the Skill/Trade test will be called for a Competitive written examination in Mental Ability Test, General Awareness, English Language and concerned subject. The final merit list will be prepared on the basis of the performance of the candidates in the competitive written examination. Syllabus for the examination is attached herewith as **Annexure-!**.

5) How to apply:

- a. Eligible candidates are required to apply ONLINE through our website http://www.cecri.res.in
- b. If the candidate does not have a valid email id, he/she should create a new valid email id before applying online.
- c. Online application will be available in CSIR–CECRI website http://www.cecri.res.in from 09:00 a.m. on 28.08.2021 (Saturday) to 05.00 p.m. on 27.09.2021 (Monday).
- d. The last date for submitting online application and remittance of application fee is **27.09.2021.** This date will be the same for the candidates belonging to far-flung areas.
- e. The candidate has to remit an application fee of Rs.500/- through Net Banking only (Payment of fee through Mobile Banking should be avoided as it does not match with the banker's transaction reference number) to the following account and fill up the transaction details in the prescribed columns of online application:
