



#### **Mobile Score**







#### The only minor issues found are:

- Serve images in next-gen format. Image formats like WebP and AVIF often provide better compression than PNG or JPEG, which means faster downloads and less data consumption
- Properly size images. Serve images that are appropriately-sized to save cellular data and improve load time.







Roadmap was found on the website and is displayed above. All milestones are on track so far and they are heading to the next phase of their plan.

The Project aims to release an NFT marketplace in October, and run a lot of marketing campaigns after the successful release of their token in PancakeSwap. Game releases and exchange listings are planned for November.
