- (1) The Convention entered into force on 13 July 1962, i.e., three months after deposit of a second instrument of accession following three signatures without reservation of ratification. For any other Governments, it will enter into force three months after deposit of their instruments of ratification or accession.
- (2) Extended on the same date to Jersey, the Isle of Man and the Bailiwick of Guernsey. Extended with effect from 14 March 1974 to Hong Kong.
- (3) In accordance with Article 23, does not consider itself bound by Article 6, paragraph 1 (a).
- (4) Extended to the Netherlands Antilles and to Aruba.
- (5) Greenland and the Faroe Islands are considered as territories to which the Convention shall not apply without special notification.
- (6) Extended to the Principality of Liechtenstein, for such time as the Treaty of Customs Union with Switzerland remains in force.
- (7) Extended to the territory of Papua and the Trust Territory of New Guinea, with effect from 15 May 1968.
- (8) Extended to the Hong Kong, China with effect from 1 July 1997.
