## PUBLIC ACCOUNTS COMMITTEE ITS ROLE AND FUNCTIONS

#### Dr Rup Narayan Das

he Public Accounts Committee (PAC) which was set up in 1921 in India is commemorating its centenary this year. It is the oldest Parliamentary Committee in the country. The fact that it has continued its existence all these years in spite of of a number of other creation Parliamentary Committees including the Standing Departmentally Related Committees in subsequent years speaks of its continued relevance in our Parliamentary system.

The rationale behind the Public Accounts Committee can be found in Article 265 of the Constitution which provides that no tax can be levied or collected except by authority of law. Further, Article 266(3) of the Constitution envisages that no moneys out of the Consolidated Fund of India or the Consolidated Fund of a State shall be appropriated except in accordance with law and for the purposes and manner provided in the Constitution. To put it



simply, no money can be drawn or spent by the government without prior approval by Parliament or the legislature of the government and

rupees every year for meeting the expenditure of various departments of the makes specific appropriation for this purpose under different heads. Financial sanctions Parliament grants hundreds of crores of provide checks on the dispensation of

public funds by the Ministries and it is the prerogative of Parliament to ensure that the sanctioned funds have been spent prudently, frugally following due diligence. However in view of its size and complexity of state activities coupled with dearth of time at its disposal, it is not possible for Parliament to scrutinise, if the sum approved has been utilised properly or not. It has, therefore, delegated the task of scrutiny and control over the public expenditure to three financial Committees of Parliament, viz, Public Accounts Committee, the Estimates Committee and the Public Undertakings Committee.The Public Accounts Committee examines the accounts showing the appropriation of sum of money granted by Parliament for the expenditure of the Union government, the Annual Financial Accounts of Government of India and such other accounts laid before Parliament with their respective Audit Reports as the



## WHAT IS OPHTHALMO-

Ophthalmology is a medical branch which deals with the diagnosis and treatment of eye conditions. The term ophthalmology comes from the Greek language, ophthalmos means "eye" and luke means "doctors." It handles both medicinal and surgical solution of the diseases related to the physiology and anatomy of the human eye.

#### WHO IS AN OPHTHALMO-LOGIST?

An ophthalmologist is a doctor specializing in the diagnosis and

treatment of eye disorders." An ophthalmologist differs from optometrists and opticians depending on their level of training and what they can treat. There are different types of eye care professionals: optometrists, ophthalmologists and there is a third "O" among eye care providers: the optician.

Optometrist: Optometrists examine eyes for both vision and health problems, and correct refractive errors by prescribing glasses and contact lenses. Some optometrists also provide low vision care and vision therapy. They do everything from prescribing glasses or contacts for patients, to diagnosing eye problems and disease. Optometrists may also participate in your pre- and post-operative care if you have eye surgery performed by an ophthalmologist.

Ophthalmologist: An ophtha-Imologist is a medical doctor (MD) who specialises in eve and

vision care. Ophthalmologists are trained to perform eye tests, diagnose and treat disease. prescribe medications and perform eye surgery. They also write prescriptions for glasses and contact lenses.

Optician: Opticians are technicians trained to design. verify and fit eveglass lenses and frames, contact lenses, and other devices to correct eyesight. They use prescriptions supplied by ophthalmologists or optometrists, but do not test vision or write prescriptions for visual correction. Opticians are not permitted to diagnose or treat eye diseases.

If your eyes are healthy and don't require specialised medical or surgical treatment you should

## 100 CRORE COVID-19 VACCINE DOSES ADMINISTERED







## CONGRATULATIONS INDIA!

ndia witnessed the triumph of science, enterprise and collective spirit of 130 crore Indians when the country achieved the landmark milestone of administering 100 crore COVID-19 vaccinations in one of the world's largest and fastest vaccination drives.

The journey of administering 100 crore 'Made in India' vaccines - Covaxin and Covishield - to the citizens of India started on January 16, 2021 under the leadership of Hon'ble Prime Minister Shri Narendra Modi. Since the dawn of the pandemic. India has shown its commitment to protecting its citizens by taking on this arduous and formidable task involving enormous resources, unstinted support of the States/UTs, untiring efforts of Health Care Workers. Front Line Workers and proactive participation of all stakeholders. Immunization programme was being implemented in India, as in other countries, in a phased manner to cover healthcare providers, frontline workers and the most vulnerable.

100 crore vaccine doses is an unprecedented accomplishment, and the world applauds India. Let's take a look at the journey of India's vaccination achievement. Here are the highlights:

29 November, 2020: The Government of India announced the third stimulus package of Rs. 900 Crore for the Mission COVID Suraksha - The Indian COVID-19 Vaccine Development Mission. This grant was to be provided to the Department of Biotechnology (DBT) for the Research & Development of Indian COVID-19 vaccines.

The important objectives of the fund were accelerating pre-clinical & clinical development; licensure of COVID-19 vaccine candidates that were currently in clinical stages or ready to enter the clinical stage of development, establishing clinical trial sites, and

strengthening the existing immunoassay laboratories, central laboratories and suitable facilities for animal studies, production facilities and other testing facilities to support COVID-19 vaccine development. The other important objective was to support the development of common harmonized protocols, training, data management systems, regulatory submissions, internal and external quality management systems and accreditations.

3 January, 2021: Drugs Controller General of India (DCGI) granted approval to vaccines of Serum Institute India (CovIshield) and Bharat Biotech (Covaxin).

M/s Serum Institute of India, Pune presented a Recombinant Chimpanzee adenovirus vector vaccine (Covishield) encoding the SARS-CoV-2 Spike (S) glycoprotein with technology transfer from AstraZeneca/Oxford University. M/s Bharat Biotech developed a Whole Virion Inactivated Corona Virus Vaccine (Covaxin) in collaboration with ICMR and NIV (Pune), from where they received the virus seed strains.

16 January, 2021: Prime Minister Narendra Modi launched pan India rollout of the first phase of COVID-19 vaccination drive. In the first phase of the drive, Healthcare Workers were prioritised.

This marked the world's largest vaccination program, covering the entire length and breadth of the country. The Prime Minister said that usually it takes years to prepare a vaccine but here in India, in such a short time, not one but two made-in-India vaccine were launched.

- 2 February, 2021: Vaccination of the Frontline Workers (FLWs) started.
- 19 February, 2021: India crossed a landmark milestone more than 1 crore vaccine doses administered against COVID-19. It took India 34 days to

achieve the landmark feat, the second fastest in the world.

1 March, 2021: Commencement of the next phase of COVID-19 vaccination for those were are over 60 years of age and for people aged 45 and above with

specified co-morbidities. The Prime Minister also took his first dose of the COVID-19 vaccine at AlIMS New Delhi. In a tweet, he said, "Took my first dose of the COVID-19 vaccine at AlIMS. Remarkable how our doctors and scientists have worked in quick time to strengthen the global fight against COVID-19. I appeal to all those who are eligible to take the vaccine. Together, let us make India COVID-19 free!"

- 10 April 2021: India becomes the fastest country to administer 100 million (10 crore) doses of COVID-19 vaccine. India achieved the feat in 85 days.
- 13 April, 2021; Russia's Sputnik V approved for emergency use in India. Government authorises foreign-produced COVID vaccines with emergency approval of WHO-listed agencies
- 30 April 2021: Drone use permission granted to ICMR for study of Vaccine delivery using drones and conditional exemption to the Government of Telangana for conducting experimental Beyond Visual Line of Sight (BVLOS) drone flights for delivery of vaccines.
- 1 May, 2021: The Liberalised and Accelerated Phase-3 Strategy of COVID-19 Vaccination came into force.
- 13 May, 2021: The gap between two doses of Covishield Vaccine extended from 6-8 weeks to 12-16 weeks based on recommendation of COVID Working Group chaired by Dr N K Arora. Based on the available real-life evidences, particularly from UK, the COVID-19 Working Group agreed for increasing the dosing interval to 12-16 weeks between two doses of Covishield vaccine.
- 2 July, 2021: Pregnant Women became eligible for COVID-19 Vaccination after Dr. N.K. Arora's,


Chairperson of the COVID-19 Working Group of the National Technical Advisory Group on Immunization (NTAGI), recommendations. 2.27 lakh pregnant women received COVID-19 Vaccines in less than a month (till 30 July, 2021).

13 August, 2021: First nasal vaccine developed by Bharat Biotech supported by Department of Biotechnology, Biotechnology Industry Research Assistance Council (DBT-BIRAC) gets nod of regulator for Phase 2 Trial. Bharat Biotech's Intranasal vaccine was the first nasal vaccine that received the regulatory approval for Phase 2 trials. BBV154 is an intranasal replication-deficient chimpanzee adenovirus SARS-CoV-2 vectored vaccine. BBIL has in-licensed technology from Washington University in St Louis, USA.

- 20 August, 2021: Zydus Cadila received approval for Emergency Use Authorization (EUA) from the DCGI for ZyCoV-D, the world's first and India's indigenously developed DNA-based vaccine for COVID-19 to be administered in humans including Children 12 years and above. Developed in partnership with the Department of Biotechnology, Government of India under the 'Mission COVID Suraksha' and implemented by BIRAC, ZyCoV-D has been supported under COVID-19 Research Consortia through National Biopharma Mission for Preclinical studies, Phase I and Phase II Clinical Trials and under the Mission COVID Suraksha for Phase III Clinical
- 13 September, 2021: India's cumulative COVID-19 vaccination Coverage exceeds 75 crore shots.
- 17 September, 2021: Highest ever vaccination figure of 2.5 crore doses administered in a single day making India's Cumulative COVID-19 Vaccination Coverage cross the 79 crore mark.
- 4 October, 2021: Shri Mansukh Mandaviya, Union Minister for Health and Family Welfare launched ICMR's Drone Response and Outreach in North East (i-Drone). This is a delivery model to make sure that life-saving vaccines reach everyone. First time in South Asia, a "Make in India' drone used to transport COVID-19 vaccines over an aerial distance of 15 kms in 12-15 min.
- 15 October, 2021: Himachal Pradesh's Kinnaur becomes the first fully vaccinated district in the country.
- 21 October 2021: 100 crore mark reached.

#### PUBLIC ACCOUNTS COMMITTEE: ITS ...

#### Composition

The Public Accounts Committee consists of not more than 22 members comprising 15 members who are elected by the Lok Sabha every year from among its members according to the principle of proportional representation by a single transferable vote and not more than 7 members of the Rajya Sabha to be nominated by that House. The Chairman of the Committee is appointed by the Speaker, Lok Sabha from amongst its members.

The PAC has to ascertain that due diligence is scrupulously observed in such spending. It is significant to note

Committee may deem appro- that since 1967, an important member belonging to Opposition Party has been appointed as the Chairman of PAC. Veteran Parliamentarians like M.R. Masani, Atal Behari Vaipavee, Jyotirmay Basu, Professor Hiren Mukherjee, Narasimha Rao, T.A. Pai, R. Venkat Raman, Jaswant Singh, Dr. Murali Manohar Joshi, just to name a few have occupied the position and discharged the responsibility with great distinction.

> In scrutinising the Appropriation Accounts of the Government of India and the Reports of the C&AG, the PAC have to satisfy:

> (a) That the money shown in the accounts as having been disbursed were legally available for and applicable to the service or purpose to

- which they have been applied or charged.
- (b) That the expenditure conforms to the authority which govern it; and
- (c) That every re-appropriation has been made in accordance with the provisions made in this behalf under rules framed by competent authority.

#### Role of Comptroller & **Auditor General**

In discharging its responsibility to scrutinise the public expenditure and to ascertain if due diligence has been exercised in incurring such expenditure, the Public Accounts Committee is guided by the Comptroller and Auditor General, who is regarded as the 'friend, philosopher and guide of the Committee'. Article 151 of the Constitution requires the Comptroller and Auditor General of India to submit its report(s) on the

accounts of the Union and State money has been spent by the governments to the President or Governor as the case may be who will cause them to be laid before the Parliament or the State Legislature. The Audit Reports, Finance Accounts and Appropriation accounts after they are presented to the Parliament or State legislature stand referred to the Public Accounts Committee, which takes cognizance with the reports of C&AG. The PAC has, however, inherent powers for critique of the nation's finances. So its mandate is broad and comprehensive; of course it should not override the jurisdiction of sister Parliamentary Committees.

The Committee, on its own, on some occasions in the past initiated enquiries into various irregularities which were made public even though no formal Audit Report was presented to the House on the subject and it is within the power of the PAC to initiate such enquiries suomoto. Although the Committee is not concerned with questions of policy of the government, if the Committee finds during evidence that a particular policy is not vielding the desired results or is leading to waste, it is open to the Committee to report to the House that a change in the policy is called for.

Since 1962-63, the Committee has also started examining the revenue receipts of the Government of India. If any Government on any service during the financial year in excess of the amount granted by Parliament for that purpose, the Committee examines with reference to the facts of each case the circumstances leading to such an excess and presents a report thereon to the House. In recent years, the activities of the government have increased many fold, particularly with regard to public welfare measures resulting in huge investment. More over due to technological advancement, the economy has become more complex. All these developments are challenges before the government, the Parliament and the Public Accounts Committee.

#### Effectiveness

The recommendations of the Committee have far reaching effect in toning up financial administration. Implementation of its recommendations by the government is watched seriously by the Committee through the Action Taken Report. Hence the Committee is held in high esteem and most of its recommendations are accepted by the government and implemented.

If you already have a medical eye condition such as glaucoma, macular degeneration or cataracts -it is important to seek care from an eye care professional who is highly trained and skilled in monitoring and treating your condition. In many cases, this may mean that medical or surgical eye care by a specially trained ophthalmologist is required.

#### HOW TO BECOME AN OPHTHALMOLOGIST?

Aspirants who wish to specialize in Ophthalmology will first have to complete an Undergraduate course in MBBS (Bachelor of Medicine and Bachelor of Surgery), followed by a postgraduate degree in Ophthalmology like MD (Doctor of Medicine), and MS (Master of Surgery), depending on what practice they would like to build a career in

#### For MBBS (UG-level):

Aspiring candidates must have passed their 12th Board examination with a minimum aggregate of 50%. The core subjects in the said examination must be Physics. Chemistry, and Biology.

#### For MS/MD/other PG courses in Ophthalmology:



#### WHAT DOES AN OPHTHAL-MOLOGIST DO2 WORK DESCRIPTION

The roles and responsibilities of an ophthalmologist include diagnosing and treating all eye conditions There are several ophthalmologists who are involved in scientific research on the causes and cures of an eye ailment. Several times ophthalmologists recognise other health problems irrelevant to the human eve and refer those patients to the concerned doctor for treatment The responsibilities of an Opthal-

- Providing routine care such as vision testing and prescribing classes and contact lenses

- The birth anniversary of a great icon and a brave warrior, Bhagwan Birsa Munda ji is falling on the 15th of November. The way Bhagwan Birsa Munda fought to protect his culture, his forest, his land, it could have only been done by 'Dharti Aaba'! He taught us to be proud of our culture and roots. The foreign rule subjected him to countless threats and applied Immense pressure, but he did not relinquish the tribal culture. He strongly opposed every such policy of foreign rule, which was detrimental for environment. Bhagwan Birsa Munda was always at the forefront while helping the poor and the distressed. He also made the society aware towards eliminating social evils. The British government put him in jail; he was tortured to such an extent that he left us at the age of less than 25 years. He left us, but only in the body; in the public psyche, Lord Birsa Munda resides forever! His life remains an inspirational force for the people.

Many companies are also setting up manufacturing units. The Army, Navy and Air Force have also placed orders worth more than Rs 500 crores with the Indian drone companies. And this is just the beginning. We must not stop here. We have to become a leading country in Drone Technology. For this, the Government is taking all possible steps.

## **News Digest**

#### NATIONAL

#### ■ PM Modi launches mega health infrastructure mission

Prime Minister Narendra Modi has launched the PM Ayushman Bharat Infrastructure Mission with a total outlay of 64,180 crore rupees. Launching the nationwide scheme from Mehandiganj in Varanasi on 26th October 2021, Mr



Modi said, under this mission, the government will expedite the development of a network of treatment and critical care units in every nook and corner of the country. It will provide affordable, accessible and cheap holistic healthcare facilities in the country. Health and Wellness Centers will be opened in villages and cities and facilities like free medical consultation, free tests, and free medicine will be provided in these centres. For serious illnessess, thirty thousand new critical care-related beds are being added in 600 districts and referral facilities will be given in 125 districts under this mission. The Prime Minister also inaugurated nine medical colleges in Uttar Pradesh on 26th October 2021. The Medical Colleges are situated in Siddharthnagar, Etah, Hardoi, Pratapgarh, Fatehpur, Deoria, Ghazipur, Mirzapur and Jaunpur districts.

#### ■ Four-year Integrated Teacher Education Programme notified

Ministry of Education has notified the four-year Integrated Teacher Education Programme (ITEP). It will be a holistic Bachelor's Degree programme for B.A. - B.Ed, B.Sc.-B.Ed. and B.Com.-B.Ed. as mandated by the National Education Policy (NEP)- 2020. As per the NEP 2020, teacher engagement from the year 2030 onwards will be only through ITEP. It will be offered in pilot mode initially in about 50 selected multidisciplinary institutions across the country. The commencement of four-year ITEP will begin from the academic session 2022-23. Admission for the same will be carried out by the National Testing Agency (NTA) through the National Common Entrance Test (NCET).

#### ■ MGNF phase-II to facilitate skill development at grassroots

The Ministry of Skill Development and Entrepreneurship has launched phase II of the Mahatma Gandhi National Fellowship. The scheme alms to create opportunities for young and dynamic individuals to take up or contribute to projects meant for enhancing skill development at the grassroots. The two-year fellowship would include classroom sessions by academic partner Indian Institute of Management (IIM) on ways to create credible plans and identify barriers in raising employment, economic output, and promoting livelihoods in rural areas. Union Minister Dharmendra Pradhan has said that tremendous transformations are taking place across sectors which will create demand for new skills and more skilled professionals. He stressed on skill mapping at the district level and directed skill development efforts accordingly.

#### ■ Indian Coast Guard Ship 'Sarthak' dedicated to the Nation

In a significant boost to the maritime safety and security of the Nation, the indigenously built Indian Coast Guard Ship Sarthak was dedicated to the nation at Goa on 28 October 2021. The ship will be based at Porbandar in Gujarat and will operate on India's Western Seaboard under the operational and administrative control of the Commander, Coast Guard



Region (Northwest). Sarthak is fitted with state-of-the-art equipment, sensors and weapons which enable it to function as a command platform and undertake mandated Coast Guard duties including search and rescue, combating maritime crimes and preserving and protecting the marine environment.

India successfully test fires surface to surface ballistic missile Agni-5 Surface to surface ballistic missile, Agni-5 was successfully launched from APJ Abdul Kalam Island in Odisha on 27 October 2021. Agni-5 is capable of striking targets at ranges up to 5,000 kilometers with a very high degree of accuracy. It uses a three-stage solid-fuelled engine. The successful launch is in line with India's policy to have 'credible minimum deterrence' that underpins the commitment to 'No First Use'.

#### INTERNATIONAL

#### India, ASEAN call for freedom of navigation and overflight in South China Sea

Prime Minister Narendra Modi and ten ASEAN countries have affirmed the importance of maintaining and promoting peace, stability, safety and security in the South China Sea and ensuring freedom of navigation and overflight. An official statement issued at the end of the 18th India-ASEAN Summit said that both sides noted the importance of promoting a rules-based order in the region including through upholding adherence to international law, especially the United Nations Convention on the Law of the Sea (UNCLOS).

#### ■ China clarifies new law will not change its position on border issues

China has said its new land border law will not affect the implementation of existing border treaties or change the country's position on border-related questions. Beijing's response came after India's Ministry of External Affairs expressed concerns about the legislation in view of a protracted military standoff between India and China along the Line of Actual Control (LAC) in eastern Ladakh. China's parliament, the National People's Congress (NPC), passed the law on 23 October 2021 specifying the way military and local authorities will govern and guard the country's 22,000 km of land border shared with 14 countries including India. The law, which says China's sovereignty and territorial integrity are "sacred and inviolable", talks about the role of military defence of China's land borders alongside improving social and economic development in border areas.

#### **ECONOMY**

#### ■ Shaktikanta Das reappointed as RBI Governor for three more years

The government has approved the reappointment of Shaktikanta Das as Governor of the Reserve Bank of India for a period of three years. The Appointments Committee of the Cabinet has approved the reappointment of Mr Das. The re-appointment will be effective from 10th December this year until further orders.



#### Krishi UDAN 2.0 for optimization of agri-harvesting

The Civil Aviation Ministry has released Krishi UDAN 2.0. The scheme proposes to facilitate and incentivize the movement of agri-produce by air transportation. It lays out the vision of improving value realization through better integration and optimization of agri-harvesting and air transportation. The scheme aims to aid the goal of doubling farmers' income by removing barriers in the supply chain, logistics and transportation of farm produce. The Krishi UDAN 2.0 will be implemented at 53 airports across the country mainly focusing on Northeast and tribal regions and is likely to benefit freight forwarders and airlines as well.

#### AIIB, ADB to co-finance USD 2 billion loan for India's fight against COVID-19

As India crossed the milestone of administering one billion doses of COVID-19 vaccines, it is leveraging its membership of multilateral financing institutions to





boost the immunization rate of the country's eligible population. Beijing-based multilateral development bank Asian Infrastructure Investment Bank (AIIB) and the Asian Development (ADB) will co-finance a USD 2 billion loan for India to procure COVID-19 vaccines under ADB's Asia Pacific Vaccine Access Facility (APVAX). The AIIB is considering providing USD 500 million and the Manila-based ADB is expected to finance USD 1.5 billion. About 667 million doses of COVID-19 vaccines were expected to be procured through the loan, according to project details mentioned on the Bank website. He said the vaccines will be purchased by the Government of India through a competitive process and the ADB will be administering the purchasing system and implementing it under ADB's APVAX, or Asia-Pacific Vaccine Access Facility, mechanism.

#### ■ RBI allows FPIs to invest in debt securities issued by REITs, InvITs

The Reserve Bank of India (RBI) has decided to allow Foreign Portfolio Investors (FPIs) to invest in debt securities issued by Real Estate Investment Trusts (REITs) and Infrastructure Investment Trusts (InvITs). The move is expected to provide much-needed patient capital and liquidity to the new asset class. Finance Minister Nirmala Sitharaman, in the Union Budget, 2019, had allowed FPIs to invest in REITs and InvITs, but the enabling was yet to take place. The Central Bank has now amended the Foreign Exchange Management (Debt Instrument) Regulations, 2021 to allow such investments.

## Former Cricket Captain Rahul Dravid formally applies for head coach's post

Former Captain Rahul Dravid is all but certain to be the Indian Cricket team's next head coach after he formally applied for the high-profile position on 26 October 2021. Dravid had recently met the BCCI brass in Dubai on the sidelines of the IPL final between Kolkata Knight Riders and Chennal Super Kings. During the meeting, BCCI President Sourav Ganguly and Secretary Jay Shah had



spoken to him about taking up the position once Ravi Shastri steps down at the end of India's campaign in the ICC T20 World Cup.
