#### RESOLUTION NO. 06-2019-GOODS-RSM

# RECOMMENDING THE AWARD OF CONTRACT VIA PUBLIC COMPETITIVE BIDDING TO PT INDUSTRI KERETA API (PERSERO) FOR THE PROCUREMENT OF TEN (10) AIR CONDITIONING UNITS FOR PASSENGER COACH

WHEREAS, the PNR Rolling Stock Maintenance Department sees the need to procure TEN (10) AIR CONDITIONING UNITS FOR PASSENGER COACH herein referred to as "Goods", with an Approved Budget for the Contract (ABC) THIRTY-FIVE MILLION AND 00/100 PESOS (PHP 35,000,000.00), covered by General Appropriations Act for CY 2014 (GAA CY 2014). The funding for the project is covered by SARO-BMB-F-14-0008200 (Annex "A");

WHEREAS, the PNR Board of Directors issued Resolution No. 237-2018 (Annex "B") approving the said ABC and authorizing the Philippine National Railways Bids and Awards Committee 2 (PNR BAC 2) to conduct public bidding in accordance with Republic Act No. 9184 and its 2016 Implementing Rules and Regulations, subject to the usual accounting and auditing rules of the Commission on Audit and in accordance with all applicable laws, rules, and regulations;

**WHEREAS**, in pursuance of the above, and in compliance with R.A. 9184 and its R-IRR, the PNR BAC 2 initiated the public bidding process for the Infrastructure by conducting a pre-procurement conference on 30 July 2018 (Annex "C");

WHEREAS, in pursuance of the above, the PNR BAC 2 invited all interested bidders to participate in a competitive bidding. Such Invitation to Bid was duly advertised/published in the Business Section of the Philippine Star dated 01 August 2018 (Annex "D) and at the same time, posted to the Philippine Star by the PNR website, and on the PNR bulletin board (Annex "D-1");

WHEREAS, on 09 August 2018, a Pre-Bid Conference was held and was attended by two (2) prospective bidders as shown in the attendance sheet (Annex "E");

WHEREAS, on 23 August 2018, the formal submission and opening of bids was conducted and two (2) bidders submitted their bidding documents; during the said opening of bids, the PNR BAC 2 checked the submitted documents against a checklist of required documents using the non-discretionary "pass/fail" criterion, as stated in the Instruction to Bidders of the Bidding Documents; hence, the result of the Bid opening is as follows:

WHEREAS, on 22 August 2018 the PNR BAC 2 issued Bid Bulletin No. 1 moving the deadline of submission and opening of Bids for the Procurement of Ten (10) Air Conditioning Units for Passenger Coach from the original date 23 August 2018 to 24 August 2018, 2:00 pm at PNR Board Room. A copy of said notice is attached as Annex "F";

**WHEREAS**, on the same date the PNR BAC 2 issued **Bid Bulletin No. 2** again moving the deadline of submission and opening of bids from the original date 23 August 2018 to 30 August 2018, 2:00 pm at PNR Board Room due to lack of indicative quorum. A copy of said notice is attached as **Annex "G"**;

WHEREAS, on 29 August 2018 the PNR BAC 2 issued Bid Bulletin No. 3 moving the deadline of submission and Opening of Bids for the Procurement of Ten (10) Air Conditioning Units for Passenger Coach from 30 August 2018 to 10 September 2018, 2:00 pm at PNR Board Room due to lack of indicative quorum. A copy of said notice is attached as Annex "H";

WHEREAS, on 10 September 2018, the formal Submission and Opening of the Bids was conducted and One (1) Bidder submitted their Eligibility Documents. The PNR BAC 2 checked the submission against a checklist of required documents using the non-discretionary "pass/fail" criteria, as stated in the Instruction to Bidders of the project Bidding Documents.

WHEREAS, the PNR BAC 2 approved and adopted the TWG's Bid Evaluation Report dated 11 September 2018 (Annex "J") which indicates that the bid submission of PT INKA (Persero) passed the evaluation and was responsive. Further, the total calculated amount it offered in the amount of Thirty Three Million Four Hundred Eighty Five Thousand Six Hundred Fifty Pesos (Php 33,485,650.00), is the Lowest Calculated Bid (LCB). Consequently, a Notice of Lowest Calculated Bid and submission of Post-Qualification Requirements dated 19 September 2018, was sent to PT INKA (Persero). A copy of said notice is attached as Annex "K";

WHEREAS, on 26 September 2018, after the conduct of post-qualification on the bid submission of PT INDUSTRI KERETA API (PERSERO), the TWG submitted its Post-Qualification Report (Annex "L") recommending the post-disqualification of PT INKA (Persero) on the ground of its failure to comply with the requirements and conditions specified in the Bidding Documents, to wit:

WHEREAS, in view of the urgent necessity of the Goods to be procured, the PNR BAC 2 conducted a **Pre-Procurement Conference** on 20 November 2018 as shown in the minutes of meeting (Annex "N") and its attendance sheet (Annex "N-1");]. Thereafter, the PNR BAC 2 once again invited all interested bidders to participate in a public competitive bidding. On 22 November 2018 (Annex "O") The second **Invitation** to Bid for the Procurement of Ten (10) Air Conditioning Units for Passenger Coach was duly advertised/published in the Business Section B13 of the Philippine Star, and was

posted to the PhilGEPS website, the PNR website, and on the PNR bulletin board as certified by the Head of the BAC Secretariat (Annex "0-1");

WHEREAS, on 29 November 2018, a Pre-Bid Conference was held and one (1) prospective bidder attended as shown in the minutes of meeting (Annex "P") and its attendance sheet (Annex "P-1");






