# CHARACTERISTIC FORMS OF COMPLEX CARTAN GEOMETRIES II

#### BENJAMIN MCKAY

ABSTRACT. Characteristic class relations in Dolbeault cohomology follow from the existence of a holomorphic Cartan geometry (for example, a holomorphic conformal structure or a holomorphic projective connection). These relations can be calculated directly from the representation theory of the structure group, without selecting any metric or connection or having any knowledge of the Dolbeault cohomology groups of the manifold. This paper improves on its predecessor [34] by allowing noncompact and non-Kähler manifolds and by deriving invariants in cohomology of vector bundles, not just in scalar Dolbeault cohomology, and computing relations involving Chern–Simons invariants in Dolbeault cohomology. For the geometric structures previously considered in its predecessor, this paper gives stronger results and simplifies the computations.

#### 1. Introduction

Geometers have developed an extensive knowledge of holomorphic geometric structures on smooth projective varieties, and on many other complex manifolds. These geometric structures are rare, while meromorphic geometric structures are far too common. So is it natural to seek important special examples of meromorphic geometric structures. We prepare for the arrival of such structures by considering how we might compute residue integrals of invariants, i.e. Chern–Simons invariants, around their singularities.

We prove that any invariant polynomial relation between Atiyah classes of homogeneous holomorphic vector bundles on the model of a holomorphic Cartan geometry is also satisfied on that holomorphic Cartan geometry in Dolbeault cohomology. Our work is similar to the construction of [17], building a holomorphic cohomology theory directly in the structure equations of these geometric structures.

# 2. HOLOMORPHIC CARTAN GEOMETRIES

2.1. **Notation.** Denote the Lie algebra of a Lie group H as  $\mathfrak{h}$ , and similarly denote the Lie algebra of any Lie group by the corresponding fraktur font expression. All Lie groups are complex analytic and finite dimensional. All H-modules are finite dimensional and holomorphic. Denote the left invariant Maurer–Cartan 1-form on H as  $h^{-1}dh$ . Take a holomorphic right principal bundle  $H \to E \to M$ . For each vector  $v \in \mathfrak{h}$ , denote also by v the associated vector field on E: for any  $x \in E$ ,

$$v(x) = \left. \frac{d}{dt} \right|_{t=0} x e^{tv}.$$

If we wish to be more precise, we denote the vector field v on E as  $v_E$ . For any H-action on a manifold X, denote by  $E \times^H X$  the quotient of  $E \times X$  by the diagonal right H-action  $(e,x)h = (eh,h^{-1}x)$ . If V is a complex analytic H-module, denote the associated vector bundle by  $\mathbf{V} := E \times^H V$ .

- 2.2. Cartan geometries. A complex homogeneous space (X,G) is a complex manifold X and a complex Lie group G with a holomorphic transitive action on X. A morphism of complex homogeneous spaces  $(\varphi,\Phi)\colon (X,G)\to (X',G')$  is a holomorphic map  $\varphi\colon X\to X'$  equivariant for a holomorphic Lie group morphism  $\Phi\colon G\to G'$ . Pick a point  $x_0\in X$  and let  $H:=G^{x_0}$  be the stabilizer. Denote by  $\mathfrak g$  be the Lie algebra of G. A holomorphic Cartan geometry, modelled on (X,G), on a complex manifold M is a holomorphic principal H-bundle  $H\to E\to M$  and a holomorphic connection  $\omega\in\Omega^1_{E_G}\otimes^G\mathfrak g$  on the associated principal G-bundle  $E_G:=E\times^H G$  so that the inclusion  $E\to E_G$  is complementary to the horizontal space  $(\omega=0)\subset TE_G$ . We also denote by  $\omega$  the pullback of  $\omega$  to E.
- 2.3. Soldering. Let  $\mathfrak{g}_{-} := \mathfrak{g}/\mathfrak{h}$ . The soldering form is the 1-form  $\omega_{-} := \omega + \mathfrak{h} \in \Omega^{1}_{E} \times^{H} (\mathfrak{g}/\mathfrak{h})$ . Let  $\pi_{M} : E \to M$  be the obvious quotient map M = E/H. The soldering form yields a surjective vector bundle morphism

$$TM \to E \times^H \mathfrak{g}_-$$

by taking each  $e \in E$  and vector  $v \in T_e E$ , say with  $\pi_E(e) = m \in M$ , to both  $\pi'_E(e)v \in T_m M$  and to  $(e,w) \in E \times \mathfrak{g}_-$  by  $w = v \, \lrcorner \, \omega + \mathfrak{h}$ . Let  $H_+ \subseteq H$  be a closed complex subgroup acting trivially on  $\mathfrak{g}_-$ . Let  $\underline{H} := H/H_+$  and  $\underline{E} := E/H_+$ . This morphism descends to

$$TM \cong E \times^{\underline{H}} \mathfrak{g}_{-}.$$

Motivated by this isomorphism, our goal is not to find characteristic classes of E but of E.

2.4. Curvature. Since  $\omega$  is a connection on  $E_G$ , its curvature

$$\Omega := d\omega + \frac{1}{2} [\omega \omega]$$

is semibasic, so pulls back to  ${\cal E}$  to be a multiple of

$$\omega_-^2 \in \Omega_E^2 \otimes^H \Lambda^2 \mathfrak{g}_-,$$

say  $\Omega = K\omega_{-}^{2}$ .

- 2.5. Langlands decompositions. A Langlands decomposition of a complex Lie group H is a semidirect product decomposition  $H = H_0 \ltimes H_+$  in closed complex subgroups, where  $H_+$  is a connected and simply connected solvable complex Lie group and  $H_0$  is a reductive complex linear algebraic group. For example:
  - (1) This definition generalizes the usual Langlands decomposition of any parabolic subgroups of any complex semisimple Lie group [29] p. 481.
  - (2) Every connected and simply connected complex Lie group H admits a Langlands decomposition in which  $H_0$  is a maximal semisimple subgroup and  $H_+$  is the solvradical [41] p. 244 theorem 3.18.13.
  - (3) Any connected complex Lie group H admits a faithful holomorphic representation just when it admits a Langlands decomposition in which  $H_0$  is a complex linearly reductive group and  $H_+$  is the nilradical [24] p. 595 theorem 16.2.7.
  - (4) Every complex linear algebraic group H (perhaps disconnected) admits a Langlands decomposition in which  $H_0 \subset H$  is a maximal reductive subgroup and  $H_+ \subset H$  is the unipotent radical [26] p. 117 theorem 4.3. In all of our examples below, H will be complex linear algebraic.

Every connected and simply connected solvable complex Lie group  $H_+$  is biholomorphic to complex affine space [24] p. 543 theorem 14.3.8, and so is a contractible Stein manifold.

Take a complex homogeneous space (X,G), a point  $x_0 \in X$ , define  $H := G^{x_0}$  and denote the Lie algebra of  $H \subseteq G$  as  $\mathfrak{h} \subseteq \mathfrak{g}$ . A Langlands decomposition of a

complex homogeneous space (X,G) with X=G/H is a Langlands decomposition  $H=G_0\ltimes G_+$  together with a splitting  $\mathfrak{g}=\mathfrak{g}_-\oplus\mathfrak{g}_0\oplus\mathfrak{g}_+$  into  $G_0$ -modules. We will usually insist also that  $G_+$  acts trivially on  $\mathfrak{g}_-:=\mathfrak{g}/\mathfrak{h}$ , so that the tangent bundle of X is an associated vector bundle of the principal right bundle  $G_0=H/G_+\to G/G_+$ .

2.6. Infinitesimal characteristic forms. Take a complex homogeneous space with Langlands decomposition, in our notation as above. Take a finite dimensional  $\mathfrak{g}_0$ -module V. The Atiyah form  $a=a_V$  is the element

$$a \in \mathfrak{g}_+^* \otimes \mathfrak{g}_-^* \otimes \mathfrak{gl}_V$$
.

given by

$$a(x,y) = -\rho_V \circ \operatorname{proj}_{\mathfrak{q}_0}([xy]),$$

for  $x \in \mathfrak{g}_+, y \in \mathfrak{g}_-$ . If V is not specified, we take  $V := \mathfrak{g}_0$  in the adjoint representation. (Note that we do *not* require that V be a  $G_0$ -module, so there might not be an associated vector bundle.) The *Chern forms*  $c_k$  are

$$c_k \in \operatorname{Sym}^k(\mathfrak{g}_+ \otimes \mathfrak{g}_-)^*$$

given by

$$\det\left(I + \frac{i}{2\pi}a\right) = 1 + c_1 + c_2 + \dots = c.$$

Analogously define the Chern character forms and Todd forms. More generally, if f is a  $\mathfrak{g}_0$ -invariant complex symmetric multilinear form on  $\mathfrak{g}_0$ , say of degree k, we associate to f the element, denoted by the same name,

$$f \in \operatorname{Sym}^k(\mathfrak{g}_+ \otimes \mathfrak{g}_-)^*$$

given by

$$f(a,\ldots,a).$$

The Chern-Simons form of f is

$$T_f(u, v, w_+, w_-) := \sum_{j=0}^{k-1} a_j f(u, \underbrace{v, \dots, v}_{j}, \underbrace{a(w_+, w_-), \dots, a(w_+, w_-)}_{k-j-1}))$$

where

$$a_j := \frac{(-1)^j (k-1)!}{(k+j)! (k-1-j)!}$$

and

$$u, v \in \mathfrak{g}_0,$$
  
 $w_+ \in \mathfrak{g}_+,$   
 $w_- \in \mathfrak{g}_-.$ 

(N.B. the expression for  $a_j$  is not the same as in the paper of Chern and Simons [16]; their  $A_j$  is  $A_j = a_j/2^j$ .) The splitting principle: if  $0 \to U \to V \to W \to 0$  is an exact sequence of  $\mathfrak{g}_0$ -modules, extend a basis of U into a basis of V, so

$$a_V = \begin{pmatrix} a_U & * \\ 0 & a_W \end{pmatrix}$$

and compute the determinant: c(U)c(W) = c(V). The tangent bundle Atiyah form is

$$a_T \colon x \in \mathfrak{g}_+, y \in \mathfrak{g}_-, z \in \mathfrak{g}_- \mapsto \frac{a(x,y)z + a(x,z)y}{2}.$$

# 3. CHARACTERISTIC CLASSES

3.1. The Atiyah bundle. We review some well known material to establish notation and terminology, following the standard references [3, 16]. Take a holomorphic right principal bundle

$$\begin{array}{c} H \longrightarrow E \\ \downarrow^{\pi} \cdot \\ M \end{array}$$

Let  $ad_E := E \times^H \mathfrak{h}$ . The *H*-invariant exact sequence

$$0 \longrightarrow \ker \pi' \longrightarrow TE \xrightarrow{\pi'} \pi^*TM \longrightarrow 0$$

of vector bundles on E quotients by H-action to an exact sequence of vector bundles on M:

$$0 \longrightarrow \mathrm{ad}_E \longrightarrow \mathrm{At}_E \longrightarrow TM \longrightarrow 0$$

with middle term  $\operatorname{At}_E = TE/H$  the Atiyah bundle. A holomorphic  $(C^{\infty})$  splitting s of this exact sequence determines and is determined by a holomorphic  $(C^{\infty})$  (1,0)-connection  $\omega = \omega_s$  for the bundle  $E \to M$ , which is the unique (1,0)-form so that  $s(v) \sqcup \omega = 0$  and  $w \sqcup \omega = w$  for  $w \in \mathfrak{h}$ , i.e. the splitting lifts each tangent vector to its horizontal lift [3]. Write the section as  $s = s_{\omega}$ .

3.2. The connection bundle. The connection bundle of E is the affine subbundle  $\mathscr{A}_E \subset T^*M \otimes_M \operatorname{At}_E$  consisting of complex linear maps which split the sequence over some point of M;  $\mathscr{A}_E \to M$  is a holomorphic bundle of affine spaces, modelled on the vector bundle  $T^*M \otimes_M \operatorname{ad}_E$ . So holomorphic  $(C^{\infty})$  (1,0)-connections are precisely holomorphic  $(C^{\infty})$  sections of the connection bundle  $\mathscr{A}_E$ . Differences of two connections lie in  $T^*M \otimes \operatorname{ad}_E$ . The Atiyah class of  $H \to E \to M$  is the class in  $H^1(M, T^*M \otimes \operatorname{ad}_E)$  given by differences of holomorphic connections on open subsets of M. Each element  $v \in \operatorname{At}_{E,m}$  is an H-invariant section of  $TE|_{E_m} \to \pi^*TM|_{E_m}$ . Each fiber  $\mathscr{A}_{E,m}$  is the set of all H-invariant sections  $\omega$  of

$$T^*E \otimes \mathfrak{h}|_{E_m}$$

so that  $v \, \neg \, \omega = v$  for  $v \in \mathfrak{h}$  with *H*-invariance:

$$\omega_{eh} = \operatorname{Ad}_h^{-1} r_h^{-1*} \omega_e$$

for  $h \in H$ .

Denote the bundle map as  $\delta \colon \mathscr{A}_E \to M$ , with pullback

$$\begin{array}{ccc} E\times_M \mathscr{A}_E & \stackrel{\Delta}{\longrightarrow} E \\ \downarrow & & \downarrow \\ \mathscr{A}_E & \stackrel{\delta}{\longrightarrow} M. \end{array}$$

Each point  $x \in E \times_M \mathscr{A}_E$  can be represented uniquely as  $x = (m, e, \omega_0)$  for some  $m \in M$ ,  $e \in E_m$ ,  $\omega_0 : T_e E \to \mathfrak{h}$  so that  $w - \omega_0 = w$  for  $w \in \mathfrak{h}$ . Conversely, every such triple  $(m, e, \omega_0)$  represents a unique point  $x \in E \times_M \mathscr{A}_E$ . The map  $\Delta$  is then expressed as  $\Delta(x) = \Delta(m, e, \omega_0) = e$ . The right action of H on  $E \times_M \mathscr{A}_E$  is represented by

$$(m, e, \omega_0)h = (m, eh, \omega_0')$$

where

$$\omega_0' = \mathrm{Ad}_h^{-1}(\omega_0 \circ r_h^{-1'}).$$

There is a holomorphic connection  $\omega$  on  $E \times_M \mathscr{A}_E$  defined for a tangent vector  $v \in T_x (E \times_M \mathscr{A}_E)$  by  $v \sqcup \omega = (\Delta'(x)v) \sqcup \omega_0$  [5]. Given a holomorphic  $(C^{\infty})$  (1,0)-connection  $\omega_0$  on  $E \to M$ , map  $\Phi \colon e \in E \to \Phi(e) := (m, e, \omega_0) \in E \times_M \mathscr{A}_E$  and compose with the bundle map  $\pi \colon E \times_M \mathscr{A}_E \to \mathscr{A}_E$  to get a section of the connection bundle. Pullback the bundle  $E \times_M \mathscr{A}_E$  by the section to get a map  $\varphi \colon E \to \mathscr{A}_E$ ,

so that  $\varphi^* E \times_M \mathscr{A}_E = E$  has pullback connection  $\varphi^* \omega = \omega_0$ . The Dolbeault class  $[(d\omega_0)^{1,1}]$  is the Dolbeault representative of the Atiyah class.

The connection bundle of a vector bundle is the connection bundle of its associated principal bundle.

If V is a finite dimensional  $\mathfrak{h}$ -module, it might not be an H-module, so there might be no associated vector bundle, but we can still define an Atiyah class. Write our module's  $\mathfrak{h}$ -action as  $\rho \colon \mathfrak{h} \to \mathfrak{gl}_V$ . The  $\mathfrak{h}$ -module  $\rho(\mathfrak{h}) \subset \mathfrak{gl}_V$  is an H-module, since  $\mathfrak{h}$  is an H-module. Each local choice of holomorphic connection  $\omega$  on E gives a differential form  $\rho \circ \omega$  valued in  $\rho(\mathfrak{h})$ . The Atiyah class of  $H \to E \to M$  is the class  $a(M, \mathbf{V}) \in H^1(M, T^*M \otimes (E \times^H \rho(\mathfrak{h})))$  given by differences of such forms on overlaps of open subsets of M, even though  $\mathbf{V}$  need not exist; we say that  $\mathbf{V}$  is the ghost of a departed vector bundle. Write the module action as  $\rho_V \colon \mathfrak{h} \mapsto \mathfrak{gl}_V$ . For any (1,0)-connection  $\omega$  on E, the (1,1)-form  $(\rho_V \circ d\omega)^{1,1}$  is semibasic, valued in  $E \times^H \rho(\mathfrak{h})$ , representing that Atiyah class in Dolbeault cohomology.

3.3. Connection bundles of Cartan geometries. Take a complex homogeneous space (X,G) with Langlands decomposition. Take a holomorphic Cartan geometry  $E \to M$  with model (X,G). Take a point  $m \in M$ , a point  $e \in E_m$  and a tangent vector  $v \in T_m M$ . Let  $\underline{e} := eG_+ = q(e)$ . Applying the Langlands decomposition to the Cartan connection  $\omega$ , which is valued in  $\underline{\mathfrak{g}}$ : write it as

$$\omega = \omega_- + \omega_0 + \omega_+,$$

to define its projections to  $\mathfrak{g}_-, \mathfrak{g}_0, \mathfrak{g}_+$ . Let  $\underline{E} := E/G_+$  and denote the projection map as  $\pi_{\underline{E}} : e \in E \mapsto \underline{e} \in \underline{E}$ . The 1-form  $\omega_0$ , being semibasic, determines a covector  $\omega_e : T_{\underline{e}} \underline{E} \to \mathfrak{g}_0$  for each  $e \in E$ , uniquely defined by  $\pi_E^* \omega_e = \omega_0$ . Map

$$\Phi \colon e \in E \mapsto (m, \underline{e}, \omega_e) \in \underline{E} \times_M \mathscr{A}_E$$

which we quotient by  $G_0$ -action to get

applying the commutative diagram of section 3.1 on the preceding page but to  $\underline{E}$  instead of E.

Lemma 3.1.  $\Phi^*\omega = \omega_0$ 

*Proof.* For  $m \in M$ ,  $e \in E_m$ ,  $v \in T_eE$ , let

$$x := (m, e, \omega_e) = \Phi(e) \in \underline{E} \times_M \mathscr{A}_E.$$

so 
$$\Delta(x) = \Delta(m, \underline{e}, \omega_e) = \underline{e}$$
. Compute

$$v \, \lrcorner \, (\Phi^* \omega)_e = \Phi'(e)v \, \lrcorner \, \omega_x,$$

$$= \Delta'(x)\Phi'(e)v \, \lrcorner \, \omega_e,$$

$$= (\Delta \circ \Phi)'(e)v \, \lrcorner \, \omega_e,$$

$$= \pi'_{\underline{E}}(e)v \, \lrcorner \, \omega_e,$$

$$= v \, \lrcorner \, \pi^*_{\underline{E}}\omega_e,$$

$$= v \, \lrcorner \, \omega_0.$$

Since  $\omega$  is a holomorphic connection, we find its curvature is  $\Omega := d\omega + \frac{1}{2}[\omega\omega]$ , and pulls back to  $\Omega_0 := d\omega_0 + \frac{1}{2}[\omega_0\omega_0]$ , even though  $\omega_0$  is not a connection. The Bianchi identity  $d\Omega = [\Omega\omega]$  ensures the analogous identity  $d\Omega_0 = [\Omega_0\omega_0]$  even though  $\omega_0$  is not a connection and  $\Omega_0$  is not the curvature of a connection.

Similarly, for any  $G_0$ -invariant complex polynomial function  $f: \mathfrak{g}_0 \to \mathbb{C}$ , thought of as a symmetric multilinear form, the expression

$$f_E := f(\Omega_0, \dots, \Omega_0)$$

is the pullback of the Chern form  $f_{\underline{E} \times_M \mathscr{A}_{\underline{E}}}$  for the connection  $\omega$  on the bundle  $\underline{E} \times_M \mathscr{A}_{\underline{E}} \to \mathscr{A}_{\underline{E}}$ . In particular,  $f_E$  is a closed holomorphic differential form. Similarly define

$$T_{f,E} := T_f(\omega_0, [\omega_0 \omega_0], \omega_+, \omega_-),$$

which is the pullback of the Chern–Simons form  $T_{f,\underline{E}\times_M\mathscr{A}_{\underline{E}}}$ , hence  $dT_{f,E}=f_E$ . Note that  $\mathfrak{g}_0\oplus\mathfrak{g}_+=\mathfrak{h}\subseteq\mathfrak{g}$  is a Lie subalgebra, so

$$0 = [\mathfrak{g}_0 \mathfrak{g}_0]_- = 0,$$
  

$$0 = [\mathfrak{g}_0 \mathfrak{g}_+]_- = 0,$$
  

$$0 = [\mathfrak{g}_+ \mathfrak{g}_+]_- = 0.$$

Also  $\mathfrak{g}_+ \subseteq \mathfrak{h}$  is an ideal so

$$0 = [\mathfrak{g}_+ \mathfrak{g}_+]_0.$$

Moreover  $\mathfrak{g}_+$  acts trivially on  $\mathfrak{g}/\mathfrak{h}$ , so

$$0 = [\mathfrak{g}_+ \mathfrak{g}_-]_- = 0.$$

Finally,  $\mathfrak{g}_{-},\mathfrak{g}_{0},\mathfrak{g}_{+}$  are  $G_{0}$ -modules, so

$$0 = [\mathfrak{g}_0 \mathfrak{g}_-]_0 = 0,$$
  

$$0 = [\mathfrak{g}_0 \mathfrak{g}_-]_+ = 0,$$
  

$$0 = [\mathfrak{g}_0 \mathfrak{g}_0]_+ = 0,$$
  

$$0 = [\mathfrak{g}_0 \mathfrak{g}_+]_0 = 0.$$

Split by Langlands decomposition our expression for the curvature of any Cartan connection,

$$\Omega = d\omega + \frac{1}{2}[\omega\omega] = K\omega_{-}^{2}:$$

as,

$$\begin{split} \Omega_{+} &= d\omega_{-} + \frac{1}{2} [\omega_{-}\omega_{0}]_{-} + \frac{1}{2} [\omega_{0}\omega_{-}]_{-}, \\ &= K_{-}\omega_{-}^{2} - \frac{1}{2} [\omega_{-}\omega_{-}]_{-}, \end{split}$$

$$\Omega_{0} = d\omega_{0} + \frac{1}{2}[\omega_{0}\omega_{0}] + \frac{1}{2}[\omega_{+}\omega_{-}]_{0} + \frac{1}{2}[\omega_{-}\omega_{+}]_{0}, 
= K_{0}\omega_{-}^{2} - \frac{1}{2}[\omega_{-}\omega_{-}]_{0}, 
\Omega_{+} = d\omega_{+} + \frac{1}{2}[\omega_{-}\omega_{+}] + \frac{1}{2}[\omega_{+}\omega_{-}] + \frac{1}{2}[\omega_{0}\omega_{+}] + \frac{1}{2}[\omega_{+}\omega_{0}] + \frac{1}{2}[\omega_{+}\omega_{+}], 
= K_{+}\omega_{-}^{2} - \frac{1}{2}[\omega_{-}\omega_{-}]_{+}.$$

Under action of any  $h_+ \in G_+$ ,

$$\begin{split} r_{h_+}^* \begin{pmatrix} \omega_- \\ \omega_0 \\ \omega_+ \end{pmatrix} &= r_{h_+}^* \omega, \\ &= \operatorname{Ad}_{h_+}^{-1} \omega, \\ &= \begin{pmatrix} I & 0 & 0 \\ -\pi_0 h_+ & I & 0 \\ (I - \operatorname{Ad}_{h_+}^{-1}) \pi_0 h_+ - \operatorname{Ad}_{h_+}^{-1} \pi_+ h_+ & \operatorname{Ad}_{h_+}^{-1} - I & \operatorname{Ad}_{h_+}^{-1} \end{pmatrix} \begin{pmatrix} \omega_- \\ \omega_0 \\ \omega_+ \end{pmatrix}. \end{split}$$

3.4. Smooth reduction of structure group. Take a complex homogeneous space (X,G) with Langlands decomposition. Take a holomorphic Cartan geometry  $E \to M$  with that model. Split the Cartan connection  $\omega = \omega_- + \omega_0 + \omega_+$ . Then  $\omega_- \in \Omega^1_E \otimes^H \mathfrak{g}_-$  is the soldering form and  $\omega_0 \in \Omega^1_E \otimes^{G_0} \mathfrak{g}_0$  is the pseudoconnection form.

Since  $H/G_0$  is contractible,  $E/G_0 \to M$  admits a  $C^{\infty}$  section  $s \colon M \to E/G_0$  i.e. a  $C^{\infty}$   $G_0$ -reduction of structure group. The 1-form  $\omega_0$  on E pulls back to a 1-form  $\omega_0$  on  $s^*E$ . Let  $E := E/G_+$ , a holomorphic principal right  $\underline{H}$ -bundle  $\underline{H} \to \underline{E} \to M$ . The 1-form  $\omega_0$  extends from  $s^*E$  to a unique 1-form on  $\underline{E} \cong s^*E$  which we also denote  $\omega_0$ , and which satisfies  $v \, \lrcorner \, \omega_0 = v$  for  $v \in \mathfrak{g}_0$ .

**Lemma 3.2.** The 1-form  $\omega_0$  on  $\underline{E}$  associated to any  $C^{\infty}$  (or holomorphic)  $G_0$ -reduction is a  $C^{\infty}$  (holomorphic) (1,0)-connection 1-form.

*Proof.* Pick a point  $(m, e) \in s^*E$ , i.e. with  $m \in M$  and  $e \in E_m$  and  $eG_0 = s(m)$ . So  $\omega_0$  at the corresponding point of  $\underline{E}$  is the 1-form which pulls back by  $E \to \underline{E}$  to become  $\omega_0$  at the point e. If we replace (m, e) by some point (m, eh), for some  $h \in H$ ,

$$r_h^*\omega_0 = \operatorname{Ad}_h^{-1}\omega_0.$$

In particular, if  $h \in G_+$ , then  $r_h^*\omega_0 = \omega_0$ . By definition, we extend  $s^*\omega_0$  to  $\underline{E}$  by  $\underline{H}$ -equivariance. Since  $\omega_0$  is complex linear on tangent spaces of E,  $\omega_e$  is complex linear on tangent spaces of E. For any  $v \in \mathfrak{h}$ ,  $v - \omega = v$ , so  $v - \omega_0 = v$ .

3.5. Characteristic forms and classes. The Atiyah form,  $k^{\text{th}}$  Chern form, Chern character form, Todd form, etc. of a Cartan geometry with Cartan connection  $\omega$  is the form identified by  $\omega$  with the Atiyah form,  $k^{\text{th}}$  Chern form, Chern character form, Todd form, etc. and similarly for any  $G_0$ -invariant homogeneous polynomial function  $f: \mathfrak{g}_0 \to \mathbb{C}$ .

**Lemma 3.3.** The Atiyah class,  $k^{th}$  Chern class, and so on, in Dolbeault cohomology of the bundle  $E \to M$  of a Cartan connection  $E \to M$  with Langlands decomposition is the class of the (1,1)-part, (k,k)-part, and so on, of the pullback by a  $C^{\infty}$  section s of the Atiyah form.

*Proof.* The Atiyah class [3] of  $\underline{E}$  is represented by

$$a(M, \underline{E}) = [\bar{\partial}\omega_0] = [(d\omega_0)^{1,1}].$$

If we pick any  $C^{\infty}$  reduction, the 2-form  $(d\omega_0)^{1,1}$  pulls back to  $s^*E$  to become

$$-\operatorname{proj}_{\mathfrak{g}_0}\left(\rho_{\mathfrak{g}}(\omega_+^{0,1})\wedge\omega_-\right),$$

where  $w \in \mathfrak{g} \mapsto \operatorname{proj}_{\underline{\mathfrak{h}}}(w) \in \underline{\mathfrak{h}}$  is the  $G_0$ -invariant linear projection. The Atiyah class is represented by

$$(d\omega_0)^{1,1} = -\operatorname{proj}_{\mathfrak{g}_0}\left(\rho_{\mathfrak{g}}(\omega_+^{0,1}) \wedge \omega_-\right) \in V_M^{1,1}$$

where  $V \subset \mathfrak{g}_0$  is the projection to  $\mathfrak{g}_0$  of the span of

$$\rho_{\mathfrak{g}}(\mathfrak{g}_+)(\mathfrak{g}_-) \subset \mathfrak{g}.$$

Example 3.4. If the first Chern form of a complex homogeneous space vanishes, then every complex manifold with a Cartan geometry modelled on that complex homogeneous space has a holomorphic connection on its canonical bundle.

Corollary 3.5. For a complex manifold admitting a holomorphic Cartan geometry, whose model has a Langlands decomposition with  $G_+$  acting trivially on  $\mathfrak{g}/\mathfrak{h}$ , the Atiyah class of the tangent bundle is the (1,1)-part of the pullback by any  $C^{\infty}$  section of the form identified by the Cartan connection with the tangent bundle Atiyah form.

The symmetry of the tangent bundle Atiyah class is well known. If  $T \subset G_0$  is a Cartan subgroup, then T has conjugates Zariski dense in  $G_0$ . So the invariant polynomials are determined by their values on T, so expressed in terms of T-weights. Relations among the T-weights acting on  $\mathfrak{g}_0$  give equations on the Chern classes in Dolbeault cohomology. Our main aim in this paper is to improve on those well known equations.

**Theorem 3.6.** For any holomorphic (X,G)-geometry, the Atiyah class of any vector bundle associated to any  $\mathfrak{g}$ -module vanishes, and hence the Chern classes and all of their associated Chern-Simons classes except perhaps  $T_{c_1}$ .

*Proof.* The Atiyah classes are pulled back from  $E_G$ , which has the Cartan connection as a holomorphic connection, so all Atiyah classes vanish. The Chern–Simons classes are (p+1,p) parts of polynomials in the curvature, so vanish except perhaps for p=0, i.e.  $T_{c_1}$ .

Therefore the Atiyah classes of any Cartan geometry modelled on a complex homogeneous space (X,G) lie in the quotient of Atiyah classes of the  $\mathfrak{h}$ -modules by those of the  $\mathfrak{g}$ -modules as defined above. We will adopt a formal cohomology theory below in which the associated formal Atiyah classes vanish.

### 4. Example: Projective connections

A projective connection is a Cartan geometry modelled on  $(X, G) = (\mathbb{P}^n, \mathbb{P}SL_{n+1})$ . So  $H \subset \mathbb{P}SL_V$  is the stabilizer of a point of projective space, i.e. the set of matrices (defined up to n+1 root of unity scalar multiple) of the form

$$\begin{bmatrix} g_0^0 & g_i^0 \\ 0 & g_j^i \end{bmatrix}$$

with i, j = 1, 2, ..., n. The subgroup  $G_+ \subseteq H$  consists of the matrices of the form

$$\begin{bmatrix} 1 & g_i^0 \\ 0 & \delta_j^i \end{bmatrix}.$$

Recall the conventional notation [15]. Write the Cartan connection not as  $\omega$  but as  $\Omega \in \Omega^1_E \otimes \mathfrak{gl}_{n+1}$ . Define

$$\omega^{i} := \Omega_{0}^{i},$$
  

$$\omega_{j}^{i} := \Omega_{j}^{i} - \delta_{j}^{i} \Omega_{0}^{0},$$
  

$$\omega_{i} = \Omega_{i}^{0},$$

so that

$$\begin{split} \Omega_0^0 &= -\frac{1}{n+1} \omega_i^i, \\ \Omega_0^i &= \omega^i, \\ \Omega_j^i &= \omega_j^i - \frac{\delta_j^i \omega_k^k}{n+1}, \\ \Omega_i^0 &= \omega_i. \end{split}$$

In this notation, the structure equations of a projective connection expand out to

$$0 = d\omega^{i} + \omega_{j}^{i} \wedge \omega^{j},$$
  

$$0 = d\omega_{j}^{i} + \omega_{k}^{i} \wedge \omega_{j}^{k} - (\delta_{j}^{i}\omega_{k} + \delta_{k}^{i}\omega_{j}) \wedge \omega^{k},$$
  

$$0 = d\omega_{i} - \omega_{j}^{j} \wedge \omega_{j}$$

modulo first and second order torsion, i.e. the curvature of the Cartan connection.

The group  $G = \mathbb{P}SL_{n+1}$  acts transitively on all complex bases of tangent spaces of  $\mathbb{P}^n$ . Hence the bundle  $\underline{E}$  is the frame bundle of the manifold M. Its Atiyah class is represented by

$$a(TM) = d\omega_j^i + \omega_k^i \wedge \omega_j^k = (\delta_j^i \omega_k + \delta_k^i \omega_j) \wedge \omega^k$$

modulo torsion. Taking trace gives the first Chern class representation:

$$2\pi c_1(TM) = (n+1)\sqrt{-1}\omega_k \wedge \omega^k.$$

For simplicity of notation, denote  $\mathfrak{g}_{-}$  as  $\mathbb{C}^{n}$ . So  $\mathfrak{g}_{+}=\mathbb{C}^{n*}$  and  $\mathfrak{g}_{0}=\mathfrak{gl}_{n}$ . Take  $G_{0}\subset H$  to be the matrices

$$\begin{bmatrix} g_0^0 & 0 \\ 0 & g_j^i \end{bmatrix},$$

giving a Langlands decomposition. The Atiyah class is represented by an element

$$a \in \mathfrak{g}_{\perp}^* \otimes \mathfrak{g}_{\perp}^* \otimes \mathfrak{g}_0 = \mathbb{C}^n \otimes \mathbb{C}^{n*} \otimes (\mathbb{C}^n \otimes \mathbb{C}^{n*}),$$

given, for  $x \in \mathfrak{g}_+ = \mathbb{C}^{n*}$  and  $y, z \in \mathbb{C}^n$ , by

$$a(x, y)z = z(x \cdot y) + y(x \cdot z).$$

The first Chern class in Dolbeault cohomology is represented by the first Chern form

$$2\pi c_1(x,y) = \sqrt{-1}(n+1)x \cdot y.$$

Hence

$$\sqrt{-1}(n+1)a = 2\pi I \otimes c_1 + 2\pi c_1 \otimes I.$$

We recover:

**Theorem 4.1** (Molzon and Mortensen [35]). Take a complex manifold M with a holomorphic projective connection. Then, in Dolbeault cohomology,

$$\sqrt{-1}(1+\dim M)a(TM)=2\pi I\otimes c_1(TM)+2\pi c_1(TM)\otimes I.$$

Conversely, Molzon and Mortensen prove that if this condition is satisfied, then the complex manifold admits a holomorphic projective connection, which can be chosen to be normal.

**Corollary 4.2.** A holomorphic projective connection on a complex manifold arises from a holomorphic affine connection just when the complex manifold has  $c_1 = 0$  in Dolbeault cohomology.

The bundle  $\mathcal{O}(1) \to \mathbb{P}^n$  is acted on by  $\mathrm{SL}_{n+1}$ , but not by  $\mathbb{P}\mathrm{SL}_{n+1}$ . Let  $\hat{H} \subset \mathrm{SL}_{n+1}$  be the set of matrices of the form

$$g = \begin{pmatrix} g_0^0 & g_i^0 \\ 0 & g_i^i \end{pmatrix}$$

and let

$$\rho(g) = \frac{1}{g_0^0}.$$

For any integer d, let  $\mathbb{C}_d$  be  $\mathbb{C}$  but with  $\hat{H}$ -module structure imposed by  $\rho_d \coloneqq \rho^d$ . Let  $\mathcal{O}(d)$  be the associated line bundle  $\mathcal{O}(d) =:= \mathrm{SL}_{n+1} \times^{\rho} \mathbb{C}_d$ . The group  $H \subset \mathbb{P}\mathrm{SL}_{n+1}$  is the image of  $\hat{H} \subset \mathrm{SL}_{n+1}$ , i.e.  $\hat{H}$  modulo (n+1)-roots of unity. Hence  $\mathbb{C}_d$  is an H-module just when n+1 divides d. The subalgebra of  $\mathfrak{h}$  acting trivially on  $\mathbb{C}_d$  contains  $\mathfrak{g}_+$ , so  $\mathbb{C}_d$  is an  $\mathfrak{h} = \mathfrak{h}/\mathfrak{g}_+$ -module. For a projective connection, when n+1 does not divide d,  $\mathcal{O}(d)$  is not an associated bundle. By our general theory of characteristic classes, it still has an Atiyah class  $a(\mathcal{O}(d))$ , and Chern classes  $c_k(\mathcal{O}(d))$ . Hence it is convenient to write this  $\mathfrak{h}$ -module  $\mathbb{C}_d$  also as  $\mathcal{O}(d)$ .

Recall  $V := \mathbb{C}^{n+1}$  is the obvious  $\mathfrak{g}$ -module as  $\mathfrak{g} = \mathfrak{sl}_{n+1}$ ; note that this is not a trivial representation. By theorem 3.6 on page 9, the Atiyah class of the vector bundle V associated to V vanishes on any projective connection geometry. So we can work modulo this Atiyah class. The theory above describing Atiyah forms does not apply to V, as it has nontrivial  $G_+$ -action, so is not defined on E.

Note that  $\mathcal{O}(-1) \subset V$  is an  $\hat{H}$ -submodule and tensoring gives  $\mathcal{O} \subset V \otimes \mathcal{O}(1)$ . Recall the Euler sequence on  $\mathbb{P}^n$ :

$$0 \to \mathcal{O} \to V \otimes \mathcal{O}(1) \to T \to 0$$

where  $T = \mathfrak{g}/\mathfrak{h}$ .

Let us rewrite this directly in terms of a projective connection on a manifold:

$$\begin{aligned} a_V(M) &= \rho_V(\nabla \omega), \\ &= \nabla \Omega - \begin{pmatrix} 0 & 0 \\ \nabla \omega^i & 0 \end{pmatrix}, \\ &= 0 - 0 \end{aligned}$$

up to torsion terms.

Let us consider this vanishing more geometrically. Locally (say on a cover by open sets  $M_a \subset M$ ), we can lift any H-bundle  $E \to M$  to a  $\hat{H}$ -bundle  $E_a \to M_a$  and in doing so lift the projective connection to a holomorphic Cartan geometry modelled on  $(\mathbb{P}^n, \hat{G}), \hat{G} := \mathrm{SL}_{n+1}$ ). So  $\Omega$  is a holomorphic connection for the associated vector bundle  $E_a \times^{\hat{H}} \mathbb{C}^{n+1}$ . Indeed it suffices to note that V is a  $\hat{G}$ -module, and so the Cartan connection extends to a holomorphic connection on the associated  $\hat{G}$ -bundle. So the Atiyah class vanishes:  $a_V = 0$  on each  $E_a$ . But the Atiyah classes in these calculations, as ghost vector bundle Atiyah classes, are defined on E and pull back to each  $E_a$  to have this same representation as a differential form, and so  $a_V = 0$  on E.

Apply the splitting principle to the Euler sequence:

$$c(V \otimes \mathcal{O}(1)) = c(\mathcal{O}(1)^{\oplus n+1}) = (1 + c_1 \mathcal{O}(1))^{n+1} = c(T)$$

in Dolbeault cohomology and therefore

$$(n+1)c_1(\mathcal{O}(1)) = c_1(T).$$

**Theorem 4.3.** On any n-dimensional complex manifold with holomorphic projective connection,

$$(n+1)^k c_k(T) = \binom{n+1}{k} c_1^k(T)$$

in Chern forms modulo torsion and curvature, and hence also as Chern classes in Dolbeault cohomology. Equivalently

$$1 + ch = (n+1)e^{c_1/(n+1)}$$

in Chern forms modulo torsion and curvature, and hence also as Chern classes in Dolbeault cohomology.

We can compute this more directly in the structure equations, using the Chern character, as

$$(-2\pi i)c_1 = (n+1)\omega_i \wedge \omega^i.$$

(Note that we actually compute such things formally, as polynomials in the formal Atiyah class, but we can do so as if we are working with the differential forms of the structure equations.) It helps to write  $\omega^{ij}$  to mean  $\omega^i \wedge \omega^j$ ,  $\omega_i^j$  to mean  $\omega_i \wedge \omega^j$ , and so on. Similarly  $a_{k\ell}^{ij}$  means  $a_j^i a_\ell^k$  and so on. Set  $\mathrm{ch}_j := \mathrm{ch}_j(T)$  to be the Chern character components,

$$\begin{aligned} &(-2\pi i)^{j} j! \operatorname{ch}_{j} = a_{i_{2}i_{3}\dots i_{j}-1}^{i_{1}i_{j}}, \\ &= (\delta_{i_{2}}^{i_{1}}\omega_{k}^{\phantom{k}k} + \omega_{i_{2}}^{\phantom{i_{1}i_{1}}}) \dots (\delta_{i_{1}}^{i_{j}}\omega_{k}^{\phantom{k}k} + \omega_{i_{1}}^{\phantom{i_{1}i_{j}}}), \\ &= n(\omega_{k}^{\phantom{k}k})^{j} \\ &+ \sum_{p=0}^{j-1} \binom{j}{p} (\omega_{k}^{\phantom{k}k})^{p} \omega_{i_{2}}^{\phantom{i_{1}i_{1}}i_{2}\dots i_{j-p}}, \\ &= n(\omega_{k}^{\phantom{k}k})^{j} \\ &+ \sum_{p=0}^{j-1} \binom{j}{p} (\omega_{k}^{\phantom{k}k})^{p} (-1)^{j-p} \omega_{i_{1}}^{i_{1}i_{2}} \dots i_{j-p}^{i_{1}i_{2}}, \\ &= n(\omega_{k}^{\phantom{k}k})^{j} \\ &+ \sum_{p=0}^{j-1} \binom{j}{p} (\omega_{k}^{\phantom{k}k})^{p} (-1)^{j-p+1} \omega_{i_{1}}^{\phantom{i_{1}i_{2}}i_{2}\dots i_{j-p}}, \\ &= \binom{n+1}{p} \binom{j}{p} (-1)^{j-p+1} \left(\omega_{k}^{\phantom{k}k}\right)^{j}, \end{aligned}$$

so that

$$\frac{\operatorname{ch}_{j}}{n+1} = \frac{\left(\frac{\operatorname{ch}_{1}}{n+1}\right)^{j}}{j!}$$

for  $j = 1, 2, \dots$  So finally

$$1 + ch = (n+1)e^{c_1/(n+1)}$$
.

4.1. Chern-Simons forms. As a symmetric polynomial on  $\mathfrak{h}$ , let

$$\operatorname{ch}_{j}' := \operatorname{ch}_{j} - \frac{(n+1)}{j!} \left( \frac{c_{1}}{n+1} \right)^{j}.$$

We have found above that  $\operatorname{ch}_j' = 0$  in Dolbeault cohomology on any complex manifold with holomorphic projective connection. Hence  $T_{\operatorname{ch}_j'}$  drops to define a class in Dolbeault cohomology, the associated Chern–Simons class, on any complex manifold with a holomorphic projective connection.

**Theorem 4.4.** If a complex manifold M of complex dimension n admits a holomorphic projective connection then in Dolbeault cohomology  $0 = \operatorname{ch}_2' = \cdots = \operatorname{ch}_n'$  and

$$\sum_{j=2}^{n} {j \choose 2} T_{\text{ch}'_j} = T_{\text{ch}'_2} \wedge e^{c_1/(n+1)}.$$

Proof. Note that the Atiyah class of a projective connection is

$$a_i^i = \delta_i^i \omega_k \wedge \omega^k + \omega_j \wedge \omega^i$$
.

Hence the Chern-Simons invariant is

$$\begin{split} j(-2\pi i)^{j}j!T_{\text{ch}_{j}} &= \omega_{i_{2}}^{i_{1}} \wedge a_{i_{3}}^{i_{2}} \wedge \ldots \wedge a_{i_{1}}^{i_{j}} \\ &\quad + a_{i_{2}}^{i_{1}} \wedge \omega_{i_{3}}^{i_{2}} \wedge \ldots \wedge a_{i_{1}}^{i_{j}} \\ &\quad + \ldots \\ &\quad + a_{i_{2}}^{i_{1}} \wedge a_{i_{3}}^{i_{2}} \wedge \ldots \wedge \omega_{i_{1}}^{i_{j}}, \\ &= \omega_{i_{2}}^{i_{1}} \wedge a_{i_{3}}^{i_{2}} \wedge \ldots \wedge a_{i_{1}}^{i_{j}} \\ &\quad + \omega_{i_{3}}^{i_{2}} \wedge a_{i_{4}}^{i_{3}} \wedge \ldots \wedge a_{i_{1}}^{i_{j}} \wedge a_{i_{2}}^{i_{1}} \wedge a_{i_{2}}^{i_{1}}, \\ &\quad + \ldots \\ &\quad + \omega_{i_{1}}^{i_{j}} \wedge a_{i_{2}}^{i_{1}} \wedge a_{i_{3}}^{i_{2}} \wedge \ldots \wedge a_{i_{j}}^{i_{j-1}}, \\ &= j\omega_{i_{2}}^{i_{1}} \wedge a_{i_{3}}^{i_{2}} \wedge \ldots \wedge a_{i_{1}}^{i_{j}}. \end{split}$$

Sum over over all ways to pick p of the Atiyah class expressions (of which there are j-1 in all) to expand out as  $\delta_{i_\ell}^{i_\ell-1}\omega_k\wedge\omega^k$  and j-1-p to expand out as  $\omega_{i_\ell}\wedge\omega^{i_\ell-1}$ :

$$(-2\pi i)^{j} j! T_{\text{ch}_{j}} = \sum_{p=0}^{j-1} {j-1 \choose p} (\omega_{k}^{k})^{p} \wedge \omega_{i_{2}i_{3}}^{i_{1}} \dots i_{j-p}^{i_{j-p}}$$

$$= (\omega_{k}^{k})^{j-1} \wedge \omega_{i}^{i} + \sum_{p=0}^{j-2} {j-1 \choose p} (-1)^{j-p-1} (\omega_{k}^{k})^{p} \wedge \omega_{i_{2}}^{i_{1}i_{2}} \dots i_{j-p}^{i_{j-p}}$$

$$= (\omega_{k}^{k})^{j-1} \wedge \omega_{i}^{i} + \left(\sum_{p=0}^{j-2} {j-1 \choose p} (-1)^{j-p-1}\right) (\omega_{k}^{k})^{j-2} \wedge \omega_{i_{2}}^{i_{1}i_{2}} \dots i_{j-p}^{i_{j-p}}$$

$$= (\omega_{k}^{k})^{j-1} \wedge (\omega_{i_{k}}^{i} + \omega_{\ell i}^{i})$$

$$= (\omega_{k}^{k})^{j-2} \wedge (\omega_{i_{k}}^{i} + \omega_{\ell i}^{i})$$

$$= \left(\frac{-2\pi i c_{1}}{n+1}\right)^{j-2} 2(-2\pi i)^{2} T_{\text{ch}_{2}}.$$

Dividing off  $-2\pi i$  factors:

$$j!T_{\text{ch}_j} = 2T_{\text{ch}_2} \left(\frac{c_1}{n+1}\right)^{j-2},$$

which we can write as

$$\binom{j}{2}T_{\mathrm{ch}_j} = T_{\mathrm{ch}_2} \wedge \frac{1}{(j-2)!} \left(\frac{c_1}{n+1}\right)^{j-2}.$$

Similarly

$$T_{\mathrm{ch}_1^j} = T_{c_1} \wedge c_1^{j-1},$$

from which the result follows.

#### 5. Example: 1-flat foliations

Consider a complex manifold M bearing a holomorphic projective connection and a holomorphic subbundle of the tangent bundle. As a model, fix a projective linear subspace  $\mathbb{P}^{p-1} \subset \mathbb{P}^{p+q}$  and let  $X = \mathbb{P}^{p+q} - \mathbb{P}^{p-1}$ . Foliate by taking all p-dimensional projective subspaces containing  $\mathbb{P}^{p-1}$ . Write  $\mathbb{P}^{p-1}$  as the projectivization of the linear subspace of vectors

$$\begin{pmatrix} 0 \\ x^i \\ 0 \end{pmatrix}$$

The group G of all projective transformations preserving  $\mathbb{P}^{p-1}$  acts transitively on X fixing that foliation, consisting of elements

$$\begin{bmatrix} g_0^0 & 0 & g_J^0 \\ g_0^i & g_j^i & g_J^i \\ g_0^I & 0 & g_J^I \end{bmatrix} \in \mathbb{P}\mathrm{SL}_{p+q+1} \,.$$

The reader familiar with the method of equivalence will see that this model emerges from application of the method [18], being the unique example of maximal dimensional symmetry group of a holomorphic projective connection with a holomorphic subbundle of the tangent bundle. We take the projective connection  $E_1 \to M$ , and consider the subbundle  $E_2 \subset E_1$  on which the soldering form identifies elements of the given vector subbundle  $V \subset TM$  with elements of  $\mathbb{C}^p \oplus 0 \subset \mathbb{C}^{p+q}$ . On this subbundle,  $\omega_i^I$  vanishes on the vertical directions, so is semibasic, say  $\omega_i^I = t_{ij}^I \omega^j + t_{iJ}^I \omega^J$ . The antisymmetric part  $t_{ij}^I - t_{ji}^I$  is the obstruction to V being a foliation. The symmetric part remaining is the shape operator; [37] p. 31. The reduction of structure group following the method of equivalence is not of constant type in general, so to ensure constant type we insist that will only study totally geodesic holomorphic foliations, i.e.  $t_{ij}^I = 0$ .

Differentiating the equation  $\omega_i^I = t_{ij}^I \omega^j + t_{iJ}^I \omega^J$ , we find that  $dt_{iI}^I = q\omega_i + t_{jI}^I \omega_i^J$  modulo semibasic terms. The set of points  $E \subset E_1$  at which  $t_{iI}^I = 0$  is a principal H-subbundle, where H is the set of all elements of G of the form

$$\begin{bmatrix} g_0^0 & 0 & g_J^0 \\ 0 & g_j^i & g_J^i \\ 0 & 0 & g_J^I \end{bmatrix}.$$

Consider the subgroup  $G_0$  of elements of the form

$$\begin{bmatrix} g_0^0 & 0 & 0 \\ 0 & g_j^i & 0 \\ 0 & 0 & g_J^I \end{bmatrix}$$

and the subgroup  $G_+$  of elements of the form

$$\begin{bmatrix} 1 & 0 & g_J^0 \\ 0 & \delta_j^i & g_J^i \\ 0 & 0 & \delta_I^I \end{bmatrix}.$$

Since our model has no further reduction of structure group, the method of equivalence finishes at E. We are inclined to pretend that this is a Cartan geometry with Cartan connection

$$\omega = \omega_{-} \oplus \omega_{0} \oplus \omega_{+} = (\omega^{i}, \omega^{I}) \oplus (\omega^{i}_{j}, \omega^{I}_{J}) \oplus (\omega_{I})$$

with model (X,G) as above. It might not be a Cartan connection, because the curvature might not be semibasic.

We compute that

$$\begin{split} d\omega_j^i + \omega_k^i \wedge \omega_j^k &= \delta_j^i \omega_K \wedge \omega^K - t_{jk}^J \omega_J^i \wedge \omega^k - t_{jK}^J \omega_J^i \wedge \omega^K, \\ d\omega_J^I + \omega_K^I \wedge \omega_J^K &= \delta_J^I \omega_K \wedge \omega^K + t_{kL}^I \omega_J^k \wedge \omega^L, \end{split}$$

modulo semibasic terms, i.e. modulo the various  $\omega^k \wedge \omega^\ell$ . We see that our theory will not allow to compute equations on the characteristic classes of the  $H/G_+$ -bundle unless  $0=t^I_{jk}=t^I_{jK}$ , i.e. the vector subbundle  $V\subset TM$  is a foliation F with totally geodesic leaves and also the invariant  $t^I_{iJ}$ , a 1-form on the leaves of the foliation valued in traceless endomorphisms of the normal bundle, must vanish. Such foliations we call 1-flat for the projective connection.

Every 1-flat foliation is a Cartan geometry modelled on (X,G), with

$$\begin{split} d\begin{pmatrix} \omega^i \\ \omega^I \end{pmatrix} &= -\begin{pmatrix} \omega^i_j & \omega^i_J \\ 0 & \omega^I_J \end{pmatrix} \wedge \begin{pmatrix} \omega^j \\ \omega^J \end{pmatrix}, \\ d\begin{pmatrix} \omega^i_j & \omega^i_J \\ 0 & \omega^I_J \end{pmatrix} &= -\begin{pmatrix} \omega^i_k & \omega^k_K \\ 0 & \omega^I_K \end{pmatrix} \wedge \begin{pmatrix} \omega^k_j & \omega^k_J \\ 0 & \omega^K_J \end{pmatrix} \\ &+ \begin{pmatrix} \delta^i_j \omega_K \wedge \omega^K & \omega_J \wedge \omega^i \\ 0 & (\omega_J \delta^I_K + \omega_K \delta^I_J) \wedge \omega^K \end{pmatrix} \end{split}$$

modulo semibasic terms.

Since a 1-flat foliation occurs on a complex manifold with holomorphic projective connection, it has the same characteristic class and Chern–Simons equations we found before. But we will also find some new ones. The total Chern class of the tangent bundle TF of the foliation F in Dolbeault cohomology is

$$c(TF) = \det \left( I - \frac{\sqrt{-1}}{2\pi} \delta^i_j \omega_K \wedge \omega^K \right) = \left( 1 - \frac{\sqrt{-1}}{2\pi} \omega_K \wedge \omega^K \right)^p$$

so that

$$c_k(TF) = \binom{p}{k} c_1(TF)^k$$

for  $k = 1, 2, \dots, q$ . We also see that

$$c_1(TF) = -\frac{i}{2\pi}p\omega_K \wedge \omega^K$$

and

$$c_1(TM/TF) = -(q+1)\frac{i}{2\pi}\omega_K \wedge \omega^K$$

so that

$$p c_1(TM/TF) = (q+1) c_1(TF),$$

and so

$$c_1(TM/TF)^{q+1} = c_1(TF)^{q+1} = 0.$$

In terms of  $c_1(TM)$ ,

$$c_1(TM) = c_1(TF) + c_1(TM/TF),$$

giving

$$c_k(TF) = \binom{p}{k} \left(\frac{p}{p+q+1}c_1(TM)\right)^k,$$

$$c_k(TM/TF) = \binom{q+1}{k} \left(\frac{q+1}{p+q+1}c_1(TM)\right)^k.$$

Take any  $GL_q$ -invariant polynomial P of degree  $\geq q+1$ , perhaps valued in a finite dimensional holomorphic  $GL_q$ -module. Write, as above,

$$\nabla \omega_J^I = d\omega_J^I + \omega_K^I \wedge \omega_J^K.$$

We find

$$P(\nabla \omega_I^I) = P(\delta_I^I \omega_K \wedge \omega^K + \omega_I \wedge \omega^I),$$

modulo torsion, expands out to have more than q 1-forms  $\omega^K$  in each term. But there are only q such 1-forms, so

$$P(\nabla \omega_I^I) = 0$$

modulo torsion. The Chern–Simons form is then

$$T_P = P(\omega_J^I, \nabla \omega_J^I, \dots, \nabla \omega_J^I)$$

which also vanishes, modulo torsion, if there are more than q 1-forms  $\omega^K$  in each term, i.e. if P has degree q+2 or more. We recover the Baum–Bott theorem [4] p. 287 for our holomorphic folation, with results of Kamber and Tondeur [28]:

**Theorem 5.1.** Take a complex manifold with a holomorphic projective connection and a 1-flat foliation. All Chern classes, in Dolbeault cohomology, of the normal bundle of the foliation, of degree more than the codimension of the foliation, vanish. All of their associated Chern–Simons classes, in Dolbeault cohomology, of degree at least two more than the codimension of the foliation, vanish.

Again, we stress that this theorem is a direct consequence of the linear algebra computation of  $[\mathfrak{g}_+\mathfrak{g}_-]_0$  for  $G \subset \mathrm{GL}_{p+q}$  the stabilizer of a p-dimensional linear subspace.

From the structure equations, we see that:

**Theorem 5.2.** Take a complex manifold M equipped with a holomorphic projective connection and a 1-flat totally geodesic foliation. On each leaf, the tangent bundle of the leaf admits a holomorphic affine connection, as does the normal bundle of the leaf. Hence all characteristic classes of those bundles restrict to each leaf to vanish in Dolbeault cohomology.

# 6. Example: projective connections and split tangent bundle

Take a complex manifold M with a holomorphic projective connection  $E \to M$  and split tangent bundle  $TM = U \oplus V$ . Let  $E' \subset E$  be the set of points at which the soldering form identifies the splitting with  $\mathbb{C}^p \oplus \mathbb{C}^q = \mathbb{C}^{p+q}$ . Hence  $\omega_i^I$  and  $\omega_i^I$  both become semibasic on E'. As above,  $dt_{iI}^I = p\omega_i + t_{jI}^I\omega_i^J$  and  $dt_{Ii}^i = q\omega_I + t_{Ji}^i\omega_I^J$ . We let  $E'' \subset E$  be the set of points at which  $0 = t_{II}^I$  and  $0 = t_{Ii}^I$ . The structure equations of a projective connection (modulo torsion and curvature) are

$$\begin{split} d\omega^{i} + \omega^{i}_{j} \wedge \omega^{j} + \omega^{i}_{J} \wedge \omega^{J} &= 0, \\ d\omega^{I} + \omega^{i}_{J} \wedge \omega^{j} + \omega^{I}_{J} \wedge \omega^{J} &= 0, \\ d\omega^{i}_{j} + \omega^{i}_{k} \wedge \omega^{k}_{j} + \omega^{i}_{K} \wedge \omega^{K}_{j} &= \left(\delta^{i}_{j}\omega_{k} + \delta^{i}_{k}\omega_{j}\right) \wedge \omega^{k} + \delta^{i}_{j}\omega_{K} \wedge \omega^{K}, \\ d\omega^{i}_{j} + \omega^{i}_{k} \wedge \omega^{k}_{J} + \omega^{i}_{K} \wedge \omega^{K}_{J} &= \omega_{J} \wedge \omega^{i}, \\ d\omega^{J}_{j} + \omega^{I}_{k} \wedge \omega^{k}_{j} + \omega^{I}_{K} \wedge \omega^{K}_{j} &= \omega_{j} \wedge \omega^{I}, \\ d\omega^{I}_{J} + \omega^{I}_{k} \wedge \omega^{k}_{J} + \omega^{I}_{K} \wedge \omega^{K}_{J} &= \delta^{I}_{J}\omega_{k} \wedge \omega^{k} + \left(\delta^{I}_{J}\omega_{K} + \delta^{I}_{K}\omega_{J}\right) \wedge \omega^{K}, \\ d\omega_{I} &= \omega^{j}_{i} \wedge \omega_{j} + \omega^{J}_{i} \wedge \omega_{J}, \\ d\omega_{I} &= \omega^{j}_{I} \wedge \omega_{j} + \omega^{J}_{I} \wedge \omega_{J}. \end{split}$$

These reduce on E'', modulo torsion, to

$$\begin{split} d\omega^i + \omega^i_j \wedge \omega^j &= 0, \\ d\omega^I + \omega^I_J \wedge \omega^J &= 0, \\ d\omega^i_j + \omega^i_k \wedge \omega^k_j &= 0, \\ d\omega^I_J + \omega^K_I \wedge \omega^K_J &= 0, \end{split}$$

which are the structure equations of Cartan geometry modelled on a product of affine spaces, each acted on by the affine group. The Atiyah class of the tangent bundle vanishes.

**Theorem 6.1.** On a complex manifold, a choice of holomorphic projective connection and a splitting of its tangent bundle into a direct sum imposes an affine connection on the tangent bundle. In particular, all characteristic classes of the tangent bundle vanish in Dolbeault cohomology.

The generalizes a result of Kobayashi and Ochiai [30] p. 85 theorem 6.6; their result requires that the splitting be into tangent bundles of foliations.

#### 7. EXAMPLE: GRASSMANNIAN GEOMETRIES

A  ${\it Grassmannian~geometry}$  is a Cartan geometry modelled on the complex homogeneous space

$$(X,G) = (\operatorname{Gr}_p \mathbb{C}^{p+q}, \mathbb{P}\operatorname{SL}_{p+q}).$$

The structure equations:

$$0 = d \begin{pmatrix} \omega_j^i & \omega_J^i \\ \omega_I^i & \omega_I^I \end{pmatrix} + \begin{pmatrix} \omega_k^i & \omega_K^i \\ \omega_L^i & \omega_L^K \end{pmatrix} \wedge \begin{pmatrix} \omega_j^k & \omega_J^k \\ \omega_K^i & \omega_L^K \end{pmatrix}$$

modulo torsion,  $i, j, k = 1, 2, \dots, p, I, J, K = p + 1, \dots, p + q$ . Split into the obvious Langlands decomposition:

$$\omega_{-} = \begin{pmatrix} 0 & 0 \\ \omega_{j}^{I} & 0 \end{pmatrix}, \omega_{0} = \begin{pmatrix} \omega_{j}^{i} & 0 \\ 0 & \omega_{J}^{I} \end{pmatrix}, \omega_{+} = \begin{pmatrix} 0 & \omega_{J}^{i} \\ 0 & 0 \end{pmatrix}$$

The tangent bundle is a tensor product of two bundles, which have Atiyah class representatives

$$\begin{split} d\omega_j^i + \omega_k^i \wedge \omega_j^k &= -\omega_K^i \wedge \omega_j^K, \\ d\omega_J^I + \omega_K^I \wedge \omega_J^K &= +\omega_J^k \wedge \omega_k^I, \end{split}$$

modulo curvature. Differentiating the soldering forms

$$d\omega_i^I = -\omega_{iJ}^{Ij} \wedge \omega_i^J$$

modulo torsion, where

$$\omega_{i,I}^{Ij} := \delta_i^j \omega_J^I - \delta_J^I \omega_i^j.$$

So the Ativah class of the tangent bundle is represented by

$$\begin{split} a &= d\omega_{iJ}^{Ij} + \omega_{iK}^{Ik} \wedge \omega_{kJ}^{Kj}, \\ &= \delta_i^i \omega_J^k \wedge \omega_k^I + \delta_J^I \omega_K^j \wedge \omega_i^K \end{split}$$

modulo curvature.

Define  $\mathfrak{h}$ -modules  $U = \mathbb{C}^p$  and  $Q = \mathbb{C}^q$  by, for

$$v = \begin{pmatrix} v_j^i & v_J^i \\ 0 & v_J^I \end{pmatrix} \in \mathfrak{h},$$

$$\rho_U(v) = (v_j^i),$$
  
$$\rho_Q(v) = (v_J^I)$$

giving an exact sequence

$$0 \to U \to \mathbb{C}^{p+q} \to Q \to 0$$

of  $\mathfrak{h}$ -modules. In terms of Lie algebras,  $\mathfrak{g}_+ = U \otimes Q^*$ , say, and  $\mathfrak{g}_- = Q \otimes U^*$ . Elements  $x \in U \otimes Q^*$  and  $y \in Q \otimes U^*$ , thought of as linear maps  $x \colon Q \to U$  and  $y \colon U \to Q$ , have compositions  $xy \in U^* \otimes U$  and  $yx \in Q^* \otimes Q$ . The Atiyah class of the tangent bundle is represented by

$$a(x, y_1)y_2 = -y_1xy_2 + y_2xy_1.$$

The same expression holds identically for the Lagrangian Grassmannian, except that  $x, y_1, y_2$  are symmetric square matrices.

Note that  $\mathbb{C}^{p+q}$  is an  $\mathfrak{sl}_{p+q}$ -module so has vanishing Atiyah class. Clearly U and Q descend to  $\mathfrak{h}$ -modules. The  $\mathfrak{h}$ -module  $T:=U^*\otimes Q$  is an  $\underline{H}$ -module, and the associated vector bundle on any Grassmannian geometry is the tangent bundle. Neither U nor Q are  $\underline{H}$ -modules. Nonetheless, as previously we write a(U) and a(Q) for their Atiyah forms. The splitting principle gives

$$1 = c(\boldsymbol{U})c(\boldsymbol{Q})$$

for total Chern forms, while

$$ch(T) = ch(U) ch(Q)$$

for total Chern character forms. Hence on any complex manifold with Grassmann geometry, the characteristic classes in Dolbeault cohomology have similar factorizations to those of the Grassmannian.

#### 8. Example: conformal geometries

Take the quadratic form

$$q(x,y) := {}^{\mathsf{T}}\!xy + {}^{\mathsf{T}}\!yx,$$

for  $x, y \in \mathbb{C}^{n+1}$ . Write vectors as  $x = (x_0, x_1, \dots, x_{n+1})$ . The group  $G = \mathbb{P} O_q = \mathbb{P} O_{2n+2}$  of invertible matrices preserving q up to factor, modulo rescaling, has Lie algebra  $\mathfrak{g} = \mathfrak{so}_{2n+2}$  consisting of the matrices of the form

$$\begin{pmatrix} a & b \\ c & -^{\mathsf{T}}a \end{pmatrix}$$

with  $0 = {}^{\mathsf{T}}b + b = {}^{\mathsf{T}}c + c$ . Split up each such matrix into

$$\begin{pmatrix} a_{00} & a_{0j} & 0 & b_{0j} \\ a_{i0} & a_{ij} & b_{i0} & b_{ij} \\ 0 & c_{0j} & -a_{00} & -a_{j0} \\ c_{i0} & c_{ij} & -a_{0i} & -a_{ji} \end{pmatrix}$$

The group G acts on the quadric hypersurface  $X = X^{2n} = (q(x,y) = 0) \subset \mathbb{P}^{2n+1}$ , i.e. the set of all null lines, with the element  $x_0 = [1, 0, \dots, 0]$  having stabilizer H with Lie algebra  $\mathfrak{h}$  given by

$$\begin{pmatrix} a_{00} & a_{0j} & 0 & b_{0j} \\ 0 & a_{ij} & b_{i0} & b_{ij} \\ 0 & 0 & -a_{00} & 0 \\ 0 & c_{ij} & -a_{0i} & -a_{ji} \end{pmatrix}$$

with  $0 = b_{ij} + b_{ji} = c_{ij} + c_{ji}$ . It is convenient to write this as

$$\begin{pmatrix} a & a_j & 0 & -b_j \\ 0 & a_{ij} & b_i & b_{ij} \\ 0 & 0 & -a & 0 \\ 0 & c_{ij} & -a_i & -a_{ji} \end{pmatrix}$$

The space  $\mathfrak{g}_- = \mathfrak{g}/\mathfrak{h}$  consists of the elements of the form

$$(x,y) \cong \begin{pmatrix} 0 & 0 & 0 & 0 \\ x_i & 0 & 0 & 0 \\ 0 & -y_j & 0 & -x_j \\ y_i & 0 & 0 & 0 \end{pmatrix}.$$

So  $\mathfrak{h}$  acts on  $\mathfrak{g}_{-}$  as

$$\begin{pmatrix} x_i \\ y_i \end{pmatrix} \mapsto \begin{pmatrix} a_{ij} - \delta_{ij}a & b_{ij} \\ c_{ij} & -a_{ji} - \delta_{ij}a \end{pmatrix} \begin{pmatrix} x_j \\ y_j \end{pmatrix},$$

i.e.

$$\rho_{\mathfrak{g}_{-}} \begin{pmatrix} a & a_{j} & 0 & -b_{j} \\ 0 & a_{ij} & b_{i} & b_{ij} \\ 0 & 0 & -a & 0 \\ 0 & c_{ij} & -a_{i} & -a_{ji} \end{pmatrix} = \begin{pmatrix} a_{ij} - \delta_{j}^{i} a & b_{ij} \\ c_{ij} & -a_{ji} - \delta_{ij} a \end{pmatrix}.$$

Hence the subalgebra  $\mathfrak{g}_+$  acting trivially on the tangent space  $T_{x_0}X$  consists of the elements of the form

$$v = \begin{pmatrix} 0 & a_j & 0 & -b_j \\ 0 & 0 & b_i & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & -a_i & 0 \end{pmatrix}.$$

Bracketing these two gives

$$\begin{pmatrix} a_k x_k - b_k y_k & 0 & 0 & 0 \\ 0 & -b_i y_j - x_i a_j & 0 & x_i b_j - b_i x_j \\ 0 & 0 & y_k b_k - x_k a_k & 0 \\ 0 & a_i y_j - y_i a_j & 0 & a_i x_j + b_j y_i \end{pmatrix}.$$

Applying  $\rho_{\mathfrak{g}_{-}}$  gives a representative for the Atiyah class of the tangent bundle:

$$\rho_{\mathfrak{g}_{-}}(v)(x,y) = \begin{pmatrix} -b_i y_j - x_i a_j - \delta_{ij}(a_k x_k - b_k y_k) & x_i b_j - b_i x_j \\ a_i y_j - y_i a_j & y_i b_j + a_i x_j - \delta_{ij}(a_k x_k - b_k y_k) \end{pmatrix}.$$

Taking trace, the first Chern class of the tangent bundle is represented by

$$-2n(a_k x_k - b_k y_k) = -2nq((a, -b), (x, y)).$$

Expand out to see that

$$\rho_{\mathfrak{g}_{-}}(v)(x_{1}, y_{1})(x_{2}, y_{2}) = -q((a, -b), (x_{1}, y_{1}))(x_{2}, y_{2})$$
$$-q((a, -b), (x_{2}, y_{2}))(x_{1}, y_{1})$$
$$-q((x_{1}, y_{1}), (x_{2}, y_{2}))(b, -a).$$

The same result holds for odd dimensional conformal geometries, with the same proof. Hence we recover

**Theorem 8.1** ([27] p. 6 proposition 2.2). The Atiyah class of any holomorphic conformal geometry on any complex manifold M satisfies

$$ia(T) \dim M = 2\pi c_1(T) \otimes I + 2\pi I \otimes c_1(T) + 2\pi q \otimes q^* c_1(T)$$

in Dolbeault cohomology.

A holomorphic Riemannian metric is a holomorphic Cartan geometry modelled on  $(X, G) = (\mathbb{C}^n, \mathcal{O}_n \ltimes \mathbb{C}^n)$ .

**Corollary 8.2.** A holomorphic conformal geometry arises from a holomorphic Riemannian geometry just when  $c_1 = 0$  in Dolbeault cohomology.

Write a quadric  $Q^n \subset \mathbb{P}^{n+1}$  as Q = G/H as above, with  $G = \mathbb{P}\operatorname{O}_q$ , and also as  $\hat{G}/\hat{H}$ , where  $\hat{G} = \operatorname{O}_q$  is the orthogonal group of the quadratic form q. Any smooth quadric hypersurface  $Q^n \subset \mathbb{P}^{n+1}$  has exact sequence

$$0 \to TQ \to \left. T\mathbb{P}^{n+1} \right|_Q \to N_{Q/\mathbb{P}^{n+1}} \to 0$$

and we have normal bundle

$$N_{Q/\mathbb{P}^{n+1}} = \mathcal{O}(2)|_{Q}$$
.

The bundles  $\mathcal{O}(2)|_Q$ ,  $T\mathbb{P}^{n+1}|_Q$  are the associated vector bundles of the H-representations taking each

$$g = \begin{bmatrix} g_0^0 & g_J^0 \\ 0 & g_J^I \end{bmatrix} \in H$$

to

$$\rho_{\mathcal{O}(2)}(g) = (g_0^0)^{-2}, \rho_{T\mathbb{P}^{n+1}}(g) = (g_0^0)^{-1}g_I^I.$$

The bundle  $\left.T\mathbb{P}^{n+1}\right|_{O}$  has exact Euler sequence

$$0 \to \mathcal{O} \to \mathbb{C}^{n+2} \otimes \mathcal{O}(1) \to T\mathbb{P}^{n+1} \to 0.$$

The line bundle  $\mathcal{O}(1)$  is not an associated vector bundle for H, but of the  $\hat{H}$ -representation

$$g = \begin{pmatrix} g_0^0 & g_J^0 \\ 0 & g_J^I \end{pmatrix} \in \mathcal{O}_q \mapsto (g_0^0)^{-1}.$$

Nonetheless, as above, every  $\hat{H}$ -module determines a unique  $\mathfrak{h}$ -module, since  $\hat{H} \to H$  is an isomorphism of Lie algebras. Every  $\mathfrak{h}$ -module has an Atiyah class on any complex manifold with a holomorphic conformal geometry. The  $\mathfrak{h}$ -module  $\mathbb{C}^{n+2}$  is a  $\mathfrak{g}$ -module; by theorem 3.6 on page 9, its Atiyah class vanishes. Writing these in the obvious notation, we find

**Theorem 8.3.** On any complex manifold of complex dimension n with a holomorphic conformal structure,

$$(1+2\alpha)c(T) = (1+\alpha)^{n+1},$$

in Dolbeault cohomology, where  $\alpha = c_1 \mathcal{O}(1)$  is the Chern class in Dolbeault cohomology of the "ghost line bundle"  $\mathcal{O}(1)$ .

If we don't like "ghost line bundles", clearly  $\alpha = 2c_1\mathcal{O}(2) = c_1(T)/(n-1)$ . So we can write this out as

$$\left(1 + \frac{2c_1(T)}{n-1}\right)c(T) = \left(1 + \frac{c_1(T)}{n-1}\right)^{n+1}.$$

Kobayashi and Ochiai expand out this expression explicitly. Write the dimension n of our complex manifold as n=2m or n=2m+1. For a real variable h, expand in a Taylor series

$$\sum_{q=0}^{m} (1+h)^{n-2q} h^{2q} = 1 + a_1 h + a_2 h^2 + \dots$$

**Theorem 8.4.** On any complex manifold of complex dimension n with a holomorphic conformal geometry,

$$n^k c_k(T) = a_k c_1(T)^k,$$

for k = 1, 2, ..., n, in Dolbeault cohomology.

Kobayashi and Ochiai [31] p. 596 theorem 3.20 prove a weaker result, for only the top Chern classes, but in de Rham cohomology. It seems possible to obtain relations on Chern–Simons classes as we did for projective connections.

#### 9. Slovák cohomology

We have seen that Dolbeault cohomology has the advantage of not feeling curvature or torsion terms in Atiyah classes arising in holomorphic Cartan geometries, but the disadvantage of employing differential forms which are not holomorphic, so does not naturally extend into other categories besides complex manifolds. The holomorphic de Rham cohomology has the advantage of being purely holomorphic, so having natural analogues in other categories, but the curvature and torsion do not drop out of the calculations. We formulate a cohomology theory, which we call Slovák cohomology, defined in terms of a Cartan geometry, which has both advantages and neither disadvantage.

9.1. Models of Cartan geometries. Take a complex homogeneous space (X, G) with  $x_0 \in X$ ,  $H := G^{x_0}$ , and a Langlands decomposition. Let

$$\Lambda^{p,q,r} := \Lambda^p \mathfrak{g}_-^* \otimes \Lambda^q \mathfrak{g}_0^* \otimes \Lambda^r \mathfrak{g}_+^* \subset \Lambda^{p+q+r} \mathfrak{g}^*.$$

In the splitting,  $G_+$  acts on

$$\mathfrak{g} = \mathfrak{g}_- \oplus \mathfrak{g}_0 \oplus \mathfrak{g}_+$$

as

$$\rho_{\mathfrak{g}}(g_+) \begin{pmatrix} v_- \\ v_0 \\ v_+ \end{pmatrix} = \begin{pmatrix} I & 0 & 0 \\ \pi_0 g_+ & I & 0 \\ \pi_+ g_+ & \mathrm{Ad}_{g_+} - I & \mathrm{Ad}_{g_+} \end{pmatrix} \begin{pmatrix} v_- \\ v_0 \\ v_+ \end{pmatrix}$$

so  $\Lambda^{p,q,r}$  might not be a G-module, only a  $G_0\text{-module,}$ 

$$\Lambda_{p+q+r}^{\geqslant p,\leqslant r} \coloneqq \bigoplus \Lambda^{p',q',r'}$$

where the sum is over p', q', r' with

$$p' \geqslant p,$$

$$r' \leqslant r,$$

$$p' + q' + r' = p + q + r.$$

From our matrix above,  $\Lambda_{p+q+r}^{\geqslant p,\leqslant r}$  is an H-submodule of  $\Lambda^{p+q+r}\mathfrak{g}^*$ . Let

$$\underline{\Lambda}^{p,q,r} := \Lambda_{p+q+r}^{\geqslant p, \leqslant r} / \Lambda_{p+q+r}^{\geqslant p, \leqslant r-1},$$

the quotient H-module. Take a  $G_0$ -module  $\rho_V \colon G_0 \to \operatorname{GL}_V$ . Extend V to an H-module, by making  $G_+$  act trivially. Let  $V^{p,q,r} := V \otimes \underline{\Lambda}^{p,q,r}$ .

9.2. Wedge product. Wedging  $\Lambda^{p,q,r}$  gives

$$\Lambda_{p+q+r}^{\geqslant p,\leqslant r}\otimes\Lambda_{p'+q'+r'}^{\geqslant p',\leqslant r'}\to\Lambda_{p+p'+q+q'+r+r'}^{\geqslant p+p',\leqslant r+r'}$$

This descends to the quotient as the wedge preserves the various numbers of factors. Hence we have a wedge product

$$\xi \in \underline{\Lambda}^{p,q,r}, \eta \in \underline{\Lambda}^{p',q',r'} \mapsto \xi \, \wedge \, \eta \in \underline{\Lambda}^{p+p',q+q',r+r'}.$$

Similarly, for  $G_0$  modules V, W, we have a wedge product

$$\xi \in \underline{V}^{p,q,r}, \eta \in \underline{W}^{p',q',r'} \mapsto \xi \wedge \eta \in \underline{V \otimes W}^{p+p',q+q',r+r'}.$$

Clearly a similar but more sophisticated theory arises if we use a more subtle grading of the Lie algebra  $\mathfrak{g}$ , as in the theory of parabolic geometries.

9.3. Cartan geometries. Take a Cartan geometry  $H \to E \to M$  with model (X,G) with a Langlands decomposition. Take an  $G_0$ -module  $\rho_V \colon G_0 \to \operatorname{GL}_V$ . Extend V to an H-module by making  $G_+$  act trivially. Let  $W := V^{p,q,r}$ . Sections of the associated vector bundle are represented by holomorphic H-equivariant functions  $f \colon E \to W$ , i.e.  $r_h^* f = \rho_W(h)^{-1} f$ , for any  $h \in H$ .

A Slovák cochain is an  $G_0$ -equivariant holomorphic map  $f \colon E \to W$ . Since f is not required to be H-equivariant, Slovák cochains are not generally sections of the associated vector bundle on M. Instead they are holomorphic sections of a holomorphic vector bundle over  $E/G_0$ . Nonetheless, we write the set of Slovák cochains as  $\mathbf{W} = \underline{\mathbf{V}}^{p,q,r}$ . Locally lift f to an  $G_0$ -equivariant holomorphic map  $F \colon E \to V_{p+q+r}^{\geqslant p,\leqslant r}$ . From F, we define a V-valued form  $\xi$  on E, given by

$$\xi = F\omega_{-}^{p'} \wedge \omega_{0}^{q'} \wedge \omega_{+}^{r'},$$

with various sums made implicit, including summing over  $p' \ge p$ ,  $r' \le r$  with p' + q' + r' = p + q + r. Let  $\nabla := d + \omega_0 \wedge$ , so

$$\nabla \xi := d\xi + \rho_V(\omega_0) \wedge \xi.$$

As a differential form valued in the vector space V,

$$\mathcal{L}_v \xi = v \, \lrcorner \, d\xi + d(v \, \lrcorner \, \xi)$$

for any vector field v, and in particular for  $v \in \mathfrak{h}$ . As a V-valued differential form,  $r_h^* \xi = \rho_V(h)^{-1} \xi$  for any  $h \in G_0$ . Hence for  $v \in \mathfrak{g}_0$ ,

$$\mathcal{L}_v \xi = -\rho_V(v)\xi,$$

**Lemma 9.1.** On Slovák cochains,  $0 = v \, \neg \, \nabla + \nabla v \neg \, for \, v \in \mathfrak{g}_0$ .

*Proof.* If we let  $\eta = v \, \neg \, \xi$ , we find

$$\begin{split} v \, \lrcorner \, \nabla \xi &= v \, \lrcorner \, (d\xi + \rho_V(\omega_0) \, \wedge \, \xi), \\ &= -d(v \, \lrcorner \, \xi) + \mathcal{L}_v \xi + \rho_V(v) \xi - \rho(\omega_0) (v \, \lrcorner \, \xi), \\ &= -d\eta - \rho_V(v) \xi + \rho_V(v) \xi - \rho(\omega_0) \eta, \\ &= -\nabla \eta. \end{split}$$

Note that

$$\nabla \omega_{-} = d\omega_{-} + \rho_{\mathfrak{g}_{-}}(\omega_{0}) \wedge \omega_{-},$$

$$\nabla \omega_{0} = d\omega_{0} + \frac{1}{2} [\omega_{0}\omega_{0}],$$

$$\nabla \omega_{+} = d\omega_{+} + \rho_{\mathfrak{g}_{+}}(\omega_{0}) \wedge \omega_{+}.$$

In particular,  $\nabla$  has components which raise indices (p,q,r) by

$$(1,0,0) \} \text{ if } p > 0,$$

$$(1,-1,1) \\ (2,-1,0) \} \text{ if } q > 0$$

$$(2,0,-1) \\ (0,0,1) \} \text{ if } r > 0$$

$$(1,0,0) \\ (0,0,1) \} \text{ for } \nabla F.$$

So  $\nabla$  takes

$$V^{p,q,r} \rightarrow V^{p+2,q-1,r} \oplus V^{p+2,q,r-1} \oplus V^{p+1,q,r} \oplus V^{p+1,q-1,r+1} \oplus V^{p,q,r+1}$$

and takes

$$V_{p+q+r}^{\geqslant p,\leqslant r}\to V_{p+q+r+1}^{\geqslant p,\leqslant r+1},$$

so descends to the quotient, the Slovák differential

$$d \colon \boldsymbol{V}^{p,q,r} \to \boldsymbol{V}^{p,q,r+1}$$

In the quotient,  $\rho_V(\omega_0) \wedge = 0$ , so we can write  $\nabla$  as d. The Slovák differential is the quotient of the exterior derivative, because the connection form term drops out, but the Cartan geometry identifies sections with forms so the cohomology depends on the Cartan geometry. From another perspective,  $\nabla$  acts on holomorphic sections as a quotient of the holomorphic relative de Rham operator, modulo an exterior differential system. Hence  $d^2=0$ , i.e. the Slovák differential is a differential, with cohomology the Slovák cohomology

$$H^{p,q,r}(M, \mathbf{V})$$
.

When we compute in the quotient, all curvature terms lie in the denominator so

$$\nabla \omega_{-} = -\rho_{\mathfrak{g}_{-}}(\omega_{+}) \wedge \omega_{-},$$

$$\nabla \omega_{0} = a(\omega_{+}, \omega_{-}),$$

$$\nabla \omega_{+} = -\frac{1}{2}[\omega_{+}\omega_{+}].$$

If we write out a cochain  $\xi$  as

$$\xi = F\omega_{-}^{p'} \wedge \omega_{0}^{q'} \wedge \omega_{+}^{r'}$$

then we can write

$$\nabla F = F^- \omega_- + F^0 \omega_0 + F^+ \omega_+.$$

In the quotient we fully expand out

$$\nabla \xi = F^{+}\omega_{+} \wedge \omega_{-}^{p'} \wedge \omega_{0}^{q'} \wedge \omega_{+}^{r} + F(\nabla \omega_{-} \wedge \dots).$$

The differential equation of Slovák closure in the quotient is a constant coefficient linear equation, depending only on the infinitesimal model and on  $F^+$  and F at each point.

Let  $V^{p,q,r}$  be the sheaf of  $G_0$ -invariant V-valued (p+q+r)-forms  $\xi$  on H-invariant open subsets of E which are locally expressed as p wedge products of components of  $\omega_-$ , q of  $\omega_0$  and r of  $\omega_+$ . The  $G_+$ -action does not preserve  $V^{p,q,r}$ , as we saw in section 3.3 on page 6. But it preserves the quotient sheaf  $\underline{V}^{p,q,r}$ . For example, our right action above makes the quotients of  $\omega_-, \omega_0, \omega_+$  holomorphic global sections of  $\underline{V}^{1,0,0}, \underline{V}^{0,1,0}, \underline{V}^{0,0,1}$ . Note that they are  $G_0$ -invariant only;  $\omega_0$  is not  $G_+$ -invariant unless this Atiyah class vanishes.

Example 9.2. For projective connections, the action of  $h \in G_+ = \mathbb{C}^{n*}$  on  $\omega_0 = (\omega_j^i)$  is

$$r_h^* \omega_j^i = \omega_j^i + (\delta_j^i h_k + \delta_k^i h_j) \omega^k.$$

**Lemma 9.3.** If a Slovák cycle is  $G_+$ -invariant, then it is closed.

*Proof.* Repeating the argument from lemma 9.1 on the facing page, if  $\xi$  is an  $G_+$ -invariant cochain, then  $0 = v \, \neg \, \nabla \xi + \nabla (v \, \neg \, \xi)$  for any  $v \in \mathfrak{g}_+$ .

Take two vectors  $v_1, v_2, \in \mathfrak{h}_+$ . Note that  $v_1 - \xi$  is not  $H_+$ -invariant, but the "error"

$$\mathcal{L}_{v_2}(v_1 \, \lrcorner \, \xi) = [v_2 v_1] \, \lrcorner \, \xi,$$

is lower order, i.e. has r-1 copies of  $\omega_+$ . Similarly when we repeatedly hook, we don't get invariant differential forms, but the "error" vanishes in the quotient. Hooking in r+1 vectors  $v_1, \ldots, v_{r+1} \in \mathfrak{h}_+$ ,

$$(v_1, \ldots, v_{r+1}) \, \neg \, \nabla \xi = \pm \nabla ((v_1, \ldots, v_{r+1}) \, \neg \, \xi) = 0$$

in the quotient. So in the quotient,  $\nabla \xi = 0$ .

**Lemma 9.4.** On Slovák cochains  $\xi$  in  $\underline{V}^{p,q,0}$ , i.e. p,q,r with  $r=0, \nabla \xi=0$ just when  $\xi$  is  $G_+$ -invariant and hence the pullback of a holomorphic section of  $V^{p,q,0} := V \otimes \Omega_M^p \otimes \operatorname{ad} \underline{E}^{\otimes q} \text{ from } \underline{E} = E/G_+.$ 

*Proof.* We note that the denominator in the definition of  $V^{p,q,0}$  vanishes, i.e. its sections are vector-bundle valued differential forms. Clearly the following are equivalent:

- The differential  $\nabla \xi$  vanishes in  $\underline{\boldsymbol{V}}^{p,q,1}$
- $d\xi + \omega_0 \wedge \xi$  belongs to  $V_{p+q+1}^{\geqslant p,\leqslant 0}$
- $0 = v (d\xi + \omega_0 \wedge \xi)$  for any  $v \in \mathfrak{g}_+$
- $0 = v \, \exists \, d\xi = 0$  for any  $v \in \mathfrak{g}_+$  (since  $v \, \exists \, \omega_0 = 0$  and  $v \, \exists \, \xi = 0$  already),
- $0 = v \, \exists \, d\xi + d(v \, \exists \, \xi)$  for any  $v \in \mathfrak{g}_+$  (since  $v \, \exists \, \xi = 0$  already),
- $0 = \mathcal{L}_v \xi$  for any  $v \in \mathfrak{g}_+$ ,
- $0 = r_{e^{tv}}^* \xi$  for any  $v \in \mathfrak{g}_+$ ,  $0 = r_{g_+}^* \xi$  for any  $g_+ \in G_+$  (since  $G_+$  is connected).

We have already argued that  $\nabla^2 = 0$ , but to be clear we check again:

**Lemma 9.5.** The Slovák differential  $\nabla$  is a differential, i.e.  $\nabla^2 = 0$ .

Proof. Since

$$\nabla^2 = (d + \omega_0 \wedge)(d + \omega_0 \wedge),$$

$$= d^2 + d(\omega_0 \wedge) + \omega_0 \wedge d + \omega_0^2,$$

$$= 0 + (d\omega_0) \wedge -(\omega_0 \wedge d) + \omega_0 \wedge d + \omega_0^2,$$

$$= (d\omega_0 + \omega_0^2) \wedge,$$

$$= \rho_V(\nabla \omega_0) \wedge,$$

$$= a_V(\omega_-, \omega_+) \wedge,$$

is (1,0,1), we see that on the quotient  $\nabla^2 = 0$ .

Lemma 9.6. The Slovák differential is H-invariant. So Slovák cohomology is an H-module.

*Proof.* Under right  $H_+$ -action on E, on  $\mathbf{V}^{p,q,r}$ ,

$$\begin{split} r_{h_+}^* \nabla &= r_{h_+}^* (d + \rho_V(\omega_0) \wedge), \\ &= dr_{h_+}^* + \rho_V(r_{h_+}^* \omega_0) \wedge r_{h_+}^*, \\ &= dr_{h_+}^* + \rho_V(\omega_0 - \pi_0 h_+ \omega_-) \wedge r_{h_+}^*, \\ &= \nabla r_{h_+}^* - \rho_V(\pi_0 h_+ \omega_-) \wedge r_{h_+}^*, \end{split}$$

has "error term"  $\rho_V(\pi_0 h_+ \omega_-) \wedge$  of type (1,0,0), so vanishing in the quotient, i.e.  $\nabla$  becomes *H*-invariant in the quotient.

Since the fibers of  $E/G_0 \to M$  are contractible and Stein, the sheaf cohomology of any holomorphic vector bundle over M pulls back by isomorphism when we pull back vector bundles to  $E/G_0$  [12] p. 365. So the  $G_0$ -invariant Stein open sets of  $E/G_0$  are precisely the preimages of the Stein open sets of M.

Lemma 9.7. On any Stein open set in M, the Slovák cohomology is trivial in positive degree. It is therefore isomorphic to Čech cohomology of the vector bundle  $V^{p,q,0} := V \otimes \Omega_M \otimes \operatorname{ad} \underline{E}$  over the image in M of that open set.

*Proof.* We can assume that M is Stein and hence  $E/G_0$  is Stein. By a theorem of Serre [33] p. 142 Proposition 5, the preimage of  $E/G_0$  in E is Stein. We have seen that the Slovák differential in the quotient  $\mathbf{V}^{p,q,r}$  is the exterior derivative. So on any Stein open set in E, any Slovák-closed form of positive degree r is d-exact. Since the group  $G_0$  is reductive, it contains a maximal compact real subgroup which is Zariski dense. Averaging over the Haar measure of this subgroup, we ensure that any Slovák-closed form is  $G_0$ -invariantly exact.

9.4. Characteristic classes. We define as above the Chern classes, Chern–Simons classes, Atiyah class, and so on, in Slovák cohomology. Note that the Chern–Simons forms vanish as Slovák classes, except perhaps for the final term

$$T_f = f(\omega_0, d\omega_0^{k-1})$$

if f is a homogeneous polynomial on  $\mathfrak{g}_0$  of degree k, because other terms have lower grade r in the trigrading p,q,r.

Example 9.8. If a holomorphic vector bundle is the pull back of the universal bundle from a holomorphic map to the Grassmannian, or more generally to some complex manifold with a holomorphic Grassmannian geometry, we can use the above apparatus to define a kind of Slovák cohomology for that bundle, which maps then to the Dolbeault cohomology, taking the pulled back Slovák Chern classes to the usual Chern classes in Dolbeault cohomology.

#### 10. SLOVÁK TO DOLBEAULT

10.1. **Just repeat the proofs.** All of the theorems we have stated above about Chern classes and Chern–Simons classes in Dolbeault cohomology have the same proofs in Slovák cohomology.

10.2. The Dolbeault map. Take a complex homgeneous space (X,G) with point  $x_0 \in X$ , let  $H := G^{x_0}$ , take a Langlands decomposition  $H = G_0 \ltimes G_+$  and take a holomorphic (X,G)-Cartan geometry  $H \to E \to M$ . Recall we let  $\underline{E} := E/G_+$ , a holomorphic principal right  $G_0$ -bundle  $G_0 \to \underline{E} \to M$ . Recall that since  $H/G_0$  is contractible,  $E/G_0 \to M$  admits a  $C^{\infty}$  section  $s : M \to E/G_0$  i.e. a  $C^{\infty}$   $G_0$ -reduction of structure group. The pullback

$$s^*E \longrightarrow E$$

$$\downarrow \qquad \qquad \downarrow$$

$$M \longrightarrow E/G_0$$

makes  $s^*E$  a  $G_0$ -bundle equivariantly mapped to E, and composing  $s^*E \to E \to \underline{E}$  gives an isomorphism of  $G_0$ -bundles. The inverse isomorphism is a  $G_0$ -equivariant map which we also denote by  $s \colon \underline{E} \to E$ . Conversely, every  $G_0$ -equivariant map  $s \colon \underline{E} \to E$  quotients to a reduction  $s \colon M \to E/G_0$ .

The pullback by this map  $s \colon \underline{E} \to E$  takes  $\omega_-$  to a semibasic (1,0)-form  $s^*\omega_-$ , since  $\omega_-$  is a semibasic (1,0)-form on E. Since  $s^*\omega_0$  is a (1,0)-connection, it is in particular a (1,0)-form. However, the pullback  $s^*\omega_+$  may have (1,0) and (0,1) parts. Fix a  $G_0$ -module V. Recall that  $V^{p,q,r}$  is the collection of holomorphic differential forms  $\xi$  on E valued in the associated vector bundle V, which have type (p,q,r) in the Langlands decomposition  $\mathfrak{g} = \mathfrak{g}_- \oplus \mathfrak{g}_0 \oplus \mathfrak{g}_+$ . So the pullback  $s^*\xi$  of  $\xi$  to  $s^*E$  has Dolbeault decomposition into parts

$$(p+q+r,0), (p+q+r-1,1), \ldots, (p+q,r).$$

To each such  $\xi$ , we associate the V-valued (p+q,r)-form  $\xi^{\bar{\partial}}=(s^*\xi)^{p+q,r}$  defined as the (p+q,r)-part of the pullback to  $\underline{E}$ :

$$V^{p,q,r} \mapsto V^{p+q,r}$$
.

This map takes

$$V_{p+q+r}^{\geqslant p,\leqslant r} \to V^{p+q,r}$$

Hence it takes

$$V_{p+q+r}^{\geqslant p,\leqslant r-1} \to 0.$$

So it is defined on the quotient. The resulting object  $\xi^{\bar{\partial}}$  is a  $C^{\infty}$  section of

$$V \otimes \Omega^{p,r} \otimes (\operatorname{ad} E)^{* \otimes q}$$
.

The Dolbeault map preserves wedge products. The Slovák operator is taken to

$$(\nabla \xi)^{\bar{\partial}} = (s^* \nabla \xi)^{p+q,r+1},$$

$$= (s^* d\xi + \rho_V (s^* \omega_0) \wedge s^* \xi)^{p+q,r+1},$$

$$= (ds^* \xi)^{p+q,r+1},$$

$$= ((\partial + \bar{\partial}) s^* \xi)^{p+q,r+1},$$

$$= \bar{\partial} (s^* \xi)^{p+q,r},$$

$$= \bar{\partial} \xi^{\bar{\partial}}.$$

Hence the Slovák operator becomes the Dolbeault operator, and we map Slovák cohomology to Dolbeault cohomology. The Dolbeault isomorphism then maps Slovák cohomology to sheaf cohomology

$$H^r(M, \mathbf{V} \otimes \Omega^p \otimes (\operatorname{ad} \underline{E})^{* \otimes q})$$
.

In particular, when 0 = p = q we compute in sheaf cohomology  $H^r(M, \mathbf{V})$ .

10.3. Changing reduction. Take two  $C^{\infty}$  reductions of structure group, i.e.  $C^{\infty}$  sections  $s_0, s_1 \colon M \to E/G_0$ . They are equivalent to  $G_0$ -equivariant maps  $s_0, s_1 \colon \underline{E} \to E$ , so  $s_1 = s_0 g_+$  for a unique  $C^{\infty} g_+ \colon \underline{E} \to G_+$  with

$$r_{g_0}^* g_+ = \operatorname{Ad}_{g_0}^{-1} g_+$$

for  $g_0 \in G_0$ .

**Lemma 10.1.**  $s_1^*\omega = \operatorname{Ad}_{g_+}^{-1} s_0^*\omega + g_+^{-1} dg_+$ .

*Proof.* Pick a point  $e_0 \in \underline{E}$ , a vector  $v \in T_{e_0}\underline{E}$  and a curve e(t) with  $e(0) = e_0$  and e'(0) = v. Let

$$u := \frac{d}{dt} \bigg|_{t=0} g_{+}(\underline{e}_{0})^{-1} g_{+}(\underline{e}(t)) = \left( g_{+}(\underline{e}_{0})^{-1} \right)'_{g_{+}(\underline{e}_{0})} g'_{+}(\underline{e}_{0}) v.$$

Compute

$$s_{1}'(\underline{e}_{0})v = \frac{d}{dt}\Big|_{t=0} s_{1}(\underline{e}(t)),$$

$$= \frac{d}{dt}\Big|_{t=0} s_{0}(\underline{e}(t))g_{+}(\underline{e}(t)),$$

$$= \frac{d}{dt}\Big|_{t=0} s_{0}(\underline{e}(t))g_{+}(\underline{e}_{0}) + \frac{d}{dt}\Big|_{t=0} s_{0}(\underline{e}_{0})g_{+}(\underline{e}(t)),$$

$$= r_{g_{+}(e_{0})}'(s_{0}(\underline{e}_{0}))s_{0}'(\underline{e}_{0})v + u(s_{1}(\underline{e}_{0})).$$

Hence

$$\begin{split} s_1^*\omega(v) &= \omega(s_1'(\varrho_0)v), \\ &= \omega(r_{g_+(\varrho_0)}'(s_0(\varrho_0))s_0'(\varrho_0)v + u(s_1(\varrho_0))), \\ &= (s_0^*r_{g_+(\varrho_0)}^*\omega)(v) + u \\ &= (s_0^*r_{g_+(\varrho_0)}^*\omega)(v) + g_+^{-1}dg_+(v), \\ &= (s_0^*\operatorname{Ad}_{g_+(\varrho_0)}^{-1}\omega)(v) + g_+^{-1}dg_+(v), \\ &= (\operatorname{Ad}_{g_+(\varrho_0)}^{-1}s_0^*\omega)(v) + g_+^{-1}dg_+(v). \end{split}$$

Expressed in components of the Cartan connection,

$$s_1^* \begin{pmatrix} \omega_- \\ \omega_0 \\ \omega_+ \end{pmatrix} = \rho(g_+)^{-1} s_0^* \begin{pmatrix} \omega_- \\ \omega_0 \\ \omega_+ \end{pmatrix} + \begin{pmatrix} 0 \\ 0 \\ g_+^{-1} dg_+ \end{pmatrix}$$

where

$$\rho(g_{+})^{-1} = \begin{pmatrix} I & 0 & 0 \\ -\pi_{0}g_{+} & I & 0 \\ (I - \operatorname{Ad}_{g_{+}}^{-1})\pi_{0}g_{+} + \operatorname{Ad}_{g_{+}}^{-1}\pi_{+}g_{+} & \operatorname{Ad}_{g_{+}}^{-1} - I & \operatorname{Ad}_{g_{+}}^{-1} \end{pmatrix}.$$

# 11. ČECH-DOLBEAULT COHOMOLOGY

We briefly recall Čech–Dolbeault cohomology [1], since we need the associated notation below. Fix a complex manifold M, a holomorphic vector bundle  $\mathbf{V} \to M$ , and a cover  $\{M_a\}$  by open sets  $M_a \subset M$ . To each tuple  $A := (a_0, a_1, \ldots, a_k)$  assign

$$M_A := M_{a_0} \cap M_{a_1} \cap \cdots \cap M_{a_k}$$

and let

$$A/i := (a_0, a_1, \dots, \hat{a}_i, \dots, a_k)$$
.

Let  $M_k$  be the disjoint union of all choices of k-fold overlaps:

$$M_k := | M_A,$$

for  $A = (a_0, a_1, \dots, a_k)$ . Each point of  $M_k$  is a pair (x, A), where  $x \in M_A$ . Define local biholomorphisms

$$\hat{\imath} : (x, A) \in M_k \mapsto (x, A/i) \in M_{k-1},$$

for i = 0, 1, ..., k:

$$\cdots \Longrightarrow M_2 \Longrightarrow M_1 \Longrightarrow M_0 \longrightarrow M$$

The Čech differential  $\delta$  is

$$\delta \xi = \sum_{i=0}^{k} (-1)^i \hat{\imath}^* \xi$$

for  $\xi$  on  $M_k$  a  $C^{\infty}$  V-valued differential form.

Let  $M_{\bullet}$  be the disjoint union of the  $M_k$ . A  $C^{\infty}$  V-valued (p,q)-form on  $M_{\bullet}$  is a  $C^{\infty}$  V-valued (p,q-k) form on each  $M_k$ , changing signs when we permute the entries in any  $A=(a_0,\ldots,a_k)$ . Let F be the function F=k on  $M_k$ . The Čech–Dolbeault differential is  $\check{\partial}=\delta+(-1)^F\bar{\partial}$ . The Čech–Dolbeault (p,q)-cochains of V for the given open cover are the  $C^{\infty}$  V-valued (p,q)-forms on  $M_{\bullet}$ . For example

$$\check{\partial} \{ \xi_a, \xi_{ab}, \dots \} := \{ \bar{\partial} \xi_a, \xi_b - \xi_a - \bar{\partial} \xi_{ab}, \dots \}.$$

The Čech–Dolbeault differential takes (p,q)-cochains to (p,q+1)-cochains, and satisfies  $\check{\mathcal{O}}^2=0$ . For any Stein cover, the usual Dolbeault cohomology is isomorphic to Čech–Dolbeault cohomology by  $\xi\mapsto\{\xi_a,\xi_{ab},\ldots\}:=\{\xi,0,0,\ldots\}$ , see [1]. Take a complex Lie group H and a holomorphic principal right H-bundle  $H\to$ 

Take a complex Lie group H and a holomorphic principal right H-bundle  $H \to E \to M$ . Suppose that each  $E_a := E|_{M_a}$  has a  $C^{\infty}$  complex linear connection 1-form  $\omega_a$ . The Atiyah class of  $E \to M$  is the Čech–Dolbeault class of

$$a(M, E) = \{ \xi_a, \xi_{ab}, \xi_{abc}, \dots \} = \{ \bar{\partial} \omega_a, \omega_a - \omega_b, 0, 0, \dots \} = \check{\partial} \{ \omega_a, 0, 0, \dots \}.$$

Careful: a(M,E) is written here as an ad E-valued (1,1)-chain on M, and as  $\check{\partial}$  of a cochain, but not as  $\check{\partial}$  of an ad E-valued (1,0)-chain on M; only of such a cochain on E. Nonetheless, this makes clear that a(M,E) is  $\check{\partial}$ -closed on M, as it is  $\check{\partial}$ -exact on E, and  $\check{\partial}$  commutes with pullback. This class is independent of the choice of connections and vanishes if and only if  $E \to M$  admits a holomorphic connection [1].

#### 12. CZECHOSLOVAK COHOMOLOGY

We develop a Čech variant of Slovák cohomology. Fix a holomorphic principal right H-bundle  $E \to M$  and a cover  $\{M_a\}$  of M by open sets  $M_a \subset M$ . Adopt notation as for Čech–Dolbeault cohomology. Let  $E_A := E|_{M_A}$ . Pick a complex homogeneous space (X,G) with Langlands decomposition. On  $E \to M$ , pick a holomorphic (X,G)-geometry with Cartan connection  $\omega$ . A holomorphic section of  $\underline{V}^{p,q,r}$  on  $M_{\bullet}$  is a holomorphic section of  $\underline{V}^{p,q,r-k}$  on each  $M_k$  which changes sign when two indices are permuted in a tuple  $A = (a_0, \ldots, a_k)$ :

$$\underline{\boldsymbol{V}}_{M_{\bullet}}^{p,q,r} \subset \underline{\boldsymbol{V}}_{M_0}^{p,q,r} \oplus \underline{\boldsymbol{V}}_{M_1}^{p,q,r-1} \cdots \oplus \underline{\boldsymbol{V}}_{M_r}^{p,q,0}$$

Let F be the function F = k on  $M_k$ . The *Czechoslovak differential* is  $\check{\nabla} = \delta + (-1)^F \nabla$ . The *Czechoslovak* (p, q, r)-cochains of V for the given open cover are holomorphic sections of  $V^{p,q,r}$  on  $M_{\bullet}$ . For example

$$\check{\nabla}\left\{\xi_{a},\xi_{ab},\ldots\right\} \coloneqq \left\{\nabla\xi_{a},\xi_{b}-\xi_{a}-\nabla\xi_{ab},\xi_{bc}+\xi_{ca}+\xi_{ab}+\nabla\xi_{abc},\ldots\right\}.$$

**Lemma 12.1.** The Czechoslovak differential takes (p,q,r)-cochains to (p,q,r+1)-cochains, and satisfies  $\check{\nabla}^2 = 0$ .

*Proof.* Writing  $A = (a_0, \ldots, a_k)$ , take a holomorphic local section  $\xi$  of  $\underline{V}^{p,q,r-k}$  on each  $M_A$ , say represented by a local section of  $V^{p,q,r-k}$ . So

$$(\delta \xi)_{(x,A)} = \sum_{i=0}^{k} (-1)^{i} (\hat{\imath}^{*} \xi)_{(x,A)},$$
$$= \sum_{i=0}^{k} (-1)^{i} \xi_{(x,A/i)},$$

increasing value of r by 1. We note that  $(-1)^F \delta = -\delta(-1)^F$ , as  $\delta$  decreases the number of indices.

$$\begin{split} (\check{\nabla}^2 \xi)_{(x,A)} &= ((\delta + (-1)^F \nabla)^2 \xi)_{(x,A)}, \\ &= (\delta^2 \xi)_{(x,A)} + (\delta (-1)^F \nabla \xi)_{(x,A)} + (\nabla (-1)^F \delta \xi)_{(x,A)} + (\nabla^2 \xi)_{(x,A)}, \\ &= (\delta (-1)^F \nabla \xi)_{(x,A)} - ((-1)^F \nabla \delta \xi)_{(x,A)}. \end{split}$$

The Czechoslovak cohomology

$$H^{p,q,r}(M_{\bullet}, \mathbf{V})$$

is the cohomology of the Czechoslovak differential. Note that it will in general depend on the choice of open cover  $M_{\bullet}$  of M. The  $\check{C}ech\ map$  is

$$\xi \in \underline{V}^{p,q,r} \mapsto \{\xi_a, \xi_{ab}, \dots\} := \{\xi, 0, 0, \dots\}.$$

**Theorem 12.2.** The Čech map is a cochain map from Slovák cochains to Czechoslovak cochains, injective in cohomology.

*Proof.* Write the Čech map as  $\xi \mapsto \check{\xi}$ . So

$$\begin{aligned}
\check{\xi}_a &= \xi, \\
\check{\xi}_{ab} &= 0, \\
\check{\xi}_{abc} &= 0, \\
\vdots
\end{aligned}$$

Using  $\nabla \xi$  in place of  $\xi$ ,

$$\begin{split} (\nabla \xi)_a^{\vee} &= \nabla \xi, \\ (\nabla \xi)_{ab}^{\vee} &= 0, \\ (\nabla \xi)_{abc}^{\vee} &= 0, \\ \vdots \end{split}$$

So

$$(\check{\nabla}\check{\xi})_a = \nabla\check{\xi}_a = \nabla\xi$$
$$(\check{\nabla}\check{\xi})_{ab} = \check{\xi}_b - \check{\xi}_a - \nabla\check{\xi}_{ab} = 0,$$
$$(\check{\nabla}\check{\xi})_{abc} = 0 + (-1)^2 0 = 0,$$
$$\vdots$$

using the hypothesis that  $\nabla \xi = 0$  and  $\xi_a = \xi_b = \xi$  is globally defined. So  $\xi \mapsto \check{\xi}$  is a cochain map.

Suppose that  $\check{\xi} = \check{\nabla} \eta$ . Then

$$\begin{aligned}
\check{\xi}_a &= \xi = \nabla \eta_a, \\
\check{\xi}_{ab} &= 0 = \eta_b - \eta_a - \nabla \eta_{ab}, \\
\vdots
\end{aligned}$$

So  $0 = \nabla \eta_b - \nabla \eta_a - \nabla^2 \eta_{ab}$ , i.e.  $\nabla \eta_a$  is globally defined, and  $\xi = \nabla \eta_a$ . Therefore the Čech map is injective in cohomology.

12.1. Cup product. The cup product of Czechoslovak classes  $\xi, \eta$  is

$$(\xi \cup \eta)_{a_0...a_k} := \sum_{j=0}^k (-1)^{(p+q+r-j)(k-j)} \xi_{a_0...a_j} \wedge \eta_{a_j...a_k}.$$

if  $\xi$  is a section of  $\underline{\boldsymbol{V}}^{p,q,r}$  and  $\eta$  a section of  $\underline{\boldsymbol{W}}^{p,q,r}$ , so  $\xi \cup \eta$  is a section of  $\underline{\boldsymbol{V}} \otimes \underline{\boldsymbol{W}}^{p+p',q+q',r+r'}$ . Note that  $\check{\nabla}(\xi \cup \eta) = (\check{\nabla}\xi) \cup \eta + (-1)^{p+q+r}\xi \cup \check{\nabla}\eta$  as in [38].

12.2. Quotient cochains. A quotient cochain is a sequence

$$\{\,\xi_{ab},\eta_{ab},\eta_{abc},\dots\,\}\in \underline{V}_{M_1}^{p,q,r}\oplus\underline{V}_{M_1}^{p,q,r-1}\cdots\oplus\underline{V}_{M_r}^{p,q,0}$$

with  $\xi_{ab} \in \underline{V}^{p,q,r}$ ,  $\eta_{ab} \in \underline{V}^{p,q,r-1}$  both on  $M_{ab}$ , but after the first step,  $\eta_A$  is just a usual Czechoslovak cochain. Map each Czechoslovak cochain

$$\{\xi_a,\xi_{ab},\ldots\}$$

to a quotient cochain by

$$\{\xi_a,\xi_{ab},\ldots\}\mapsto\{\xi_a-\xi_b,\xi_{ab},\ldots\}.$$

The kernel consists precisely of the image of the Slovák cochains in the Czechoslovak cochains. On the quotient cochains, we use the same Czechoslovak differential:

$$\check{\nabla}\left\{\xi_{ab},\eta_{ab},\eta_{abc},\ldots\right\} = \left\{\nabla\xi_{ab},\xi_{ab} - \nabla\eta_{ab},\eta_{bc} + \eta_{ca} + \eta_{ab} + \nabla\eta_{abc},\ldots\right\}.$$

The map to quotient cochains makes a short exact sequence of complexes: Slovák cochains to Czechoslovak cochains to quotient chains.

**Lemma 12.3.** Suppose that all triple overlaps of sets  $M_a$  in our cover are empty. Then the quotient cohomology is trivial, so Slovák cohomology is isomorphic to Czechoslovak cohomology.

Proof. Take a quotient cocycle

$$\xi = \{ \xi_{ab}, \eta_{ab} \}.$$

The condition that  $\xi$  is a cocycle is

$$0 = \check{\nabla} \xi = \{ \nabla \xi_{ab}, \xi_{ab} - \nabla \eta_{ab} \}.$$

So  $\xi_{ab} = \nabla \eta_{ab}$ . Let

$$\zeta = \{ \eta_{ab}, 0 \},\,$$

so

$$\check{\nabla}\zeta = \{ \nabla \eta_{ab}, \eta_{ab} - \nabla 0 \} = \xi.$$

**Lemma 12.4.** For any open cover of M, the Čech cohomology of  $V^{p,q,0} := V \otimes \Omega^p_M \otimes \Lambda^q$  ad E of that open cover injects in the Czechoslovak cohomology of  $V^{p,q,*}$  of the same open cover.

*Proof.* By lemma 9.4 on page 24, on any open set, each Slovák cocycle is identified precisely with a holomorphic section of  $V^{p,q,0}$ . Take any  $\eta$  in the Čech cohomology of  $V^{p,q,0}$  on M and identify it with a Slovák-closed form in  $\underline{V}^{p,q,0}$  with the same name  $\eta$ . Map it to

$$\eta' = \{0, 0, \dots, 0, \eta_A\}.$$

The differential commutes (up to an irrelevant sign). So each  $\delta$ -exact  $\eta$  maps to some  $\eta'$  both  $\delta$  and  $\nabla$  exact so  $\check{\nabla}$ -exact. Conversely,  $\eta'$  is Czechoslovak exact just when  $\eta = \delta \alpha + \nabla \beta$  for some  $\alpha, \beta$ . But  $\eta$  is in  $\underline{V}^{p,q,0}$  so  $\beta = 0$  and so  $\eta$  is  $\delta$ -exact.  $\square$ 

Remark 12.5. On  $E/G_0$ , let

$$\Omega_{-} := (\omega_{-}, \omega_{+}),$$

$$\Omega_{0} := \omega_{0}.$$

In this way, the (X,G)-geometry on M induces an (X',G')-geometry on  $M':=E/G_0$ , where  $G':=(\mathfrak{g}_-\oplus\mathfrak{g}_+)\ltimes G_0$  and  $H':=G_0$  so X'=G'/H' with Cartan connection  $\Omega:=\Omega_-\oplus\Omega_0$  and Langlands decomposition  $H'_0:=H_0$ . By the same argument, for an open covering  $\{M_a\}$  of M, with corresponding preimages  $\{M'_a\}$  in M', the Czechoslovak cohomology of the (X',G')-geometry for that open covering is also

the Čech cohomology of  $V^{p,q,0}$  of that covering on M' or equivalently of the original covering on M.

**Proposition 12.6.** The Czechoslovak cohomology of  $\underline{V}^{p,q,*}$  over any Stein open cover is isomorphic to the Čech cohomology of  $V^{p,q,0} \to M$ .

*Proof.* We follow [8] p. 98 theorem 8.9: take any r-cocycle  $\xi$ . It lies in our double complex along a diagonal line, with finitely many terms. Each term  $\xi_k$  maps to the right and up, and the sums or differences vanish, with suitable signs. The term on the upper left maps to zero by  $\nabla$ , and that on the lower right maps to zero by  $\delta$ . On a Stein open cover,  $\nabla$ -closed implies  $\nabla$ -exact on each open set, so the upper left is  $\nabla$ -exact:  $\xi_k = \nabla \eta_k$ . Replace  $\xi_{k+1}$  by  $\xi_{k+1} \pm \delta(\eta_k)$ , we can get this to be  $\nabla$ -exact, and so on. Finally, we leave only  $\xi_r$ , i.e. the part arising from Čech cohomology.  $\square$ 

**Lemma 12.7.** If  $E/G_0$  is a Stein manifold then the Slovák cohomology group of the cochains  $\underline{V}^{p,q,r}$  is isomorphic to Czechoslovák cohomology and hence to the sheaf cohomology group

$$H^r\big(M,\boldsymbol{V}^{p,q,0}\big)$$

where  $V^{p,q,0} := V \otimes \Omega_M^p \otimes \Lambda^q$  ad  $\underline{E}$ .

*Proof.* Since the fibers of  $E/G_0 \to M$  are contractible and Stein, the sheaf cohomology of any holomorphic vector bundle over M pulls back by isomorphism when we pull back vector bundles to  $E/G_0$  [12] p. 365. Just use the open cover consisting of one open set.

12.3. Czechoslovak characteristic classes. The Czechoslovak Atiyah class of  $E \to M$  is the Czechoslovak class image of the Slovák Atiyah class by the Čech map:

$$a(M, E) = \{ \xi_a, \xi_{ab}, \xi_{abc}, \dots \} = \{ \nabla \omega_0, 0, 0, \dots \}.$$

12.4. Czechoslovak to Čech–Dolbeault. Take a  $C^{\infty}$  reduction of structure group  $s_a \colon M_a \to E_a/G_0$ . The *Dolbeault map* on Czechoslovak cohomology is

$$\{\xi_a, \xi_{ab}, \dots\}^{\bar{\partial}} = \{\xi_a^{\bar{\partial}}, \xi_{ab}^{\bar{\partial}}, \dots\}.$$

By lemma 10.1 on page 26, change in choice of reduction has no effect on the resulting Dolbeault class.

**Lemma 12.8.** The maps defined above between cochains: Slovák, Dolbeault, Czechoslovak, Čech-Dolbeault, are commuting morphisms of differential complexes.

12.5. Wedge and cup product. We define the cup product of Czechoslovak cochains  $\xi, \eta$  by

$$(\xi \cup \eta)_{a_0 \dots a_k} \coloneqq (-1)^{(p+q+r-j)(k-j)} \xi_{a_0 \dots a_j} \wedge \eta_{a_j \dots a_k}$$

if  $\xi \in \underline{V}^{p,q,r}$  and  $\eta \in \underline{W}^{p',q',r'}$ , giving a cochain valued in the tensor product. We can check the Leibnitz identity against the differential.

12.6. Relative cohomology. Take a subcollection I' of indices a from our collection I of indices a of open sets  $\subset \{M_a\}$  from our cover. The open set

$$M' \coloneqq \bigcup_{a \in I'} M_a$$

has an associated collection of Czechoslovak chains built using the sets  $M_a$  with  $a \in I'$ . A relative cochain relative to I' is a cochain  $\xi$  for which every  $\xi_A$  vanishes if all entries of A come from I'. Define relative Czechoslovak cohomology as the cohomology of these. The obvious short exact sequence from relative to all cochains, and then to I'-cochains gives a long exact sequence in cohomology.

If the open covers are chosen Stein, then the relative Slovák cohomology (in the sense of a flabby resolution of Slovák cohomology) is isomorphic to the relative Czechoslovak cohomology [39] p. 3 Theorem 2.4.

Consider the special case when we have a holomorphic Cartan geometry defined on M-S, for some compact complex subvariety  $S \subset M$ . Let  $M_0 := M-S$ . The Slovák cohomology of S is

$$H^{p,q,r}[S,\boldsymbol{V}] \coloneqq \varinjlim_{M_1 \supset S} H^{p,q,r}(M_{\bullet},\boldsymbol{V})\,,$$

where the limit is over open sets  $M_1 \subseteq M$  containing S. We hope to compute residue integrals of Chern–Simons invariants here as in [1].

#### 13. HOMOGENEOUS EXAMPLES

A homogeneous Cartan geometry is a complex manifold X' with a holomorphic Cartan geometry, say modelled on (X,G), invariant under the holomorphic action of a complex Lie group G', i.e. the Lie group acts as holomorphic bundle automorphisms preserving the Cartan connection, acting transitively on X'. Pick a point  $e_0 \in E$  and let  $x_0 \in X'$  be its image in X'. Each  $g \in G'^{x_0}$  determines an element  $h(g) \in H$  by  $ge_0 = e_0h(g)$ , and holomorphic Lie group morphism  $G'^{x_0} \to H$ . Let  $G'_0 := h^{-1}G_0$ . Then  $G'/G'_0 \to E/G'_0$  is a principal bundle morphism, pulling the sheaf of Slovák cochains back to a sheaf over  $G'/G'_0$ . As a holomorphic principal H-bundle over X',  $E_{X'} = G' \times^{G'^{x_0}} H$ . A real vector subspace of a complex vector space is totally real if its tangent spaces are totally real in the tangent spaces of the complex manifold. A complex Lie group is reductive if it is the complexification of a compact Lie group.

**Theorem 13.1.** Take a homogeneous holomorphic Cartan geometry (X', G'), with notation as above. Suppose that G' is reductive, and that the subgroup  $G'_0 = h^{-1}G_0$  of G' is reductive. Then Slovák cohomology is isomorphic to Dolbeault cohomology via the Dolbeault map.

*Proof.* The homogeneous space  $G'/G'_0$  is a Stein manifold [2] p. 160 Corollary 2, [33] Theorem 1. The sheaf of Slovák cochains is a sheaf over  $G'/G'_0$ , consisting of the holomorphic functions on G' which are  $G'_0$ -equivariant for the induced  $G'_0$ -representation. Slovák cohomology is isomorphic to Dolbeault via the Dolbeault isomorphism by lemma 12.7 on the previous page.

Example 13.2. Even for flag varieties, this isomorphism does not appear to have been known.

A C-space (X', G') is a simply connected compact complex manifold X' acted on holomorphically, faithfully and transitively by a connected complex Lie group G' [6, 7, 20, 21, 22, 23, 42]. For example, every generalized complex flag variety is a C-space. For every C-space (X', G'), any Levi factor of G' acts transitively on X', so we can replace G' by that Levi factor, a connected complex semisimple Lie group [42] p. 4 theorem 2.2. Moreover, the maximal compact subgroup of that complex semisimple Lie group is a compact and connected semisimple Lie group also acting transitively on X' [42] p. 13, Theorem 1. So in particular, G' can be assumed reductive without loss of generality.

Corollary 13.3. Take a C-space (X', G'). Take a G'-homogeneous holomorphic Cartan geometry on X', with  $G'_0 = h^{-1}G_0$  reductive as above. Then Slovák cohomology of that holomorphic Cartan geometry is isomorphic to Dolbeault cohomology via the Dolbeault map.

*Proof.* We can replace G' by a Levi factor, so assume that G' is reductive.  $\Box$ 

#### 13.1. Hirzebruch proportionality.

Corollary 13.4 (Hirzebruch proportionality [25]). Suppose that M is a compact complex manifold bearing a holomorphic parabolic geometry, i.e. a holomorphic Cartan geometry with model (X,G) is a generalized flag variety. Associate to each complex polynomial p in Chern classes in Dolbeault cohomology its integral  $\int_M p(c_1,\ldots,c_n)$ , a map

$$\int_M : p(x_1, \dots, x_n) \in \mathbb{C}[x_1, \dots, x_n] \mapsto \int_M p(c_1, \dots, c_n) \in \mathbb{C}.$$

Then there is a constant  $a_0 \in \mathbb{C}$  so that  $\int_M = a_0 \int_X$ .

Remark 13.5. We can't make use of Chern–Simons classes here, since they are (p+1,p) in Dolbeault cohomology, and we don't have a means of computing equations on the usual de Rham Chern–Simons classes.

*Proof.* Note that we define these integrals by taking any representative differential form, and they are defined because that form is defined up to adding something from  $\bar{\partial}\Omega^{n,n-1} = d\Omega^{n,n-1} \subseteq d\Omega^{2n-1}$ . There is a G-invariant positive line bundle on X, hence we can pick some polynomial  $p_0$ , with

$$\int_{X} p_0(c_1, \dots, c_n) \neq 0$$

a nonzero integer. Every other polynomial p has

$$\int_{X} p(c_{1}, \dots, c_{n}) = b_{p} \int_{X} p_{0}(c_{1}, \dots, c_{n}) \neq 0$$

for some complex number  $b_p$ , and hence

$$p(c_1, \ldots, c_n) - b_p p_0(c_1, \ldots, c_n) = 0$$

in de Rham cohomology, so in Dolbeault cohomology by the Hodge isomorphism. Hence  $\int_M (p-b_p p_0) = 0$ , so  $\int_M p = b_p \int_M p_0$ , and thus

$$\int_{M} p = a_0 \int_{X}$$

where

$$a_0 \coloneqq \frac{\int_M p_0}{\int_X p_0}.$$

See [32] for calculations of some Chern numbers of flag varieties.

## 14. CARTAN'S 5 VARIABLE PAPER

Recall that a plane field is a rank 2 holomorphic subbundle of the tangent bundle of a complex manifold. A plane field on a 5-fold M is skew if, near each point of M, it has local holomorphic sections X,Y so that

are linearly independent. To be more concrete, consider an open subset of  $\mathbb{C}^5$  with holomorphic coordinates written as

with the holomorphic exterior differential system  ${\mathscr I}$  generated by

$$dy - y'dx, dy' - y''dx, dz - z'(x, y, y', y'', z)dx,$$

where z' = z'(x, y, y', y'') is a holomorphic function which is *skew* at the generic point, i.e. satisfies

$$\frac{\partial^2 z'}{\partial (y'')^2} \neq 0.$$

At points where z' is skew, the differential forms in  $\mathscr I$  vanish precisely on the span of the vectors

$$X = \partial_{y''}, Y = D_x := \partial_x + y'\partial_y + y''\partial_{y'} + z'\partial_z$$

which span a skew plane field, as

are linearly independent. Conversely, all skew plane fields on 5-folds occur locally this way [19] section 76 p. 320 ("En résumé, ..."), [43] p. 2. The Hilbert-Cartan equation is

$$z' = \frac{(y'')^2}{2}$$

for functions y = y(x), z = z(x). Cartan [13] proved that the skew plane field associated to the Hilbert–Cartan equation has a 14-dimensional Lie algebra of infinitesimal symmetries, acting transitively. He also proved that it is locally isomorphic to any skew plane field with a Lie algebra of infinitesimal symmetries of dimension more than 7. Let  $(X, G_2)$  be the the flag variety with Dynkin diagram  $\iff$ , i.e. the unique 5-dimensional complex homogeneous space of  $G_2$  which is not the adjoint variety. Cartan [13] proved that there is a unique  $G_2$ -invariant skew plane field on X. The skew plane field of the Hilbert–Cartan equation is the pullback of the skew plane field on X, pulled back to the affine open cell of X (also known as the open Schubert cell or the big cell [9] p. 6), realizing the Lie algebra of symmetry vector fields of the Hilbert–Cartan equations as the Lie algebra of  $G_2$ .

In the process of proving these results (among others), Cartan [13] associates to each skew plane field a fiber bundle of  $2^{nd}$  order frames on which he defines a coframing of 1-forms

$$\omega_1,\ldots,\omega_5,\overline{\omega}_1,\ldots,\overline{\omega}_7,\chi_1,\chi_2$$

We follow Cartan closely here, and we assume complete familiarity with his paper in this section, so we will provide no further explanation of his paper. Consider Cartan's equations (5) from [13] section 31 p. 149 (p. 967 in [14]):

$$d\omega_{1} = \omega_{1} \wedge (2\varpi_{1} + \varpi_{4}) + \omega_{2} \wedge \varpi_{2} + \omega_{3} \wedge \omega_{4},$$

$$d\omega_{2} = \omega_{1} \wedge \varpi_{3} + \omega_{2} \wedge (\varpi_{1} + 2\varpi_{4}) + \omega_{3} \wedge \omega_{5},$$

$$d\omega_{3} = \omega_{1} \wedge \varpi_{5} + \omega_{2} \wedge \varpi_{6} + \omega_{3} \wedge (\varpi_{1} + \varpi_{4}) + \omega_{4} \wedge \omega_{5},$$

$$d\omega_{4} = \omega_{1} \wedge \varpi_{7} + \frac{4}{3}\omega_{3} \wedge \varpi_{6} + \omega_{4} \wedge \varpi_{1} + \omega_{5} \wedge \varpi_{2},$$

$$d\omega_{5} = \omega_{2} \wedge \varpi_{7} - \frac{4}{3}\omega_{3} \wedge \varpi_{5} + \omega_{4} \wedge \varpi_{3} + \omega_{5} \wedge \varpi_{4},$$

and his equations (8) from the same section (see table 1 on the facing page). Cartan does not provide equations for the exterior derivatives of  $\chi_1, \chi_2$ ; we will provide a partial remedy for this below.

Unfortunately, no one has so far succeeded (to my knowledge) in obtaining explicit coordinate expressions for the 1-forms in Cartan's paper. It is not difficult to obtain explicit coordinate expressions for  $\omega_1, \ldots, \omega_5$ , but they are very long; I was not able to compute the 1-forms  $\varpi_1, \ldots, \varpi_7, \chi_1, \chi_2$ .

We point out concerns about Cartan's structure equations. As there are  $\varpi \wedge \omega$  terms in  $d\varpi$ , this is not a G-structure. To see that it is also not a Cartan connection, we need to differentiate the structure equations using a computer algebra system, to

obtain equations for  $d\chi_1, d\chi_2$ . Robert Bryant [10] alters Cartan's choices of  $\chi_1, \chi_2$ , defining

$$\begin{pmatrix} \chi_1' \\ \chi_2' \end{pmatrix} := \begin{pmatrix} \chi_1 \\ \chi_2 \end{pmatrix} + \begin{pmatrix} -\frac{3}{8}C_1 & -\frac{3}{8}C_2 & B_2 & A_2 & A_3 \\ -\frac{3}{8}C_2 & -\frac{3}{8}C_3 & -B_3 & -A_3 & -A_4 \end{pmatrix} \omega.$$

Robert notes that  $\omega, \varpi, \chi'$  is a Cartan geometry modelled on the homogeneous space  $(X, G_2)$ . Cartan does not provide equations for  $d\chi_1, d\chi_2$ , but with some effort one can compute that


$$d\begin{pmatrix} \chi_1' \\ \chi_2' \end{pmatrix} = \begin{pmatrix} 2\varpi_1 + \varpi_4 & \varpi_3 \\ \varpi_2 & \varpi_1 + 2\varpi_4 \end{pmatrix} \wedge \begin{pmatrix} \chi_1' \\ \chi_2' \end{pmatrix} + \begin{pmatrix} \varpi_5 \wedge \varpi_7 \\ \varpi_6 \wedge \varpi_7 \end{pmatrix}$$

modulo  $\omega \wedge \omega$  curvature terms.

Comparing Cartan's notation [13] to ours above,

$$\omega_{-} = \begin{pmatrix} \omega_{1} \\ \omega_{2} \\ \omega_{3} \\ \omega_{4} \\ \omega_{5} \end{pmatrix}, \quad \omega_{0} = \begin{pmatrix} 2\varpi_{1} + \varpi_{4} & \varpi_{2} \\ \varpi_{3} & \varpi_{1} + 2\varpi_{4} \end{pmatrix}, \quad \omega_{+} = \begin{pmatrix} \varpi_{5} \\ \varpi_{6} \\ \varpi_{7} \\ \chi'_{1} \\ \chi'_{2} \end{pmatrix}.$$

Up to constant nonzero rational number factors, these are the dual 1-forms in the Lie algebra of  $G_2$  corresponding to root vectors in the pattern



which, with the indicated rescalings as above, I suspect become a Chevalley basis for  $G_2$ , although this seems to be difficult to check. Note that the right half of the root system, together with the points on the vertical through the origin, consists of the root vectors which span the parabolic subgroup of  $G_2$  stabilizing a point of X. Since  $\chi_1 = \chi'_1$  and  $\chi_2 = \chi'_2$  up to holomorphic semibasic torsion terms, we can treat them as equal in calculating Slovák cohomology. The Slovák differentials are immediate from the equations above for the differentials:

$$\nabla \omega_1 = 0,$$

$$\nabla \omega_2 = 0,$$

$$\nabla \omega_3 = \omega_1 \wedge \varpi_5 + \omega_2 \wedge \varpi_6,$$

$$\nabla \omega_4 = \omega_1 \wedge \varpi_7 + \frac{4}{3}\omega_3 \wedge \varpi_6,$$

$$\nabla \omega_5 = \omega_2 \wedge \varpi_7 - \frac{4}{3}\omega_3 \wedge \varpi_5,$$

and

$$\nabla \varpi_{1} = \frac{1}{3}\omega_{3} \wedge \varpi_{7} - \frac{2}{3}\omega_{4} \wedge \varpi_{5} + \frac{1}{3}\omega_{5} \wedge \varpi_{6} + \omega_{1} \wedge \chi_{1},$$

$$\nabla \varpi_{2} = -\omega_{4} \wedge \varpi_{6} + \omega_{1} \wedge \chi_{2},$$

$$\nabla \varpi_{3} = -\omega_{5} \wedge \varpi_{5} + \omega_{2} \wedge \chi_{1},$$

$$\nabla \varpi_{4} = \frac{1}{3}\omega_{3} \wedge \varpi_{7} + \frac{1}{3}\omega_{4} \wedge \varpi_{5} - \frac{2}{3}\omega_{5} \wedge \varpi_{6} + \omega_{2} \wedge \chi_{2}$$

and

$$\nabla \varpi_5 = 0,$$

$$\nabla \varpi_6 = 0,$$

$$\nabla \varpi_7 = \frac{4}{3} \varpi_5 \wedge \varpi_6,$$

$$\nabla \chi_1' = \varpi_5 \wedge \varpi_7,$$

$$\nabla \chi_2' = \varpi_6 \wedge \varpi_7,$$

For example, the Cartan 3-form is

$$\omega_{4} \wedge \varpi_{1} \wedge \varpi_{5} + \omega_{5} \wedge \varpi_{2} \wedge \varpi_{5} + \omega_{4} \wedge \varpi_{3} \wedge \varpi_{6}$$

$$+ \omega_{5} \wedge \varpi_{4} \wedge \varpi_{6} - 2\omega_{4} \wedge \omega_{5} \wedge \varpi_{7} - \omega_{3} \wedge \varpi_{1} \wedge \varpi_{7}$$

$$- \omega_{3} \wedge \varpi_{4} \wedge \varpi_{7} - 2\omega_{3} \wedge \omega_{4} \wedge \chi_{1} - 2\omega_{1} \wedge \varpi_{1} \wedge \chi_{1}$$

$$- \omega_{2} \wedge \varpi_{2} \wedge \chi_{1} - \omega_{1} \wedge \varpi_{4} \wedge \chi_{1} - 2\omega_{3} \wedge \omega_{5} \wedge \chi_{2}$$

$$- \omega_{2} \wedge \varpi_{1} \wedge \chi_{2} - \omega_{1} \wedge \varpi_{3} \wedge \chi_{2} - 2\omega_{2} \wedge \varpi_{4} \wedge \chi_{2}.$$

This is closed in the Slovák differential, giving an element in Slovák cohomology  $H^{1,1,1}$ . The Atiyah class of the plane field is

$$\begin{split} a &= \nabla \omega_0, \\ &= d\omega_0 + \frac{1}{2} \big[ \omega_0 \omega_0 \big], \\ &= \begin{pmatrix} 2 \nabla \varpi_1 + \nabla \varpi_4 & \nabla \varpi_2 \\ \nabla \varpi_3 & \nabla \varpi_1 + 2 \nabla \varpi_4 \end{pmatrix}, \\ &= \begin{pmatrix} \omega_3 \wedge \varpi_7 - \omega_4 \wedge \varpi_5 + 2\omega_1 \wedge \chi_1 + \omega_2 \wedge \chi_2 & -\omega_4 \wedge \varpi_6 + \omega_1 \wedge \chi_2 \\ -\omega_5 \wedge \varpi_5 + \omega_2 \wedge \chi_1 & \omega_3 \wedge \varpi_7 - \omega_5 \wedge \varpi_6 + \omega_1 \wedge \chi_1 + 2\omega_2 \wedge \chi_2 \end{pmatrix} \end{split}$$

$$\begin{pmatrix}
2\varpi_1 + \varpi_4 & \varpi_2 & 0 & 0 & 0 \\
\varpi_3 & \varpi_1 + 2\varpi_4 & 0 & 0 & 0 \\
\varpi_5 & \varpi_6 & \varpi_1 + \varpi_4 & 0 & 0 \\
\varpi_7 & 0 & \frac{4}{3}\varpi_6 & \varpi_1 & \varpi_2 \\
0 & \varpi_7 & -\frac{4}{3}\varpi_5 & \varpi_3 & \varpi_4
\end{pmatrix}.$$

But the associated graded has representation

$$\begin{pmatrix} 2\varpi_1 + \varpi_4 & \varpi_2 & 0 & 0 & 0\\ \varpi_3 & \varpi_1 + 2\varpi_4 & 0 & 0 & 0\\ 0 & 0 & \varpi_1 + \varpi_4 & 0 & 0\\ 0 & 0 & 0 & \varpi_1 & \varpi_2\\ 0 & 0 & 0 & \varpi_3 & \varpi_4 \end{pmatrix},$$

so that it is an associated vector bundle of the first order G-structure. The reader can then check (by hand!) that

$$c_2 = 11(c_1/5)^2,$$
  
 $c_3 = 13(c_1/5)^3,$   
 $c_4 = 9(c_1/5)^4,$   
 $c_5 = 3(c_1/5)^5$ 

which agrees with [34] (a calculation done by computer).

Consider the Chern–Simons form in Slovák cohomology of the last relation, as shown in table 2. For the differential form  $\Psi$  in table 3 on the facing page,

$$\nabla \Psi = T_{5^5 c_5(T) - 3c_1(T)^5}$$

in the Slovák differential. Hence on any reduction of structure group to an  $G_0$ -bundle, the Chern–Simons class of  $T_{5^5c_5(T)-3c_1(T)^5}$  vanishes in Dolbeault cohomology. So any 5-fold with a skew plane field has not only the above relations among Chern classes in Dolbeault cohomology, but also the vanishing of this Chern–Simons invariant in Dolbeault cohomology. Moreover, there is no residue from that Chern–Simons form on the singular hypersurface of a meromorphic skew plane field on a complex 5-fold.

#### 15. CONCLUSION

We can now employ constraints on characteristic classes and Chern–Simons classes from generalized flag varieties to yield constraints on Dolbeault cohomology of complex manifolds carrying holomorphic geometric structures with a wide selection of different models. It remains to make a theory of such structures on singular varieties, generalizing the theory of singular locally Hermitian symmetric varieties, on which some results about characteristic class invariants are known [36] which generalize Hirzebruch's proportionality theorem. The results above should help in classifying all holomorphic Cartan geometries which are both modelled on and also defined on C-spaces. There are many interesting examples yet to compute of relations on Chern–Simons invariants following our method above.
