## Part A

Changes effected by order of the Secretary of State under sections 7, 11 and 13 of the Local Government and Public Involvement in Health Act 2007

### *1. There is one order establishing the electoral arrangements of a new unitary (single tier) local authority*

### THE CORNWALL (ELECTORAL ARRANGEMENTS AND CONSEQUENTIAL AMENDMENTS) ORDER 2009 – S.I. 2009 No. 850

This order was made on 30 March 2009. It abolished the existing 71 electoral divisions of the county of Cornwall and provided for the creation of 123 new electoral divisions for the new county council.

### 2. There are two orders dealing with the implications of structural change<sup>1</sup> for particular issues in individual restructuring areas

#### THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (AREAS AND MEMBERSHIP OF PUBLIC BODIES IN BEDFORDSHIRE AND CHESHIRE) ORDER 2009 – S.I. 2009 No. 119

This order was made on 28 January 2009 and came into force 1 April 2009. It provides for changes to the membership of Fire and Police Authorities and Valuation Tribunals.

### THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (MISCELLANEOUS AMENDMENTS AND OTHER PROVISION) ORDER 2009 – S.I. 2009 No. 837

This order was made on 30 March 2009 and came into effect on 1 April 2009. Amongst other things it provides for the preservation of historic traditions and counties (Cheshire and Bedfordshire), transfers of pensions funds and changes to Port Health Authorities and membership of National Parks and Conservation Boards.

It creates Charter Trustees to preserve the traditions of the following areas:

Cheshire East - The towns of Crewe and Macclesfield

Cheshire West and Chester – The City of Chester and Ellesmere Port

County Durham – The City of Durham

Seven structural change orders creating nine single tier (unitary) councils in Bedfordshire, Cheshire, Cornwall, County Durham, Northumberland, Shropshire and Wiltshire were made in February/March 2008. The new councils came into being on 1 April 2009.

### Changes effected by regulations of the Secretary of State under section 14 of the Local Government and Public Involvement in Health Act 2007

### 1. There are nine sets of regulations dealing with the implications of structural change for particular issues in all restructuring areas

### THE LOCAL GOVERNMENT (STRUCTURAL AND BOUNDARY CHANGES) (STAFFING) REGULATIONS 2008 – S.I. 2008 No. 1419

These regulations were made on 2 June 2008 and came into force on 28 June 2008. Amongst other things they provide for TUPE to apply to the transfer of staff as part of structural change and transitional staffing arrangements.

### THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (TRANSITIONAL ARRANGEMENTS) REGULATIONS 2008 – S.I. 2008 No. 2113

These regulations were made on 4 August 2008 and came into force 29 August 2008. Amongst other things they provide for continuity of matters and the discharge of functions during the transitional period (i.e. before the reorganisation day of 1 April 2009).

# THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (TRANSFER OF FUNCTIONS, PROPERTY, RIGHTS AND LIABILITIES) REGULATIONS 2008 – S.I. 2008 No. 2176

These regulations were made on the 14 August 2008 and came into effect on 8 September 2008. They provide for the transfer of functions, property (including land), rights and liabilities including the establishment of caretaker councils and arrangements in cases of dispute.

### THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (TRANSITIONAL ARRANGEMENTS) (No. 2) REGULATIONS 2008 – S.I. 2008 No. 2867

These regulations were made on 5 November 2008 and came into effect on 28 November 2008. Amongst other things they provide for continuity in references to councils to be amended in enactments, agreements, approvals etc and preparations of statutory plans and strategies, transitional arrangements for planning and licensing and issues relating to honorary aldermen and honorary freemen.

### THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (FINANCE) REGULATION 2008 – S.I. 2008 No. 3022

These regulations were made on 20 November 2008 and came into force 24 December 2008. They provide for consequential, transitional and supplementary arrangements in relation to the exercise of functions under the 1988 and 1992 Local Government Finance Acts.

### THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (FURTHER FINANCIAL PROVISIONS AND AMENDMENT) REGULATIONS 2009 – S.I. 2009 No. 5

These regulations were made on 5 January 2009 and came into force on 29 January 2009. They provide for the establishment of collection and general funds, the treatment of collection funds, surpluses and deficits and make arrangements for the first year of Charter Trustees (precepts).

#### THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (FURTHER TRANSITIONAL AND SUPPLEMENTARY PROVISION AND MISCELLANEOUS AMENDMENTS) REGULATIONS 2009 – S.I. 2009 No. 276

These regulations were made on 12 February 2009 and came into force on 11 March 2009. They provide for functions relating to schools, councillors conduct, accounts of predecessor councils and other financial matters, changes of name and a small amendment of the Local Government (Structural and Boundary Changes) (Staffing) Regulations 2008.

### THE CHARTER TRUSTEES REGULATIONS 2009 – S.I. 2009 No. 467

These regulations were made on 3 March 2009 and came into effect on 1 April 2009. Amongst other things they provide for the transfer and upkeep of historic and ceremonial property to and by Charter Trustees, the functions of Charter Trustees, including the appointment of additional charter trustees, and the appointment of the mayor and other administrative arrangements.

### THE LOCAL GOVERNMENT (STRUCTURAL CHANGES) (FURTHER TRANSITIONAL ARRANGEMENTS AND STAFFING) REGULATIONS 2009 – S.I. 2009 No. 486

These regulations were made on 4 March 2009 and came into effect on 31 March 2009. Amongst other things they make further provision for continuity matters including for the conduct of councillors and standards committees and for Port Health Authorities.

## Part B

### Changes effected by order of the Secretary of State under the Local Government and Rating Act 1997

# There are 11 orders made by the Secretary of State, which give effect to recommendations made following district reviews carried out under section 9 of the Local Government and Rating Act 1997

#### THE ALNWICK (PARISHES) ORDER 2008 – S.I. 2008 No. 1573

This order transferred areas between the parishes of Alwinton, Biddlestone, Callaly, Hepple, Netherton, Rothbury, Snitter, and Whitton and Tosson. The order was made on 13 June 2008 and came into effect on 1 April 2009.

#### THE COPELAND (PARISHES) ORDER 2009 - S.I. 2009 No. 574

This order transferred areas between the parishes of Arlecdon and Frizington, Bootle, Cleator Moor, Egremont, Ennerdale and Kinniside, Eskdale, Irton with Santon, Lamplugh, Millom, Millom Without, Moresby, Muncaster, St Bees, Wasdale, Whicham and the unparished area. The order was made on 4 March 2009 and came into effect on 1 April 2009.

### THE DAVENTRY (PARISHES) ORDER 2008 - S.I. 2008 No. 2739

This order amalgamated the parishes of Church Brampton and Chapel Brampton to create a new parish to be called Church with Chapel Brampton. The order directed the Daventry District Council to establish a parish council for the new parish. The order also transferred areas between the parishes of Brockhall, Byfield, Cold Ashby, Dodford, Elkington, Flore, Guilsborough, Holcot, Long Buckby, Moulton, Norton, Ravensthorpe, Watford, Weedon Bec Whilton and Woodford cum Membris. The order was made on 16 October 2008 and came into effect on 1 April 2009.

### THE LICHFIELD (PARISHES) ORDER 2008 – S.I. 2008 No. 2740

This order abolished the parishes of Alrewas and Fradley, and Streethay and created two new parishes to be called Alrewas, and Fradley and Streethay. The order directed the Lichfield District Council to establish parish councils for the new parishes. The order was made on 16 October 2008 and came into effect on 1 April 2009.

#### THE NORTH DORSET (PARISHES) ORDER 2008 – S.I. 2008 No. 3142

This order transferred areas between the parishes of Anderson, Blandford Forum, Blandford St Mary, Bryanston, Child Okeford, Iwerne Courtney or Shroton, Iwerne Minister, Kington Magna, Langton Long Blandford, Marnhull, Pimperne, Stourpaine, Tarrant Keyneston, Tarrant Monkton, Tarrant Rawston, Tarrant Rushton, Todber, West Stour and Winterborne Kingston. The order was made on 5 December 2008 and came into effect on 1 April 2009.

### THE NORTH WILTSHIRE (PARISHES) ORDER 2008 – S.I. 2008 No. 3141

This order transferred areas between the parishes of Bremhill, Calne, Calne Without, Castle Combe, Cherhill, Chippenham, Chippenham Without, Compton Bassett, Corsham, Dauntsey, Grittleton, Hilmarton, Kington St Michael, Langley Burrell Without, Lyneham and Bradenstoke, Nettleton, North Wraxall, Stanton St Quintin and Tockenham. The order was made on 5 December 2008 and came into effect on 1 April 2009.

### THE RESTORMEL (PARISHES) ORDER 2008 – S.I. 2008 No. 1313

This order created four new parishes to be called Carlyon, Pentewan Valley, St Austell and St Austell Bay. The order directed the Restormel Borough Council to establish parish councils for the new parishes. The order was made on 13 May 2008 and came into effect on 1 April 2009.

### THE SALISBURY (PARISHES) ORDER 2008 – S.I. 2008 No. 1283

This order transferred areas between the parishes of Pitton and Farley and West Dean. The order was made on 12 May 2008 and came into effect on 1 April 2009.

### THE SHREWSBURY AND ATCHAM (PARISH) ORDER 2008 - S.I. 2008 No. 1321

This order created a new parish to be called Shrewsbury. The order directed the Shrewsbury and Atcham Borough Council to establish a parish council for the parish. The order was made on 13 May 2008 and came into effect on 1 April 2009.

### THE WANSBECK (PARISHES) ORDER 2009 – S.I. 2009 No. 120

This order created five new parishes called Ashington, East Bedlington, Newbiggin by the Sea, North Bedlington and West Bedlington. The order directed the Wansbeck District Council to establish parish councils for the new parishes. The order was made on 28 January 2009 and came into effect on 1 April 2009.

### THE YORK (PARISHES) ORDER 2009 – S.I. 2009 No. 573

This order abolished the parishes of Strensall and Towthorpe and created one new parish called Strensall with Towthorpe. The order directed the York City Council to establish a parish council for the new parish. This order also transferred areas between the parishes of Bishopthorpe, Dunnington, Holtby, Rawcliffe, Skelton and the unparished area. The order was made on 4 March 2009 and came into effect on 1 April 2009.

## Part C

# Changes effected by local authorities' action or order as notified to the Secretary of State

# 1. There are five orders, made by local authorities, which give effect to changes to boundaries and electoral arrangements of parishes under section 88 of the Local Government and Public Involvement in Health Act 2007

### THE ARUN DISTRICT COUNCIL (REORGANISATION GOVERNANCE) EAST PRESTON AND KINGSTON ORDER 2009

This order makes alterations to the boundaries of the parishes of East Preston and Kingston. The order was made on 8 May 2009 and comes into effect on 1 April 2010.

#### THE BEDFORD BOROUGH (REORGANISATION OF COMMUNITY GOVERNANCE) ORDER 2008

This order established three parish wards for the parish of Brickhill, namely East, North, and South and West and made electoral arrangements for each of the new wards. The order was made on 26 November 2008 and came into effect on 1 April 2009.

### THE KING'S LYNN AND WEST NORFOLK (FELTWELL AND SOUTHERY) ORDER 2008

This order made alterations to the boundaries of the parishes of Feltwell and Southery. The order was made on 1 August 2008 and came into effect on the same day.

### THE MID SUFFOLK (PARISH BOUNDARIES) ORDER 2009

This order made changes to the boundaries of the parishes of Akenham, Bacton, Badwell Ash, Barham, Barking, Battisford, Baylham, Buxhall, Claydon, Combs, Denham, Drinkstone, Great Ashfield, Great Blakenham, Great Bricett, Great Finborough, Haughley, Hoxne, Needham Market, Ringshall, Shelland, Stowmarket, Westhorpe, Wetherden, Whitton, Woolpit, and to parish wards for the parishes of Combs, Haughley and Stowmarket. The order was made on 28 January 2009 and came into effect on 1 April 2009.

### THE SHROPSHIRE (PARISH COUNCIL OF SHREWSBURY) ORDER 2009

This order established a parish council for the parish of Shrewsbury. The order was made on 24 March 2009 and came into effect on 1 April 2009.

# 2. There are 11 orders, made by local authorities, which give effect to the constitution of a new parish under section 87 of the Local Government and Public Involvement in Health Act 2007

### THE BRADFORD (REORGANISATION OF COMMUNITY GOVERNANCE) ORDER 2009

This order created a new parish of Trident. The order established a parish council and made electoral arrangements for the new parish. The parish and parish council will have the style of Community. The order was made on 12 February 2009 and came into effect on 1 April 2009.

### THE LANCASTER CITY COUNCIL (REORGANISATION OF COMMUNITY GOVERNANCE) ORDER 2009

This order created a new parish of Morecambe. The order established a parish council and made electoral arrangements for the new parish. The order was made on 2 March 2009 and came into effect on 1 April 2009.

### THE NORTHUMBERLAND COUNTY COUNCIL (REORGANISATION OF COMMUNITY GOVERNANCE) (BLYTH) ORDER 2009

This order created a new parish of Blyth. The order established a parish council and made electoral arrangements for the new parish. The order was made on 19 February 2009 and came into effect on the day after it was made.

### THE NORTHUMBERLAND COUNTY COUNCIL (REORGANISATION OF COMMUNITY GOVERNANCE) (CRAMLINGTON) ORDER 2009

This order created a new parish of Cramlington. The order established a parish council and made electoral arrangements for the new parish. The order was made on 19 February 2009 and came into effect on the day after it was made.

### THE NORTHUMBERLAND COUNTY COUNCIL (REORGANISATION OF COMMUNITY GOVERNANCE) (SEATON VALLEY) ORDER 2009

This order created a new parish of Seaton Valley. The order established a parish council and made electoral arrangements for the new parish. The parish has the style of Community. The order was made on 19 February 2009 and came into effect on the day after it was made.

### THE SOUTH CAMBRIDGESHIRE DISTRICT COUNCIL (REORGANISATION OF COMMUNITY GOVERNANCE) ORDER 2009

This order created a new parish of Orchard Park. The order established a parish council and made electoral arrangements for the new parish. The parish and parish council will have the style of Community. The order also transferred areas between the parishes of Impington, Milton and Orchard Park. The order was made on 25 February 2009 and came into effect on 1 April 2009.

#### SOUTH NORTHAMPTONSHIRE COUNCIL COMMUNITY GOVERNANCE (PARISHES OF CHIPPING WARDEN AND EDGCOTE) ORDER 2008

This order amalgamated the parishes of Chipping Warden and Edgcote to create a new parish of Chipping Warden and Edgcote. The order was made on 5 September 2008 and came into effect on 1 October 2008.

#### THE DISTRICT OF THANET (REORGANISATION OF COMMUNITY GOVERNANCE) ORDER 2009

This order created a new parish of Ramsgate. The order established a parish council and made electoral arrangements for the new parish. The order was made on 25 February 2009 and came into effect on 1 April 2009.

### THE DISTRICT OF UTTLESFORD (PARISHES OF FLITCH GREEN AND LITTLE DUNMOW) ORDER 2008

This order created a new parish of Flitch Green. The order established a parish council and made electoral arrangements for the new parish. The order was made on 26 November 2008 and came into effect on 1 April 2009.

### THE WILTSHIRE (PARISH OF SALISBURY) ESTABLISHMENT AND ELECTORAL ARRANGEMENTS ORDER 2009

This order created a new parish of Salisbury. The order established a parish council and made electoral arrangements for the new parish. As a result the Charter Trustees for Salisbury were abolished. The order was made on 23 March 2009 and came into effect on 1 April 2009.

### THE WYRE BOROUGH COUNCIL (REORGANISATION OF COMMUNITY GOVERNANCE) ORDER 2009

This order created a new parish of Fleetwood. The order established a parish council and made electoral arrangements for the new parish. The order was made on 31 March 2009 and came into effect on 1 April 2009.

#### 3. There are three local authorities that have given notice of a change of style under section 75 of the Local Government and Public Involvement in Health Act 2007

### BROUGHTON PARISH TO BROUGHTON COMMUNITY (ALLERDALE BOROUGH COUNCIL)

Broughton Parish has changed its style to Broughton Community. The order came into effect on 17 November 2008.

### GREAT BURSTEAD AND SOUTH GREEN VILLAGE (BASILDON DISTRICT COUNCIL)

Great Burstead and South Green Parish have changed the style to Great Burstead and South Green Village. The change came into effect on 16 March 2009.

### GREAT COATES PARISH TO GREAT COATES VILLAGE (NORTH EAST LINCOLNSHIRE)

Great Coates Parish changed style and parish name to Great Coates Village. The change came into effect on 21 October 2008.

# 4. There is one order made under section 59 of the Local Government and Public Involvement in Health Act 2007 to change the name of a borough ward

### **BOROUGH OF HALTON – HALTON CASTLE WARD ORDER 2009**

This order changed the name of the electoral ward of Castlefields to Halton Castle. The change came into effect on 29 January 2009.

### 5. There are 10 orders made under section 17 of the Local Government and Rating Act 1997 amending electoral arrangements<sup>2</sup>

### PARISH OF CATWORTH (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order reduces the number of councillors from nine to seven. This order was made on 28 February 2008 and comes into effect on 5 May 2011.

### PARISH OF ELTON (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order reduces the number of councillors from eleven to nine. This order was made on 28 February 2008 and comes into effect on 6 May 2010.

### PARISH OF GODMANCHESTER (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order increased the number of councillors from fifteen to seventeen. This order was made on 28 February 2008 and came into effect on 1 May 2008.

### PARISH OF GREAT AND LITTLE GIDDING (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order reduced the number of councillors from eight to seven. This order was made on 28 February 2008 and came into effect on 1 May 2008.

### PARISH OF GREAT STAUGHTON (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order reduces the number of councillors from eleven to nine. This order was made on 28 February 2008 and comes into effect on 5 May 2011.

### PARISH OF HOLME (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order reduces the number of councillors from nine to seven. This order was made on 28 February 2008 and comes into effect on 5 May 2011.

#### PARISH OF TADCASTER TOWN COUNCIL – EAST WARD (COUNCILLORS) ORDER 2007 (SELBY DISTRICT COUNCIL)

This order reduced the number of councillors from nine to eight. This order was made on 27 November 2007.

### PARISH OF TILBROOK (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order reduces the number of councillors from seven to five. This order was made on 28 February 2008 and comes into effect on 5 May 2011.

### PARISH OF UPWOOD AND THE RAVELEYS (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order reduces the number of councillors from eleven to nine. This order was made on 28 February 2008 and comes into effect on 5 May 2011.

### PARISH OF YAXLEY (COUNCILLORS) ORDER 2008 (HUNTINGDONSHIRE DISTRICT COUNCIL)

This order increases the number of councillors from thirteen to seventeen. This order was made on 28 February 2008 and comes into effect on 5 May 2011.

### 6. There are three orders made under section 16 of the Local Government and Rating Act 1997 providing for the creation of a parish council

### THE RESTORMEL (CARLYON, ST AUSTELL, ST AUSTELL BAY AND PENTEWAN VALLEY PARISH COUNCILS) ORDER 2009

This order established four parish councils for the parishes of Carlyon, St Austell, St Austell Bay and Pentewan Valley. This order was made on 30 March 2009 and came into effect on 31 March 2009.

### THE SHROPSHIRE (PARISH COUNCIL OF SHREWSBURY) ORDER 2009

This order established one parish council for the parish of Shrewsbury. This order was made on 24 March 2009 and came into effect on 1 April 2009.

### THE DISTRICT OF WANSBECK (PARISH COUNCILS) (ESTABLISHMENT AND ELECTORAL ARRANGEMENTS) ORDER 2009

This order established five parish councils for the parishes of Ashington, Newbiggin by the Sea, East Bedlington, North Bedlington and West Bedlington. This order was made on 19 February 2009 and came into effect on 20 February 2009.

### 7. There are four orders made under section 91 of the Local Government Act 1972 making temporary appointments
