CALL TO ORDER

Mayor Riley H. Rogers called the Public Hearing to order in the New Village Hall at

6:37 p.m.

ROLL CALL

PLEDGE OF ALLEGIANCE/ PRAYER

Prayer was led by Mr. Edward Crayton.

Village Administrator Stan Urban read aloud the Notice of Public Hearing:

Notice is hereby given that pursuant to Section 39.2 of the Environmental Protection Act (415 ILCS 5/39.2), the Mayor and Board of Trustees of the Village of Dolton will hold a public hearing on February 1, 2016, at 6:30 p.m. to consider the application of Water Integrated Treatment Systems, LLC for approval of siting of a pollution control facility at 14753 Greenwood Road, Dolton, Illinois. Members of the public will be allowed to comment on the proposed application at the public hearing. A copy of the application is available for viewing in the office of the Village Clerk.

Notice of the hearing had also been sent by certified mail, published in the Daily Southtown, and posted at the New Village Hall pursuant to statute.

Mr. Urban introduced Neil Goulden owner, and Ricardo Martinez, operator, of Water Integrated Treatment Systems.

Mr. Goulden explained that the facility takes non-hazardous, non-sanitary industrial waste water for removal of contaminants and discharge back into the public sewer system pursuant to Metropolitan Water Reclamation District (MWRD) standards. The facility is permitted by MWRD. This last permit is for designation as a pollution control facility by the Illinois Environmental Protection Agency (IEPA).

Trustee Hunt asked if removal of the contaminants creates a smell. Mr. Goulden answered that some of the contaminants brought in have an order, but the facility is completely indoors with odor containment facilities and procedures. The company has received no complaints. There is no odor in the offices or standing immediately outside of the building.

Gerritt Ghezzi, resident, asked whether the water is being piped in or trucked in and how many gallons are being brought in each day. Mr. Goulden said the water was being trucked in. Mr. Martinez said that approximately 20,000 gallons are trucked in.

Dan Lee, resident, asked where the water was coming from. Mr. Goulden said there are many sources. One customer is Waste Management, which disposes of rain water after it has filtered through its landfills. Mr. Lee asked if water from other sources would have other contaminants. Mr. Goulden said yes, but they are non-hazardous, non-sanitary.

There were no further questions.

There being no further business before the Board of Trustees, on a motion by Trustee Pierson to adjourn the Public Hearing, second by Trustee Brown, Mayor Rogers asked for a roll call to adjourn.
