Village of Dolton Regular Meeting Board of Trustees Monday, June 3, 2019

CALL TO ORDER

Mayor Riley H. Rogers called the Regular Meeting of the Board of Trustees to order in the New Village Hall at 6:34 p.m.

PLEDGE OF ALLEGIANCE/ PRAYER

Prayer was led by Deputy Fire Chief Don Rush.

ROLL CALL

The following trustees were present: Tammie Brown, Tiffany Henyard, Andrew Holmes, Jason House, Edward Steave. Trustee Deborah Denton was absent.

Also, present: Village Clerk Mary Kay Duggan, Village Administrator Elizabeth Scott, Village Attorney John B. Murphey, Village Engineer Ron Smith, and department heads.

A quorum was present.

GENERAL ANNOUNCEMENTS

Trustee Henyard protested Mayor Rogers' elimination of her proposed agenda items: reinstatement of Chief Collins, promotions of officers, and status of Fire Station #2.

Mayor Rogers said that he would address the matter of Chief Collins later in his report.

In response to Trustee Henyard's question as to who decides the agenda, Mayor Rogers responded that the mayor does. Trustee Henyard noted that it had been board policy that a trustee could add any item to the agenda. In response to Trustee Henyard's question, the village clerk confirmed that it had been recent board practice that a trustee could place anything on the agenda.

(Promotion of police officers is on the agenda per Acting Chief Mobley.)

CITIZENS ADDRESS

Limited to Discussion of Agenda Items;

Mayor Rogers said that non-residents would not be speaking tonight. Anyone causing a disruption would be removed. Questions to the board would not be answered by board members during Citizens Address.

Duane Muhammad, resident and former trustee, asked Attorney Murphey whether the bond issue to pay Homewood Disposal would increase property taxes, and asked how the village may recover reimbursements from the TIF district as proposed.

Attorney Murphey cited the renewals of the bond passed by the board of trustees in recent years, so a further renewal would have no impact on property taxes.

Valeria Stubbs, resident and former trustee, questioned the proposed Class 8 tax incentive for the Marathon station on Sibley Blvd. She also asked how the village may claim reimbursement from the TIF District from 2005 to present.

Resident, 148th and Chicago Rd., urged residents to read Chief Collins' online letter.

Cheryl Hill, resident, was removed from Citizens Address at the order of Mayor Rogers.

Trina Downs, resident, protested the mayor's exercise of authority and urged the board to vote no to the tax breaks for businesses.

Kiana Belcher, resident, asked about the Class 8 certification for 1317 E. Sibley Blvd.

Felita Crayton, resident, asked trustees to reconsider their votes for Class 8 tax incentives, TIF transfers, and bond issues.

Stan Brown, resident, asked how much is in the TIF and how much may be taken out of the TIF.

Resident, Irving Ave., asked how residents may get information on how citizens can participate. Resident further asked the new trustees are they happy with what's going on? What is the mayor doing that is illegal?

Sandra Wells, resident, and south suburban Director of Neighborhood Residential Services (NHS), asked the board to take into consideration citizen comments asking for information and participation.

MAYOR'S REPORT

Mayor Rogers reported that he is once again visiting Dolton schools in the last weeks to distribute ice cream and offer safety tips along with the police and fire chiefs.

On May 25th, the village held a renaming ceremony for Chicago Road, now Dr. Martin Luther King Jr. Drive. Mayor Rogers noted that not all signs are up. Some will be installed by IDOT.

Mayor Rogers noted a press conference by former employees, including Police Chief Collins, and said that Chief Collins' assertion that he was terminated is incorrect. Chief Collins resigned. Mayor Rogers acknowledged that he was dissatisfied with the increase in crime as shown by reported crime statistics, staffing delays, and other serious issues. He expressed his further disappointment that the chief would participate in a press conference that was not truthful.

CITIZENS ADDRESS General

Mayor Rogers reminded residents that they are limited to three minutes

Mayor Rogers advised former employee Karen Hicks that she would not be speaking this evening. Ms. Hicks was escorted from the meeting at Mayor Rogers' direction.

Trina Downs, resident, again, asked whether there was someone responsible for the water billing.

Resident, 14300 block of Dante asked about a reported shooting on May 31st.

Diane Lofton, resident, asked whether it was normal to have police officers stationed for citizens address questioned the new practice of having citizens address at the beginning of the meeting; and asked whether the proposed purchase, of vehicles was included in the budget.

Resident, 14400 Block of Blackstone, reported alley flooding from the sewer hole behind her garage.

Cheryl Hill and reported a garage roof at 142nd and Lincoln completely caved in; sewers blocked, and a street light out at 144th and Greenwood.

Denise Fields, former Housing Director, asked Mayor Rogers if she was going to get paid for her sick time.

Resident suggested that the village follow the City of Chicago's police explorers model, and said that residents are looking for affordable housing opportunities. Resident further asked Mayor Rogers if any of his decisions have been found to be illegal.

Garrett Ghezzi, resident, objected to the addition of \$100 per year contribution to the Dolton Chamber of Commerce as part of the business license increase, thereby forcing businesses to join. He said that the better approach would have been to increase the fees to the same amount and include chamber membership as a benefit.

AJ Burse, resident and former trustee candidate, questioned the legality of forcing businesses to join the Chamber of Commerce, asked about the status of the village recodification, and volunteered his assistance.
