Special Meeting Board of Trustees

Thursday, June 25, 2020

CALL TO ORDER Pursuant to notice duly posted, Mayor Riley H. Rogers called the Special Meeting of the Board of Trustees to order in the New Village Hall at 5:39 pm.

The following trustees were present: Tiffany Henyard, Jason House, and Edward Steave. Trustee Tammie Brown entered the meeting at 5:42 p.m. Trustees Deborah Denton and Andrew Holmes were absent.

Also present: Village Clerk Mary Kay Duggan, Village Attorney John B. Murphey, Village Administrator Elizabeth Scott and department heads. Village Attorney Ron Smith was absent.

A quorum was present.

At Mayor Rogers' request, Trustee Henyard led the Board of Trustees in prayer.

OLD BUSINESS

- A. Resolution No. 20 R-003  
Supporting a Proposed Class 8 Classification for Certain Property Within the Village of Dolton – 15339 Chicago Road

Mayor Rogers introduced Mr. Firoz Vohra, proposed developer, who explained that the property would be used to sell groceries at wholesale prices, cooked foods, and "essential items."

Amending Title 6, "Motor Vehicles and Traffic" Chapter 3 "Rules of the Road" to Add Section 6-3-25 "Operating a Motor Vehicle While Using an Electronic Device"
- C. Ordinance No. 20-008  
Amending Title 6 "Motor Vehicles and Traffic" Chapter 6 "Vehicle Equipment and Condition" to Add Sections 6-6-10 "Vehicle Window Tint"; 6-6-11 "Squealing of Tires Prohibited"; 6-6-12 "Vehicle Requiring Splash Guard"; and 6-6-13 "Covers or Tarpaulins Required for Certain Loads"
- D. Ordinance No. 20-009  
Amending Title 6, "Motor Vehicles and Traffic" Chapter 8 "Pedestrians" to Add Section 6-8-6 "Railroad Crossings"

- E. Ordinance No. 20-010  
Amending Title 1 "Administrative" Chapter 4 "General Penalty" Section  
1-4-4-F "Schedule of Fines"

Commander Lewis Lacey said that these proposed ordinances had been previously presented to the board for its consideration. Mayor Rogers added that they allow for administrative fees for tickets for various moving vehicle violations, including loud music and vehicle window tint. In response to Trustee Henyard's questions, Commander Lacey elaborated on the provisions for truck splash guards, added window tint, truck route violations, and squealing tires. Attorney Murphey explained that all of these are presently state violations, but the ordinances would allow the village to issue tickets for municipal court, which would recoup the fines instead of the state.

*Mayor Rogers noted Attorney Murphey's comments regarding court enforcement. Attorney Murphey added that the purpose is law enforcement, but ticketing locally is more convenient to residents than going to the Markham courthouse.*

Not everyone has internet access. Have copies at the village hall.

How do you plan to keep us safe on July 4<sup>th</sup>?

*Commander Lacey noted that the traffic unit will be back in force as of July 1<sup>st</sup>.*
