AN ACT

RENAMING THE MUNICIPALITY OF RODRIGUEZ IN THE PROVINCE OF RIZAL AS THE MUNICIPALITY OF MONTALBAN

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- SECTION 1. The Municipality of Rodriguez in the Province Rizal is hereby renamed as THE Municipality of Montalban.
 - **SEC. 2.** The renaming of THE Municipality of Rodriguez as Municipality of Montalban shall be effective upon ratification of the majority of the votes cast by qualified voters in a plebiscite to be conducted and supervised by the Commission on Elections (COMELEC) in the present Municipality of Rodriguez in compliance with Section 13 (g) of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991.
- The expenses for such plebiscite shall be borne by the Municipality of Rodriguez, Province of Rizal.
- SEC. 3. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
