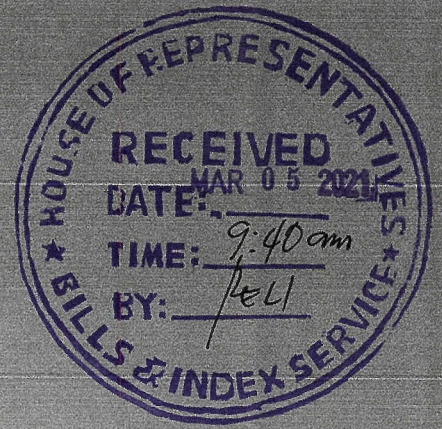

HOUSE BILL NO. 8899

AN ACT
RENAMING THE MUNICIPALITY OF RODRIGUEZ IN THE PROVINCE OF RIZAL AS THE
MUNICIPALITY OF MONTALBAN

*Be it enacted by the Senate and the House of Representatives
of the Philippines in Congress assembled:*

1 **SECTION 1.** The Municipality of Rodriguez in the Province Rizal is hereby
2 renamed as THE Municipality of Montalban.

3 **SEC. 2.** The renaming of THE Municipality of Rodriguez as Municipality of
4 Montalban shall be effective upon ratification of the majority of the votes cast by
5 qualified voters in a plebiscite to be conducted and supervised by the Commission
6 on Elections (COMELEC) in the present Municipality of Rodriguez in compliance
7 with Section 13 (g) of Republic Act No. 7160, as amended, otherwise known as the
8 Local Government Code of 1991.

9 The expenses for such plebiscite shall be borne by the Municipality of
10 Rodriguez, Province of Rizal.

11 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the
12 Official Gazette or in a newspaper of general circulation.
