Minutes of the Annual Meeting of the Covenant Ministerium

Omaha, Nebraska June 27, 2019

The Continuing Education Module in the morning was hosted by three ethnic association leaders, Juana Nesta (MHIPE), Mary March (CAPA), and Mike Thomas (AAMA). Opening worship was led by Brandi Sanders and the worship team.

2019 MINISTERIUM OFFICERS

Liz Mosbo VerHage, president Robert Johnson, vice-president Beth Ernest, secretary Mark Tao, vice-secretary Lavern Holdeman, treasurer Parliamentarian: Taylor Burgoyne

CALL TO ORDER

Liz Mosbo VerHage, president, called the meeting to order at 10:20 a.m. She reminded us that we are doing new things in this meeting and have been diligent in seeking the correct way to do them.

OPENING PRAYER

Robert Johnson, vice-president, offered the opening prayer.

TRAINING ON ELECTRONIC VOTING

LUMI rep Kyle Fletcher introduced the ministerium to the LUMI hand-held voting devices that would be used for most votes.

ORGANIZATION OF THE MEETING

The organization of the meeting was addressed by President VerHage. She explained that after reports and business, the hearings of two pastors contesting their removal will be held in executive session.

Adoption of Standing Rules. Taylor Burgoyne, parliamentarian, moved the adoption of the standing rules. By a vote of 441 yes (99.1 percent) to 4 no (.89 percent) with 2 abstentions, the standing rules were adopted.

Approval of Agenda, including Consent Agenda Items. The agenda and consent agenda items were introduced by Beth Ernest, secretary. They included:

- 1) the report on the approval of the 2018 minutes;
- 2) the authorization for approval process for the 2019 minutes;
- 3) the following appointments: parliamentarian: Taylor Burgoyne; sergeants-at-arms: Darren Olson (chair), Brian Alnes, Todd Harris, Keith Robinson, Kecia Stroot, Mark Chapman; tellers: Karen Figueroa, John Lloyd, Andrew Wollitzer, Shirley Bragdon
 - 4) 2018–2019 Financial Report
 - 5) 2018–2019 Audit Report

A motion to approve the agenda including the consent agenda passed with the following votes: yes 451 (99.33 percent), no 3 (.66 percent), abstain 5.

Good Standing. The requirements of good standing for Covenant clergy were reviewed by Mark Tao, vice-secretary.

Registration for this Ministerium annual meeting was reported as the highest ever with 530 pastors (Alaska 11; Canada 5; Central 103; Cov offices 3; East Coast 37; Great Lakes 24; Midsouth 7; Midwest 66; Northwest 134; Pacific Northwest 39; Pacific Southwest 74; Serve Globally 16; Southeast 10).

Secretary Ernest commended the new Ministerium website to all present (www.eccclergy.org) and thanked Mark Tao, Ted Law, and Rick Lindholz for their work. The website will have annual meeting documents but also other information needed for pastors. Suggestions for content or improvement are welcome.

Greeting from Colleagues. Greetings from colleagues unable to be present were noted with gratitude, including many who emailed that they have been praying and fasting for this meeting.

PROPOSED BYLAW AMENDMENT

Secretary Ernest introduced a proposed amendment to Article III, Section 1 of the bylaws. The amendment cleans up language due to previous changes in credentialing:

Section 3.1. Membership in the Covenant Ministerium is defined in the Constitution and Bylaws of the Evangelical Covenant Church. All members shall maintain good standing in a regional ministerial association. Good standing within the Covenant Ministerium includes annual dues, a current profile, annual completion of a vocational growth tool and regular healthy connections with ministerial colleagues. Licensed theological students, [M]inisters and missionaries in the inactive category, and ministers serving ECC congregations without ECC credentials shall be associate members without voting privileges or the holding of office in the Covenant Ministerium.

The proposed amendment removes the words "Licensed theological students," beginning the sentence with "Ministers and missionaries." The rationale for the change is that the LTS category is no longer offered.

The vote on the amendment was as follows: yes 434 (97.74 percent), no 10 (2.25 percent) abstain 8. The amendment passed.

RECOGNITION OF OUTGOING EXECUTIVE COMMITTEE MEMBERS

President VerHage thanked the following outgoing members of the Ministerium Executive Committee for their service: Heidi Wiebe (Midwest), Joe Muzzi (Great Lakes), Roberto Ghione (MHIPE), Jeff Saville (CCA), Susan Cosio (ACCW), and Wayne Park (CAPA).

RECOGNITION OF OUTGOING MINISTERIUM OFFICERS

Outgoing Ministerium officers were recognized and thanked by Secretary Ernest and President VerHage. These officers were Robert Johnson, vice-president, and Lavern Holdeman, treasurer, each of whom received a gift for their work on behalf of the Ministerium.

IN MEMORIUM

Jeannette Conver, ACCW president, read the list of pastors, missionaries, and spouses who had died since the last meeting and offered a prayer of gratitude for their service to the gospel and the Covenant. The list included 17 pastors, 10 missionaries, and 16 spouses.

MINISTERIUM BUDGET FOR 2020

The Ministerium Budget for 2020 was presented by Treasurer Holdeman, who outlined changes in the budget. Discussion ensued on a decrease for the Sustaining Pastoral Excellence amount. The change had been discussed with SPE staff and is partially reflected in an increase to our ethnic associations, which will be given directly rather than run through SPE.

The budget passed by the following vote: yes 435 (97.74 percent); no 12 (2.68 percent) abstain 7.

GREETINGS FROM EXECUTIVE MINISTER NOMINEES

Greetings were given from Paul Robinson, nominee for executive minister of love mercy do justice, and Paul Lessard, nominee for executive minister of start and strengthen churches.

REPORT FROM NOMINATING COMMITTEE

On behalf of the Nominating Committee, Vice-Secretary Tao presented the nominees for Ministerium officers. No additional nominees came from the floor. Candidates for vice-president: Deidra Clark and Dieula Previlon.

Vote: Previlon 234 (52 percent), Clark 216 (48 percent). Previlons was elected vice-president.

Candidates for treasurer: Joe Muzzi and Eric Hedberg

Vote: Hedberg 262 (57.71 percent) Muzzi 192 (42.29 percent). Hedberg was elected treasurer.

REPORTS FROM ECC EDUCATIONAL INSTITUTIONS

CHET. Ed Delgado, president of Centro Hispano Estudios Teologicos (CHET) spoke of the excitement of seeing alumni of CHET now becoming leaders in the church and denomination. He will be leaving that position in November 2019, making a transition after twelve years. Applause was offered for President Delgado's inspired leadership of CHET and his contribution to our denomination and Latino/a ministry.

North Park Theological Seminary. Dave Kersten, dean of North Park Theological Seminary, spoke of over 170 new students, the IGNITE seminary program in the Pacific Southwest Conference, and the School for Restorative Arts in Statesville Correctional Center where a second cohort has been enrolled. A television documentary has been produced about this program. Stephen Chester, professor of New Testament, has taken a call to Wycliff in Toronto as of August 1. Kersten introduced the recommended replacement, the Dennis Edwards (MDiv Trinity; PhD Catholic University of America) who also brought greetings.

Dwight Perry, academic dean of North Park Theological Seminary, reported on the recent task force on preparation for pastoral leadership. This wideranging survey of pastors in various settings, roles, and licensure produced a seventy-one-page document that will inform theological education for years to come. He noted it is one of the most representative surveys in Covenant history. The first finding of many is the most important impact on ministry is our spiritual and emotional health, followed by biblical and theological preparedness, communication skills, leadership, and intercultural competency. Perry has found that the both the strength and the weakness of the Covenant is our relationship commitment. The task force is now working on implementing the findings.

North Park University. Mary Surridge, president North Park University, submitted a report that can be found online.

REPORT FROM ECC PRESIDENT

John Wenrich, ECC president, reminded the Ministerium of the importance of the Annual Meeting as the celebration of the ordination and commissioning of pastors. He lifted up the Holy Spirit as the "blazing center" of our mission and introduced a coming suite of resources on the Spirit that will be out for Midwinter 2020. He spoke of the Six-fold Test, relinquishing leadership of the Ethnic Commission, the growing President's Book Club, and his appreciation of Lance Davis. He ended with Paul's prayer for the spiritual growth found in Ephesians 3: 14-21.

PRAYER

Vice-president Johnson prayed for the work represented in the preceding reports and for our leaders and institutions.

The meeting recessed for lunch at 11:50 a.m. and reconvened at 1 p.m.

PENSION PLAN UPDATE

Paul Hawkinson, director of pensions and strategic adviser, outlined the major changes in the Covenant Pension Plan that will go into effect at the end of 2019 and which establishes financial options for Covenant pastors in a time when many denominations' pension plans are failing.

IDENTITY, LEADERSHIP, ONE BODY

President VerHage reported on the state of the Ministerium, emphasizing "identity, leadership, one body—Covenant Affirmations, and the Six-fold Test." Lifting up the many diverse concerns of conference ministeriums and associations articulated by the members of the Executive Committee of the Ministerium in November 2018, she noted that all twenty-five members named seeing God at work and the need to be focused on God and dependent on God. Citing Ephesians 4:4-5, she listed lies we must reject lest we be divided and diverted from our task of reconciliation. In these times, we are committed to: 1) identity (#rootedin-Christ), 2) leadership (#elevateleadership), and 3) one body (#unitedindiverstiy). She closed by calling us to suffer and share with one another.

RESOLUTION ON ANTIRACISM

A resolution on antiracism was brought by David Swanson (by video) Michelle Clifton-Soderstrom, who asked that the resolution be received as a call to racial righteousness, which is at the heart and center of the gospel. The substance of the resolution follows:

Resolution on Antiracism

Be it resolved that the members of the Covenant Ministerium support the following:

1) Invite white members of the Covenant Ministerium to sign the public Relational Covenant below affirming one's personal commitment to anti-racism and increased cultural competency. The covenant includes recognizing, naming, and engaging the laments and committing to specific and measurable steps to resist racist and divisive behaviors.

- 2) Members of the Covenant Ministerium call on the Executive Board of the Ministerium and the executive boards of the conference ministerial associations to promote the Relational Covenant and encourage white credentialed ministers to prayerfully consider signing it.
- 3) The Covenant Ministerium requests that denominational and conference boards receive implicit bias training and that the conference superintendents collaborate with Love Mercy Do Justice to make available antiracism and cultural competency training for white clergy.
- 4) Guidelines be formulated by a working group who will 1) identify structures to ensure an equity of voice and agenda across race, ethnicity, and culture in conference ministerial associations and the ECC ministerium, and 2) provide suggestions about how boards and associations can be more hospitable to all the cultural expressions of Covenant clergy and implementing changes to eliminate white cultural dominance. The working group will be comprised of a representative from each of the ethnic associations, a representative from the Executive Board of the Ministerium, the director of racial righteousness, the authors of this proposal as affirmed by the ethnic associations to collaborate in this work, and other credentialed ministers as identified by the working group.
- 5) The Covenant Ministerium submits for action to the Board of the Ordered Ministry that they identify a process in consultation with the ethnic associations, the director of racial righteousness, and the executive minister of develop leaders in which conflicts related to this antiracism work can be resolved if necessary. A person with less authority may need structural assistance in bringing up an experience of racism related to a person with more organizational power.

Motion seconded. A robust discussion including the merit or harm of strong wording, if it should be rewritten by either a multi-ethnic group or non-white group, the need for white people to own their privilege, the necessity of strong language, and recognizing our own racism. Juana Nesta of MHIPE explained that the ECC ethnic associations worked closely with Swanson and Clifton-Soderstrom, the authors of the document.

The resolution passed with the following vote: yes 406 (84.4 percent); no 75 (15.6 percent).

REPORT FROM THE BOARD OF THE ORDERED MINISTRY

Mark Pattie, chair of the Board of the Ordered Ministry spoke in appreciation of the phenomenal stories BOOM gets to hear over the years of what God is doing in the church. BOOM's job is to help the church and Ministerium flourish. He cited the "watershed moment" for the Ministerium in the cases being tried that day. Care and discipline have been offered by giving BOOM's best view on how the rules and guidelines should be followed and interpreted. The votes this afternoon will be an opportunity for the Ministerium to offer feedback and discern whether BOOM has interpreted correctly. He urged us to assume the best in one another, noting that issues in interpretation of Scripture are between people who are deeply committed to Scriptures, to the Body of Christ, and to loving one another and our neighbors. To frame the issue before us as "some of us love and some of us don't is to frame it incorrectly." Philippians 1:9: "I pray that your love may overflow more and more with knowledge and insight."

MOTION ON GUIDELINES ON HUMAN SEXUALITY

A motion to consider changing lines 117-119 on the Guidelines on Human Sexuality was presented by Amanda Olson and Bill Orris. Olson noted that the motion does not mean changing the ECC position on gay marriage or allowing ECC clergy to perform gay weddings, rather allows pastoral care in "ministering to all members of the faith community according to particular needs."

The motion is as follows: that the Covenant Ministerium, submit to the Board of the Ordered Ministry for their consideration, the following revision to the Guidelines for Covenant Pastors and Congregations Regarding Human Sexuality's Pertaining to Officiating (lines 110-119):

Retain lines 112-115 (which read):

1) Clergy credentialed by the ECC are not permitted to officiate at same-sex unions, blessings or marriages, nor at male-female unions or blessings outside of permanent, lifelong vows (for example, the request of a couple to avoid the loss of benefits or pension rights by not legally marrying)."

Change lines 117-119 from:

2) Clergy credentialed by the ECC may attend the wedding or blessing of a samesex couple or male-female union or blessing but may not participate in the service other than as a participant with the congregation.

To:

2) Officiating is defined as presiding over the service of marriage, including the declaration of intent, vows, giving and receiving of rings, or the pronouncement/declaration of marriage.

The motion was seconded. Discussion included a perceived sufficiency of the present wording of the guidelines, a desire to "make space" for pastors whose ministry context includes people and families in the LGBTQ community, a suggestion to update the language of our current statement, and the importance of our call to love and minister out of our relationships, guided by the Holy Spirit.

The motion failed by the following vote: yes 216 (43.63 percent); no 279 (56.36 percent); abstain 12.

VOCATIONAL SERVICE RECOGNITION

Vice-President Johnson called forward the twenty-four pastors present of fifty-six honored for a lifetime of service to the gospel. We thank God for their decades of faithful service.

REPORT FROM EXECUTIVE MINISTER OF DEVELOP LEADERS

Lance Davis reited the cutting-edge work being done with Lilly grants, including on debt retirement for clergy. A contractor has been hired to help implement the new Covenant Leadership Training Institute, which will allow pastors to access resources virtually. Asked to develop a statement on freedom and responsibility, BOOM has decided to add the word "unity." This will go through the Covenant's resource paper process. Davis spoke of his personal goal of resourcing rural/town and country pastors.

RECOMMENDATION FOR APPROVAL OF CANDIDATES

The Ministerium received a recommendation from the Board of the Ordered Ministry to recommend to the ECC Annual Meeting that the ordination of Dan Collison and Steve Armfield be revoked. Both Dan Collison and Steve Armfield asked to contest the removal of their credentials, and a hearing was held among Ministerium members per *Robert's Rules* (refer to the Ministerium Hearing Info Sheet for further information). Therefore, the meeting entered into executive session. The session adjourned at 5:45 p.m. for dinner, returning after dinner for the second hearing.

The resulting action was that the Board of the Ordered Ministry's recommendation for the removal of Pastors Steve Armfield and Dan Collison's ministerial credentials and the striking of their names from the roster of ECC clergy were recommended to the ECC Annual Meeting. It is noted that this unprecedented act in Covenant history was a difficult experience for the Ministerium.

RESOLUTION OF THANKS

A resolution of thanks was brought by the secretary. Parliamentarian Burgoyne and President VerHage received standing ovations for their professionalism and calm during the difficult hearings. Secretary Ernest sang a C.O. Rosenius hymn over the gathered pastors, "Now Anxious Heart Awake from Your Sadness," a reminder that God remains ever our help and guide.

CLOSING PRAYER AND ADJOURNMENT

President VerHage closed in prayer.

The meeting adjourned at 10:30 p.m.

Minutes of the 134th Annual Meeting of the Evangelical Covenant Church

Hilton Omaha, Omaha, Nebraska June 27-29, 2019

FIRST BUSINESS SESSION Friday, June 28, 2019 8:30 a.m.

1. MORNING WORSHIP

Moderator Jonathan Wilson called the meeting to order, and then recognized Marc Jefferson to lead the assembly in worship. The moderator also recognized Alex Rahill, interim executive minister of start and strengthen churches, who led Agenda Item 9, Church Planting Commissioning. Rahill called the church planters forward for covenant document signing and prayer.

2. OPENING STATEMENT BY THE MODERATOR

The moderator explained procedures, issued an opening statement, and introduced the officers and staff on the platform. The moderator recognized Erin Chan Ding, executive director of communications, who gave an announcement about the new Covenant app. The moderator recognized Tanya Constanza, manager of sustaining pastoral excellence and Covenant orientation, who announced that supporting materials were available in Spanish.

3. GREETING FROM MIDWEST CONFERENCE

The moderator recognized Tammy Swanson-Draheim, superintendent of the Midwest Conference, who greeted the assembly on behalf of the conference and its churches, and prayed.

LUMI VOTING DEVICE

Vice-moderator Wes Gibson recognized Kyle Fletcher, technician for Lumi Global to provide a brief orientation on the electronic voting system. In answer to a point of clarification, he explained that an "abstain" vote would not be counted toward the total votes and would not be reflected in the vote percentages. Sample votes were taken.

4a. REPORT ON CREDENTIALS AND MOTION

The moderator recognized Hollis Kim, chair of the credentials committee, who presented the following motion: "Those persons who have currently been registered and certified as delegates with the committee on credentials together with those who shall subsequently be registered and certified in the course of this Annual Meeting shall constitute the official roster of the 134th Annual Meeting of the Evangelical Covenant Church."

Hollis then reported that registration as of Friday morning included 952 credentialed voting delegates and 180 additional registrants in various non-voting categories for a total registered conference attendance of 1,132.

The motion carried.

5. ACTION ON THE STANDING RULES

The moderator recognized Wes Gibson, vice-moderator, who, on behalf of the agenda committee with the concurrence of the Executive Board, moved the adoption of the standing rules as follows:

STANDING RULES OF ORDER 2019 COVENANT ANNUAL MEETING

1) Obtaining the Floor

Only persons wearing appropriate credentials as delegates, advisers, or resource persons may be present on the floor of the Annual Meeting or request speaking privileges. With the exception of points of order, points of personal privilege, or other items that require urgent attention, only those persons who approach a microphone shall be recognized by the moderator.

2) Voting

Voting on motions will typically be by electronic vote utilizing the LUMI devices.

3) Time Limits

- a) Reports that contain no proposal for action by the meeting shall be limited to ten (10) minutes, including the question period, with the exception of the president's report, the treasurer's report, and items specified in the agenda as longer reports.
- b) Debate on any main motion, including its subsidiary motions, shall be limited to thirty (30) minutes, except as otherwise specified in these standing rules and the agenda. No amendment or other subsidiary motion to a main motion shall be allowed until debate on the main motion has ceased or ten (10) minutes have passed.
- c) No speech in debate may exceed three (3) minutes unless this period is extended by a majority vote at the request of the speaker.
 - d) Time limits may be extended for a specific period by a two-thirds vote.

4) Action on Involuntary Removals

From time to time the Executive Board recommends to the Annual Meeting that churches be removed from membership. Throughout our history, all churches recommended for removal from membership accepted the Executive Board's decision. In other words, we have not experienced a circumstance in which a church was involuntarily dismissed from membership pursuant to Section 4.4 of our Bylaws. This Section 4.4 provides that congregations shall have the opportunity to defend themselves before the Annual Meeting and that the Annual Meeting shall vote on the recommendation of the Executive Board. Likewise, we have not experienced a circumstance in which an ordained minister has objected to his or her dismissal as recommended by the Board of the Ordered Ministry and approved by the Covenant Ministerium as provided in Section 10.3.e of the Rules of the Ordered Ministry. At this Annual Meeting, either or both of these matters may come before us for action. To address these matters in a fair and sensitive fashion, the Annual Meeting will proceed as follows:

a. The church seeking to defend themselves from removal shall have fifteen (15) minutes to speak. The church may designate up to four members of the church to speak on the church's behalf and may determine how to allot their fifteen (15) minutes. The Executive Board shall have up to fifteen (15) minutes to respond through its designated representatives.

b. An ordained minister objecting to dismissal shall have five (5) minutes to speak on why he or she should not be dismissed. The Board of the Ordered Ministry shall have up to five (5) minutes to respond through its designated representatives.

c. On each of these actions, debate that follows the presentations shall proceed according to these Standing Rules, Section 3), Time Limits b), c), d).

5) Submission of Motions in Writing

All main motions and complex subsidiary motions shall be submitted in writing to the secretary.

6) Items of Business Not on the Agenda

The Bylaws provide in Section 7.8.a.ii that "Items of business that are not on the agenda may be submitted in writing by a delegate to the moderator. If the item submitted is in order, a majority vote of the delegates present and voting shall be required to place that item on the agenda." It is further strongly requested that such items be submitted to the moderator as early as possible in the course of the meeting.

7) Consent Agenda

Items on the consent agenda are routine, procedural, informational, self-explanatory non-controversial items that require action but generally don't require discussion or debate. Acting on these items moves the meeting along, allowing for more time for substantive issues. Items on the consent agenda may be removed from the consent agenda at the request of any two delegates. Items removed from the consent agenda shall be acted upon by the assembly at a place in the agenda determined by the moderator. If the consent agenda is not adopted by the unanimous consent of the meeting, then each of the items on the consent agenda shall be acted upon by the assembly as a separate motion at a place in the agenda determined by the moderator.

8) Nominations from the Floor

A nomination from the floor shall be accepted only if the person nominated has agreed to have his or her name placed in nomination. (Note that the Bylaws provide in Section 7.9.c.v.2 and 7.10.j.ii that a delegate making a nomination may provide descriptive information similar in scope and content to that provided to the Annual Meeting by a nominating board or committee.)

9) Run-off Elections

In the case of an election with three or more candidates, if no candidate receives a majority of votes after two rounds of voting, then beginning with the third round, the candidate with the lowest number of votes in that round will be eliminated. In the event of a tie among the lowest vote-getters, those tied will not be eliminated in that round. A candidate may withdraw at any point. Voting rounds will continue until one candidate receives a majority of votes.

10) Modification of Agenda Order

The moderator shall have the discretion to revise the order of agenda items to accommodate scheduling needs.

11) Electronic Recording

Personal electronic recordings are forbidden during executive session and during any other times of the business sessions.

Agenda Committee Members

Jonathan Wilson, moderator; Wes Gibson, vice-moderator; Michael DeLong, secretary; Eric Filkin, parliamentarian; Rebecca Gonzalez, ECC secretary; John Wenrich, ECC president A motion was made and seconded to amend item 4 pertaining to action on involuntary removals to permit the Annual Meeting to amend motions that come from the Executive Board. The moderator ruled that action on the proposed amendment would be suspended until after dealing with the main motion.

Mark Olson of Bellingham, Washington, commented that the wording on item 4 was not clear, that normally the action to remove a church was initiated by the church, not the Executive Board. He made no motion but requested that his comment be placed in these minutes.

A voice vote was taken on adopting the standing rules apart from item 4. The motion carried.

The amendment to rule 4 to permit the Annual Meeting "to amend motions that come from the Executive Board" was then picked up for consideration. Discussion followed.

A delegate called the previous question. Delegates voted to end debate. The motion passed.

Delegates voted on the amendment to permit the Annual Meeting to amend motions that come from the Executive Board. The motion to amend failed.

Delegates voted on the motion to adopt rule 4 as written. The motion passed with 88.6 percent voting in favor, and 11.36 percent voting against.

The moderator reminded the delegates about proper decorum when voting on sensitive issues.

11. REPORT OF THE PRESIDENT

The moderator recognized John Wenrich, president. Wenrich reminded the delegates that Covenanters are 1) people of the Book, "We stand where the Bible stands, wherever it stands," 2) we are people of mission, a union of churches on mission

together, and 3) we are people of gracious conviction, who are grounded in the historic and global interpretive consensus of Scripture. Wenrich reported that LGBTQ+ persons are welcome in Covenant churches, and that the Embrace suite of resources are provided to help us learn how to love and care for all. He said that we confess we are not doing all we could and should be doing, and that we resolve as a matter of our commitment to compassion, mercy, and justice to actively work and speak out against prejudice, hatred, and violence against the LGBTQ+ community and all sexual minority individuals in society, in the body of Christ, and in our own denomination. He said we are a people of gracious conviction and that it's not an easy thing living as such, and that we don't have to compromise convictions to be compassionate.

Wenrich noted that twelve churches were joining the ECC, and then delegates would be voting to remove churches from the roster. Most of the churches have closed but from time to time there are churches that choose to voluntarily withdraw because they no longer in good faith can live within our tent. He said that we thank them and respect them for their decision to graciously and voluntarily withdraw their membership. This is the peaceful and gentle spirit of the Covenant. We can affirm their decision because of how we have chosen to live together, he said. He also said that a pastor's credentials are not one's own, that they are extended in trust by the Covenant which both authorizes and limits aspects of their use. Likewise, he said, a congregation's membership is not an irrevocable right, but the expression of voluntary partnership. Wenrich said that we face a decision that is both distressing and painful. "It is with a heavy heart that I and many others come to this Annual Meeting," he said. "We are voting on the Covenant Executive Board's recommendation to remove First Covenant of Minneapolis from the roster of Covenant churches. As a people of the Book, this decision is about how we interpret Scripture. And we have had these conversations in various venues over the last 20 years with clarity. As a People of Mission, this decision is bout how we carry out the mission and live as mission friends, faithfully declaring God's word in a culture where it is not popular. Our common mission will best be accelerated by the living out of the gospel with clarity, strengthened by our polity and our mutual responsibilities. As a people of gracious conviction, this decision is about how we love all people without compromising our biblically and communally discerned convictions."

President Wenrich then lead the delegates in a brief prayer, followed by silence.

Following Wenrich's report, the moderator recognized Valerie Thomas, member of the Executive Board, who prayed.

8. ACTION ON CHURCHES APPLYING FOR MEMBERSHIP

The moderator recognized Alex Rahill, interim executive minister of start and strengthen churches and director of church planting. Rahill invited the conference superintendents and directors of church planting to introduce pastors and representatives from each church applying for membership. Upon the recommendation of the respective conferences and on behalf of the Executive Board, Rahill moved that the 134th Annual Meeting accept the following churches into membership in the Evangelical Covenant Church:

10. ACTION ON REMOVAL OF CHURCHES FROM THE ROSTER

a. Voluntary Removal from Membership. The moderator recognized Rebecca Gonzalez, who on the recommendation of the respective conferences and on behalf of the Executive Board, moved that the following churches be removed from the roster of member churches (she noted that Worship Frontier Covenant Church in Newton, Massachusetts, which was listed in the delegate notebook to be removed from the roster was not, in fact, a member church):

The motion to remove the churches from the roster carried.

Vice-Moderator Wes Gibson shared announcements regarding lunch and submission of questions. He then prayed for the churches voluntarily removed from the roster and for lunch.

The meeting was recessed for lunch to be reconvened at 12:30 p.m. in executive session.

SECOND BUSINESS SESSION Friday, June 28, 2019 12:35 p.m.

10. ACTION ON REMOVAL OF CHURCHES FROM THE ROSTER (cont'd)

b. Action on Involuntary Removal from Membership of FCCM. The moderator announced that the meeting was in executive session. He recognized Rebecca Gonzalez, who read Section 4.4 of the Covenant Constitution: "Member congregations that through decision or practice are out of harmony with the principles, policies, programs, or institutions of the ECC may be dismissed from the ECC according to the procedures state in the Bylaws."

She then read from Section 4.4, paragraphs a., b., and c., of the Bylaws dealing with involuntary dismissal from membership.

- a. Charges that a congregation is out of harmony with the ECC shall be presented to its conference executive board, which shall immediately inform the Executive Board of the ECC and the president of the ECC of the charges.
 - i. If the conference executive board finds the charges to be credible, the conference executive board shall seek to guide the congregation into harmony with the ECC. The conference executive board shall then make a report and recommendation to the Executive Board of the ECC and the president of the ECC.
 - ii. The Executive Board of the ECC shall independently consider the credibility of the charges based on all the information and recommendations available to it. The Executive Board of the ECC may then, at its initiative and in communication with the regional conference, seek to guide the congregation into harmony with the ECC. If the Executive Board of the ECC determines that the congregation is and remains out of harmony with the ECC, the Executive Board of the ECC shall make a report and recommendation to the Annual Meeting of the ECC.

iii. The Annual Meeting shall vote on the recommendation of the Executive Board.

iv. If a congregation is dismissed from membership in the ECC by action of the Annual Meeting of the ECC, its membership in the regional conference shall also be terminated.

b. In all cases, congregations shall have opportunity to defend themselves before the conference executive board, the Executive Board of the ECC, and the Annual Meeting of the ECC.

c. The Executive Board of the ECC shall make special provision for charges made against a member congregation that is not located within a regional conference."

Gonzalez explained that the process as stated in the Bylaws had been entered into with First Covenant Church of Minneapolis (FCCM). She directed delegates to details and timeline of the developments in the delegate notebook, and presented the following recommendation from the Executive Board:

"Because FCCM is and remains out of harmony with the ECC after all steps required or allowed by Section 4.4 of the ECC Bylaws and attempts to bring the congregation back into harmony have been unsuccessful, the Executive Board of the ECC recommends to the 134th Annual Meeting that FCCM be involuntarily dismissed from the roster of ECC churches."

Moderator Jonathan Wilson restated executive session guidelines: no private recordings are permitted, nor are delegates free to share information later.

He explained that debate will proceed after the appeal and tesponse, according to Standing Rules. Motions to postpone another year or to another Annual Meeting will be ruled out of order as this is the Annual Meeting charged with this business.

Wilson invited the representatives from First Covenant Church of Minneapolis to come forward.

FCCM was given 15 minutes for their appeal, which included a video of their ministry, and comments by three representatives of the church: Brian Wass, church leadership member; Carina Aleckson, church chair; John E. Phelan Jr., church resource personnel.

Wilson then invited the representatives from ECC Executive Board forward.

The response from the Executive Board was also limited to 15 minutes, and included comments by Jenell Pluim, Executive Board chair, and Jeff Houston, Executive Board vice-chair.

Following the appeal and response, the moderator reminded the delegates that the recommendation to remove FCCM from the roster of ECC churches required a two-thirds vote.

After re-emphasizing the parameters of debate, the floor was opened for delegate discussion and debate.

A delegate requested to have minority-opinion Executive Board members speak. The moderator ruled that such would be out of order. An appeal to the chair was raised, prompting a vote. A "yes" vote agrees with the moderator, a "no" vote agrees with the appeal. The results were 766 "yes" votes, 261 "no" votes and 9 abstentions. The moderator's ruling stood.

Discussion continued for total of 30 minutes. A motion to extend debate

an additional 30 minutes was made and seconded. The motion required a twothirds yes vote. The results were 755 (73 percent) "yes" votes, 273 (26 percent) "no"votes, and 10 abstentions. The motion to extend debate passed.

The limit of extended time was once again reached. A motion was made and seconded to extend debate 15 minutes. The motion to extend failed by a vote of 482 (47 percent) "yes" votes, and 529 (52 percent) "no" votes, and 9 abstentions.

The moderator then called for the question. A request for a moment of silent prayer was made and granted before delegates voted on the motion.

The results of the vote were 776 yes (75 percent); 256 no (25 percent), with 13 abstentions. The motion to remove First Covenant Church of Minneapolis from the Covenant roster of churches passed.

The executive session was then closed and other attendees were invited back into the room.

The moderator made the following announcement to the public meeting: "Based on the recommendation of the Executive Board and the involuntary removal from roster process we have just walked through, the 134th Annual Meeting has accepted the Executive Board recommendation that FCCM is and remains out of harmony with the ECC after all steps required or allowed by Section 4.4 of the ECC Bylaws and attempts to bring the congregation back into harmony have been unsuccessful, FCCM is therefore involuntary dismissed from the roster of ECC churches."

Moderator Wilson invited Wes Gibson, vice-moderator, and Angela Lee, executive director of ministry development, to lead the assembly in a time of lament and corporate prayer.

4b. SECOND CREDENTIALING REPORT

The moderator recognized Hollis Kim, chair of the credentials committee, who presented the following second credentialing report: total credentialed voting delegates, 1050; total additional registrants in non-voting categories, 166; total registered conference attendance, 1216.

12. ELECTION OF EXECUTIVE MINISTERS

a. Start and Strengthen Churches. The moderator recognized Dwayne Tissell, chair of the nominating committee for the executive minister of start and strengthen churches, who gave an overview of the committee's process and then presented the following nomination: "The nominating committee of the executive minister of start and strengthen churches, with the concurrence of the Covenant Executive Board, nominates Paul Lessard to serve as executive minister of start and strengthen churches."

The moderator opened nominations from the floor. There were none and the nominations were closed.

The delegates voted. Lessard was elected by a vote of 930 yes (96 percent), 33 no (3 percent), and 8 abstentions.

Phil Print, Executive Board member, prayed for Lessard.

b. Love Mercy and Do Justice. The moderator recognized Cindy Wu, secretary of LMDJ executive committee of the Executive Board and member of the nominating committee for the executive minister of love mercy and do justice. She gave an overview of the committee's process, and then presented the following

nomination: "The nominating committee of the executive minister of love mercy and do justice, with the concurrence of the Covenant Executive Board, nominates Paul Robinson to serve as executive minister of love mercy and do justice."

The moderator opened nominations from the floor. There were none and the nominations were closed.

The delegates voted. Robinson was elected by a vote of 880 yes (99 percent), 5 no (0.56 percent), and 14 abstentions.

Alice Lee, Executive Board member, prayed for Robinson.

c. Make and Deepen Disciples. The moderator recognized John Stewart, member of the Executive Board, who presented the following nomination: "The nominating committee of the executive minister of make and deepen disciples, with the concurrence of the Covenant Executive Board, nominates Michelle Sanchez to a second term as executive minister of make and deepen disciples."

The moderator opened nominations from the floor. There were none and the nominations were closed.

The delegates voted. Sanchez was elected by a vote of 806 yes (91 percent), 78 no (8 percent).

Michael Jordan, Executive Board member, prayed for Sanchez.

d. Serve Globally. The moderator recognized Donna Erickson, chair of Serve Globally executive committee of the Executive Board, who presented the following nomination: "The nominating committee of the executive minister of serve globally, with the concurrence of the Covenant Executive Board, nominates Al Tizon, for a second term to serve as executive minister of serve globally."

The moderator opened nominations from the floor. There were none and the nominations were closed.

The delegates voted. Tizon was elected by a vote of 869 yes (98 percent), 16 no (1 percent), and 7 abstentions.

Christine Rosell, Executive Board member, prayed for Tizon.

33. REPORT FROM NORTH PARK THEOLOGICAL SEMINARY

The moderator recognized David Kersten, dean of North Park Theological Seminary, to give a report, in which he highlighted the renovation of Nyvall Hall and showed a video about the school's program at Stateville Correctional Center.

Kersten then brought a motion on behalf of the North Park University Board of Trustees with the concurrence of the Board of the Ordered Ministry and the ECC Executive Board, that Dennis Robert Edwards be called to the faculty of the seminary as associate professor of New Testament.

The delegates voted. Edwards was called to the faculty by a vote of 851 yes (98 percent), and 10 no (1 percent), with 17 abstentions.

Edwards shared remarks and thanks. Vicki Reier, member of the Executive Board, offered prayer for Kersten and Edwards.

14. ACTIONS TO BE TAKEN FROM THE ORDERED MINISTRY

The moderator recognized Lance Davis, who presented the following motion: "The Board of the Ordered Ministry, with the concurrence of the Covenant Ministerium, recommends to the 134th Annual Meeting the dismissal of the following person from the ministry of the Evangelical Covenant Church and the removal of his name from roster of Covenant ministers: Dan Collison."

The moderator recognized Dan Collison to present an appeal of the motion. He

was given five minutes for the appeal, and was then excused from the room.

The moderator then recognized Lance Davis to give a report summarizing the interactions between Collison and the ECC leadership. He was given five minutes.

After about 20 minutes of debate and five minutes before the afternoon session was scheduled to conclude, a delegate called for the question, which would close debate. The vote needed a two-thirds majority to pass.

Delegates voted as follows: 565 yes (60 percent), 370 no (39 percent), and 18 abstentions. The motion failed, and debate continued.

Concerns arose regarding children in child care that needed to be pick up. After 15 minutes a delegate called for the question.

Delegates voted as follows: 628 yes (69 percent), 287 no (30 percent), and 17 abstentions. The motion passed, and debate ended.

A delegate moved to appeal the chair. A majority vote on the appeal would reinstate debate.

Delegates voted on the the appeal as follows: 281 yes (30 percent),654 no (69 percent), 11 abstentions. The appeal was defeated.

The delegates then voted on the motion to remove Dan Collison's ministerial credentials. The vote was as follows: 731 yes (77 percent), 212 no (22 percent), 17 abstentions. The motion passed.

At 5:20 p.m. a motion was made to recess and reconvene at 6:30 p.m. A friendly amendment changed the time to reconvene to 7 p.m. Delegates passed the motion by the following vote: 821 yes (90percent), 82 no (9 percent), 9 abstentions.

THIRD BUSINESS SESSION Friday, June 28, 2019 7 p.m.

There was 10 minutes of music and prayer by a worship leader. The moderator explained that the scheduled evening worship service was cancelled in order to continue the business session which had continued beyond the original scheduled time because of extensive debate. and then the moderator reconvened the meeting in executive session.

Change in Standing (cont'd). The moderator declared executive session and anyone who was not a voting delegate or who otherwise had permission to remain, was told to leave the room.

The moderator recognized Lance Davis, who presented the following motion: "The Board of the Ordered Ministry, with the concurrence of the Covenant Ministerium, recommends to the 134th Annual Meeting the dismissal of the following person from the ministry of the Evangelical Covenant Church and the removal of his name from roster of Covenant ministers: Steven Armfield."

The moderator recognized Steve Armfield and his advocates—his daughter, Lindsay Small, and son-in-law Kyle Small—to present an appeal of the motion. He was given five minutes for the appeal, and was then excused from the room.

The moderator recognized Lance Davis to give a report summarizing the interactions between Armfield and the ECC leadership. He was given five minutes.

Debate ensued. When the time given for debate was reached, a delegate moved to extend debate for an additional 30 minutes. The motion was seconded.

Delegates voted as follows to extend debate: 251 yes (27 percent), 663 no (72 percent), 8 abstentions. The motion to extend debate failed.

Delegates then voted on the motion to remove Steve Armfield's ministerial credentials: 637 yes (71 percent), 259 no (28 percent), 29 abstentions. The motion passed.

The moderator ended the executive session.

The moderator recognized Lance Davis to bring the following motion: "The Board of the Ordered Ministry, with the concurrence of the Covenant Ministerium, recommends to the 134th Annual Meeting the dismissal of Gary Lucht from the ministry of the Evangelical Covenant Church and the removal of his name from roster of Covenant ministers." There was no appeal to this motion.

Delegates voted as follows on the motion: 737 yes (94 percent), 42 no (5 percent), 106 abstentions. The motion passed.

24. FISCAL YEAR 2018 FINANCIAL REPORT

The moderator recognized Steve Klimkowski, treasurer and executive director of finance, to give a report on the fiscal 2018 results, which ended January 31, 2019. He reported that church giving and individual donor support make up about 60 percent of our denominational budget, and highlighted the good work that is done through Covenant ministries. He said that the Covenant Church is financially sound, and that "we have adequate resourses to both sustain and advance our mission, and we have built adequate reserves to help us weather temporary financial adversity." He expressed concern about ongong decline in local Covenant church giving, which he said was the "life blood of denominational ministry." In 2000, churches gave an average of 6 percent of their income to the denomination. That figure is now less than 2.5 percent.

Klimkowski said the finance team's guiding principal is "to serve diverse ministry needs while ensuring sustainability." Goals are to increase unrestricted mission reserves; maintain a margin to protect against future downturns; sustain ministries and deploy new mission opportunities; and protect the church. He reported that 2018 saw a core mission investment (expenses) of \$17.2 million, which was 2.65 percent (about \$444,000) over budget, due to the increase in church planting that was funded by a higher draw on closed church proceeds. The year ended with a surplus of \$12,930. Additionally, there was \$9 million in project ministry activity. Local church giving made up 49 percent of ECC income, and individual donor giving represented 12 percent of income.

He reported that the ECC received a clean, unqualified audit opinion and that unrestricted reserves remain steady. Jon Bonkoski prayed for Klimkowski.

31. REPORT FROM COVENANT TRUST COMPANY

The moderator recognized Ann Weisbrock, president of Covenant Trust Company, to give her report. CTC, which provides comprehensive legacy planning and financial management resources, now has more than \$2 billion under its care. The moderator recognized Scott Dennis to pray for Weisbrock and Covenant Trust Company.

32. REPORT FROM NATIONAL COVENANT PROPERTIES

The vice-moderator recognized Peter Hedstrom, president of National Covenant Properties, who shared stories about Alaskan and Houston ministry opportunities, and thanked the church for its support of NCP. The moderator recognized David Holder to pray for Hedstrom and National Covenant Properties.

29. REPORT FROM CENTRO HISPANO DE ESTUDIOS TEOLÓGICOS

The moderator recognized Ed Delgado, president of Centro Hispano de Studios Teológicos (CHET), for a report on the school. He said that there is much to celebrate, including the ordination later this evening of two CHET graduates.

The moderator recognized John Stewart and Pia Restrepo to pray for Delgado, who will be retiring in the fall, and for the school in the time of transition.

26. REPORT FROM THE BOARD OF PENSIONS AND BENEFITS

The moderator recognized Paul Hawkinson for a presentation from the Board of Pensions and Benefits, and to bring a resolution to the Annual Meeting approving the finalization of the amendments to the Covenant Pension Plan (CPP).

Hawkinson reported that the plan is 99 percent funded and has \$241 million in assets. There are no conversations about benefit reductions.

The proposed amendments to the Pension Plan, the result of a three-year process of examination, include:

- 1) The CPP will be closed to new participants after December 31, 2019.
- 2) A new, mandatory 403(b) (9) program will be required for new credentials after December 31, 2019.
- 3) Enrolled CPP participants will have a future option to switch to the 403(b) (9).
- 4) Participants over the age of 65 (but still enrolled) will direct all future funding to the 403(b)(9).
- 5) Both plans preserve future use of the housing allowance designation for participants.
- 6) The board will launch a match fund to augment 403(b)(9) contributions in under-resourced settings.

Hawkinson then brought the following motion: "The Board of Pensions and Benefits recommends, with the concurrence of the ECC Executive Board, that the 2019 Annual Meeting approve and adopt the resolution contained in Item 26.b., allowing ECC staff to finalize the amendment of the Covenant Pension Plan, as outlined." The resolution is as follows:

WHEREAS, The Evangelical Covenant Church ("ECC") is the sponsor of the Covenant Pension Plan (the "Plan") in which certain employees of ECC and its churches, regional conferences and other similar institutions or schools who are ministers are eligible to participate; and

WHEREAS, the Plan document was most recently restated effective January 1, 2014 ("2014 Plan Restatement"); and

WHEREAS, ECC has named the Board of Pensions and Benefits of The Evangelical Covenant Church (the "Board of Pensions") as "Plan Administrator" of the Plan, with further delegation to internal staff employees at ECC; and

WHEREAS, the Annual Meeting desires to amend and restate the Plan documents as referenced below; and

WHEREAS, the trustees of the Plan are the President of The Evangelical Covenant Church, the Treasurer/Executive Director of Finance of The Evangelical Covenant Church, and the Chairman of the Board of Pensions and Benefits of the ECC; and

WHEREAS, the Annual Meeting of ECC finds it to be in the best interests of ECC and the Plan to (i) amend and restate the 2014 Plan Restatement on the terms and conditions set forth in the Amended and Restated Plan referenced below; and

WHEREAS, the following document, in substantially final form, have been presented to the Annual Meeting of the ECC in connection with the Plan:

(i) Covenant Pension Plan (As Amended and Restated Effective as of January 1, 2020), to be executed by ECC ("Amended and Restated Plan").

Now, therefore be it resolved as follows:

- 1. That the Amended and Restated Plan, and the transactions contemplated thereby, is hereby authorized, confirmed, ratified and approved.
- 2. That the President and the Executive Director of Finance/Treasurer of the ECC ("ECC Authorized Officers"), and each of them, are hereby authorized and directed to finalize the Amended and Restated Plan on behalf of ECC, and to execute, enter into, deliver and approve (singularly or jointly) the Amended and Restated Plan on behalf of ECC, and all such other vendor agreements, Internal Revenue Service filings, investment advisor agreements, actuarial agreements, plan administration agreements, certificates, and any amendments, supplements or extensions thereto, and to take such actions and pay such fees as may be necessary or advisable or convenient and proper to carry out the intent of the foregoing resolutions and to fully comply with the Amended and Restated Plan.
- 3. That the Board of Pensions and the Executive Board, pursuant to Section 11.1 of the 2014 Plan Restatement, has recommended adoption of the Amended and Restated Plan to the Annual Meeting of ECC.
- 4. That the acts and doings of the officers or other persons of ECC heretofore take which are in conformity with the intent and purposes of these resolutions are hereby ratified, confirmed and approved.
- 5. That the ECC Authorized Officers are authorized, empowered, and directed to take all other actions as they may deem necessary or desirable to carry out these resolutions.

Delegates approved the resolution by a vote of 618 yes (99.52 percent), 3 no (.48 percent), 3 abstentions.

27. 2019 ECC BYLAWS AMENDMENTS

The moderator recognized Rebecca Gonzalez, who, on behalf of the Board of Covenant Ministries of Benevolence and the Covenant Executive Board, recommended amendments to Section 12.2 paragraph h of the Covenant Bylaws, which reads:

h. Covenant Ministries of Benevolence has the following affiliated corporations, among others: Covenant Retirement Communities, Inc.; EMC Health, Inc.; LifeCenter on the Green, Inc.; and Swedish Covenant Hospital. Each of these affiliated corporations may have affiliated corporations, institutions, and entities of its own.

The proposed amendments reflect 1) the name change of Covenant Retirement Communities, Inc. to Covenant Living Communities and Services; 2) the name change of Swedish Covenant Hospital to Swedish Covenant Health; and 3) deletion of Life Center on the Green, Inc., which is no longer a legal entity as it merged with Swedish Covenant Hospital (Health). The amended paragraph would then read:

h. Covenant Ministries of Benevolence has the following affiliated corporations, among others: Covenant Living Communities and Services; EMC Health, Inc.; and Swedish Covenant Health. Each of these affiliated corporations may have affiliated corporations, institutions, and entities of its own.

Delegates voted to approve the motion by a vote of 509 (98 percent) yes, 6 (1 percent) no, and 1 abstention.

35. REPORT FROM FREEDOM, UNITY, AND RESPONSIBILITY RESOURCE PAPER

The moderator recognized Lance Davis, executive minister of ordered ministry and develop leaders, who reported that work has begun on the new resource paper on freedom, unity, and responsibility. He requested prayers for their work.

34. REPORT FROM PAUL CARLSON PARTNERSHIP

The moderator recognized Renee Hale, executive director of Paul Carlson Partnership, who presented a video and reported on work in Congo, including the Karawa Coffee, new bridges, and healthcare/hospital clinics.

Robert Ghione prayed for Hale and the work of PCP.

19. RECOGNITION OF EXECUTIVE BOARD MEMBERS CONCLUDING TERM OF SERVICE
