- 9. Serving or Retired Officers of State Government in the Pay Band of Level-29 or above shall be eligible to apply for the post.
 - Provided that in the case of a retired Government official, He/She should not have served in any Government positions since the past 2 years
- 10. He/She should have sufficient knowledge in Computers in order to monitor and analyze the Social Audit reports uploaded in the MGNREGS website.

Tenure and Remuneration
