Educational efforts or scholarly performance: "Dr. Cohen is an exceptional resident, physician, educator and advocate. Over the past 2 years, Dr. Cohen has been instrumental in leading and growing the Anti-Racism Task Force in the Department of Ob/Gyn and constantly inspires individuals to join the task force and the fight for anti-racism education and practice within the department, In addition to the many changes she has helped to implement within the department, she has also channeled her passion for patient equity into scholarly work. She recently submitted an abstract that was accepted at a national meeting on the results of her project to increase access to office hysteroscopy, a procedure that was previously only accessible by patients with private insurance. As a result of her project, within 3 months she and her team were able to refer 22 patients for office hysteroscopy with public insurance who previously would not have had access to this procedure. Dr. Cohen is an example of a resident who is not only a great physician but also an incredible advocate for her patients. She leads by example in her practice of medicine and in the way she teaches and supports her colleagues. She is compassionate, dedicated, and loved by her patients and colleagues."
