# STATUTORY BODIES (TRANSFER OF FUNCTIONS) ACT 1969

#### DEPARTMENT OF HOME AFFAIRS ORDER 1986

This Order, a copy of which is attached, was made by the Governor in Council on the 7th day of March, 1986, was approved by Tynwald on the 15th day of April, 1986, and will come into operation on the 20th January, 1987.

The Order constitutes a statutory body under the name of the Department of Home Affairs in accordance with the recommendations of the Select Committee of Tynwald on the Responsibilities of Boards of Tynwald Etc. The functions of the Home Affairs Board will vest in the new Department.

#### THE STATUTORY BODIES (TRANSFER OF FUNCTIONS) ACT 1969

#### THE DEPARTMENT OF HOME AFFAIRS ORDER 1986

In exercise of the powers conferred on the Governor in Council by sections 1, 1A and 3 of the Statutory Bodies (Transfer of Functions) Act 1969(a), and of all other enabling powers, the following Order is hereby made:-

#### Citation and commencement

1. This Order may be cited as the Department of Home Affairs Order 1986 and, subject to section 3(1) of the Statutory Bodies (Transfer of Functions) Act 1969, shall come into operation on the 20th January 1987.

# Interpretation

2. (1) In this Order "the Department" means the Department of Home Affairs established by article 3;

(2) References in this Order to functions under any enactment include references to functions under any public document made under that enactment.

#### Establishment and constitution of Department

3. (1) There is hereby established a Statutory Body under the name of the Department of Home Affairs.

(2) The Department shall be a Board of Tynwald for all purposes.

- (3) The Department shall consist of -
- (a) a chairman, who shall be a member of Tynwald, and
  - (b) 2 other members, who shall be members of Tynwald,

to be elected by Tynwald.

# Application of Boards of Tynwald Act 1952

4. The Boards of Tynwald Act 1952(b) shall apply to the Department as it applies to a Board within the meaning of that Act.

# Transfer of functions

5. The functions of the Home Affairs Board under the enactments specified in Schedule 1 shall on and after the coming into operation of this Order be exercisable by the Department.

#### Transfer of property etc.

6. (1) All real and personal property which immediately before the coming into operation of this Order was vested in or held by the Home Affairs Board for the purpose of the functions transferred by article 5 shall on the coming into operation of this Order vest in the Department without any conveyance or other assurance for the purposes of the said functions.

(2) All rights, obligations and liabilities which immediately before the coming into operation of this Order were enforceable by or against the said Board shall on or after such coming into operation be enforceable by or against the Department.

(3) All references to the said Board in any enactment, agreement, deed, instrument, application, notice or other document whatsoever shall, unless the context otherwise requires, be construed as references to the Department.

(4) All persons who immediately before such coming into operation were officers of or employed by or in the service of the said Board shall on and after such coming into operation be deemed to be officers of or employed by or in the service of the Department without further appointment.

#### Transitional provisions

7. (1) This Order does not affect the validity of anything done by or in relation to the Home Affairs Board before the coming into operation of this Order; and anything which on such date is in process of being done by or in relation to the said Board may be continued by or in relation to the Department.

(2) Anything made or done by the said Board shall, if in force on such coming into operation, have effect as if made or done by the Department so far as that is required for continuing its effect after such date.

(3) Documents or forms printed or otherwise prepared for use in connection with any functions transferred by article 5 may be so used notwithstanding that they contain references to the said Board, and those references shall be construed as references to

the Department; and likewise with references to an officer of that Board.

# Dissolution of Home Affairs Board

8. On the coming into operation of this Order the Home Affairs Board shall be dissolved.

# Consequential amendments and repeals

9. (1) The enactments specified in Schedule 2 are amended in accordance with that Schedule.

(2) The enactments specified in Schedule 3 are repealed to the extent specified in column 3 of that Schedule.
