STATUTORY RULES AND ORDERS NO. 7 OF 2015.

# **REGULATIONS**

MADE by the Minister under section 28(2) of the Immigration and Passport Act (Chapter 18:01).

(Gazetted March 19, 2015.)

1. These Regulations may be cited as the -

Short title.

# ALIENS (VISA EXEMPTION) REGULATIONS, 2015.

**2.** (1) Subject to subregulation (2), an alien shall not land in Dominica unless there is endorsed in his passport a visa of the Commonwealth of Dominica issued by the Commonwealth of Dominica or on its behalf by a British Consular Officer.

Exemption from visa requirement.

- (2) Subregulation (1) does not apply to -
  - (a) citizens of Argentina, Austria, Belgium, Bulgaria, Costa Rica, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Israel, Italy, Japan, Latvia, Lithuania, Luxembourg, Malta, Mexico, Netherlands, Norway, Poland, Republic of China (Taiwan), Romania, Slovakia, Slovenia, South Korea, Spain, Suriname, Sweden, United Kingdom, United States of America, and Venezuela who wish to visit for a period not exceeding 6 months;
  - (b) a person who holds a Schengen, American, British or Canadian visa who wishes to visit for a period not exceeding 6 months;

- (c) a citizen of Haiti who holds a valid diplomatic or official passport of the Republic of Haiti;
- (d) a citizen of Brazil who wishes to visit for a period not exceeding 3 months;
- (e) a citizen of Chile who holds a valid diplomatic or official passport of the Republic of Chile who wishes to visit for a period not exceeding 90 days in any 180 day period;
- (f) a citizen of Cuba who wishes to visit for a period not exceeding 28 consecutive days;
- (g) a passenger in transit or bona fide tourist who is in possession of a return ticket and satisfies the immigration officer that he does not intend to remain in the State for a period exceeding 21 days; and
- (h) passengers on tourist vessels.
- (3) Subregulation (2)(g) does not apply and shall not be deemed to apply to citizens of the Dominican Republic.

Repeal. Subsidiary Chap. 18:01. **3.** The Aliens (Visa Exemption) Regulations is repealed.
