He has been a guest lecturer at several universities and institutes and has authored over 100 academic and analytical publications. He holds a Ph.D in history of international relations from the Academy of Sciences of the USSR. Recent publications include "Practise what you preach. The prospects for visa freedom in Russia-EU relations" (FIIA Report no. 18, 2009) and "EU-Russia relations: unfortunate continuity" (European Issues, no. 129, 2009).

Marc Perrin de Brichambaut is the Secretary General of the OSCE since June 2005. He had previously held a number of senior positions in the French Administration, as well as in international organizations as a member of the Conseil d'Etat. He studied at France's Ecole Nationale d'Administration in Paris, from where he graduated in 1974. Ambassador de Brichambaut started his career at the Conseil d'Etat, first as an administrative judge, later as Conseiller d'Etat. In 1978, he was posted to New York to work as a Special Assistant to the United Nations Under-Secretary-General for International Economic and Social Affairs. He returned to Paris in 1981, where he became an adviser to French Foreign Minister Claude Cheysson. In 1983 and 1984 he was the Chief of Staff to Roland Dumas, then the Minister of European Affairs. When Mr Dumas became Foreign Minister, Ambassador de Brichambaut continued to serve as his Chief of Staff. In 1986, he moved to New York, as Cultural Counsellor for the French Embassy, returning to Paris in 1988 as Principal Adviser to Defence Minister Jean-Pierre Chevènement. From 1991 to 1994, he represented France as Head of Delegation at the Conference on Security and Co-operation in Europe (CSCE) in Vienna, which in due course became the OSCE. From 1994 to 1998, he headed the French Foreign Ministry's Legal Division. His most recent post prior to his appointment as OSCE Secretary General was as Director for Strategic Affairs at the French Defence Ministry from 1998.

Andrés Ortega is the Director of the Department of Analysis and Studies (Policy Unit) in the President of the Government's Office. From July 1994 to May 1996 he had been Director of Studies (Policy Planning) in the President of the Government's Office (Felipe González), where he had been an adviser since 1990. Previously (1989) he was an Executive Adviser to Foreign Affairs Minister Francisco Fernández Ordóñez. Andrés Ortega has been an editorial writer and columnist of *El País* newspaper and the first director (2004-2008) of the Spanish Edition of Foreign Policy (*Foreign Policy edición española,* published by the FRIDE foundation). Mr Ortega holds a M.Sc. in International Relations from the London School of Economics. He has published and lectured extensively on European and international affairs. In 2002 he was awarded the Salvador de Madariaga award for European Journalism. He is the author of four books: *El Purgatorio de la OTAN* (1986), *La Razón de Europa* (1994), *Horizontes cercanos: Guía para un mundo en cambio* (2000), and *La fuerza de los pocos (The power of the few,* May 2007).

Victoria Panova is an Associate Professor at the Department of International Relations and Foreign Policy at the Moscow State Institute of International Relations (MGIMO, University MFA Russia). She holds a PhD from MGIMO. Her research focuses on energy security and sustainability, regional conflicts, non-proliferation, terrorism, as well as global governance (notably the G8) in relation to Russian civil society. Since 2003, she acts as Regional Director for Russia of the G8 Research Group based at the University of Toronto (Canada). She is a member of the National Working Group of the Advisory Council of the Civil G8 project, led by Ella A. Pamfilova. As such, under the Russian G8 presidency of 2006, she was responsible for the substance and organization of the Civil G8 working group on Human Security (for more details see www.civilg8.ru). In 2008-2009 she acted as the Chief of the Sector of the Strategic Planning and Partnerships in ISEDC (International Sustainable Energy Development Centre under the auspices of UNESCO). Dr. Panova publishes in variety of national and international journals, including International Trends, New and Newest History and OECD Bulletin (HSE-SU magazine). She has written a reference textbook on the G8 and is among the regular contributors to the Global Governance series (Ashgate Publishing). During the first half of 2007 she was a Visiting fellow at University of Cambridge, from October 2008 till January 2010

she has the status of Visiting fellow at the London School of Economics and Political Sciences, at its Centre for the Study of Global Governance.

James P. Rubin served under President Clinton as Assistant Secretary of State for Public Affairs, Chief Spokesman for the State Department and senior policy adviser to Secretary of State Madeleine K. Albright from 1997 to May 2000. He conducted daily on-camera briefings for the State Department press corps and represented the administration in print, radio, and television interviews regarding U.S. diplomatic, foreign economic and national security policies during this time. After leaving Government in 2000, Mr. Rubin was appointed as a Visiting Professor of International Relations at the London School of Economics from 2001-2004, where he taught on US Foreign Policy. During 2002 and 2003 he also hosted the PBS series Wide Angle, a primetime, weekly international affairs program. During the 2004 Presidential general election, Mr. Rubin served as Senior Foreign Policy Adviser to Senator John Kerry. Between October 2005 and July 2006, Mr. Rubin anchored World News Tonight on SKY News UK, serving as host of the show, interviewing guests and offering analysis and commentary. Through 2006 and 2007 he was a World Affairs Commentator and presenter of special programs on international news for SKY. Mr. Rubin received a Bachelor of Arts degree in Political Science (1982) and a Masters in International Affairs (1984) from Columbia University. In 1998, Mr. Rubin was the recipient of Columbia University's John Jay Award for Distinguished Professional Achievement. In 2000, he received the State Department's highest honor, the Distinguished Service Award. Mr. Rubin is Vice Chairman of the Atlantic Partnership, serves on the boards of Columbia University's School of International Affairs and the International Rescue Committee UK, and is a member of the Council on Foreign Relations.

Yahia Said is a Research Fellow at the Centre for the Study of Global Governance. His experience combines academic research with private sector work and activism. Prior to joining LSE he worked as a corporate finance consultant with Ernest & Young in Russia. He also worked as a project coordinator with the Helsinki Citizens' Assembly in Prague. Yahia Said specialises in issues of economic transition and security in post-communist societies. His publications include 'The New Anti-Capitalist Movement: Money and Global Civil Society.', co-authored with Meghnad Desai, in *Global Civil Society 2001* and 'Regime Change in Iraq', co-authored with Mary Kaldor (CsGG, 2003) to name only a few. His research interests include Central and Eastern Europe; corporate finance; economic transition; former Soviet Union; international finance; Russia; transitional economies; post-conflict Iraq & Israel Palestine; post-totalitarian states.

Geneviève Schmeder is "professeur des Universités" at the Conservatoire National des Arts et Métiers (Paris). She studied Economics and Political Science in the University Paris 1-Sorbonne, holds an Agrégation in Economics, a PHD in Sciences Economiques from the University of Strasbourg and a HDR (Habilitation à Diriger des Recherches) from the University Paris 9-Dauphine. She has worked in the Directorate of Science, Technology and Industry of the OECD, at the Science Policy Research Unit of the University of Sussex (UK) and in the French Ministry of Industry. She has taught in various French and foreign Universities, been a consultant in international organisations (UNCTAD, UNESCO, ESA) and a member of the Study group on Europe's Security Capabilities. An associate editor in several French reviews, her publications include Les enjeux du changement technologique (Economica, 1986), Economie et Instabilité (Economica, 1988), The European Rupture, Restructuring the European Military Sectors in the Post Cold War World, (Edward Elgar, 1997) (with M. Kaldor), The End of Military Fordism (The United Nations University Press/Pinter, 1997) (with M. Kaldor et U. Albrecht), The Development of Modern Capitalism in the 21st Century : National Trajectories in the Age of Globalisation, (Edward Elgar 2006) (with B. Coriat et P. Petit).

Narcís Serra has been the President of CIDOB since 2000. During this time he has been the driving force behind the creation of the Barcelona Institute for International Studies (IBEI). In 1977 he was appointed Catalan Minister of Town and Country Planning and Public Works in the Government of the Generalitat chaired by Josep Tarradellas, and in April 1979, he was elected Mayor of Barcelona. In 1982, he was appointed Spanish Minister of Defence in the Government of Felipe González, and in 1991, Vice Prime Minister of the Spanish Government. From 1986 until 2004, Narcís Serra was member of the Spanish Parliament representing the province of Barcelona. His main areas of interest are the development of foreign policy, the relationship between the Armed Forces and civil

society and the global governance mechanisms, especially in the field of security. Recently, he has published "La Transición Militar" (Barcelona 2008) and, together with Joseph Stiglitz, "The Washington Consensus Reconsidered" (Oxford 2008). Narcís Serra has a B.A. in Economics from the University of Barcelona. In 1973, he obtained a Ph.D. in Economics from the Autonomous University of Barcelona (UAB), and, three years later, in 1976, he obtained a post of Professor in Economic Theory, first at the University of Seville and then at the UAB.

Valeriya Shamray is the Open Society Foundation (OSF) scholar at Maastricht University. As part of her OSF grant Valeriya is doing her internship at the CIDOB Europe Programme. She holds MA in European Studies from Maastricht University and MA in International Law from Ivan Franko National University of Lviv (Ukraine). Previously, she worked in the Training Unit of the European Union Border Assistance Mission to Moldova and Ukraine based in Odessa (Ukraine). Together with the EU experts she was responsible for the training sessions and international seminars on the topics related to EU standards and best practices in border management and customs issues for Ukrainian and Moldovan law enforcement agencies. Her professional and academic interests include European Neighborhood Policy, democratization and transformation of the post-soviet states and the perspective of European integration of Ukraine.

Olga Shumylo is the Director of the International Center for Policy Studies (ICPS) in Kyiv. Olga Shumylo is an expert on European integration who, for the last year, worked as an advisor to Ukrainian Deputy Prime Minister for European and International Integration Hryhoriy Nemyria. Over 2003-2007, Ms. Shumylo ran the European Integration Department at ICPS, where she was responsible for the centre's external relations and led its expert group preparing policy papers and briefs on critical EU-related issues. Ms. Shumylo holds a Master's degree from the London School of Economics. Her areas of specialization include EU-Ukraine relations, EU-Ukraine Free Trade Agreement, Eastern Partnership and Foreign Aid Coordination. She is the author of numerous publications.

Lord Skidelsky is Emeritus Professor of Political Economy at the University of Warwick. His three volume biography of the economist John Maynard Keynes (1983, 1992, 2000) received numerous prizes, including the Lionel Gelber Prize for International Relations and the Council on Foreign Relations Prize for International Relations. He is the author of the The World After Communism (1995) (American edition called *The Road from Serfdom*). He was made a life peer in 1991, and was elected Fellow of the British Academy in 1994. Robert Skidelsky was a boarder at Brighton College. He went on to read history at Jesus College, Oxford, and from 1961 to 1969, he was successively research student, senior student, and research fellow at Nuffield College, Oxford. In 1967, he published his first book, Politicians and the Slump, Labour Government of 1929-31, based on his D.Phil dissertation. Robert Skidelsky was an Associate Professor at the School of Advanced International Studies, John Hopkins University and in 1978 he was appointed Professor of International Studies at the University of Warwick, where he has since remained, though joining the Economics Department as Professor Political Economy in 1990. He was a founder member of the Social Democratic Party (SDP) and a chairman of the Social Market Foundation. He was made Chief Opposition Spokesman in the Lords, first for Culture, then for Treasury Affairs (1997-9), but he was sacked by the then Conservative party leader, William Hague, for publicly opposing NATO's bombing of Kosovo. In 2001, he left the Conservative Party for the cross benches. Since 2003, he has been a non-executive director of the mutual fund manager, Janus Capital. In 2008, he was made a nonexecutive director of Sistema, the Russian telecommunications giant. He is a director of the Moscow School of Political Studies and founder and executive secretary of the UK/Russia Round Table. Since 2002, he has been chairman of the Centre for Global Studies. He is also a trustee of the Manhattan Institute.

Javier Solana is the Secretary General of the Council of the EU and EU High Representative for the CFSP. Born in Madrid he holds a Doctorate in physics. He was a Fulbright scholar at several American universities. Javier Solana is a Professor of solid-state physics at Complutense University of Madrid and the author of over thirty publications in the field. Solana started his political career in 1964 when he joined Spanish Socialist Party. In 1977 he became a member of Parliament. Between 1982 and 1995 he occupied the posts of the Minister for Culture, Minister for Education and Science

and Minister for Foreign Affairs. Between 1995 and 1999 Javier Solana was the Secretary General of NATO and since November 1999 served as the Secretary General of Western European Union (WEU). In July 2004 he was appointed for a second 5-year mandate as Secretary-General of the Council of the EU and EU High Representative for the CFSP.

Ekaterina Stepanova heads a research group on non-traditional threats at the Center for International Security, Institute of World Economy and International Relations (IMEMO), since 2001. She also teaches at the European University in Saint Petersburg, the European University Center for Peace Studies, Austria, and Open University of Catalonia, Barcelona. In 2007–2009, she was on leave from IMEMO to lead the Armed Conflict and Conflict Management Programme at Stockholm International Peace Research Institute (SIPRI). Previously, she worked as a researcher at SIPRI (2003) and the Carnegie Endowment for International Peace Moscow Center (1995-2000) and held several Russian and international fellowships, including two MacArthur research fellowships (2000 and 2003) and a MacArthur NGO fellowship at King's College London (1998). Dr Stepanova is the author of four monographs, including *Terrorism in Asymmetrical Conflict: Ideological and Structural Aspects* (Oxford University Press, 2008), also published in Spanish (Buenos Aires, 2009), and *The Role of Illicit Drug Business in the Political Economy of Conflicts and Terrorism* (Moscow, 2005). The latest of her co-edited volumes is *Terrorism: Patterns of Internationalization* (New Dehli, London: Sage, 2009). She serves on editorial boards of Taylor&Francis journals *Terrorism and Political Violence* and *Security Index*.

Marika Theros is a Research Officer on Human Security at the Centre for the Study of Global Governance at the London School of Economics (LSE) and is also pursuing a PhD on US policy in Afghanistan at the LSE. She worked at the Crimes of War Project, where she developed and organized journalism training programs in Afghanistan. She has also previously worked at the Humanitarian Law Centre in Belgrade and in the Central Asian Division at IFES in Washington DC. She received a joint Master's Degree in International Affairs from Columbia University's School of International and Public Affairs and the London School of Economics in 2005.

Jordi Vaquer i Fanés is the Director of CIDOB, an international relations think tank based in Barcelona, since December 2008. He is the coordinator of EU4Seas, a European Commission funded research program bringing together partner institutions from 8 European countries to study the effects of EU policies on cooperation around the Mediterranean, Baltic, Caspian and Black Seas. Dr. Vaquer entered the CIDOB staff as the Europe Programme Coordinator in 2007. Prior to this he worked in the international affairs department of the Government of Catalonia, where he served in the Europe and in the Asia and Mediterranean sections before he became the Head of the International Relations Office. He also has professional experience as a guest lecturer of international relations at the London School of Economics and Political Science, as an observer in elections in 7 different countries, and as a junior consultant in European Commission-funded projects. Most of his publications in English and Spanish focus on Spanish foreign policy, relations between the European Union and the countries of the Maghreb, and the conflict of Western Sahara. Dr. Vaquer i Fanés received a master's degree from the College of Europe in Bruges, Belgium, and he completed a Ph.D. in International Relations at the London School of Economics in 2004.

Pere Vilanova is the Director of the Division of Strategic and Security Affairs at the Ministry of Defence, Madrid. He is a Professor of Political Science and Administration. He was a visiting scholar at the Institute for Policy Studies, Washington (1982 and 1988), Autonomous University of Mexico (1979), London School of Economics (1986), Faculty of Law and Politics, Nanterre (University of Paris IX) (1994 and 1995), University of Grenoble (1990), Center for International and Strategic Studies, University of Paris I (2000 and 2001), University of Belgrade, University of Montenegro, among others. Between 1991 and 1992 he worked as a legal adviser to the Parliament of Andorra for the Draft of the Constitution, adopted in March 1993. Since November 1993 to December 2003 he was a Judge at the Constitutional Court of Andorra and the President of that Court for the period 2000-2001. His professional experience also includes legal advising to the EUAM (European Union Administration of Mostar). Pere Vilanova is the author of numerous publications on security and defence issues.
