#### PART B

CHANGES EFFECTED BY ORDER OF THE SECRETARY OF STATE FOR THE ENVIRONMENT UNDER PART IV OF THE LOCAL GOVERNMENT ACT 1972

The following Orders altering the boundaries of Parishes or Districts or creating new Parishes or abolishing Parishes came into effect on or before 1 April 1988.

#### AVON

The Northavon (Parishes) Order 1988. (S.I. 1988 No.112)

This Order transfers areas between parishes in the district of Northavon.

#### BUCKINGHAMSHIRE

The Milton Keynes (Parishes) Order 1988 (S.I. 1988 No. 501)

This Order affects parishes and the unparished areas in the borough of Milton Keynes. It:-

- (a) transfers areas between parishes;
- (b) transfers areas between parishes and the unparished areas; and
- (c) abolishes the parish and parish council of Tyringham with Filgrave.

The Wycombe (Parishes) Order 1988 (S.I. 1988 No. 181)

This Order transfers a small area from the parish of Hazlemere to the parish of Chepping Wycombe within the district of Wycombe.

#### CHESHIRE

The Cheshire (District Boundaries) Order 1988 (S.I. 1988 No. 70)

This Order transfers an area within the county of Cheshire from the district of Vale Royal and parish of Delamere to the City of Chester and the parish of Kelsall.

The Vale Royal (Parishes) Order 1988. (S.I. 1988 No. 291)

This Order affects parishes in the district of Vale Royal. It:-

- (a) creates 2 new parishes and parish councils of Anderton with Marbury, and Whitegate and Marton;
- (b) transfers areas between parishes; and
- (c) abolishes the parishes of Anderton, Marbury, Marton and Whatcroft.

#### DERBYSHIRE

The Derbyshire (District Boundaries) Order 1988. (S.I. 1988 No.71)

#### This Order -

(a) transfers areas between the borough of Chesterfield and the district of North East Derbyshire; and

(b) makes consequential changes to parishes and electoral areas in those districts.

#### DEVON

The Devon (District Boundaries) Order 1987 (S.I. 1987 No. 1576).

This order transfers areas between the City of Exeter and the districts of East Devon and Teignbridge. The parishes affected are Broad Clyst, Brampford Speke, Clyst St. George, Sowton and Upton Pyne in the district of East Devon and Exminster, Holcombe Burnell and Ide in the district of Teignbridge. (The City of Exeter has no parishes).

The East Devon (Parishes) Order 1987. (S.I. 1987 No. 1600).

This Order transfers within the district of East Devon an area of the parish of Woodbury to the parish of Clyst St. George.

#### DORSET

The Dorset (District Boundaries) Order 1987 (S.I. 1987 No. 2228).

This Order transfers areas between the districts of North Dorset and Purbeck in the county of Dorset. Parishes affected are Anderson and Winterbourne Kingston in the district of North Dorset and Bere Regis and Bloxworth in the district of Purbeck.

#### ESSEX

The Essex (District Boundaries) Order 1987 (S.I. 1987 No. 1598)

This Order transfers an area of the district of Braintree and parish of Witham to the district of Maldon and parish of Wickham Bishops.

The Epping Forest (Parishes) Order 1987 (S.I. 1987 No. 1883).

This Order transfers an area within the district of Epping Forest from the parish of Waltham Abbey to the parish of Nazeing.

#### HEREFORD AND WORCESTER

Hereford and Worcester (District Boundaries) Order 1988. (S.I. 1988 No. 259).

This Order transfers areas between the district of Leominster and parishes of Letton, Whitney-on-Wye and Willersley and Winforton and the district of South Herefordshire and parishes of Bredwardine and Clifford. Consequential changes to local government electoral areas are made.

South Herefordshire Parishes) Order 1988. (S.I. 1988 No. 180)

This Order transfers areas between parishes in the district of South Herefordshire.

#### KENT

The Canterbury (Parish of Chestfield) Order 1988. (S.I. 1988 No. 113)

This Order creates a new parish and parish council of Chestfield in the City of Canterbury.

Tonbridge and Malling (Parishes) Order 1988. (S.I. 1988 No. 515)

This Order transfers areas between parishes, and between the parish of Hildenborough and the unparished area, within the borough of Tonbridge and Malling.

#### LEICESTERSHIRE

The Leicestershire (District Boundaries) Order 1987. (S.I. 1987 No. 2247).

This Order transfers areas between the district of Blaby and the City of Leicester, and transfers an area from the borough of Oadby and Wigston to the district of Blaby.

#### NORFOLK

The King's Lynn and West Norfolk (Parishes) Order 1988. (S.I. 1988 No. 62)

This Order affects parishes and the unparished area in the borough of King's Lynn and West Norfolk. It:-

- (a) creates four new parishes of Walpole, Walpole Cross Keys, Walpole Highway and Wiggenhall St Germans;
- (b) transfers areas between parishes;
- (c) transfers areas between the parishes of Bawsey and Grimston and the unparished area; and
- (d) abolishes the parishes of Walpole St Andrew, Walpole St. Peter, Wiggenhall St Germans and Wiggenhall St Mary the Virgin.

#### NORTHAMPTONSHIRE

The Northamptonshire and Oxfordshire (County Boundaries) Order 1988. (S.I. 1988 No. 241).

This Order transfers areas between the county of Northamptonshire and the district of South Northamptonshire and the county of Oxfordshire and the district of Cherwell.

The Northamptonshire and Warwickshire (County Boundaries) Order 1988. (S.I. 1988 No. 314).

This Order transfers areas between the county of Northamptonshire and district of Daventry and the county of Warwickshire and borough of Rugby.

The East Northamptonshire (Parishes) Order 1987. (S.I. 1987 No. 1966).

This Order affects parishes in the district of East Northamptonshire. It:-

- (a) creates a new parish and parish council of Duddington-with-Fineshade;
- (b) transfers areas between parishes; and
- (c) abolishes the parishes and parish authorities of Duddington and Fineshade.

#### NORTH YORKSHIRE

Harrogate (Parishes) Order 1988. (S.I. 1988 No. 111).

This Order affects parishes and the unparished area in the borough of Harrogate. It:-

- (a) creates the following 6 new parishes by the amalgamation of parishes: Hutton Conyers, Long Marston, North Stainley with Sleningford, Nun Monkton, Ripon, Rufforth;
- (b) transfers areas between parishes;
- (c) transfers an area from the parish of Kirkby Overblow to the unparished area; and
- (d) abolishes the following parishes:

Hutton Conyers, Nunwick cum Howgrave, Angram, Hutton Wandesley, Long Marston, North Stainley with Sleningford, Sutton Grange, Nun Monkton, Widdington, Clotherholme, Ripon, Knapton, Rufforth.

#### NOTTINGHAMSHIRE

The Nottinghamshire (District Boundaries) Order 1988. (S.I. 1988 No. 61).

This Order transfers areas between the unparished area of the district of Ashfield and the borough of Gedling and the parishes of Linby and Papplewick in that borough.

The Newark and Sherwood (Parishes) Order 1988. (S.I. 1988 No. 326).

This Order affects parishes in the district of Newark and Sherwood. It:-

- (a) creates a new parish and parish council of Rainworth;
- (b) transfers areas between parishes; and
- (c) abolishes the parish of Haywood Oaks.

#### SHROPSHIRE

The Shropshire (District Boundaries) Order 1987 (S.I. 1987 No.1737).

This Order transfers areas from the borough of Shrewsbury and Atcham and the parishes of Astley and Pimhill to the district of North Shropshire and the parish of Hadnall.

The North Shropshire (Parishes) Order 1988. (S.I. 1988 No. 293).

This Order affects parishes in the district of North Shropshire. It:-

- (a) creates 3 new parishes and parish councils of Lyneal and Welshampton, Moreton Corbet and Lee Brockhurst, and Myddle and Broughton;
- (b) transfers areas between parishes; and
- (c) abolishes the parishes of Broughton, Lee Brockhurst, Moreton Corbet, Myddle and Welshampton.

The Wrekin (Parishes) Order 1988 (S.I. 1988 No. 156).

This Order affects parishes and the unparished area in the district of The Wrekin. It:-

(a) creates 16 new parishes from areas of parishes and the unparished area, and parish councils for those parishes; following are new parishes:

Chetwynd Aston, Church Aston, Dawley Hamlets, Great Dawley, Hollin swood and Randlay, Lawley and Overdale, Madeley, Oakengates, Rodington, Stirchley and Brookside, St Georges and Priorslee, The Gorge, Tibberton and Cherrington, Waters Upton, Wellington, Wrockwardine Wood.

- (b) transfers areas between parishes;
- (c.) transfers areas from the unparished area to parishes; and
- (d) abolishes parishes:

Bolas Magna, Cherrington, Chetwynd Aston, Church Aston, Longdon on Tern, Longford, Rodington, Tibberton, Waters Upton and Woodcote.

#### SOMERSET

The South Somerset (Parishes) Order 1987. (S.I. 1987 No. 1780).

This Order transfers part of the district of South Somerset from the parish of Holton to the parish of North Cheriton.

#### ST .AFFORDSHIRE

The Stafford (Parishes) Order 1988. (S.I. 1988 No. 129).

This Order affects parishes and the unparished area in the borough of Stafford by:-

- (a) transferring areas between parishes; and
- (b) transferring areas from the unparished area to parishes.

The Staffordshire Moorlands (Parishes) Order 1988. (S.I. 1988 No. 292).

This Order affects parishes in the district of Staffordshire Moorlands by -

- (a) creating two new parishes of Caverswall and Werrington,
- (b) transferring areas between parishes, and
- (c) abolishing the parish of Caverswall and Werrington.

The Cannock Chase (Parishes) Order 1987 (S.I. 1987 No. 2259).

This Order creates 6 new parishes in the district of Cannock Chase. Parish councils are established for each new parish. The new parishes are as follows:

Brereton, Bridgtown, Cannock Wood, Heath Hayes and Wimblebury, Norton Canes, Rugeley,

#### SUFFOLK

The Babergh (Parishes) Order 1988 (S.I. 1988 No. 154).

This Order transfers areas between parishes in the district of Babergh.

The St. Edmundsbury (Parishes) Order 1988. (S.I. 1988 No. 325).

This Order affects parishes and the unparished area in the borough of St. Edmundsburg. It -

- (a) creates 3 new parishes of Bradfield Combust with Stanningfield, Rushbrook with Rougham, and The Saxhams;
- (b) transfers areas between parishes, and between parishes and the unparished area; and
- (c) abolishes the parishes of Great Saxham, Hardwick, Little Saxham, Monks Risbridge, Rushbrooke, Rougham and Stanningfield.

#### WARWICKSHIRE

The Stratford-on-Avon (Parishes) Order 1988 (S.I. 1988 No. 130)

This Order affects parishes in the district of Stratford-on-Avon. It -

- (a) creates 3 new parishes: Hodnell and Wills Pastures, Radbourn, and Upper and Lower Shuckburgh;
- (b) transfers areas between parishes; and
- (c) abolishes the parishes of Hodnell, Lower Radbourn, Lower Shuckburgh, Upper Radbourn, Upper Shuckburgh, and Wills Pastures.

#### WEST MIDLANDS

The West Midlands (District Boundaries) Order 1988 (S.I. 1988 No. 315)

This Order makes transfers between the City of Birmingham and the Borough of Solihull. It affects the parishes of Castle Bromwich and Fordbridge in the Borough of Solihull.

#### WEST SUSSEX

The Mid-Sussex (Parishes) (No.2) Order 1987. (S.I. 1987 No. 2165)

This Order transfers part of the parish of Haywards Heath in the district of Mid-Sussex to the parish of Cuckfield Rural.

#### WEST YORKSHIRE

The Bradford (Parishes) Order 1988 (S.I. 1988 No. 155)

This Order creates 2 new parishes, called Cullingworth and Oxenhope and parish councils for those parishes, in the City of Bradford.

The Kirklees (Parish of Mirfield) Order 1987 (S.I. 1987 No. 2164)

This Order creates a new parish and parish council of Mirfield in the Borough of Kirklees. A consequential change to borough electoral areas is made.
