15% Goal

- 1. An independent business;
- 2. In operation for a minimum of 4 years;
- 3. Principal place of business located in the state of Nevada;
- 4. Has all necessary Nevada licenses and registrations;
- 5. Annual revenues for the preceding 3 years has not exceeded:
 - a) \$20M in public works construction
 - b) \$10M in construction, goods, materials, equipment and general services contracts
 - c) \$2.5M in professional service, architectural and engineering services
 - d) \$3.5M in trucking
