

**Minute of IQAC meeting held on 16.8.2019**

**1. Conduct of IA test of 15 marks and test duration for 2018-19 batch and**

**2. Conduct of Quiz/Seminar/course activity**

The CIE pattern proposed for 2018-19 was discussed and finally it was decided that the complete CIE will be conducted for 100 marks having marks split as following:

IA test 1	30 marks
IA test 2	30 marks
Assignment 1	10 marks
Assignment 2	10 marks
Quiz/Seminar/Course activity	20 marks
Total	100 marks

- a. Provision for entering the marks individually for each component mentioned above will be made in the software.
- b. 100 marks will be reduced to 50 marks for the final grading.
- c. IA test paper will have two parts, Part-A and Part-B. Part-A of 5 marks having objective questions and Part-B of 25 marks will have the description type questions. The duration of the test will be 1 hour and 15 minutes. No choice in Part-A and Choice in Part-B.
- d. Two separate assignments each of 10 marks. Assignments questions should focus on checking the understanding and application of the concepts (L2 and L3) and not the remembering skill (L1). Hence, it shall consist of derivations, unsolved problems and analysis of case studies (L2, L3 and L4).
- e. As IA test paper contains the objective questions, only Seminar or Course project will be conducted for 20 marks in each course. Students themselves can form the batches each consisting of 2 to 4 students. Students will have the option of selecting either seminar related to the respective course or course project. Faculty members can also announce the list of seminar topics and course projects. It will be evaluated for 20 marks by the concerned faculty member or team of faculty members teaching that course.

**3. Quiz for 5<sup>th</sup>/7<sup>th</sup> semester BE students**

Quiz shall be conducted as per the standard format presently practiced.

**4. CP marks for 5<sup>th</sup>/7<sup>th</sup> semester students**

Class Performance marks will be based on the Seminar or Course Project. Students themselves can form the batches each consisting of 2 to 4 students. Students will have the option of selecting either seminar related to the respective course or course project. Faculty members can announce the list of seminar topics and course projects. It be evaluated for 10 marks by the concerned faculty member or team of faculty members teaching that course.

**5. Attendance requirement for IA test**

It was proposed that atleast 60% of attendance could be made compulsory for attending the IA test of respective course. As minimum 75% is the requirement before condonation, it was suggested to have 75% attendance. However, the implementation should be uniform.

**6. Observations of the autonomous visit by VTU**

IQAC members suggested that the

- COs and PEOs to be defined properly.
- Proper mention and mapping of the POs with COs in the syllabus copy, IA test paper and SEE question paper.
- Mentioning of the department, course title, course code, duration, notes on the IA test paper.
- Improving the quality of IA test and SEE question paper. As mentioned above for assignments, the question paper should focus on checking the understanding and application of the concepts (L2, L3 and L4 level) and not much on the remembering skill (L1 level).

HODs, faculty members and department IQAC members are requested to note the same.

**7. Undertaking regarding Swapping of the semester to be signed by the student and faculty was presented**

It was suggested to mail the same to the departments and the concerned students shall be informed about the same.

### **1.Mixing of Questions for SEE :**

It was decided that the mixing of question paper will be continued. It was discussed that it is the responsible of the faculty member to submit the question paper correct in all the aspects i.e. Course content, OBE levels, marks and only External Security of question paper will be conducted.

### **2.Quality of SEE question paper :**

The verification of the IA test question paper done by IQAC, Mechanical department was appreciated. It is requested that such activity should be taken up in all the departments. The verification of IA test question paper is just not limited to checking the levels (based on the words) but the content of the question paper and the solution expected from the students. This process would help to improve the quality of SEE question paper. The SEE question paper should focus more on problem solving and analysis rather than just remembering and reproducing the answer.

### **3.Valuation of scripts :**

The valuation of answer script will not be division wise but will be done by any faculty expert in that course.

### **4.Special IA test for 1<sup>st</sup> and 3<sup>rd</sup> sem students who have missed one of the IA tests and attendance is more than 75% :**

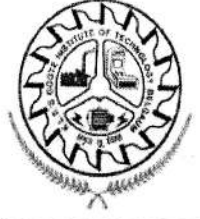
