- 7. New applications to vote by post and requests to cancel or change an existing postal or proxy vote must reach the ELECTORAL REGISTRATION OFFICER at ROOM 45, COUNTY HALL, WAKEFIELD, WEST YORKSHIRE, WF1 2QW by **5pm on Wednesday, 8 June 2022**, if they are to be effective for this election.
- 8. New applications to vote by proxy except on the grounds of an emergency must reach the ELECTORAL REGISTRATION OFFICER at ROOM 45, COUNTY HALL, WAKEFIELD, WEST YORKSHIRE, WF1 2QW by **5pm on Wednesday**, **15 June 2022**, if they are to be effective for this election.
- 9. Applications to vote by proxy on the grounds of physical incapacity or for work/service reasons must reach the ELECTORAL REGISTRATION OFFICER at ROOM 45, COUNTY HALL, WAKEFIELD, WEST YORKSHIRE, WF1 2QW by 5.00pm on Thursday, 23 June 2022. The physical incapacity must have occurred after 5pm on Wednesday, 15 June 2022. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 15 June 2022.
