BY virtue of the provisions of the Crown Lands Act, 1929-1968, and all other enabling powers, I, the said Governor, with the advice and consent of the Executive Council, do hereby:—

1. Resume the lands defined in the first schedule hereto, being the whole of the lands which were, by a proclamation published in the *Government Gazette* of the 8th day of October, 1953, at page 937, third appearing, dedicated for the purposes of a wireless base reserve.

2. Resume the lands defined in the second schedule hereto, being the whole of the lands which were, by a proclamation published in the *Government Gazette* of the 15th day of February, 1962, at page 294, dedicated for the purposes of a recreation reserve.

3. Dedicate the Crown lands defined in the third schedule hereto as a reserve for recreation purposes and declare that such lands shall be under the care, control and management of the district council of Murat Bay.

**THE THIRD SCHEDULE**

1. Declare that the Crown lands defined in the schedule hereto shall be a national park.

2. Declare that the said national park shall be known by the name of "Piccaninnie Ponds National Park."

**CROWN LANDS ACT, 1929-1968: HUNDRED OF YADNARIE—HOSPITAL RESERVE RESUMED AND FAUNA PARK RESERVE RESERVED**

BY virtue of the provisions of the Crown Lands Act, 1929-1968, and all other enabling powers, I, the said Governor, with the advice and consent of the Executive Council, do hereby:—

1. Cancel land grant register book, volume 1621, folio 159, of land for hospital purposes, as regards the lands defined in the first schedule hereto.

2. Resume the lands defined in the first schedule hereto, being the portion of the lands which were, by a proclamation published in the *Government Gazette* of the 31st day of May, 1917, at pages 885 and 886, reserved for hospital purposes.

3. Reserve the Crown lands defined in the second schedule hereto as a fauna park reserve and declare that such lands shall be under the care, control and management of the district council of Cleve.

**THE FIRST SCHEDULE**

That portion of hospital reserve, section 388, hundred of Yadnarie, county of Jervois, bounded as follows:—Commencing at a point on the southern boundary of section 388, hundred of Yadnarie, distant 27.6 links westerly from its south-eastern corner; thence westerly along portion of the said southern boundary for 203.1 links; north-north-easterly through section 388 at a north-eastern angle of 81° 53' for 102.9 links; north-easterly at a south-eastern angle of 135° 18' for 70.4 links; easterly at a south-eastern angle of 145° 34' for 102.3 links; thence south-south-easterly at a south-western angle of 98° 44' to the point of commencement.
