Early Care and Development Grant March 2018 Report



This grant is a great way to close that gap between cost of program and subsidy awards. It makes a difference in enabling us to continue serving these families.

The Vermont Legislature and Governor appropriated \$2.2 million dollars in the 2018 State Fiscal Year Budget to fund Early Care and Development Program (ECDP) Grants. The Child Development Division (CDD) is responsible for administering these grants.

ECDP Grants are meant to:

- Support early care and development programs serving low income families and young children in Vermont, particularly those serving infants and toddlers.
- Reduce the burden of co-payments on families and providers participating in the Child Care Financial Assistance Program (CC FAP)
- Help early care and development programs provide quality services that promote children's development and well-being and strengthen families


Programs Receiving Grants

465 child care programs received a grant in October and/or January, and an average of 4,750 children receiving Child Care Financial Assistance were served by these programs. Of the programs receiving a grant 148 were center based and 317 were family child care homes. Grants to center-based programs varied from \$617.50 to \$17,372.33, while grants to family child care homes ranged from \$202.50 to \$1,653.75.

Summary of Reports

91% of the programs receiving a grant completed the required report on how they spend the funds between January and March 2018. Those programs spent the funds in a variety of ways. The most common way the funds were spent was on equipment and materials for the child care program. Additional ways include,



ensuring a balanced budget, making improvements, helping families financially, and supporting staff.

44% of programs indicated in the report that they used the funds to reduce families' co-payments. However, approximately 50% more programs indicated in comments or through conversations with the grant manager that they typically discount their tuition for families receiving Child Care Financial Assistance (CCFAP). Since these programs lose money in that discount they often do not have the funds to pay staff well or buy necessary supplies. These grants enabled the programs to purchase some of those necessities. In addition, three programs indicated that without these grants they would have closed their programs this year due to lack of funds.

Early Care and Development Program Grant Report Details

Programs Eligible

Center Based Child Care and Preschool Programs (Centers) and Family Child Care Homes (Homes) that participate in VT STARS (at any STAR level) and provide services to a high number of CC FAP eligible children, particularly CC FAP eligible infants and toddlers are eligible to receive funds. The number of grants and how much programs get is limited by available funds and determined by applying the same formula to all qualifying programs every three months. Participation in other grant programs does not have any effect on eligibility for these grants. Fund Distribution

CC FAP data indicates that 70% of children participating in CC FAP are enrolled in Centers and 30% are enrolled in Homes. Therefore 70% of available funds are granted to Centers and 30% of available funds are granted to Homes.

Program Selection

Using CC FAP billing data and licensed capacity, a formula is applied to all qualifying programs to create a score. This score is used to determine where on the list a program falls for receiving a grant. The highest score is the program who has priority to receive a grant, and so on. The grants are paid out to programs based on priority until the money allocated for the quarter is spent.

A formula is applied across all qualifying programs every three months that includes these weighted factors:

- Percent of CC FAP children attending to licensed capacity of the program (70%)
- Average number of CC FAP children attending (15%)
- Average number of infants and toddlers attending (15%)


Grant Report Details

Child care programs who received a grant in the first half of the fiscal year were required to submit a report in January 2018 by answering a simple survey. 433 child care programs received a grant in October, and 406 programs received a grant in January. 423 of the programs completed the report, of those 142 of the 148 licensed center based programs who received a grant reported and 281 of the 317 family child care homes who received a grant reported.

Survey Results

There were no restrictions on how the funds could be spent for programs. Most programs used the funds in 3 or more ways. Most activities were used to support families and to maintain or improve the quality of their programs.

Programs also indicated the money was spent in additional ways including paying for liability insurance, expanding their program to serve more children, purchasing gifts and supplies for children in their care, offering family events, and providing some tuition assistance for struggling families.



Ways Programs Used Funds to Help Families

201 programs indicated that the grant funds helped families in some way, including enrolling more families eligible for CC FAP and reducing co-payments for families. Programs indicated they used the funds in additional ways the funds helped families, including:

- Added staff to reduce the ratio of students to teacher and improve quality.

- Three programs Because we didn't lose money last year 2017 we were able to remain open. We serve up to 59 children 46% of whom are on subsidy. If our program didn't meet budget, we might not have been able to stay open.
- Four programs indicated the funds helped obtain the necessarily supports and equipment needed for children with special needs.
- Purchased high quality winter gear/clothing for children in care whose families could not afford it.
- Five programs indicated the funds eliminated the need to increase the program's rates charged to families
- Three programs used the funds to incorporate some changes needed to obtain more stars, which has lowered the co-payments for families.
- Eight programs indicated the funds helped offset the loss taken by the program when families cannot pay the co-payment.


- Two programs Provided transportation for families who were unable to get their children to child care.
- Two programs indicated they held family activities in the evening to support families.

Many programs that did not indicate using the funds to reduce co-payments, indicated that the funds were used to purchase materials or fund activities they would not have been able to afford because they are keeping rates low for the families in their care.

Importance of Grant to Programs

Programs were asked to rate the grant funds in importance to their program on a scale of one to ten, with one being helpful but not important, and 10 being critical to helping the program. The average rating was 7.85.

- 321 programs (76%) indicated that the grant was between very important and critical to their program.
- 69 programs (16%) indicated that the grant was important to their program.
- 33 programs (8%) indicated that the grant was helpful but not important or somewhat important to their program.

- These grant funds are unexpected and so appreciated. We used 50% of the first check for staff bonuses and materials needed to satisfy ITERS/ECERS (environmental rating scale) requirements. Have not yet received the second check.

After 3 on-time payments, they will have earned a free "payment" that they can use immediately or bank to use later when a family "emergency" might arise. This seems to relieve a huge burden for them.

- These funds were used mostly to purchase materials and furniture for our classrooms that was very much needed and not necessarily budgeted for because we were not sure we could afford them.

- This grant is critical to the Family Center in many ways: 1) Allows for additional staffing to provide heightened levels of interaction for the 8 infants we serve that all meet higher risk definitions under our Contracted Spaces agreement with CDD. 2) Allows greater interaction (social connections) between staff and parents which builds parental resiliency. 3) Affords the Family Center the ability to provide excellent infant care balanced with administrative demands.

- We paid out \$2200 in bonuses at Christmas, and \$928 in Professional Development in December and covered a stone step with wood for \$700.
- These funds enabled us to establish a program for our families where they can earn "free" weeks of care for making a set number of payments on time. This helps when they encounter family emergencies and don't have funds to pay the copay one week.
- The fact that these funds come to us without having to spend time completing an application or writing an onerous grant report is very much appreciated!
- The grant funds were very important to helping our program not take a financial loss for tuition

that we lose out on when copays are not paid and 2 weeks is not given when children in DCF custody are relocated from the program.

Ours is not a business that can adjust costs to account for financial challenges. We can't cut staff, turn down the heat, cut grocery costs or charge more, like other businesses can. My next check will probably help me pay the salary increases I just had to give across the board just because I couldn't give my least trained staff an random raise and not my other staff. I don't even make minimum wage myself because I only get paid if we make profit and that rarely happens.
- The grant funds are critical. We had hoped to use them for bonuses or raises for staff, but with the challenges in the industry, it was critical to making sure that we operated at a loss that was under \$10k for the year instead of over that amount. We are struggling to retain and attract staff, whether qualified or not, we are struggling to keep classrooms open which hurts all families-not just those receiving support from CCFAP, and we are losing preschoolers to the public school programs who are then finding the remaining hours they need care in unregulated settings. This is the first year we have operated with openings in both of our preschool classrooms, and the leading cause has been families moving to the public school for pre-k.

- All the current staff were able to get a 3% raise. My staff had not had raises in many years. I have only had one raise in the past 7 1/2 years. Another 2 of our staff who has been here for 7 1/2 has had also only one raise. Other staff member here for 4 years, 3 years and 2 years had not had an increase in their pay since they started.
- More than 80% of our families currently benefit from CCFAP. This grant has allowed us to continually support them by not putting them in a position where they need to decide between reducing their their child's attendance hours (leading to a loss of socialization and education), and being able to afford their co-pay. We were able with this grant to support families with transportation to and from our center, we were able to build a supply of gross motor equipment that all our classrooms can utilize during the cold winter days. We also have been able to support our employees with adjusted deserving rates to remain competitive.
