ADVOCACY & ENGAGEMENT

In 2020, Global Health Council was more active than ever in working with Congress, the Trump Administration, the Biden-Harris Transition Team, the World Health Organization, and other multilateral organizations to not only emphasize the ever-growing need to improve health systems, but to also maintain the successful trajectory of many global health programs led by the United States and multilateral organizations. GHC was also hard at work advocating for opportunities for non-state actors to collaborate alongside global health experts at home and abroad. This work specifically included tireless advocacy with Congress and the Administration; the launch of the New Vision for Global Health; and participation in the World Health Assembly and WHO's Executive Board virtual meetings.

- **Advocated for the Global Health Security Act**
- **Continued outreach for increased global health funding**
- **Met with policymakers to discuss funding levels, the emergency COVID-19 response, and continued engagement with the World Health Organization and other multilateral entities**
- **Coordinated with other coalitions to advocate for emergency supplemental funding for the global health and humanitarian response to COVID-19**
- **Developed a WHO and COVID-19 clearinghouse on the GHC website**
- **Led a delegation of more than 40 people for the 73rd World Health Assembly**
 - *Drafted several statements*
- **Led delegation to 148th World Health Organization Executive Board Meeting**
- **Advocated with G-20 sherpas about the need for a global response to COVID-19**
- **Convened the global health community to hear from experts at USAID, CDC, and World Health Organization**
- **Worked alongside other global health advocates to encourage equitable access to care and the eventual COVID-19 vaccine**

Global Health Council led a series of virtual town halls to provide a space for community dialogue on the collective response to the COVID-19 pandemic. Members and partners discussed how to approach global health advocacy at a pivotal moment and considered the short- and long-term challenges and opportunities.

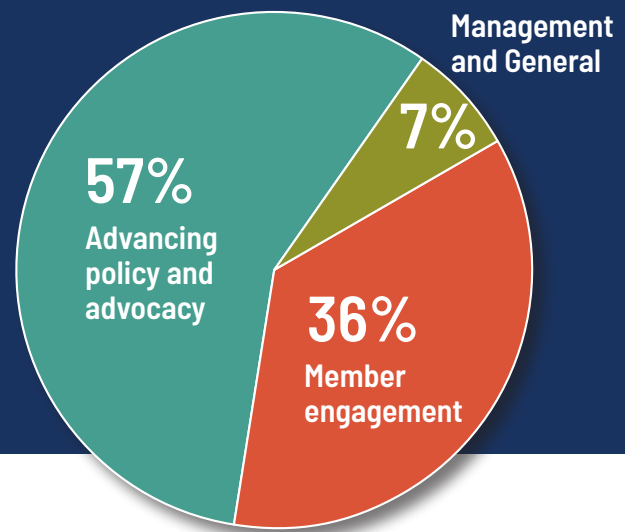
