Clothing & Advertising	<p>Clothing and advertising will be permitted in accordance with the competition regulations of the Badminton World Federation. (GCR 20 - 24)</p> <p>The player's name on the back of the clothing shall be identical to the name registered as the Last Name (or an abbreviation thereof) in the BWF Player database. Last Name is defined as the family name, surname or similar name under the respective naming protocol of the Member count. (GCR 23.3)</p> <p><u>MANDATORY CLOTHING REGULATIONS</u></p> <ol style="list-style-type: none"> 1. Name of the player is MANDATORY from the first day of the event. 2. From Quarter Finals onwards, doubles partners must wear clothing of the same color. 3. From Quarter Finals onwards, opposing players must wear clothing of significantly different colors.

<p>Doping Control</p>	<p>Doping Tests may be conducted randomly throughout the tournament. Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.</p> <p>Athletes are responsible for any substance found in their bodies. <p>Badminton Integrity</p>	<p>Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.</p> <p>To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.</p>

COVID 19 Protocols	<p>RESTRICTIONS & COVID PROTOCOL:</p> <p>IMPORTANT Note: Covid-19 protocols for this tournament may be subject to change from time to time based on the latest Indonesia immigration, border entry and control policies. Any such changes or amendments will be communicated to all participants (via their respective Member Associations).</p> <p>General Instructions:</p> <p>1. Entry requirements:</p> <p>ONLY Fully Vaccinated Players and Officials, with Vaccination Record Cards, are allowed to enter Indonesia.</p> <p>Passengers should fill the Traveler's Health Declaration before arrival and download application PeduliLindungi and register your COVID-19 vaccine certificate.</p> <p>** If you plan to fly domestically from Jakarta to Malang, please pay attention to below additional requirements :</p> <p>Domestic travelers traveling by air, sea, land transportation modes using private or public vehicles, crossings, and intercity trains from and to regions throughout Indonesia, must comply with the following provisions:</p> <ul style="list-style-type: none"> • Domestic travelers who have received the third dose of vaccination (booster) is not required to show a negative result of the RT-PCR test or rapid antigen test;

- Domestic travelers who have received only the first dose or the second dose of vaccination are required to show a negative result of the RT-PCR test whose sample is taken within 3 x 24 hours before departure;
- Domestic travelers with special health conditions or comorbid diseases that prevent them from receiving vaccinations are exempt from the vaccination requirements, but must show a negative rapid antigen test result whose sample is taken within 1 x 24 hours or a negative RT-PCR test result whose sample is taken within 3 x 24 hours before departure as well as attach doctor's certificate from a Government Hospital stating that the person concerned has not and/or is unable to take part in the COVID-19 vaccination

2. Those who need PCR tests to return to their respective countries can arrange it with the organization during the event (payment will be the person's full responsibility).

3. Insurance

Those athletes and officials who are arriving in Indonesia are advisable to have covid-19 and international insurance for any incident.

Please be aware that the tournament takes place during the current pandemic situation with COVID-19. The conditions for hosting the tournament, as well as hygiene, sanitary and preventive measures will be determined by the local authorities and BWF at all times.

All participants are required to follow the rules and guidelines of the BWF, LOC and local authorities as a condition for participating in the tournament. If the local authorities require it, each participant may have to deliver a responsible declaration before participating in the tournament. Stay at the official hotel provided by LOC.

Should the event be cancelled with short notice by the country's authorities, due to the COVID-19 situation, beyond the control of both Badminton World Federation, Badminton Asia and/ or the local organizers, neither of them will be liable for any costs related to travelling or accommodation made by players/officials for this event.
