INTRODUCTION

Gordon Campbell was elected on May 16, 2001 and sworn in as Premier June 5, 2001, taking over from Ujjal Dosanjh. Campbell was chosen leader of the Liberal Party of British Columbia by a vote at the convention held on September 11, 1993 in Vancouver (*Vancouver Province*, 12 September 1993, "Campbell Rides New Grit Wave: First-Ballot Victory for Mayor," A4). First elected to the Legislative Assembly on February 17, 1994 after winning a Vancouver-Quilchena by-election, Campbell initially served in Opposition. He was later re-elected in 1996, 2001, 2005 and 2009 in the riding of Vancouver-Point Grey.

The choice of dates for the commencement and termination of a position is not straightforward because an appointment or resignation may be announced on one date and confirmed officially on a different date. Generally the "official" date has been preferred in this document, with mention in the footnote of any other date(s) involved. If, however, there was no Order in Council (OIC) or other official notice specifically naming the minister involved, the announcement date has been used.

A list of ministers who have been designated to assume the status of acting minister in the case of absence or illness, etc. of the regularly appointed minister (not for vacant positions) is published in an OIC at irregular intervals, generally after a cabinet reorganization. These acting appointments are not covered in this document as they are for administrative purposes only. According to Bruce DeBeck, Manager of the Order in Council Administration, the people named in these OICs do not "act" in a portfolio after it has become vacant because of the death or resignation of a minister. Similarly, although ministers were sometimes asked by the premier to act in a portfolio after the resignation of the minister, unless this was confirmed by an OIC, such an appointment has not been considered official and has not been included in this document except in a footnote.

For the purposes of this document, the final date of service for cabinet ministers in the Dosanjh administration is June 5, 2001, the date Mr. Dosanjh's successor, Gordon Campbell, was sworn in as Premier. The OIC rescinding the appointment of cabinet ministers was issued on June 5, 2001, with the announcement of the new Campbell Cabinet. The OIC confirming the first appointment of cabinet ministers in Campbell's second term as Premier was issued on June 16, 2005. The OIC confirming the first appointment of cabinet ministers in Campbell's third term as Premier was issued on June 10, 2009. On November 3, 2010, Campbell announced his intention to resign after a new leader was selected at an upcoming Liberal leadership convention. Christy Clark was sworn in as Premier to replace Gordon Campbell on March 14, 2011.
