Fraud and Misrepresentation in Securitized Auto Loans (with Swarup Joshi). For this project, we seek to 1) identify misrepresentation and fraud at the loan-level in privately securitized auto loans, and 2) estimate the effect of misrepresentation on delinquency. To do so, we plan to apply fraud detection models developed in the context of securitized mortgages to securitized auto loans. We have secured a grant from the Institute of New Economic Thinking (INET GrantID: IN019-00011, \$48,083) to purchase a large data set of securitized autoloans, and are currently analyzing this data.
