Information for Contributors

Editorial Policy: Papers will be considered for publication on condition that they are submitted solely to The American Journal of Human Genetics and that they will not be reprinted or translated without consent of the editors. Each contribution will be read by two or more members of the editorial staff before notice is given of the paper's acceptance. Membership in the American Society of Human Genetics is not a prerequisite for publication in the Journal. Papers will be judged on the basis of their content of original data or interpretation, and no limit is set as to the number of printed pages which a paper may contain.

MANUSCRIPTS SHOULD BE TYPEWRITTEN DOUBLE-SPACED THROUGHOUT, INCLUDING REFERENCES, TABULAR MATERIAL, AND FOOTNOTES. FOOTNOTES AND LEGENDS FOR FIGURES AND PLATES SHOULD BE TYPED ON SHEETS SEPARATE FROM THE TEXT, AND A SEPARATE TITLE PAGE SHOULD BE PROVIDED. In addition to the original typewritten copy, a carbon or duplicate copy complete with figures, tables, and references is also needed.

Illustrations: Tables and illustrations should be planned to fit the Journal's type-page ($4\frac{3}{4} \times 7\frac{3}{4}$ inches). Exceptionally large tables and pedigree diagrams should be constructed in sections wherever possible, so as to avoid the need for folded inserts. Halftones and line drawings will be accepted in moderate numbers. Contributors will be expected to bear the excess cost of colored plates and part of the cost for excessive numbers of black-and-white illustrations and tables.

References to the literature should be cited in the text by author's name and date of publication; e.g. (Commons, Barker, and Shelton, 1950). The bibliography should be arranged alphabetically by author and should be typed double-spaced on a separate sheet under the heading: REFERENCES. The data for each reference should be arranged as follows:

COMMONS, R. R., BARKER, O. C., AND SHELTON, E. K. 1950. Sex-linked growth retardation and juvenile diabetes mellitus. *J. Clin. Endocr.* 10: 816-817.

Abbreviations for titles of medical periodicals should conform to the nomenclature adopted by the National Library of Medicine, as published in the *Index Medicus*.

Proofs and Reprints: Galley proofs and engraver's proofs will be sent to the author directly from Grune & Stratton, together with an order blank for reprints. The corrected proof and the reprint order should be sent directly to the Editor.

Membership

There are three classes of membership in the American Society of Human Genetics: active, corresponding, and associate. Active membership is open to any resident of Canada, Mexico, or the United States, who is interested in human genetic research. There are four classes of active membership: regular, sustaining, life, and patron. The annual dues, including subscription to the Journal, are \$15.00 for a regular member and \$20.00 for a sustaining member. Life members contribute \$200 and patrons \$500. Both memberships are for life and the Journal is received without additional annual charges. Corresponding membership is open to residents of foreign countries. Annual dues, including subscription to the Journal, are \$15.00. Bona fide medical and dental students and graduate students in biology may become associate members. Annual dues for associate members are \$3.00 but do not include a subscription to the Journal. Associate members who wish to receive the Journal may do so at the reduced annual rate of \$9.00 for dues and subscription. A husband-wife membership is available to active members who wish to receive only one copy of the Journal. Combined annual dues are \$19.00.

Candidates for membership must be recommended to the Secretary by a member of the Society. Election is by the Board of Directors.
