The Peterborough (Parishes) Order 2004

Made - - - - 29th March 2004

Coming into force in accordance with article 1(2)

The Secretary of State, in exercise of the powers conferred upon him by sections 14 and 23 of the Local Government and Rating Act 1997(a), and of all other powers enabling him in that behalf, hereby makes the following Order, which gives effect (without modifications) to recommendations made to him by the Peterborough City Council, following a review conducted by them in accordance with Part II of that Act, for the alteration of areas of parishes and the abolition of a parish within the district of Peterborough:

Citation, commencement and interpretation

- 1.-(1) This Order may be cited as the Peterborough (Parishes) Order 2004.
- (2) It shall come into force on 1st April 2004.
- (3) In this Order –

“the map” means the map prepared by the Office of the Deputy Prime Minister, marked “Map of the Peterborough (Parishes) Order 2004” and deposited in accordance with regulation 6(1) of the Local Government (Parishes and Parish Councils) Regulations 1999(b).

Abolition of the parish of Stanground North

2. The parish of Stanground North shall be abolished.

Alteration of parish areas

3. Each area delineated in red and designated by a letter on each map and specified by reference to that letter in column (1) of the Schedule shall cease to be part of the parish or unparished area specified in relation to that area in column (2) and shall become part of the parish or unparished area specified in column (3).

(This note is not part of the Order)

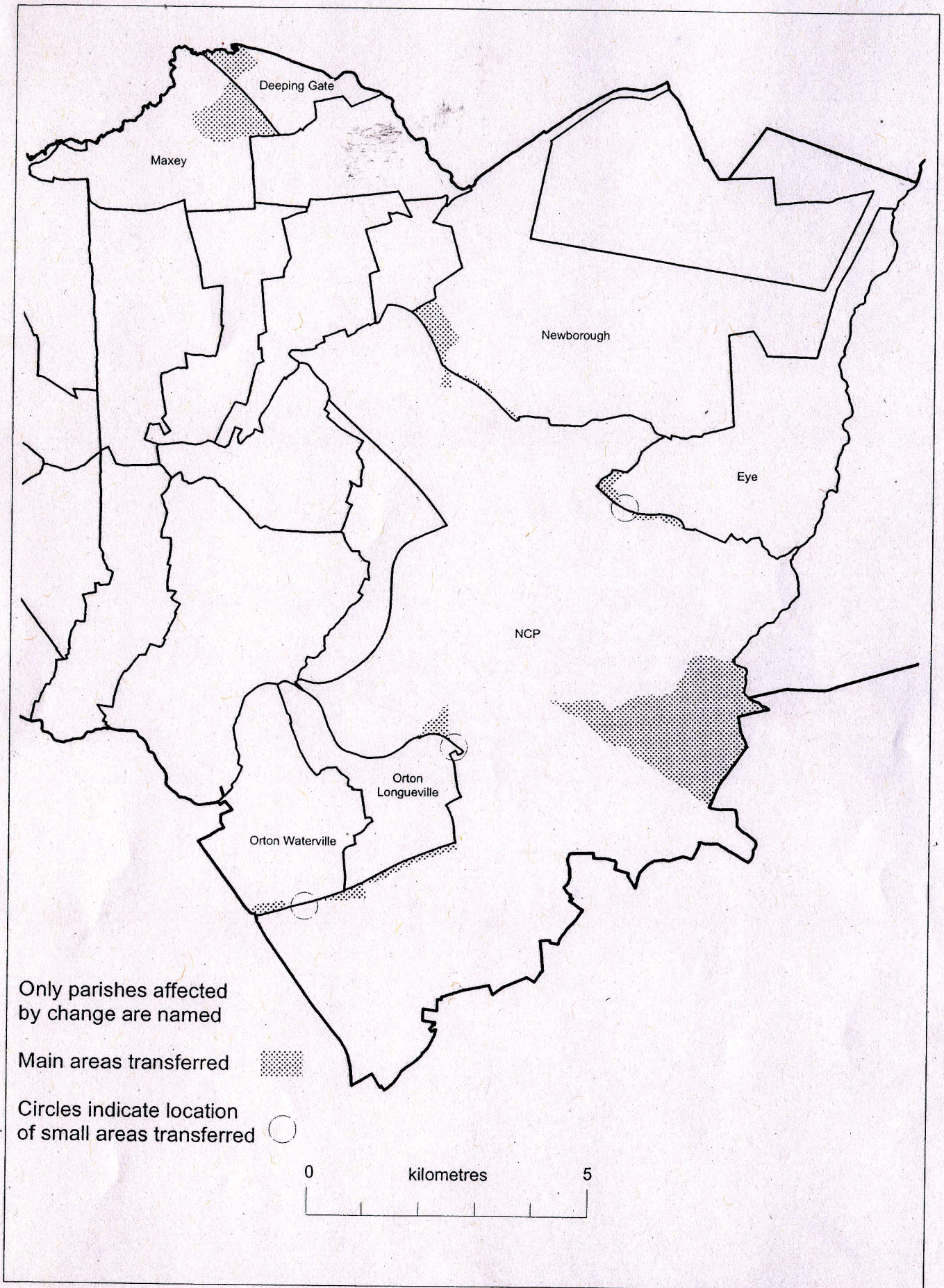
This Order gives effect (without modifications) to a recommendation resulting from a review conducted by the Peterborough City Council for the alteration of parish areas and the abolition of a parish. A map forming part of this note gives a general guide to the areas concerned.

Article 2 abolishes the parish of Stanground North

Article 3 makes alterations to the areas of parishes. On 1st April 2004 each area specified in column (1) of the Schedule to the Order will cease to be part of the parish or unparished area specified in column (2) and will become part of the parish or unparished area specified in column (3).

Article 4 specifies 1st April 2004 as the order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999, which make provision of general application in relation to orders such as this Order.
