2022 - 2023 Youth Education Application

This document will combine education applications for the following benefits:

- June 2022 Youth Grade Incentive/Honorarium
- July 2022 Youth Computer Purchase Program
- July 2022 Clothing Allowance
- November 2022 Winter Jacket Allowance

All applications must include:

- Completed Education Application (*all items are required for processing*)
- Copy of report cards for all students seeking a Grade Incentive
- Copy of transcripts (or diploma) for Graduation Honorariums
- Copy of receipts for computer reimbursement request

Program descriptions notated with (*) require additional documentation and/or required selections.

<u>Youth Grade Incentive/Honorarium*</u>: For all eligible students Pre-K/T-K—12th grade with a cumulative GPA of 2.0 or higher. Incentive amount is based on grade and GPA of each student. A copy of the 4th quarter report card or graduation certificate is required. For students on an IEP: please provide a copy of most recent IEP. Pre-K/T-K must have proof of enrollment in an education facility on file.

<u>Youth Computer Purchase Program*</u>: For all eligible students. See policy for eligibility criteria. Students are eligible to receive a computer every 2 years.

<u>Clothing Allowance</u>: For all eligible students ages 3-17 or Pre-K/T-K—12th grade. \$250 per child with proof of enrollment in an education facility. There will be a second application for the Clothing Allowance Benefit due January 1st, as a follow up on GPA and contact information. We strive to ensure that all of our children are successful and receiving the benefits and services available to them.

<u>Winter Jacket Allowance</u>: All eligible students ages 3-17 or Pre-K/T-K—12th grade who receive the July clothing allowance will automatically receive the Winter Jacket Allowance in November.

Application Submission and Review:

- Applications may be picked up at the Tribal Government Office or sent by email/mail as requested.
- Completed applications are to be submitted to the Tribal Government Office:

- Completed applications will be submitted to the Enrollment Department for enrollment and eligibility verification. A copy of the child's birth certificate must be on file for eligibility verification.
- Verified applications will be submitted to the Finance Department for processing. This check process can take up to 2 weeks. Checks will be mass mailed on the date specified.
- Checks will be mailed to the existing address on file. It can take 7-10 business days to receive a check in the mail. Stop payments will not be allowed until this 10 day window has passed.
- Program descriptions notated with (*) require additional documentation and/or required selections.
- If you need additional space for any of the benefits, please attach a separate sheet of paper with all required information.
