### DOSANJH CABINET

#### INTRODUCTION

Ujjal Dosanjh was elected leader of the New Democratic Party of British Columbia on February 20, 2000 and was sworn in as Premier February 24, 2000, taking over from Dan Miller. He was first elected to the Legislative Assembly in the general election of October 17, 1991 representing the riding of Vancouver-Kensington. He served in the Harcourt cabinet between 1991-1996 as Minister Responsible for Sports and as Minister Responsible for Multiculturism and Human Rights. He retained his appointment as Attorney General from August 16, 1995 until his Premiership. In the Clark cabinet between 1996-1999 and the Miller Cabinet between 1999-2000, he was Minister Responsible for Multiculturism, Human Rights and Immigration. The New Democratic Party of British Columbia was re-elected under Clark's leadership in the general election May 28, 1996. The first session of the 36th parliament opened June 25, 1996. The second session opened March 24, 1997, the third session opened March 26, 1998, the fourth session opened March 15, 2000 and the fifth session opened March 14, 2001.

The choice of dates for the commencement and termination of a position is not straightforward because an announcement may occur on one date and be confirmed officially on a different date. Generally the "official" date has been used in this document, with footnoted references to any other date(s) involved. If, there was no Order in Council (OIC) or other official notice specifically naming the minister involved, the announcement date has been used.

Mr. Dosanjh was sworn in as Premier on February 24, 2000. OIC 237/2000 dated February 24, 2000 continued all designations of officials in Executive Council. Mr. Dosanjh's cabinet was sworn in February 29, 2000 per OIC 239/2000. For the purposes of this document, the final date of service for cabinet ministers in the Dosanjh administration is June 5, 2001 - the date Mr. Dosanjh's successor, Gordon Campbell, was sworn in as Premier.
