After the entry deadline, the BWF Online Group Entry System will send notification to all participating Member Associations confirming receipt of final entries. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline.

Member Associations should contact BWF immediately if such notice is not received by **Wednesday, 12 April 2023** at 12:00 hrs BWF Headquarters time.

If no objection is received by BWF by **Thursday, 13 April 2023** at 23:59 hrs BWF Headquarters time, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.

#### Online Entry – Hosting Member Association Entries

Eligible player wishing to enter through the hosting Member Association must follow a different process to international entries.

BAM to receive the entry not later than 7 days, Wednesday 5<sup>th</sup> April 2023 from the dateline of online entry. Late entries will not be accepted.**

#### Withdrawals

The management of withdrawals will be run in accordance with BWF GCR 13 and 14.

Member Associations can withdraw their entries through the BWF Online Group Entry system until the last date of withdrawal without penalty (see Key Dates Section).

Withdrawals made after this date will incur a penalty in accordance with the BWF Table of Offences and Penalties (BWF Statute 2.5).

Please ensure that the Tournament Referee and Host Organiser are notified immediately in writing, clearly stating the reason for the withdrawal.

A limited number of additional accreditation passes for approved Team Officials will be available for purchase at a fee of USD\$150 by **Cash/ Credit Card**, charged to the respective Member Association, and payable at the tournament.

The fee to replace any lost or damaged accreditation passes will be USD\$100 on each occasion, charged to the respective Member Association.

The tournament reserves the right to refuse entry into any accredited venue or area or service (e.g. transportation) as a result of damaged or missing accreditation.

The fraudulent use of accreditation is strictly prohibited, and will result in access rights being removed, and penalties being applied.

#### Medical Services

A medical officer and physiotherapist service will be available during the tournament 23 – 28 May 2023 , free of charge to players.

#### Anti-Doping

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

#### Badminton Integrity

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).

The tournament host and hosting Member Association accepts no responsibility for withdrawals made due to late or refused visa applications.

It is the responsibility of the Member Association to apply for the necessary visas in sufficient time, and all matters should be directed to the Embassy in charge.

Any visa support letter issued by the tournament host does not guarantee entry into MALAYSIA; the final decision is made the Government of MALAYSIA.

COVID-19 Protocols

UPDATE AS 1<sup>st</sup> AUGUST 2022

- From 1st August 2022, all travelers are allowed to enter Malaysia regardless of their COVID-19 vaccination status and do not require a pre-departure or on-arrival COVID-19 test. There are no quarantine orders related to COVID-19 enforced by the Malaysian Government upon arrival.
- Travelers can download and activate the MySejahtera application before or after arrival to Malaysia to indicate their COVID-19 risk status while staying in Malaysia. The COVID-19 risk status in MySejahtera may be checked upon entering premises.

- Travelers who develop COVID-19 symptoms while in Malaysia should get tested and if found to be positive, are subject to the current protocol for positive COVID-19 cases as below.
  - Individuals who test positive for COVID-19 must undergo isolation via a Home Surveillance Order (HSO) for seven (7) days. Individuals can be released from isolation on the 4th, 5th or 6th day when they are asymptomatic and the result of an RTK Ag test supervised by a registered medical practitioner is negative. Discharge on the 7th day does not require any COVID-19 detection test.
- Please continue to practice COVID-19 preventive measures while in Malaysia.
- The BWF phase 4 COVID -19 Guidelines will be followed during the event .
