<p>Regulations (Conditions of Play)</p>	<p>This tournament will be run in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes, General Competition Regulations (GCR), and BWF World Tour Regulations. In the event of any dispute, the decision of the Tournament Referee will be final.</p> <p>This tournament will strictly enforce the Clothing, Equipment, and Advertising Regulations as outlined in the BWF GCR 20 – 24. This includes restrictions of certain colours for shirts, shorts, and skirts to avoid issues with virtual advertising on TV courts, as per GCR 21.7.</p>
<p>Scoring System</p>	<p>Best of three games to 21 points, as per the Laws of Badminton (BWF Statute 4.1)</p>
<p>Instant Review System</p>	<p>The Instant Review System (IRS) will be available on Court 1, and is regulated as per BWF Statute 4.1.8.</p>

After the entry deadline, the BWF Online Group Entry System will send notification to all participating Member Associations confirming receipt of final entries. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline.

Member Associations should contact BWF immediately if such notice is not received by **Wednesday, 21 June 2023** at 12:00 hrs BWF Headquarters time.

If no objection is received by BWF by **Thursday, 22 June 2023** at 23:59 hrs BWF Headquarters time, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.

Online Entry – AUSTRALIAN Entries

Eligible player wishing to enter through the hosting Member Association must follow a different process to international entries.

Australian Entries Only:

Please note - All Australian entries can only be submitted to BWF by Badminton Australia. Australian entries close **Wednesday 14 June 2023**. This is to allow for checking and endorsement of all Australian entries.

Australian entry fee is **AUD \$120.00** per person regardless of the events entered. Australian player must be a member of an Association/Club registered to their State/Territories and is of good standing. Entry fee will entitle a player access to the venue, spectators and practice areas until Friday 04 August 2023. Players who are still in the draw from Friday onwards will be issued a new accreditation pass.

Withdrawals

The management of withdrawals will be run in accordance with BWF GCR 13 and 14.

Member Associations can withdraw their entries through the BWF Online Group Entry system until the last date of withdrawal without penalty (see Key Dates Section).

Withdrawals made after this date will incur a penalty in accordance with the BWF Table of Offences and Penalties (BWF Statute 2.5).

Please ensure that the Tournament Referee and Host Organiser are notified immediately in writing, clearly stating the reason for the withdrawal.

Clothing worn during the ceremony must be in accordance with the BWF GCR.</p>

Accreditation

Access to Tournament venues and other services is provided through personalised and photographic accreditation passes. Please complete and return the accreditation form with photographs as per attached.

A limited number of additional accreditation passes for approved Team Officials will be available for purchase at a fee of **US \$200 by Cash or Credit Card**, charged to the respective Member Association, and payable at the tournament.

The fee to replace any lost or damaged accreditation passes will be USD \$100 on each occasion, charged to the respective Member Association.

The tournament reserves the right to refuse entry into any accredited venue or area or service (e.g. transportation) as a result of damaged or missing accreditation. The fraudulent use of accreditation is strictly prohibited, and will result in access rights being removed, and penalties being applied.

Medical Services

A medical officer and physiotherapist service will be available during the tournament, free of charge to players.

Anti-Doping

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out- of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Badminton Integrity

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(s).

4. Travel & Visa Details

Transport

Complimentary transportation will be provided by the tournament host between airport arrivals/departures and the official hotel, and between official hotel and the competition and practice venues.

Airport arrivals pick-up will be available starting from **Saturday 29th July 2023** at Sydney International or Sydney Domestic Airports for participants staying at the official hotel only. To request arrival pick-ups, please complete and return the Transportation Request Form attached. Please be mindful to inform the organiser should there be changes to the original transport request submitted at an earlier date.

Transportation to practice and competition venues will be from the official hotel only. A daily schedule will be posted at the tournament reception desk located in the hotel lobby.

Transport departures will only be from the official hotel and participants are strongly advised to confirm with tournament reception their scheduled departure times. Last day for complimentary transport departure is **Monday 7 August 2023**.

Visas

If a visa is required to enter Australia, we can provide a letter of invitation to assist with your application.

Please complete and return the Visa Support Request Form attached.

The tournament host and hosting Member Association will only communicate with a Member Association, and the hosting Member Association will only provide a visa support letter if the form is completed accurately and comprehensively, and supporting documentation is provided, where requested.

The tournament host and hosting Member Association accepts no responsibility for withdrawals made due to late or refused visa applications.

It is the responsibility of the Member Association to apply for the necessary visas in sufficient time, and all matters should be directed to the Embassy in charge.

Any visa support letter issued by the tournament host does not guarantee entry into Australia; the final decision is made the Government of Australia.

COVID-19 Protocols

Australia borders are open to all international travellers. Please note the following:

- You do not need to provide proof of COVID-19 vaccination to travel to and from Australia
- You do not need to provide proof of a negative COVID-19 test to meet Australian inbound travel requirements.

Some countries airlines and vessel operators may require a pre-departure test result at check-in before you can board your flight or ship. Please check the entry requirements of the country your are travelling or transiting through, and your airline or vessel operator requirements.
