## THE MINERAL INDUSTRY OF SOUTH SUDAN

In 2019, the economy of South Sudan was based largely on the production of crude petroleum (U.S. Central Intelligence Agency, 2020). The legislative framework for the mineral sector in South Sudan is provided by the Mining Act No. 36 of 2012 and the Petroleum Act of 2012. Data on mineral production are in table 1. Table 2 is a list of major mineral industry facilities.
