#### **Regional Significance Statement**

Spirit Mountain Recreation Area is a family-friendly recreation area providing the entire spectrum of four season adventure experiences from nature-based to built all within the context of the compelling natural resources of the Lake Superior watershed. Winter activities: downhill and Nordic skiing, snow tubing, fat tire mountain biking (fat biking), snowshoeing and snowmobiling. Summer activities: an adventure park (mountain coaster, zip line, mini-golf, jumping pillow) camping, mountain biking, hiking, bird watching, bouldering, and disc golf.

#### Overview/Description of Park or Trail

Spirit Mountain Recreation Area (Spirit) is a family-friendly recreation area providing the entire spectrum of four season adventure experiences from nature-based to built all within the context of the compelling natural resources of the Lake Superior watershed and the St. Louis River Estuary.

#### Groups served

Spirit is family friendly, serving all ages including adventure park activities that are kid friendly. User groups include:

Skiing and Snowboarding: Duluth Cross Country Ski Club (DXC), Team Duluth Race and Freestyle Teams, University of MN Alpine Team, College of St. Scholastica Outdoor Pursuit, and seven area high schools. Mountain biking: Cyclists of Gitchee Gumee Shores (COGGS), the National Interscholastic Cycling Association, the Duluth Composite Team.

Hiking: Superior Hiking Trail Association (SHTA)

Snowmobiling: Hermantown and Over the Hill Night Riders Snowmobile Clubs.

#### **Facilities**

Winter: downhill skiing, snowboarding, snow tubing, Nordic (cross-country) skiing, fat biking, lift-served downhill fat biking, snowshoeing and snowmobiling. 175 acres of skiable terrain has a capacity of 2,460 skiers; 26 trails have a length of 6.1 miles. Four terrain parks and a half-pipe provide interest for advanced users.

Summer: tent and RV camping; Adventure Park with an Alpine Coaster, Zip Line, Jumping Pillow; 9-hole Mini Golf; the primary trail head for the Duluth Traverse cross-country mountain biking trail as well as an all-weather mountain bike trail, downhill mountain bike trails, three pump tracks, and a skills park with progressing difficulty from beginner to advanced; bird watching and hiking on the SHT, hiking and biking on the accessible DWP multiuse trail, and disc golf.

Main Chalet houses banquet facilities, Mountain Top Shop equipment store, Mountain Top Cafe and Moosehead Bar and Grill. The Grand Ave Chalet at the bottom of the hill hosts the Riverside Bar and Grill. The Main Chalet and Grand Ave Chalet provide fee-for-service amenities that supplement and sustain Spirit Mountain: weddings and banquets account for 18.7% of revenues. Grand Ave Chalet which provides tickets, rentals, and restrooms for mountain bike activities.

#### Program summary

Thousands participate annually in year-round programming provided by Spirit or partner organizations for mountain biking, mountain biking, hiking, youth day camp, Adventure Camp, downhill skiing, Nordic, freestyle skiing, alpine racing, and snowboarding. These lessons and camps are offered for youth, families, women and teams from beginner to competitive. Spirit offers discounted and complimentary lessons to at-risk youth and is home to the Courage Kenny Rehabilitation Program adaptive ski program. Attachment 1lists Programs and Events.

#### Relationship to parks and trails

Multiple, multi-use trails come together at Spirit: the Duluth Traverse, Superior Hiking Trail, Western Waterfront Trail, DWP multi-use accessible trail and Willard Munger State Trail. These trails connect to state, regional and city parks. Snowmobile trails connect to 10 miles of groomed snowmobile trails in Duluth, 20,000 miles in Minnesota and 25,000 in Wisconsin. The Munger will eventually connect to the Cross City Trail. A future paddle access on the St. Louis River will link Spirit across Grand Ave.

#### **General Site Characteristics**

Spirit Mountain is distinct from the surrounding landscape and is visible from across the river on the Wisconsin side as a prominent and visible feature. Volcanoes and glaciers created Lake Superior and the rugged mountain terrain of Spirit Mountain and the North Shore. The St. Louis River, the largest U.S. tributary to Lake Superior, becomes a 12,000-acre freshwater estuary at the base of Spirit Mountain. The upper section is characterized by wilderness-like areas, while the lower section is characterized by urban development and an industrial and international port. A freshwater estuary is ecologically unique. The current is slow and its wide expanse allows for small water and big water experiences as well as varied paddling experiences for all skill levels. Once on the estuary it's easy to forget that the river is in an urban environment.

Within sight is Lake Superior when, combined with the estuary, provides an overwhelmingly sense of place. Glacial Lake Duluth was five to six hundred feet above the present lake level. Duluth's Skyline Drive, with its wave-cut cliffs and terraces, remains one of the highest former shore lines of Glacial Lake Duluth and a popular scenic drive for residents and visitors alike. Erosion of the high bluffs and irregular shorelines composed of volcanic rock can expose veins thomsonite crystals in these cracks that form agates that are enthusiastically hunted by visitors. Lake Superior waves can grow to large size especially in the late fall and early winter. Waves can be 12 to 15 feet and were recently recorded at 28 feet. Wave watching and photography is a popular pastime and cold water surfing and diving are increasing in popularity.

Since 2011, the City of Duluth has increased planning and investment along the St. Louis River Corridor: Spirit Mountain is the gateway to Duluth and to the outdoor recreation activities available. Development of the mountain bike facilities resident within the Spirit Mountain Recreation Area were addressed within the Duluth Master Plan submitted to the Commission in 2017. Spirit Mt. provides some of the best elevation, topography, and scenic views in the region and Minnesota. Scenic overlooks from the top of Spirit Mt. take in the City of Duluth, Lake Superior, the St. Louis Criteria #1 Images River Estuary, the Duluth-Superior Harbor and Aerial Lift Bridge, and Wisconsin. Spirit Mt is primarily forested: over 1,000 acres of old growth oak and maple forests provide stunning color displays in the fallmedlev 30bd55.pdf and habitat for myriad species. Spirit Mountain provides the best alpine skiing within 90 miles, and has been a favorite destination for Nordic skiing as well as the home for area high school ski teams. Spirit Mountain tracks recreation trends and responds with activities that address those trends. Since 2008, Spirit Mountain added the alpine coaster, the zip lines, and snow tubing to take advantage of the mountain's rugged terrain. A jumping pillow and mini and disc golf also

(relative to the most current design standards) that meet the contemporary needs of targeted user groups Winter recreation at Spirit Mountain includes downhill skiing and snowboarding, snow tubing, Nordic (crosscountry) skiing, snowmobiling, and fat biking. The Timber Twister alpine coaster can operate in the winter as well. On-site accommodation is offered at the Mountain Villas. The Main Chalet at the upper base and the Grand Avenue Chalet are open four seasons. Summer Recreation includes tent and RV camping; an adventure park complete with an Alpine Coaster, Zip Line, Jumping Pillow; 9-hole Mini Golf; bird watching and hiking on the Superior Hiking Trail, hiking and biking on the accessible DWP multiuse trail, and disc golf. The nationally recognized Spirit Mountain Bike Park includes multiple downhill trails, three pump tracks, a skills area with jump lines, crosscountry mountain biking trails and an all-weather downhill trail and cross country loop supported by a trailhead at the Grand Ave Chalet, Alpine skiing/snowboarding Alpine skiing/snowboarding is the core winter activity at Spirit Mountain. The public ski area operation is supported by equipment rentals and both group and private lessons for all ages and Season Pass memberships. Spirit Mountain is open 7 days per week, weather permitting and also offers night skiing. Spirit has a total lift capacity of 4,150 at one time. It has 5 chairlifts – 1 High Speed Detachable Quad, 1 Fixed Grip Quad, 2 Triples and 1 Double and 3 surface lifts - 1 Handle Tow, 1 Moving Carpet and 1 High Speed Rope Tow. The high speed detachable quad is fast, modern, and allows Spirit to utilize it for mountain bikes in summer and fat bikes in winter. The high speed moves many people quickly to reduce the amount of time people wait in a chairlift line. This lift is ideal for beginners as the lift slows down to make loading and unloading easier. There are 89 acres of trails over 26 marked trails with a total length of 6.1 miles. While the existing terrain is predominantly beginner and low intermediate, the four terrain parks and half-pipe provide interest for the more advanced skiers and snowboarders. Terrain parks include jumps, boxes and rails.. A half-pipe is snow-covered sloping channel with a U-shaped cross section, used by skiers and snowboarders, to perform jumps and other maneuvers. Snowmaking Spirit Mountain's snowmaking system provides 100% snow coverage. A

state of the art pump system draws 70 million to 90 million gallons of water annually from Lake Superior. Two pump stations with six pumps and motors deliver an average 4000 gallons of water pumped per minute when at full capacity to fourteen Super Pole Cat fans guns, six Standard Pole Cat fan guns, and 44 water/snow sticks. At the end of the winter season pipes and pumps move meltwater directly back into Lake Superior. Collection basins prevent runoff and debris from entering Lake Superior. Attachment 4: Criteria 1 c. Alpine facilities Nordic skiing Spirit Mountain is the crown jewel of the Duluth Nordic ski system. It has the most kilometers of any park as well as the most varied skiing terrain. When added to the adjacent Magney Snively Natural Area an additional 13.7 km through pristine woods becomes a full day of skiing from one trailhead: the only place in Duluth. One of the campground buildings is used as a warming chalet and the campground and chalet parking area provides parking. Attachment 5: Criteria 1 d. Nordic facilities Mountain/Fat bike Mountain bike trails are built per the Minnesota Department of Natural Resources and the International Mountain Bicycling Association sustainability specs and include beginner, intermediate, advanced and expert designs as well as trails that bridge the gap between levels. Spirit Mountain introduced high speed lift service for summer mountain biking in 2014. Spirit Mountain added in lift served, downhill winter fat biking in the 2015/16 ski season and was the first ski area in North America to do so. During summer months, the chairlift operates 4-5 days a week. In winter months, fat biking for lift service operates one day a week. The allweather cross country mountain bike trail is hardened to prevent damage during shoulder season or wet weather and is the only all-weather trail in the region. The Duluth Traverse cross-country mountain bike trail crosses the entire city. Within Spirit Mountain, the Duluth Traverse trail extends from the end of North 80th Avenue West to the Grand Avenue Chalet over a distance of approximately 7,200 feet. It follows the DWP trail to western Duluth. The DWP is used by downhill bikers to return to the Spirit Express II lift from the bottom of the downhill bike trails. The Bike Park consists of four top to bottom gravity trails, with a few side trails, three progressively challenging pump tracks and a skills park with jump lines just above the Grand Avenue Chalet. A pump track is a continuous loop of dirt berms and "rollers" (smooth dirt mounds) that are ridden without pedaling. There are a total of 4.8 miles of trails in the downhill portion of the bike park. The existing trail mix tends to be more suitable for intermediate riders. Expansion plans call for a fun, flowing, novice trail, suitable for cross country bikes to

introduce more riders to downhill mountain biking. Attachment 6: Criteria 1 e. Mountain Bike Facilities Snow Tubing A multi-lane snow tubing park at the top of the mountain has its own handle tow lift that brings tubers from the bottom to the top of the tubing lanes. The Adventure Park support facility provides tickets, concessions and washroom facilities. Parking is provided at the Adventure Park parking area. When weather conditions are favorable, the Alpine Coaster operates in conjunction with the tubing operation. Attachment 7: Criteria 1 f. Tubing Spirit Mountain Campground The campground is located in a wooded area and consists of 73 individual campsites equipped with fire pits, picnic tables and electricity, as well as an area for walk-in tent camping. Thirty-nine sites have water hook-ups. Campground guests can purchase discounted tickets to the activities at the Adventure Park and a walking trail links the two facilities. The campground is often fully booked during the peak summer season from mid-May to mid-October. Attachment 8: Criteria 1 g. Campground Facilities The Adventure Park The park includes an alpine coaster. zip line, mini-golf, disc golf, and a jumping pillow. An independent structure provides tickets, washrooms and a food concession that also supports the winter tubing operation. The Timber Twister alpine coaster descends on a 3.250-foot track that drops approximately 300 feet and then ascends back to the start. The Timber Flyer zip line drops 135 feet over a distance of approximately 700 feet. Riders can go solo or double on a bench seat complete with seatbelts. There is mini-golf and 18 holes of disc golf, and a jumping pillow, which is a 30 by 60-foot in ground airbag. Participation in the activities can be purchased individually or as part of a package. The Spirit Express Il chairlift also operates to provide transport for summer sightseeing. Attachment 9: Criteria 1 h. Adventure Park Sightseeing and Hiking The Superior Hiking Trail is a 310-mile long footpath that follows the ridgeline overlooking the north shore of Lake Superior from the Wisconsin border just East of Jay Cooke State Park in West Duluth to just east of the Grand Portage Reservation near the Canada-US border. The trail is designated for hiking and walking and varies in elevation from 600 to 1,300 feet above sea level. The trail traverses the mountain below the ski runs and there are spur trails connecting to the upper and lower base areas, as well as the campground and the USFS Superior National Forest Headquarters. The portion of the trail from the upper parking lot to the Grand Avenue parking lot is multi-use. From upper Spirit Mountain, there are panoramic views over the Saint Louis River and western Duluth. The Spirit Express II chairlift is open for summer sightseeing 5 days a week from late June to early September, and on weekends in the fall. Spirit boasts a designated hiking only loop experience managed by the SHTA that connects the top of the mountain to the bottom allowing for a multi hour hiking experience looping off the main SHT spine trail. Attachment 10: Criteria 1 i. Superior Hiking Trail Snowmobiling A snowmobile loop on the east side of Knowlton Creek extends from the Duluth Cross City trail behind the Lake Superior Zoo and crosses the creek on the top of the mountain. This trail extends across Skyline Parkway and around the western perimeter of the mountain to the Magney Snively Natural Area. Spirit Mountain is the host for the opening event of the International Series of Champions' Championship SnoCross Series. SnoCross incorporates challenging natural and artificial terrain features. This event attracts high caliber racers and upwards of 30,000 fans. Attachment 11: Criteria 1 j. Snowmobiles Buildings The Main Chalet and the Grand Avenue Chalet provide the necessary skier services (tickets, rentals, washrooms, food and beverage etc.) for Spirit Mountain. The Main Chalet contains 50,405 ft<sup>2</sup> and the Grand Avenue Chalet 15,100 ft<sup>2</sup>, for a total of 65,505 ft<sup>2</sup>. Service facilities are those which provide functions specifically related to the operation and management of the recreation area. These are broken down into three categories: • Operational: Services essential for the day-to-day operation of the recreation area include "back of the house" services such as administration space, employee lockers and ski patrol facilities. These facilities are located both on the mountain and in the base areas. • Staging Facilities: Services that are required as visitors arrive include ticket sales, public lockers, equipment rental and repair, program check-in and daycare, and are located at both chalets. Commercial Facilities: Services required throughout the day as visitors are on the mountain including food and bar seating, kitchen and serving areas, restrooms and accessory retail space and are located at both chalets. Attachment 12: Criteria 1 k. Buildings • Overall uniqueness is high, with new or innovative "special feature" outdoor recreational facilities of regional significance being the basis for the park. The International Mountain Bike Association designated Duluth as a Gold Ride Center in part because of the high quality trails that Spirit Mountain offers. The Ride Center™ designation represents large-scale mountain bike facilities that offer something for every rider. IMBA Ride Centers serve as social and educational hubs, where visitors can connect and learn new riding techniques and provide the full range of mountain biking experiences today's riders crave. The Zip Line and Timber Twister are unique to the region at one of

two similar recreation areas in District 1 that provide this type of ride. It provides an exemplary experience when combined with the remarkable views and extensive, quality forest environment through which they travel. Coming soon is a new Grand Ave Nordic Center at the base of the mountain that will add lighted Nordic ski trails and snowmaking. The 2.0 mile trail will serve recreational cross country skiing and regional competitions. A 1.4 mile trail connection to the top of the mountain will connect these trails and the far west Duluth neighborhoods to Spirit Mountain Nordic Center at the top of the mountain. COGGS provides volunteer work for trail construction, teaches clinics and lesson programs and sponsors events and programs. Many programs encourage underserved groups to participate and focus on getting families moving. COGGS partners annually with Kraus Anderson Construction to host the Duluth Bike Festival at Spirit Mountain. DXC sponsors programs and Nordic skiing (skate and traditional) lessons with activities that build technique, stamina, and confidence in all ages. Events include everything from a 10km race for the competitive skiers, to lessons and free ski demos for beginners, ski soccer and obstacle courses for kids. Programs and Events Tourist destination: Duluth is the fourth largest City in Minnesota and serves the regional popu-lation of 279,601. Spirit Mt. is located within the city of Duluth, the regional hub for the North and South Shores of Lake Superior, Iron-Range, and "northwoods" of north-eastern Minnesota and northwestern Wisconsin. Duluth is one of the most popular tourist destinations in the state, attracting well over 6 million visitors throughout all 4-seasons. By 2060, the number of adults participating in each of 10 different popular outdoor recreation activities is projected to increase. Depending on future demographic, economic, land use, and population changes, the activity demonstrating the most growth is day hiking. The growth in the number of participants in birding and day hiking is projected to exceed the growth of the overall population.
