Regulations (Conditions of Play)	This tournament will be run in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes, General Competition Regulations (GCR), and BWF World Tour Regulations. In the event of any dispute, the decision of the Tournament Referee will be final. This tournament will strictly enforce the Clothing, Equipment, and Advertising Regulations as outlined in the BWF GCR 20 – 24. This includes restrictions of certain colors for shirts, shorts, and skirts to avoid issues with virtual advertising on TV courts, as per GCR 21.7.

Member Associations should contact BWF immediately if such notice is not received by Wednesday, September 13, 2023 at 12:00 hrs. BWF Headquarters time.
	If no objection is received by BWF by Thursday September 14, 2023 at 23:59 hrs. BWF Headquarters time, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.
Withdrawals	The management of withdrawals will be run in accordance with BWF GCR 13 and 14. Member Associations can withdraw their entries through the BWF Online Group Entry system until the last date of withdrawal without penalty (see Key Dates Section). Withdrawals made after this date will incur a penalty in accordance with the BWF Table of Offences and Penalties (BWF Statute 2.5). Please ensure that the Tournament Referee and Host Organizer are notified immediately in writing, clearly stating the reason for the withdrawal. Video Recording and Photography

Accreditation must be clearly displayed on the cameras.
