



## 2022 ONLINE JUDGES' TESTS DIRECTIVES

All edits and new information in blue below.

*Version 2- 21 January 2022*

### **Overview**

The Executive Committee approved changing the traditional in-person judges' courses and examinations to an online format for the start of the 2022-2024 cycle. The Covid-19 pandemic has posed a great threat to hosting in-person courses. The president of the FIG Anti-doping, Medical and Scientific Commission recommended the avoidance of gathering dozens of judges into meeting rooms over several days all over the world. Travel restrictions and the financial stakes were also major factors in the decision.

The FIG has contracted STS Tests to develop and oversee the online testing for the 2022-2024 Codes of Points. This is the same company that has provided the FIG online judges' educational platform over several years.

The Technical Committees have been working diligently to provide online study materials that will be made available through the new STS educational platform. STS Tests, with materials approved by each TC, will administer online testing with major similarities to the examinations of the past cycles.

More information regarding the online tests and brevet qualification for the 2022-2024 cycle can be found in the 2022-2024 General Judges' Rules and the 2022-2024 Specific Judges' Rules for each discipline. These are now available on the FIG website.

All brevet judges of the 2017-2021 cycle that pass the online exam will retain their international brevet. They will be able to judge competitions starting 01.01.2022 using the 2022- 2024 CoP until their online test results are released in February-April, depending on the test date. The 2022-2024 brevet will become active upon passing the online test.

The FIG asks everyone for patience in this process. This procedure of study and testing we have implemented usually takes a year of planning, but we have to accomplish all tasks effectively in just a few short months because of the inability to host in-person courses. Last week we realized that we had to expand our server system because of the unprecedented number of candidates viewing videos on the study site. Everyone should see an improvement in video performance. It is also important to mention that the study and testing sites are completely independent of each other to guarantee optimal performance of both sites.

### **Study Materials**

All study materials for judges are now available only through the following access: <https://stsstudy.com/>. Note, for all study materials, three vertical dots on the left side of the screen allow you to open and close the menu.

For updated information to be seen, you must logout and login.

Study material includes the following information:

1. Competition Videos (FIG competition video library, IRCOS & PK videos)

Note: It is important to select (light up) the appropriate buttons for the year, competition, phase and apparatus/category you seek. These videos are a study supplement to material located as "TC Content".

2. TC Presentations

Found on the study platform under "TC Content".

These are the typical presentations shown live at judges' course in the past.

Read the pop-up screen carefully when you open the "TC Presentations" tab:

*-Important: Click on "Notes" on the far right to access the TC study notes throughout your review.*

*-Left click on any area in the presentation screen (except videos) to view the presentation optimally if any animations are included. Only use "Next" to advance if a full screen video is in the main content area.*

3. TC Examples

These examples can be found on the study platform under "TC Content".

Full routines (runs for PK) and TC analysis are available.

You must open the drop-down after viewing a routine. This will give you a scoring summary by the TC. Even more specific information can be seen by clicking on Analysis or Judging Sheet, located in blue above the summary details.

4. Info

This section contains Test Directives, Test Instructions (for each discipline, when finalized), Newsletter/CoP Errata (coming soon if applicable), Q & A (coming soon). New features will be added later (likely after the tests to help judges further prepare for competitions)

Test Instructions- give final details for candidates about the tests and a view of what all the candidate input screens look like.

As of today, MAG, WAG, ACRO and PK have TC Content available. New information will be added when completed and approved.

Study materials by the TCs in STS will be in the four FIG official languages (with Parkour in English and French only). English may be available before the other languages, but all preparation content will be available, as soon as possible before the Practice Test in each respective discipline.

### For New Judges for the 2022-2024 cycle

Login information to STS study platform will be sent to new brevet candidates through their NFs. This access for new judges can be sent only to new judges that need to prepare for the tests.

All past usernames and passwords used for the 2017-2021 STS study platform will work for the new 2022-2024 educational platform.

See below, in FIG Judges' Registration, for how to register new judges and receive an ID number (user name).

### For Returning Judges from the 2013-2016 cycle, with no brevet from 2017-2021

Please email the FIG at [sports@fig-gymnastics.org](mailto:sports@fig-gymnastics.org) because these judges already have an ID number, but must have their profile updated in the FIG database first.

### **Judges' Registration**

The fee for each judge to participate in the online Official Test is CHF150. This also includes the study platform access and Practice Test. Each NF will be billed directly by the FIG. **Note: RG and TRA judges will only pay CHF150 per judge, even if they register for 2 or more of their disciplines.**

NFs must use the FIG online database to register their judges. The login and password for the Practice Test and Official Test will be available **in the database** for all judges shortly after the registration process is completed by each respective NF and validated by FIG.

For all World Cups and World Championships starting after 31 March 2022, please note that a judges' brevet for the 2022-2024 cycle will be required to register and judge. Therefore, no judge can be registered at the provisional and definitive stages for these competitions after 31 March without the new brevet certification. It is fine to put "0" judges during registration for these cases and make the correction once the new brevets have been confirmed.

Registration will be open for PK and ACRO in December and all others in January/early February.

The national federations register the judges with current brevets (2017-2021) and place them in the desired test through the online Sport Database. All deadlines as shown in the Test Schedule must be respected. Judges' must be registered in the online test (dates & time zones) where they will be taking the test. **THIS IS MANDATORY.**

Moving a judge from your federation time zone into the one where the judge will be taking the test (not a choice or selection, where they live or may be working from), requires an email from your federation to the Sports Manager responsible for that discipline. The Sports Manager will open the position in the other time zone and then inform you. The NF must state the city and country where the candidate judge will take the test. Any other reason for changing time zones must be sent to the FIG Technical Coordinator, Steve Butcher at [sbutcher@fig-gymnastics.org](mailto:sbutcher@fig-gymnastics.org) to review with the FIG Secretary General and/or FIG President.

A passport or national ID Card (not driving license) will be needed for registrations to be validated, along with other required information, and the passport or national ID Card must be valid for judges to receive their final results. If judges do not have their valid passport or valid national ID Card at the time of registration, they can upload their expired passport or their expired national ID Card as a last resort. Again, a valid passport or a valid national ID Card will ultimately be needed to finalize and issue the brevet results.

If a judge has an ID number as a coach or athlete, please write to [testsupport@fig.sport](mailto:testsupport@fig.sport), as we may need to merge their profiles.

The FIG database will provide the online access information, username = their judge ID number and a password (also shown in the database). This information will need to be sent by the NF to each judge SEPARATELY so they may individually access the Practice Test and Official Test. The login and password for the STS study platform will NOT give access to the Practice Test or Official Test.

The national federations may also register a maximum of 10 new brevet judges in each discipline. For these new judges, a new profile will need to be created in the Sport Database, and as soon as possible, while respecting the deadlines set out in the Test Schedule. The FIG will need to validate (as quickly as possible) these new judges before tests. The database will provide the online access information, login = their judge ID number and a password. This information will need to be sent to each judge SEPARATELY so each judge may access the Practice Test and Official Test. The login and password for the STS Educational platform will NOT give access to the Practice Test or Official Test.

### Special Information for RG and TRA new judges:

RG- The 10 new judges may be added for RGI and RGG respectively. That is 20 total (10 in each) or 10 that do both RGI and RGG, and any other combination to fill the positions.

TRA- The 10 new judges may be added in each of the 3 disciplines (TRA, DMT & TUM). That is 30 total (10 in each) or 10 that do TRA, DMT & TUM, and any other combination to fill the slots.

A TRA or RG brevet judge from 2017-2021, with only a brevet in one of the disciplines, does not count as a new judge and may certify a brevet in any of the missing disciplines for the purposes of new registration quotas. For example, an RGI brevet judge from 2017-2021, can now certify as RGI and RGG and not count as a new RGG judge for the purposes of registration quotas.

Returning judges, judges that did not have a brevet in the 2017-2021 cycle, do not count towards your new judge quota (10 new per discipline).

### THE TESTS

#### For Login Access to the Test platform (Practice Test & Official Test):

For candidates there are two stages for the STS Tests system:

- 1) Practice Test
- 2) Official Test

#### Time and Line Deductions

Judges do not need to account for time and line deductions in their evaluations, except Parkour. In Parkour judges must keep the freestyle run time themselves and use it in their evaluation. It will not be shown on the test screen.

## Test Security

Every judge has their own specific login. The Official Test will use the same test set for all judges in a specific time zone (i.e. Western Europe). However, each time zone/test time will have a different set of routines (runs PK). All candidates in a time zone/test time will have the apparatus/categories and routines within them randomized to prevent candidate judges from collaborating. This is the reason why all candidates in a time zone take the test at the same time. It is conceivable that 10 judges in the same room will be judging different routines (runs PK) at any specific moment of the test.

### Practice Test (at <https://ststests.com>)

Approximately one week before each Official Test, candidates will have the opportunity to enter the STS Tests platform to practice and prepare for the Official Test. This test is to familiarize candidates with the login, video display quality and data entry input for their discipline. The goal is to have all candidates in a respective time zone for their specific test on the STS Tests platform to test their hardware and connection, and at the same time, allow STS to confirm all their systems are working optimally.

All candidates should login 10-15 minutes before their sessions. The login credentials will only become active a few hours before the scheduled Practice Test. This test is just a sample to get familiar with the input screens. No answers or results will be shown. The Practice Test can be completed in approximately 30 minutes to one hour depending on the discipline.

Once the Practice Test is over, candidates will have access to [this test](#) and may repeat taking it as many times as they like for 72 hours after their original Practice Test date (shown on the Judges' Tests Final Schedule in these Directives). If a judge is unable to access the practice session or has connection issues, they should contact STS and the FIG office through [testsupport@fig.sport](mailto:testsupport@fig.sport). Federations may use this email to ask other technical (IT, website) support questions as well.

Note: No reminder will be sent by FIG with judge login information. Logins are available for each candidate judge through each NF's online database. A reminder was only given for PK because it was the first Practice Test.

### Official Test (at <https://ststests.com>)

All candidates should login 10-15 minutes before their sessions. More information about this Test can be found in the "Test Instructions" for each discipline, available on the STS Study platform (when available) at <https://stsstudy.com/> under "Info" and the FIG website <https://www.gymnastics.sport/> under "Judging" and "2022 Judging Tests" and "Test Instructions". One important feature to mention is the "Submit" button. Candidates have two choices when they complete their input: 1) hit the submit button and immediately move to the next routine or 2) wait until time expires and anything entered will be automatically captured as their result. If a judge or NF has any problem, they should contact STS and the FIG office through [testsupport@fig.sport](mailto:testsupport@fig.sport).

### Official Test Security

Every judge has their own specific login. The Official Test will use the same test set for all judges in a specific time zone (i.e. Western Europe). However, each time zone/test time will have a different set of routines (runs PK). All candidates in a time zone/test time will have the apparatus/categories and routines within them randomized to prevent candidate judges from collaborating. This is the reason

why all candidates in a time zone take the test at the same time. It is conceivable that 10 judges in the same room will be judging different routines (runs PK) at any specific moment of the test.

### Final Candidate Results

Results will be administered on a 'pass/fail' basis. Final results will be sent to each NF once rechecked by the FIG office and confirmed by the respective TC President. [The results of these online tests will not be used for any judges' selection/ranking by FIG during the cycle.](#)
