Clothing & Advertising	Clothing and advertising will be permitted in accordance with the competition regulations of Badminton World Federation.(GCR 20 - 24)						
	The player's name on the back of clothing shall be identical with the name registered as the Last Name (or an abbreviation thereof) in the BWF Player database. Last Name is defined as the family name, surname or similar name under the respective naming protocol of the Member count. (GCR 23.3)						
	MANDATORY CLOTHING REGULATIONS 1. Name of player is MANDATORY from the first day of the event. 2. From Quarter Finals onwards, doubles partners must wear clothing of the same color. 3. From Quarter Finals onwards, opposing players must wear clothing of significantly different colors.						
On Court Doctor	On Court Doctor will be on duty throughout the competition at the tournament Venue.						
	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.						
Doping Control	Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
