CURRENT RESIDENTIAL WATER/SEWER RATE COMPARISON

Following is a comparison of residential (inside City) water/sewer billings for Metro Jackson cities as of **July 2023 or as noted**, assumes residential water usage of **5,400 gallons per month**.

Jackson (June 2023) (No Regional Charge)

(Service Charge \$11.55) + (Water \$3.85/ccf or \$5.15/1,000)

+ (Sewer \$5.36/ccf or \$7.17/1,000) **\$78.08**

Notes: Jackson does not include the Service charge if usage is less than 300 CF (2,244 gallons). Jackson has a "summer sewer credit" covering 5 months per year and is given to any residential customer that uses more than 300 CF/month. This is costing the City probably more than \$0.5M per year. This sewer credit should not apply until usage is 1600 CF (12,000±) or more.

Brandon (Current Rate June 2023)

+ (Regional Sewer \$6.40/1,000) **\$87.97**

Brandon bills for every metered gallon.

(Water \$12.24 Min + \$4.09/ccf or \$5.47/1,000 over 2,992) + (Sewer \$5.69 Min + \$1.94/ccf or \$2.60/1,000 over 2,992) + (Regional Sewer \$5.28/ccf or **\$7.06**/1,000) **\$75.48**

Flowood (Jan 2023)

(Water \$9.32 Min + \$0.90/1,000 over 3,500) + (Sewer \$15.92 Min + \$1.34/1,000 over 3,500) + (Regional Sewer \$4.00/1000) **\$51.10**

PRVWSD (October 2022)

(Water 14.00 Min + 5.50/1,000 over 3,000) + (Sewer <math>16.00 Min + 7.50/1,000 over 3,000) + (Regional Sewer <math>4.25/1,000 = 84.15

Clinton not included as they do not have a regional sewer charge.

Brandon, Flowood, Pearl and PRVWSD added a regional charge in the last few years to cover the West Rankin Utility Authority costs, including the treatment plant that went online in early 2022.
